Approval of Expenditure by Education Department and Rescinding Resolution # 08-0416-103

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under the Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and
- WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, # 01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the *Purchasing and Procurement Regulations*, #R100-01:AC-01, have been approved by the Tribal Ogema and Tribal Council which directs that authorization of expenditures in excess of \$10,000.00 must be made by the Tribal Council; and

- WHEREAS, the Education_ Department has budgeted \$80,000.00 for the purpose of purchasing computers for the Higher Education and 11th/12th Grade computer programs; and
- WHEREAS, the MIS Department moved \$4000 from its budget into the Education Department Budget for the purpose of supplementing the cost of software; and
- WHEREAS, the previous Resolution # 08-0416-103 did not include the additional MIS supplemental funding of \$4000; and
- WHEREAS, the Tribal Council has received a request for approval of the above expenditure;

NOW THEREFORE IT IS RESOLVED THAT Resolution # 08-0416-103 is rescinded and replaced by this resolution in which the Tribal Council of the Little River Band of Ottawa Indians hereby approves the expenditure of budgeted funds in the amount of \$84,494.00, as identified by Purchase Requisition #.
