# OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on August 21, 2024. Following are the minutes of that meeting.

Speaker Burmeister: Good morning, everyone. We are here this morning for our regular scheduled Tribal Council meeting, Wednesday, August the 21st, 2024. I have asked Councilor Wolfe if she will say the prayer, so if you're able to stand, please stand. Thank you.

# I. Opening Prayer

Councilor Wolfe: (speaking Anishinaabe) Uhm I was taught by my elders uhm to always say, it's gonna be a really short one. I don't want to take too much time, so if you know, you know. Uhm first, I want to send out prayers to those in grief, lost, hurting, or who feel alone, who are in a fog, or just need some love from Giizhemanidoo. Uhm lost a few Tribal members recently, so just want to think about those and their loved ones. Miigwech Giizhemanidoo, Miigwech to Nokomis and Mishomis, Miigwech to all the old ancient ones, the sacred animals and birds, guides, teachers, healers, helpers, our traditional healers, protectors, warriors, giants, stone people, and the good spirits of love who speak the absolute truth. I'm asking to send nothing but pure, unconditional love through everyone's whole being, to flush out all the darkness, neutralize it, bless it, purify it, and fill each person with gratitude. I ask Giizhemanidoo to give everyone their own mind, sight, and gifts back. I'm asking for the removal of blocks to our brains, minds, and thoughts, reestablish our connection to Giizhemanidoo, so that everyone has a clear mind, healthy brain, healthy thoughts, and see the absolute truth, and have a clear and powerful connection to the great mystery. Many of us helpers are getting attacked and blocked through our finances. I'm asking that all blocks be disintegrated and replaced with a beautiful flow of abundance and finances right through our whole being, to feel our spirits head-to-toe with abundances and finances. I'm also asking that abundance of blessings and finances be sent to each one who needs it, to keep each person going so they can keep helping themselves and all the people in a good way. Everything that I'm asking for is with gentle guidance and the highest good of each, and that pure love and pure healing energy fills our whole beings, our homes, our lands, our vehicles, so that we all can be spiritually safe, prosperous, and moving forward in life with ease, grace, clarity, and great pleasure. Chi-Miigwech Giizhemanidoo. I love you. We love you. I honor you. We love you. I respect you. We respect you. I believe in all of you. We

Councilor Wolfe: We're self-governance. That means we get to allocate where our dollars go. It wasn't awarded to the court. Is there more clarification?

Kathleen Bowers: Well, if you look at the paperwork, it says Tribal Courts Program. Program funds for the Tribal Courts Program base increase. It's a one-time distribution of funds.

Councilor Wolfe has brought this item forward. So, Councilor Wolfe, the floor is yours.

Councilor Wolfe: Thank you. Uhm so, this is a resolution that's imposing restriction on all funding of the tribe from being utilized, dedicated, or expended from for the Muskegon Gaming proposal. Tribal Council is acting to preserve and protect the highest standards of fiscal responsibility in order to inspire public confidence and trust. Um the reasons why this is being brought forward by me um the Ogema's failure to manage the

economic affairs enterprises property both real and personal and other interests of the tribe consistent with ordinance resolutions enacted by Tribal Council has caused an unstable economic climate of the tribe. The Tribal Ogema has constantly engaged in actions what upsurge Tribal Council's constitutional duty to manage any funds within exclusive control of the tribe whereas fiscal year 2024 operating budget has a significant shortfall of 4.2 million dollars which has been allocated from the general fund. Whereas fiscal year 2024 casino distributions are less than projected and there's an uncertainty of gaming distribution. Whereas the monthly financial reports are not current we only have its August we've only received through March. We have April that's been um postponed twice for us to receive that report. Whereas fiscal year 2025 budget drafts have been asked to be submitted with a 10 percent reduction from the fiscal year 2024 budget and then on August 1st in the 2025 annual budget hearing presented to tribal members the proposed budget by the Ogema contains a significant deficit of \$3,104,499. Whereas Tribal Council finds adoption of this resolution and content contents contained herein will provide for the public health peace, morals, education and general welfare of the Little River Band and its members. Um so it's restricting any tribal funding from being utilized, dedicated or expended for the Muskegon gaming proposal and it will remain in full force in effect until such time Tribal Council repeals modifies or replaces this resolution.

Speaker Burmeister: thank you. Um will there be any councilors that are going to abstain from this item? any councilors with questions? tribal citizens? I see we have a citizen that has her hand up go ahead Kim.

Kim McClellan: Julie, I thank you for bringing this forward this is very important um to our tribe and this should have been happening quite a long time ago thank you.

Speaker Burmeister: thank you any other citizens? go ahead Lee.

Lee McCaslin: yeah, I'm in way supportive of this because it's at a risk and the position that it's holding so at risk um we've risked a lot of things in our lifetimes and uh one of those things are are exactly what this is laid out to be an at risk so that's what I wanted to share there.

Speaker Burmeister: thank you go ahead Ogema Romanelli

Ogema Romanelli: thank you I saw this come up on the agenda I have to say that much of what councilor Wolfe has put forward is incorrect and the courts have ruled uh that have that state very much against what is uh being proposed but again I turn it over to the council to vote it up or down thank you.

Speaker Burmeister: k. Thank you go ahead councilor Wolfe.

Councilor Wolfe: Just to clarify none of the whereas is what I read are incorrect those are all accurate information, and this is to create transparent public confidence and trust in your tribal council all of those are facts thank you.

Speaker Burmeister: thank you next in the queue is councilor Crampton go ahead please.

Councilor Crampton: Yeah, everything that uh councilor Wolfe has stated is fact roma Mr. Romanelli has a problem with the truth. A few weeks ago, I asked him in front of the membership where the six million dollars was in escrow, and I needed those numbers he said he would have them to me that day. We have still yet to receive them. I was lied to by him. I was lied to by Dawn McGrady three times about the same subject. So, councilor Wolfe forgot to mention there's six million dollars missing and Mr. Romanelli talking about the court their court ruling stands until I think you all learned that just recently until council put something in place. So this was overriding ruling because there's nothing in place now so there's no ruling that could affect it but he is absolutely a liar and if you want to look back three weeks ago um you'll see the video where I asked him for the escrow numbers he said you'll have them today. We have yet to receive them that's a liar. Thank you.

Speaker Burmeister: Councilor Crampton can you just state the fact without keep saying a liar, liar just state.

Councilor Crampton: no, I can't because he lied.

Speaker Burmeister: well just please state the facts. okay um are you finished?

Councilor Crampton: He was okay he was untruthful, thank you there you go.

Speaker Burmeister: okay we are moving on to go ahead Kim.

Kim McClellan: These are questions uh for Mr. Larry Romanelli. What is incorrect about what Julie stated? and then.

Ogema Romanelli: Want me to.

Speaker Burmeister: Go ahead

Kim McClellan: And then. oh yeah, he can answer it and then I got another.

Speaker Burmeister: Oh, go ahead Kim why don't you um

Kim McClellan: Finish.

Speaker Burmeister: you can finish your questions.

Kim McClellan: okay and the other thing is is um to Mr. Romanelli how much money that's coming from the casino I don't understand how you can run the government on just \$30,000 that we received, and the budget hearing was truly sad for our tribe. Thank you.

Speaker Burmeister: Okay go-ahead Ogema.

Ogema Romanelli: I didn't understand part of the last part something about \$30,000 running the government maybe I heard it wrong.

Speaker Burmeister: No Kim could you restate that please?

Kim McClellan: with the money coming from the uh casino there was only 30,000 that was uh given to the government side. I don't understand how you can run a government on just little dollars even if it was that low amount that a lot of these um departments are run by the tribal dollars not um grants. So I'm not sure how the money is coming forward to run these departments and the people that are you know like the cost of living that you just gave out and different things within the tribe is a lot of money

Ogema Romanelli: Oh, I think I can answer that. I think what she's talking about with the \$30,000 was what came across during uh the early months of this year I may be wrong, but I think that's what she's talking about. Every year we are very aware of the uh money that comes in from the casino in our worst months it's usually in the snow time snow period and those numbers are very low. We already calculate as best we can understanding that any revenue from the government from the resort is an estimate. We don't go off from the follow the previous year, we have to go on an estimated average uh to date. I believe we're above average for this year. Uh so I I don't know what the first part of her question was. Now I kind of missed it but okay. I guess what was what was wrong with what was stated by councilor Wolfe. The issue we have here is that up till now we've had revenue that comes from the resort based off from the brick and mortar. Several years ago four or five years ago online gaming came into effect that did kind of uh take some from the brick and mortar and so now we have to look at both of those as revenue from the resort. What we do with our revenue allocation plan is is allocated is the money from the machines coming over is what we have to give to the government. We now have this other thing which is the 14 million dollars that's been collected over those four or five years that comes in over as revenue is and that's been held into a special fund that is revenue that in part takes from the brick and mortar and we as you know gave out the 14 million. Council gave out the 14 million, make sure. um that gave out the 14. Okay. That 14 million dollars was revenue from the resort. What happens here is that that 14 million dollars and I think it was stated in the meeting. I think it was June 26th where council gave it out. I asked that they not give out the 14 million dollars if they were to prove it to take 2-4 million dollars and put it back into our programs for funding. What we're talking about with what uh Miss Hinmon brought up earlier is a lack of funding in the departments we're having it within other departments too. You cannot keep the same rate of income coming in and we're doing everything we can to keep that up while employee costs go up and and employee costs go up and the cost of goods go up. So there's every need we have to uh help out the departments with extra funding I think it should have come from the online gaming in part. When you give out that revenue the revenue the other revenue is 50% to the tribal members and 50% into the government. When you give out the total 14 million dollars that's not 50% that's 100% and that will do

nothing but keep us in a financial bad position in my opinion, so I hope that clarifies part of it anyway thank you.

Kim McClellan: Thank you.

Speaker Burmeister: Um Kim does that um answer your questions?

Kim McClellan: yes, thank you.

Speaker Burmeister: okay thank you moving down um next person in the queue is Sara go ahead please.

Sara Agosa: well, I have several concerns first of all I'd like to back up to the financial report. The February 2024 financial report which states in part during the month of February the tribe received a distribution of 29,390 from the casino for January activity which is 670,000 roundabout less than the 700,000 budgeted. For February 2023 the tribe received 462,000 in distribution for activity from January 2023. So, I would like to know why the drop in distribution also I have concerns with the statements Mr. Romanelli made in the budget hearing and I've tried to get clarification from tribal council I know that the budget is being formulated however my questions can be answered just based on these financial reports. Additionally, Mr. Romanelli continues to refer to the online gaming tax reimbursement which is separate from our online gaming still we have not obtained answers where is our online gaming money where is it and where is it in the financial reports if it's being flowed through to the tribal government. Additionally, Mr. Romanelli continues to say that online gaming is taking away from our brick and mortar casino then why does he continue to push for another brick and mortar casino in Muskegon which was brought up in the budget hearing it actually it absolutely makes no sense and I would just like to convey to tribal council especially the five on council who often vote in a way that is not in the best interest of our tribe overall that you are responsible for our fiscal management and to cast your votes with the utmost integrity and ethics and to always think about the welfare and well-being of our tribal members and that just isn't happening those are my comments thank you.

Speaker Burmeister: thank you next in the queue is councilor Crampton.

Councilor Crampton: yeah, I just like to clear up some of the untruths that were told by Mr. Romanelli. Uhm first of all the 14 million is not part of the um gaming proceeds that is through a state compact that's not federal, so it doesn't follow the casino. I don't know how they're um saying that that applies IGRA applies, when there's been a case in Florida proving that it does not, and our own lawyers have told us it does not so he keeps lying to the members and telling them about the 14 million. That was not part of IGRA which is not part of our um casino income but the online gaming. He's taking and he's distributing it out to different parts, so you guys don't understand he's sitting here saying about the distribution he's also running the casino he's not just sitting here waiting for the casino to give it he's the one causing the problems over at the casino and then complaining about the money that's coming across. IGRA does not apply to the online

gaming so that was a lie and the 14 million dollars that he keeps mentioning was not part of the gaming proceeds that comes from a state compact with the governor Gretchen Whitmer so I don't know how dishonest you can get but I mean it's getting bad. Now the six million dollars that I'm talking about the council is fully aware of that puts our casino in jeopardy. We could lose our compact and I like I said I've been lied to by Dawn McGrady three times, and I've been lied to Mr. Romanelli on tape in front of you guys. There is something seriously wrong here every time I've said something economic it's proved right, I'm telling you I am concerned this guy is a bum thank you.

Speaker Burmeister: Chuck you are next in the queue. Could you come to the podium so we can hear you Chuck thank you.

Chuck Fisher: thanks, uh Chuck Fisher 1297. Uhm well there are several things uh basically I'm going to begin by uh addressing the statements by both Shannon and uh Sara which were off the point uh what we're talking about is uh postponing.

Councilor Wolfe: No, we are not postponing.

Chuck Fisher: uh or imposing restrictions on all funding of the tribe uh dedicated to trying to move the uh Muskegon uh gaming proposal forward so uh from from being from a generous perspective uh you could say that you know some of these background issues that were brought up uh in an unprofessional manner so to speak uh were uh do have some bearing on the outcome of this. Uh we've heard several people talk about uh you know, how how and why they're in favor of this and uh I would like to say that we have been on this journey for a long time. We have a lot invested in it. We have a lot of money invested in it, we have a lot of time invested in it, we have a lot of future prospects invested in this to shut this down now uh on the is is to close that door it's to close the door on those possibilities. So, uh I don't know I don't know what else to say. I think this would be premature I think it does have a place a little further on down the line as far as I understand this is still in play. I know there's a lot of people who don't think it's going to happen uh but uh Larry has a meeting on Saturday that'll you know uh help clarify all this. I'm going to ask the council to uh postpone this until uh we have a more concrete more concrete information uh regarding the uh disposition of that possibility which is really important to the tribe and its future, and the future of the citizens as well thank you.

Speaker Burmeister: Thank you. I wrote you down Matt. Okay first of all we have two citizens that have joined us so I would like to them to identify themselves. First one is Salli Wabsis could you please identify yourself?

Salli Wabsis: Good morning Salli Wabsis 3449 thank you.

Speaker Burmeister: Good morning thank you. Chelsea Densmore could you please identify yourself?

Chelsea Densmore: Yep Chelsea Densmore 3225.

Speaker Burmeister: Thank you okay next in the queue is Councilor Wolfe go ahead please.

Councilor Wolfe: Thank you. So, the first thing nothing in this resolution that I said is wrong or misleading. We're looking at the unstable economic climate of the tribe I understand that everyone there actually is no Muskegon gaming proposal on the table then other than in February when this body passed the resolution to submit a new application to take the land in trust for gaming, we don't even have that. We cannot build a casino on land that does not have land in trust for gaming our compact does not allow for two facilities one reason we haven't expanded to intern casino because they're not connected that would be two facilities. We don't have a compact amendment on the table there's there's state legislature that says no more gaming in the state of Michigan the governor did not concur when the DOI gave us the go-ahead. I don't know where you think that there's more or where people are getting mis confused or not understanding there's no possibility of a Muskegon casino. Yes, in my heart everything I would vote I want a Muskegon casino I want to see our people prosperous but the reality and the facial facts of it we don't have any more money to invest in this when it's not gonna happen it's not viable. We've heard that we know from legislature that it's not possible. Yes, our lobbyist said Hey we want to make a bunch more money submit another application we're on a fast track that's what happened in February August not one update is that a fast track six months a fast track for anybody not one update on our application. So where are we going with this? This is to protect the financial assets of the tribe transparency put confidence back in your legislators that have the financial responsibility it's in the constitution who has fiscal responsibility the management of the economic affairs the enterprises all has gone down nothing has been profitable under the rule of this Ogema. 4.2 million dollars last year asking for another 3.1 that's 7.5 in two years out of all the money we've saved in the last 20 is spent and out the door just by projections he said we're very aware of what happens in January. Why did you budget it seven hundred thousand dollars over if you know only thirty thousand is what you average you're playing with numbers you're playing with membership the 14 million dollars everyone has already addressed that absolutely correct that is state tax reimbursement money to the tribe that's the citizens money it was restricted for land purchases we see the economic hardships we see the rise in inflation that's why we decide to disperse a stimulus to the membership to help our people we know everyone the Ogema says it himself you're paying more for a loaf of bread you're paying more for milk we gave our employees a three percent raise that stimulus that was our membership's three percent raise they needed that they deserve that none of that's incorrect and that money was restricted for something out so it wasn't going to help the budget it wasn't earmarked for programs. No programs have been brought forward by the executive for those people most in need we've had members assistance with the same program since they were created in what 2004? not even an increase in the dollar amounts for those \$400 doesn't fix a car anymore you lucky if you get one tire for \$400 if you qualify some people don't qualify because they make \$10 too much for the federal poverty guidelines. None none of what I said in here this is to make this tribe stable again to reduce that unstable economic climate of the tribe there's a lot of funding going out there's a lot of

mismanagement. We have uncertainty of gaming distribution we hear it said every time online gaming's clobbering our brick and mortar and we still have renovations that we need over there we still need roof we still need parking lot re-asphalt all those have to come out of somewhere and two years in a row huge amounts we're dipping in our reserves we're dipping in our coffers 7.3 million dollars in two years out of our coffers. That's why I'm bringing this forward this Muskegon gaming proposal yes it's a want it's a wish pipe dream of the tribe it's not a it's not going to happen if we can get back on track and in two to three years where we're doing successful this over here start a 1,000 aliens come and start spending their money at the casino and we make a bunch more money we can go back and re-look at this. This is just for now in the and we make a bunch more money we can go back and re-look at this. This is just for now in the immediate to get us back right-sided that we're not spending all our reserves we don't have grant writers we can't even draw in money for that we're not generating enough income to make this sustainable this is just a temporary this is not forever but right now there's no possibility of a Muskegon gaming proposal a casino getting authorized by the DOI the BIA or the governors plus how do we know the next governor that's going to elect is going to be on board we had three governors that supported it. We didn't get through this is this is not a permanent. Right here my last now therefore it's finally resolved this resolution will remain in full force and effect until such time tribal council repeals modifies or replaces this resolution. The end of the year maybe things will be different maybe next January we won't have so much snow and we'll do we'll get our projected 700,000 distribution not 30k not 30k for February we can look at it again then this is for the last quarter of the year to restrict that money and keep it in our banks keep it in our coffers that's all I have thank you

Speaker Burmeister: Thank you we have quite the line here, so everybody please be patient um councilor Metzger you are next in the queue.

Councilor Metzger: Uh thank you ma'am uh I was going to make a motion but I see there's a lot of hands up, so I'd like to defer back to the to the general uh tribal membership thank you.

Speaker Burmeister: Okay thank you. Recorder Johnson you are next in the queue go ahead please.

Recorder Johnson: Um so I get what's being said and I understand that but I just have one question and in looking at and thinking about it um there's one thing that I I guess that hasn't actually been said or answered, but how much money has actually been spent since February on this particular item? That's what I need to know. What is the actual dollar amount and I think for public consumption that needs to be stated. What is the dollar amount that has been spent since February? That's it thank you.

Ogema Romanelli: nope

Speaker Burmeister: thank you.

Councilor Wolfe: no transparency the Ogema cannot answer and Pam can't answer the seated councilor she's never requested that before there is.

Speaker Burmeister: Councilor Wolfe you weren't in the queue.

Councilor Wolfe: with I can respond was the question to me Pam?

Speaker Burmeister: I didn't no she didn't say it she said it was an open question.

Councilor Wolfe: Put me in the queue I will respond.

Speaker Burmeister: I will do that okay I have you in the queue Ogema also.

Ogema Romanelli: Thank you.

Speaker Burmeister: Um councilor Crampton you are next in the queue go ahead.

Councilor Crampton: Yeah, I just wanted to address the unprofessional comments of Mr. Fisher I understand that his allegiance and everything, but this is the membership they need to know we can't keep lying to them like

Councilor Crampton: Mr. Fisher said that about me.

Speaker Burmeister: I'm interrupting him because he's being very disrespectful.

Councilor Crampton: He Mr. Fisher said it about me I know I know that you have a bias, but do you have to be quiet when I'm in the queue now he is all.

Chuck Fisher: What about your bias?

Speaker Burmeister: Chuck you're not in the queue. I can

Councilor Crampton: um he stated.

Speaker Burmeister: I know but I can put you in the queue I'm work if.

Councilor Crampton: Mrs. Speaker okay this is my time.

Speaker Burmeister: Without insulting I'm gonna councilor Crampton are you going to speak without insulting?

Councilor Crampton: Speaker it's my time in the queue.

Speaker Burmeister: Crampton, councilor Crampton.

Councilor Crampton: you don't have you cannot this freedom of speech.

Speaker Burmeister: I know but don't insult.

Councilor Crampton: This is listen he insulted me I'm just giving it back to him so you

did not warn him

Speaker Burmeister: Okay!

Councilor Crampton: now stop what you're doing your bias. Now what I'm talking about is councilor Wolfe is absolutely correct, council has all the information there is no agreement in place. What we have is the governor said no in February and January or February um the five council members elected it right before the membership meeting. So Mr. Romanelli could state that we're still active which is not if you read the warning all it is, is doing begging the interior and they won't even look at it because there's been no waiver from the government you need a waiver from the governor each time it isn't standing for the full time so no what we have is another dog and pony show just like Saturday. Everything Mr. Romanelli is doing is running this tribe into the ground have you guys' council sits there and looks at it all the time and discusses it. You guys know that he's just running this place into the ground, and he hides things from the membership. We have that gaming capital group he's trying to hide closed we asked that they give a presentation the membership they refuse because they know how.

Speaker Burmeister: We're getting off topic because here this is public comment type things so

Councilor Crampton: no, it isn't we're talking about his management.

Speaker Burmeister: I'm going to move along which is Sara please keep it to the point that we are discussing go ahead Sara.

Councilor Crampton: you are the worst speaker ever.

Sara Agosa: Speaker Burmeister I'd like to request how you maintain meeting decorum because when another member chastises my comment or any any other tribal members comment. Please call a point of order, being truthful and honest isn't being unprofessional and confronting our elected officials to be accountable isn't unprofessional we're seriously on a sinking ship, does the tribe really need to go down in order for members to wake up.

Councilor Crampton: This is the Manistee 500 Bumbs like Tammy

Sara Agosa: Thank you that is my comment.

Speaker Burmeister: Okay our attorney Carrie Frias has joined so Carrie could you please identify yourself.

Carrie Firas: Yes, Carrie Frias attorney

Speaker Burmeister: Thank you next in the queue is councilor Wittenberg go ahead.

Councilor Wittenberg: yeah, uh I'm just going by uh concerning uh new business uh A and to me and restricting I am for it turn around when we turn around and when when and if it does that this uh, we got a shot at it, and it's a more positive and then just everything else and what our compact says. That uh I'm all for it and you can bet and you can believe when that day happens that this nation this tribe a Little River Band of Ottawa Indian will come up with the money you can bet that, and so that's where I'm from and also if that happened before that compact let the members know and read into it that we Little River Band of Ottawa Indians we get to share with the rest of the tribes of uh Michigan. I don't know how many have read it or not or anything like that but if that would happen we'll probably get less than what we're getting across the street, but we're the one they're going to be paying the bill to turn around and have that turned around and built down there so the rest of tribes can turn around and we dish them out the money, that's what it says the way I read it in the compact so yes the things need to be changed and it does say about off-reservation gambling look into it read it see what it's uh actually says and uh and then bring it forward to see in your view of it because we all have different views and as you can see we will always have different views uh that's that's my opinion Miigwech.

Speaker Burmeister: Thank you Matt Chandler I have you next in the queue.

Matt Chandler: Matthew Chandler (Anishinaabemowin) 1687. What um I kind of like looking at the opposite of things and so if uh someone can explain to me if this doesn't pass what is the repercussions of it? what what is the route that we're going that you perceive and causing this action and I think if we can explain what happens if this doesn't pass it may be may make a little bit more sense to those of us that we keep on hearing you know this happened this happened this happened in the past but what is the projection in the future if this doesn't pass Miigwech.

Speaker Burmeister: Thank you, okay next in the queue is Kim go ahead please.

Kim McClellan: I forgot to lower my hand I'm so sorry.

Speaker Burmeister: Thank you Ogema Romanelli you are next in the queue go ahead please.

Ogema Romanelli: thank you. Uh to answer councilor Johnson's uh question uh there is no clear way to understand how much money has been spent, very little has been spent on

the Muskegon project as we know we co-pay uh for services from our attorneys and from our lobbyists they work for both branches of the government on different issues. So, it's unclear how to project how much has been spent on the Muskegon project uh since February. I about the I would just heard again from councilor Wolfe that this project is not going to happen clearly stating this project will not happen. We've had councilor Crampton state the project is dead we've heard it repeatedly over the last year, year and a half. I can tell you very clearly that is not true the project is not dead. So, when we have elected officials from Little River stating that the project is dead it only hurts to sink that ship and I keep cautioning. Please don't do that. I met with the BIA last week or two weeks ago, I can't remember in Green Bay. I have communications that show that it's an ongoing project from those people that we hire both legislative and executive of the work that we're doing most of this cannot be brought forward. Can I assure this tribe that that casino is going to happen. I cannot never could never have said that it's a sure bet we've invested a lot of money and a lot of time but to continually say from our elected officials that the project is not going to happen and that is dead only hurts our efforts. Now I'm having a meeting on Saturday which was brought up I'm asking you you said that you said that the legislature has not or as. Can I please speak? I know but I can't I can hear that. My apologies but so it was said that the legislature will not approve it uh I want to see that document where the legislature absolutely said they will not approve it because we have not even gone to the legislature yet that would be for a three part or a class three gaming we haven't even got there yet so please show me the document where the legislature uh said they wouldn't approve it. Finally we have Sara Agosa that stated that the way I'm running things is a sinking ship it continues to sink. I just got the court back uh response whereas Sara Agosa and I believe Jolene O'Signac pardon me if I have the wrong O'Signac um yes sure I can but in in fact it is not a sinking ship as noted in that court I'll leave it at that thank you very much.

Speaker Burmeister: Thank you councilor Wolfe you're next in the queue.

Councilor Wolfe: It's a public law that the Ogema should be aware of. He's saying he has these meetings he has these things going on all those were at expense of the tribe. Hard to calculate when they're not recorded as that none of that updates have been given to tribal council of that gaming to trust application, no financial accountability from the Ogema has been given to tribal council. We're at August 21st and we only have financial reports through March that have been accepted, that is available to membership those are the unstable factors and things of the tribe why we're imposing this. No money needs to be expended to go move forward with the Muskegon casino proposal Muskegon gaming proposal however you want to call it at this time. Distribution what was projected from the casino for 2025, 20 million 222 dollars 204 dollars the budget brought by forward by the Ogema for 2025, 25 million 729 614 dollars. No grant writer since April some of that's not even real those numbers aren't there, we're not going to get those grant dollars in that one that's postponed today 70,000 dollars none of it is it that's all for a staff person, no services no uh supplies to have classes no supplies for prevention activities. Only salary wages and fringes and still going to need a supplement to cover those because of the three percent raise for that employee to make budget on that to pay her, her whole wage so we're just paying her for office work no outreach no

programming. There's other budgets available tribal dollars sure the casino distribution makes us for a 3.1 million 400 499 deficit that's why I'm imposing a restriction. That communication isn't clear we didn't know he was meeting with the BIA two weeks ago; did he have anyone from the legislative go and see and bring that information back to us if he didn't want to share. No. That's what we're doing we're protecting the assets of the tribe for the tribal membership bringing forward and imposing this restriction. There's nothing on the books I can say dead I can say it's not going to happen we all know we didn't get concurrence we all know we after that we put a resolution forward to take that land into trust for non-gaming. Guess what a car salesman does? guess what our lobbyists did? guess what our attorney did? We have another chance do it do it it's a fast track; hurry up we got to move on this. February dead in the water. We're not moving nowhere it's protecting the assets of the tribe it's protecting the tribal memberships money. This money ain't mine. I ain't trying to keep it from Larry if we could if we could have it every way we wanted. I'd give them a blank check, but reality is that's not going to help or benefit our people. We're saddling our next even if this moves forward we're saddling the next seven generations with 280 million dollars' worth of debt to build that facility and if it's managed like across the street and we get a distribution of 30,000 for January how are we going to make ends meet? how are we going to even make the payments? it was viable at one time 2012 yeah it was a support just like councilor Wittenberg said if it came to us and they said here's all your boxes are checked go ahead and do it. We do it you know what we did when the governor said no? The Ogema by himself illegally stopped our payment in lieu of taxes the 6 million dollars Crampton's talking about missing. We didn't pay that to the state. You think the state wants to work with us when we just took away all their funding? you think they're going to say go ahead and move Little River we believe in you. Plus, it's the governor's last term. We got to go lobby the governor all over again that's the reason this is in place. We know how much lobbying costs; we know what we're paying for. No accurate accounting because it's not specific. We sent three people to meet with the BIA partners in action; not one person from the legislative went. We didn't just send three people we sent the three highest paid people of the tribe to that conference. It's all kinds of things in here this is the financial instability climate what this is being brought forward that's what this proposal is for to change it to make this happen. We can't just keep putting our money down putting our money down putting our money down wishing and wishing. We all want to be prosperous. We all think fast money with the casino; there's other ventures out there we can invest in. We've been unsuccessful in a lot of our ventures this is another one that to date is unsuccessful Kern Valley, Diversity Network, Muschigon construction there's a list of them and guess what the end of the day we're not generating revenue. Our EDC doesn't have a dividend plan for the tribe. We've invested millions dollars in property. We don't have a grant writer to draw in and expand program and services. The other tribes are clobbering us because they're taking all the money because we're not applying for them. We just keep going with reoccurring we don't even check and see if our numbers that we're getting reoccurring that the BIA tells us are accurate to our population. Housing. Well, they told us it was 382 but it's not then Tara came back when after I asked that question yeah, we can get it bumped up, we can get more dollars. Those things aren't happening, that's the management we need to be focusing on get this tribe right-sided don't come to us don't present to membership a 3.1 million dollar deficit

and have no way to make it up and keep on asking for spending on the front the 14 million dollar tax team reimbursement that's directly for programs, nothing's been proposed about it except the one I proposed on his recommendation.

Catastrophic relief. When I presented it two weeks after he asked me to, he said I need six months before I can look at it, you wanted it, I wrote it. Gave it to you six months before you can give me a comment to date. I haven't received one comment. I moved it forward three weeks later said I'll give you two more weeks. Still working on it. Get in language all nine of us are comfortable with to get assistance to members to the most in need, to those people that have a house fire, to those people that get struck by natural disaster. Those where we need to prioritize our dollars and like I said this isn't for all the end of time. This doesn't say indefinitely it says until such time tribal council re-evaluates and looks at it that's our constitutional obligation. That's all this is about. I don't know we can go all over all day of what we want and don't want and wish and don't wish. Right now, there's nothing on the table but expense for the tribe to lobby for a Muskegon gaming proposal and at this time. We're not stable enough to continue down that road. That's my comment thank you.

Speaker Burmeister: Thank you. Chuck did you still want to be in the queue? okay you are next in the queue then.

Chuck Fisher: I'd like to uh thank you Julie for the detailed uh uh very detailed explanation uh that you gave related to this particular item. Uh for the most part and I know you have more information than I do uh that's a given you know. So, I I know that you know uh I'm you know kind of out of the loop on on all of this but uh and I agree with everything that you stated uh largely. The the uh I think I understood that too. Uh so I'm not sure that you know everybody that's you know uh listening or the council or you know uh understands what this is doing you know to the prospects of of actually actualizing uh the endeavor that this impacts and uh it doesn't sound like the Ogema and the council have met together; to you know try to you know come to a common a common understanding uh in terms of working you know through this in order to assure you know um the best outcome. Uh I continue to believe that you know in spite of everything that you said you know this is still uh premature and and closing the door on you know those possibilities as remote as they are. Which you know uh there there's not much in the way of indication you know from from what I know that you know this this is you know something that we can you know we can count on; but we've we've we've been betting on this for you know a long time. Uh and you know uh from my from my point of view I think we just need to continue to you know uh see this through uh the I understand the shortfalls. Uh maybe maybe that's just you know the effort could be continued with a you know less of a budget uh but just just dropping it uh uh the the if we just drop it the legislature the governor everything else you know that's that you know in case they come in line if we're not trying to push that forward. That's not going to happen either so uh that's just going to make this harder to uh realize so I'm saying just give it a chance thank you.

Speaker Burmeister: Thank you. Lee you are next in the queue go ahead please.

Lee McCaslin: Yeah, and I am a question uh you know I'm I'm looking at the risk that risk and my name is uh Gailey Crane at birth that's old business. You know and uh that old business of that name change and stuff like that. This is new business and I've always spoke about the health safety and the welfare of our people almost every time and the advanced appropriations that are being distributed that are in the wash you know by the executive branch. Um you know how much of those appropriations get washed over to our members that are uh living hand hand to mouth just barely enough to eat or feed. Um we all know uh incidents back there about that and uh you know it's not about pushing your vote that gma it's about riding your own boat and truly respect um the full council for the distribution that came in time of need. You know um but people are still living out there uh hand to mouth and the one percent back there that are ruling um because I'm just a share owner in this. I'm just a shareholder you know of something that was supposed to be really beautiful come together and old business has already taught me already shown me that that passed. You know right now this new business coming up is absolutely beautiful to take back that bill of rights and uh cross-reference that to our own tribal laws and I appreciate Julie much and all council that's coming together um to take care of more than just the one or two percent back there in Manistee. The the same properties as we all most of us had um provided for this opportunity to take care of ourselves. Um you know 21 years ago came to a fork in the road and uh it's it's there and it's not forgotten um with that I'm I'm totally in support of new business of this nature Miigwech.

Speaker Burmeister: Thank you. Next in the queue is councilor Crampton go ahead please.

Councilor Crampton: Thank you well I just wanted to point out to the membership that I've had hindsight it's 2020 so you might want to rewatch the video again the BIA does not approve a gaming site. That would be the department of the interior. So, I can I appreciate the Ogema meeting with the BIA that is not approval. There's nothing in Mrs. uh council Wolfe's uh resolution that doesn't say that we can't go back if Mr. Romanelli gets a yes and in fact, I mean I would I'll tell you all right now I will um back it up totally if he gets a yes, but the facts are that we have a no. There is no other answer than no. The governor has publicly stated she wants nothing to do with Little River. This is a first year or I'm sorry a second term issue if you note um this is for the membership's consumption because I know some of the people down there don't get this. Um every governor that's approved and back this up has done so in their second term because it's a hot button issue with the second with the other tribes what they want to do is they want to make the decision and then get out of office. They will not make the decision in the first term of office. This governor is a no-go. The next governor will not even touch it for four years; for four years when we had this up and running and we had the um what was it the shoreline task force? um when we went back and looked at the money that was supposed to be spent, we hadn't we have no way to trace that money because nobody followed anything. Mr. Romanelli and the Shoreline task force they were supposed to have meetings to release money and there's none of that. So, that was terrible mismanagement of that first effort terrible mismanagement. This needs to go in place because this is absolute that casino right now is absolutely dead, and I'll tell you why it's dead for all reasons I just told you. Plus, we need a new feasibility study. Mr. Romanelli is

absolutely scared to death of the feasibility study because what he's working off is one that was contemplated before online gaming any new feasibility study will tell you this is a loser from the get-go; it was a winner until online gaming came in. Now you're brick and mortar. That's all the people from the area that you can drive there. There's people sitting in Mexico right now that are probably gaming on Soaring Eagles at the Eagle and even the people in around the area; do they want to spend the extra 50 bucks to travel to a casino when they can go on an app that costs less than 1 million dollars? oh yeah and Sag Chip is uh gonna bring in a record amount this year they've already been publishing it uh that's off their app. So, I'd back this up totally if we have a feasibility study that says what it's not going to say any feasibility study right now will tell you. I don't know how Mr. Romanelli is selling you these used cars that he is but when he's telling you that we're taking a hit from online gaming across the street go back and watch the tape and what he said why would you want a brick and mortar? and those we need a new feasibility study because those costs of building and the cost of the loan and everything we're all based on old numbers. Now since with the economic crisis the building material has gone up labor has gone up everything's gone up. So, you're going to pay four times what we originally have for something that's not going to make any money because online gaming is going to chew it to pieces. The things that have been said here today are just so irrational from the executive it's you need to watch this tape back and people need to really sit down and think, and that house resolution is house resolution 42 it was passed to say no more off-site gaming. That's why all the rest of the tribes and their new compacts are asking for online gaming. So, it's house resolution 42 thank you.

Speaker Burmeister: Thank you councilor Metzger you are next in the queue.

Councilor Metzger: I would still like to make a motion. I'll make a motion to accept resolution 24-0821-146 imposing restriction on all funding and tribes from being utilized, dedicated, or expanded for the Muskegon gaming proposal.

Councilor Wolfe: support

Sara Agosa: I just need to respond to Mr. Romanelli's reference of a court order. That we have a chance to respond. That's my comment thank you.

Speaker Burmeister: Go ahead Ogema.

Ogema Romanelli: Okay thank you. Just I I think we spent a lot of time on this and as I suggested you know just voted up or down, I appreciate uh councilor Metzger bringing it to that point. A few things that I I need to cover and again uh these statements are made. Councilor Crampton just said that the governor wants nothing to do with little River Band of Ottawa Indians. That this will not happen future governor who we don't know. I'd like to see that in writing where the governor said that please because when you make a statement like that it's it's crucial. Also, said that the legislature will not approve Little River's uh interest I'd like to see that document. I'm not aware of either one of those. We talk about past investments whether it be the tribe out west or the call center or Muschigon those all happened before this Ogema, and it was stated by councilor Wolfe that the top three employees of the tribe top three paid employees of the tribe went to Green Bay and met with a BIA. Please provide that information to show that because I know that not to be correct. Thank you.

Speaker Burmeister: Thank you. Um actually councilor Wolfe you were I have you written down if you still have a comment.

Councilor Wolfe: So, one thing for clarification that was a conference BIA partners in action that was for tribal consultation again none of the legislator was invited. Why I say the top three paid of the tribe Ogema Romanelli, chief of staff, tribal manager those are the three that traveled there. Maybe they're not the highest paid but they're definitely not the three lowest paid. When we look at this resolution it is just now to bring back a financial economic climate to the tribe, stability for today. Budget season is coming September 15th we're going to get the proposed budget from the Ogema right now has a 3.1-million-dollar deficit projections from the casino, 20 million dollars for 2025 all those are factors. Who would do their personal finances like this? who would use their lifetime savings to go on a dream project that we have no concurrence, we have no agreement. We have a pending application, and you know why we have a pending application because at the bottom of our rejection letter it said if circumstances change. The tribe circumstances hasn't changed the state of Michigan's chances hasn't changed but we went after it again. We took another bite of the apple for what? to put the debt on the next seven generations a debt a huge debt and we're already dipping in our coffers 7.2 in the last two years it's a lot of ways we can generate revenue outside of a casino. We missed the bucket on cannabis. We missed the bucket every month on third party billing. We don't capture all our health care dollars. We don't capture all our housing dollars because we go with status quo. We go with the numbers that are there, when we do something, we do it that's how we've always done it. This is about bringing a positive change for the entire tribe. This is looking at my fiduciary responsibility, that's why I proposed this. There's one, two, three, four, five deficits that I clearly showed you where we're sitting in an uneconomic. It's unstable. No plan came forward and said hey we're going to bring in five grant writers. We try to get grant writers. We called them strategic

planners. 2021 voted down didn't happen. There's all kinds of things we can do to generate revenue, we're not doing it. I'm ready to move on the motion.

Speaker Burmeister: Councilor Crampton you are next and then we are going to take the vote on the motion that's on the floor. Go ahead please.

Councilor Crampton: Okay thank you. Uh yeah Mr. Romanelli set up a meeting with I think it was called the Charette group and then he left the room. Uh we were all sitting there when Mr. Charette told us the governor wants nothing to do with this so that's uh that's uh just one of the truths that I'm trying to get through the membership and councilor Wolfe brought up a very good um point and something that's been disturbing me greatly. Mr. Romanelli has not only turned in a deficit for the last years he's actually depleting our coffers what we've saved. He's mismanaged for two years, and he's done it so badly that now he's going after our savings. You guys this is not happening in any other tribe. That he would have been removed long time ago if there weren't five people on council, they agree with everything. You're about to learn some things about the last vote they took without a legal review that I don't think any you'll be surprised that it was that and talk about unprofessional. Then there's a couple other ones that you're going to learn too. Mrs. Wolfe is trying to save this tribe and I wholeheartedly agree and I'm telling you go back and look. You can all yell and and say what you want to say. Every time I've said economically it's been absolutely correct. Mr. Romanelli has nothing but hyperbole and lies. House resolution 42 the BIA does not approve compacts, the interior does. Six million dollars is missing. There's no escrow account. We're three million dollars in deficit this year, four million dollars last year. It'll be worse next year. You got a guy that's going on one end running the casino and then coming over here and complaining about how that is horrible you guys. Do you guys see the flim flam game that's being run. If you were absolutely if you knew anything about business and you like you said, we all know that that's our downtime you would be prepared for that. Maybe some layoffs heck no go back and look who all they were hiring and for what salaries and what benefits. That's horrible mismanagement horrible mismanaging. The fact that Mr. Romanelli does not even know that the 14 million dollars was not part of gaming revenue and can never be at the casino is another fact and members need to consider somebody that unknowledgeable of business should not be in that position and the fact that we are just we are into the ground folks. I thought I'd never say this he's running this tribe into the ground. Thank you.

**B.** Indian Health Services Funding Safety Grate-back-up Generator. Ogema Romanelli, Gary Lewis and Greg Walters have brought this item forward, so the floor is yours Gary.

Gary Lewis: Thank you everyone. So, this is to um this is initial stages of an MOA so normally we wouldn't actually be here but there's a dollar amount attached to this, and I didn't feel comfortable committing the tribe to cost share without having a resolution done prior to that. Um so generically we would just sign this, and this gets the ball rolling for IHS to come back with an actual MOA and costs and then there would be acceptance of funds but because there is a cost share in this one I brought it forward first before I actually signed it and so this is to install a safety grate and a backup generator for the housing um lift station. The cost is \$3,151 to us.

Speaker Burmeister: Thank you will there be any councilors that are going to abstain from this item? councilors with questions? Go ahead councilor Metzger.

Councilor Metzger: Thank you, madam speaker, uh yesterday I kind of caught that you have two buildings that are not residential that affects the cost and one of those buildings is the

Councilor Metzger: Housing maintenance.

Gary Lewis: Correct.

Councilor Metzger: Is that correct?

Gary Lewis: Correct.

Councilor Metzger: Isn't that part of the residential project?

Gary Lewis: No so they don't they don't they just consider it like the um the dwelling itself that's for occupancy for living so of the houses we have there they separated the pavilion and um the maintenance, maintenance garage itself because you can't live in there.

Councilor Metzger: So, the maintenance garage has its own lift station?

Gary Lewis: No that's it it feeds into the lift station from there but IHS as far as funding they only fund uh dollars for homes so because that's not a home that's not included and

so generically um, they won't fund anything. So, if the casino was part of this and the casino is 98% of our flow they would only fund that 2% so it'd be they would only fund 2% of the 135,000 and we'd have to come up with the rest but in this case there's only two dwellings that aren't homes if that makes sense, I hope I explained that good.

Councilor Metzger: Well, I'm trying to figure it out you know because it does it is tied in.

Gary Lewis: It is tied in yep so; the pavilion has a restroom in there as well and that goes to the lift station but for IHS funding they won't fund that because it's not an actual dwelling.

Councilor Metzger: All right thank you for that clarification, Gary.

Gary Lewis: In this case it's reversed 99% of the flow is from houses and the other 1% or whatever it comes out to is not from homes.

Councilor Metzger: Miigwech.

councilor Wolfe brought this item forward, so the floor is yours.

Councilor Wolfe: Thank you. So, this is for myself to attend the Indian gaming association mid-year conference and expo it's a place for leaders in the tribal gaming community. I'm going on behalf of the gaming commission as their liaison for tribal council. Um what it does is it offers learning networking and sharing ideas on the topics in gaming. I'm going to be taking commissioner training level three it is scheduled for Tulalip Washington September 16th through 18<sup>th</sup>. Um some of the topics there that I went over in the work session um seeds of sovereignty, cannabis in Washington I think that will help us we've defaulted on that because it's legally through state but illegal federal. So, if we see some of the processes other tribes are doing to implement that may be something we can look forward to, plenary note green energy and in Indian country, and plenary note on Wednesday integrating ai and gaming operations and then it has breakout sessions um for navigating state compact negotiations. We'll be up for compact

negotiations in 2024. Um again talking about cannabis solutions for tribes they have um leading the green energy movement opportunities for opportunities for tribes, innovation future innovations and emerging technologies um tribal casino and security um with data and IA enabled marketing overview and efficiency and security on player engagement. no one from the commission is able to attend the conference. So, I will be bringing that back and sharing with them the materials I receive out there and this is my uh travel dollars that are allocated in the budget for 2024 that I will be using. So, it'll be coming out of tribal council's budget and that's all I have.

So so no it's it's fine and why do I have to listen to the insults? I've been trying to be decent and to be above that it's very difficult but because I I'm a better person I guess, and I can sleep better, and everybody holds me to a higher standard amazing anyways.

Speaker Burmeister: Go ahead.

Councilor Metzger: thank you madam speaker. Uh council member Wolfe I find the action that that you're proposing very honorable and transparency. You know I can see the conflict that this council has at times amongst itself and to offer a no vote or an abstention is honor. I want to say Chi Miigwech to council member Wolfe.

money and one being me. In fact, it was the very first one to do so. I went down to Mrs. Gamelin and said how? we're getting this? and she said yes everybody who takes a trip gets the money that's left over, and I said that's not right, and I returned the money. She had a hard time finding a form to do it and I said what's the problem? she goes you're the first one to ever do it. So that's usually why councilors abstain thank you.

## B. Ogema Weekly Status and Business Update

Ogema Romanelli, the floor is yours. Thank you.

Ogema Romanelli: I just have one item. I want to announce that to the membership that I am having a meeting Saturday at 1pm. In this lodge room, it will be recorded, and zoom will be available for listening purposes only. Thank you.

Speaker Burmeister: Thank you. Go ahead, Councilor Metzger.

Councilor Metzger: Thank you, Madam Speaker. Excuse me, Ogema. What is the purpose of this meeting?

Ogema Romanelli: Yes, the purpose of this meeting is are there is a lot of information going around, whether it's on Facebook or within the government center or on the street that I would like to have clarified. I've invited others. You're welcome to come and let's produce documents behind the statements because a lot of times there's information going out without documentation. As I stated earlier, I'd like to see the document where the legislature has turned down our um Muskegon Casino project. I would like to see the statement where the governor said she does nothing, wants nothing to do with Little River. And I'd like to see this statement, the document that shows that the top three paid employees of the government went to Green Bay. For example, there is the ethnicity question on me that's been thrown around for 17 years uh that I am not tribal, and I would like to see the documentation and I will produce if they produce their documentation, I would absolutely produce mine. One thing I have to mention is the problem with when you say that, especially for the Ogema of a tribe, that that person is not Native American, you talk about creating ill will towards a tribe, that's what you do. We know that the 100% audit is coming up or trying to be brought up and passed. We know that a statement has been made by an elected official that says pretty much half of the tribe should be gone if we did the audit. Those are very, very damaging statements. I'm offering up myself to be the first one that you look at. Just bring the documentation and I will put that rumor to rest. The proper way to do it is to do a mistake of fact with the enrollment board, but apparently that's not the way these people like to deal with it. So just bring the documentation that's been carried around for 17 years and let's get through it. There are other major questions and concerns that are thrown out there and let's let the members see and let's speak face-to-face. That's what the reason is for the meeting.

Councilor Metzger: Miigwech.

Ogema Romanelli: Thank you.

Councilor Metzger: Thank you for the personal invite.

Speaker Burmeister: Thank you. Next in the queue is Councilor Crampton. Go ahead, please.

Councilor Crampton: Well, despite that, unless the members haven't been paying attention for the last 20 years, Mr. Romanelli does it before every election to try and throw shade on people he doesn't like. It's usually an informational meeting or something like that. There's nothing going to be hashed out. It's a dog and pony show. He stood on stage and said 100% audit, bring it, and then acted like he was terrified and fought against it as hard as he could. Just elect. Let's um do this. Let's pass the enrollment audit because other tribes don't have ah saying things about their Ogema because their Ogema doesn't fight an enrollment audit and five of its council members don't run like they're scared to death. That's what happens in other tribes. No, I won't be attending any dog and pony show that proves nothing or you're just your election campaign thing and it should be looked at as an election interference. He does this every time there's an election. He's fooling no one. He's mismanaged this thing into the ground. He's looking for an escape. Let's just do the enrollment audit. How about this, Mr. Romanelli? Uh let's do the enrollment audit. Me and you are the first ones. Me and you. Other than that, have fun Saturday.

Speaker Burmeister: Thank you. Go ahead, Sara.

Sara Agosa: In response, I'd just like to say that Mr. Romanelli controls the documentation. Additionally, information requests go unanswered. So how can we provide documentation if we can't even get our information requests fulfilled? In response to Mr. Romanelli's enrollment, if there's controversy around your enrollment, just show your documentation. There doesn't have to be a match. Just show it. Put the rumors to rest. That's what any other tribal chairperson would do. I'm really concerned about this meeting. In addition, I saw the announcement and it appears as though you will not allow us to interact in the meeting. You've shut us out, the majority of the tribe, once again. And it appears as though Zoom will not be utilized. And that's just absolutely not okay. That is not a proper meeting when over half of the tribe can't even interact. So, I don't think a lot of people really want to participate in this meeting. Thank you. That is my comment.

Speaker Burmeister: Thank you. Next in the queue is Lee. Go ahead please.

Lee McCaslin: Yeah, is that invitation open to the press? Um to the Ogema? Does that extend to the to the press coverage?

Councilor Wever: He said no.

Speaker Burmeister: Lee, I don't know, but he said no.

Lee McCaslin: Miigwech

Speaker Burmeister: Okay, go ahead, Councilor Crampton.

Councilor Crampton: Thank you. Yeah, um this is an obvious dog and pony show. How much is it going to cost the tribe to do Mr. Romanelli's campaign thing that he does every

Councilor Wolfe: Thank you. So first, I want to um talk about what the election board has announced the 2025 regular election that was announced on August 19, 2024. They did send an individual mailing out that was mailed from them. So it should be reaching all tribal members. Um if you have any questions, contact the election board. Also, another notice from the election board during the implementation of changes for voter registration and its regulations, it was brought to the election board's attention that there were areas that were not clear regarding regulatory requirements for registration. There is clarifying language adopted to address these concerns. Number one, voter registration enacted will not affect the October 2024 membership meeting. Citizens have until November 1 to register, which is clearly after the date of the membership meeting, but the board added language to clarify that this voter registration process will apply for the April 2025 membership meeting. Tribal ID expiration dates will not impact voter registration eligibility until July 2025. This language was added to clarify that any citizen that files a voter registration within the timeline will not be rejected for an expired tribal ID. The addition to the effective date provides citizens and enrollment department a full

year to update any expired tribal ID. The board added language up to 50 days prior to election as the filing deadline for any voter registration forms. This means the deadline to register for the primary regulation regular primary and regular elections is now November 1, 2024. If a citizen misses the November 1 deadline, they can still vote in the regular election by making sure to file their registration form by February 14, 2025. There will be no time left to fix a registration form that may need attention if the forms are sent at the last minute and received on February 14. Please make sure to send your registration forms in ASAP. The regulation changes are immediately in effect as the board proved the clarifying language on July 26, 2024. Anyone who anyone that has not filed their voter registration form must do so to ensure they will be eligible to vote in the 2025 primary and regular regular elections and that is from the election board. Um the other one I have is a free community event. It's Manistee County Annual Suicide Awareness and Prevention event. Um It's a wellness event for Suicide Prevention Awareness Month. Um It starts at 6:30 and goes to 6 p.m. They're going to have some speakers, awareness, education, health booth, um 4:30 to 6 p.m. I don't know if that's what I said. Um free chair massages, support circle, balloon artists, door prizes. Um they said Dial-A-Ride was going to operate free to and from the event and it's sponsored by LRBOI, Be da Bin Behavioral Health, Manistee Friendship Society and the Manistee County Suicide Awareness and Prevention Coalition and then the contact person for that I believe is from Manistee Friendship Society and that's Cassandra and the phone number listed for her is 231-398-0434. And that's all I have. Thank you.

### D. Public Comment Period

Uhm I'm going to start with uhm back in March, we had a council meeting that was very long, March 27th. And there during uhm open session, there were enrollment folders from a 2004 audit that we believe were for enrollment. There were two folders that were we were in a heated discussion. And those were brought in and uhm thrown on the table. And I'm going to try to make this short. We had councilors that left, and we lost quorum and the rest that remained there did not want to touch those files because we didn't know what was in those files. And we never reviewed those files. So, we had called public safety to come in and get those files. So, they did come in, they got the files, we asked that they be put in the evidence room. And then on Friday, we were uh there were four of us that went over to public safety and wanted to have an investigation started because there were accusations from tribal citizens that said that those files had been turned over to the US Attorney's Office. So, we didn't know if this was true or not true. So, we asked public safety if they could do an investigation because that's where it starts the process. And so, uhm I asked Robert to come in today, uhm I asked him if he had a report on that, I asked him the status of it. And so, he came in today, and he has a report on those files, and he will be returning them. So, Robert, I'm going to turn the floor over to you.

Director Medacco: Okay, council, I'm just gonna, I don't usually talk about cases. So, I'm gonna make it short and sweet. So, we were uh advised that somebody was in possession of possible stolen items. And these items were these documents here that was uh allegedly the 2004 audit. Uhm after reviewing the documents that were recovered by one of my officers and doing the investigation, this is more or less an enrollment. When I took over, there was a stack of papers on my desk before SORNA was enacted. So, this is like reference material to create an ordinance. This is not an audit whatsoever. There are some documents in there that would probably be used as reference material. Those documents that were in there that specified maybe two or three families were self-filled out. They were not from an audit firm whatsoever. Uhm obviously, these two folders, which are substantial to say the least, but they contain emails and even stuff from Little Traverse on their enrollment situation, but by no means was anybody in possession of any stolen items. This is just a reference material that any council member could have access to. So,

Councilor Wolfe: (Laughing)

Director Medacco: it's not an audit whatsoever. I don't have possession of an audit with, Uh I mean, I'm gonna shoot for even back then, 2004 probably around 3,000, 4,000. Like I said, this is substantial paper, but definitely not 3,000 pieces of paper.

Councilor Wolfe: (Laughing) according to

So that would be a conflict.

Director Medacco: The director's mother is not contained in this document, unfortunately.

Councilor Crampton: I'm sorry. Please uh observe the queue. Uhm, I don't care whether she's in there or not. There's still a conflict of interest, and we've asked for the feds to investigate. To what you're watching right now is a story being made up by the people who took council, and they just admitted that four people went over there. That's not council. That's not council. So public safety acted on four people. We need an investigation on how those documents got out of there, how four people can just call public safety and public safety take them out. If we call us four a call and tell you to take things out of council chambers, are you going to do it? If me, Julie Wolfe, uh Wittenberg, Metzger call you and say take papers out of council chambers, are you going to do it?

Director Medacco: Yep.

Councilor Crampton: Okay, us four will do that. We'll get an enrollment audit for you, buddy. Thank you.

Director Medacco: You've done it a hundred times so far, so I don't know what you're talking about.

Councilor Crampton: What are you talking about a hundred times? Explain yourself.

Director Medacco: You filed on your on behalf of yourself.

Councilor Crampton: What do you mean file on half of myself? What are you talking about? Please elaborate.

Councilor Crampton: Yeah, just to make a few observations, uh uhm Mr. uh or I'm sorry, Robert Medacco was correct. Director Medacco was correct. There is no outside agency. The 2004 audit was an internal audit. Everyone knows that. One of the first lines on the audit was do not show to the FBI or BIA too many mistakes. (laughing) But we've already offered an investigation that should be going to the feds very soon on how those left council chambers, because I do not believe council actually put that in the chambers. I don't believe four people can uhm take them out of council chambers. And I also believe that if I heard Mr. Medacco correctly, or Director Medacco, I apologize, correctly, uhm there was he got a complaint that there were stolen files and that did not happen to be the case. That's called filing a false police report. So, if I heard him correctly, I'm gonna go back and watch the tape as soon as it's up. But if I heard him correctly, we had four council members file a false police report. So, I'll be checking into that. Now also be checking on status of our FBI investigation on how those got out of council chambers because I have a sneaky suspicion. That's what this is all about. And you're all terrified of that. That's why Mr. uh Medacco was saying there doesn't need to be an investigation. Well, you should have thought about that before you did it. And I'll be following up on the filing the false police report. If you did, then that's crime. Thank you.

Speaker Burmeister: Thank you. Next in the queue is Sara. Go ahead, please.

Sara Agosa: I would like to say some words in honor of Carol Ann Chabot, our beloved tribal elder who left this world and returned to the infinite cosmos. I'm very grateful for Carol Ann's diligence, determination, and dedication to our tribe. She honored our ancestors and left good seeds for the next generations. Carol Ann left a legacy for all of us to continue to seek justice and to work for the betterment of all tribe citizens. And we will continue forward as she would want us to. And I just want to say rest in peace, Carol Ann. We will always remember you with gratitude. Thank you.

At the work session the other day with people from the resort, again today, it's one thing to call another elected official names and disagree. That's fine. But we need to stop making references to our hardworking employees, both at the government and at the resort. Specifically, Councilor Crampton has done this repeatedly. He interrupts. He calls liars. The other day he called our CFO from across the street a liar, thief, sneaky. And this should not be allowed to happen in our meetings. I'm begging this council to please cease that behavior. If I were running the meeting, I would absolutely remove those people when they first made a statement such as being called a liar. I would remove them for the rest of the meeting. It's one thing to say you disagree or it's misinformation. That's fine. But when you say they're a liar, you're attacking the person. And this happens week after week, month after month. And it's not only Councilor Crampton. There are others and they know who they are, but specifically him. I want to ask this council one more time to please stop allowing

councilors to insult, degrade, whatever, our hardworking staff. Our staff is very well equipped and very much overworked. Thank you.

Speaker Burmeister: Thank you. Brenda, I have you next in the queue.

Brenda Cogswell: Ani Brenda Cogswell, 0829. Uhm first and foremost, Miigwech to all of our elected officials. You have stepped up and gone into a firing line that's heated. My comment is not directed at any one person. And it is not to also diminish your passion or commitment. Uhm this would be my first Tribal Council meeting that I have attended in over 20 years. I uhm I sat in the back of the room and very familiar with Robin rules of order. And I believe that's what you have attempted to run your meetings by. And I very easily grabbed one. It says a quorum must be present for a business to be conducted. All members have the right, equal rights, privileges and obligations. No person should speak until recognized by chair. Personal remarks or side discussions during debates are out of order. Only one question at a time may be considered. And it just goes on. Uhm and that's all I have to say, based on the very short period of time that I've witnessed Tribal Council meeting. That I would like it if you would try and treat each other with more respect. Miigwech.

Speaker Burmeister: Thank you. Next in the queue is Lee. Go ahead, please.

Lee McCaslin: Miigwech, speaker. I'm thinking about that Isko day that's out back at that fire, that sacred fire, the heart. And uh and Carol, Carol Ann and uhm her family, you know, in that grief. And no matter what society, if it's Midewiwin. You know, if it's the sun dancers or if it's the people of Longhouse. The cultural war that's been going on here is, you know, tremendous. And, uh you know, some of us practice our culture in a great way. And others, you know, nine 21 years ago, I had nine years of surveillance under my belt as being a supervisor in surveillance. So, all those little bits and pieces that you pick up along the light highway is an experience. The old business right there on that day when I was tending fire. To my release of, you know, your judicial system that was the assistant prosecutor at the time had relieved me of my duties for the river. And, uh you know, we're coming to that four days, one year, and then four years later. And all those traditional settings and all those different meanings along that Me this show. And to see this, uhm people poking that fire, them are our children. Those embers. And Julie, I really appreciate you trying to remove people poking that fire. Because it's untraditional to continue to poke that fire. And, uh you know, asking about the press, I didn't think that that was too far out of the line. PBS does great stations and great stories on real, real traditional values. And, you know, in those lodges, we always meet people along the way. And there are helpers, you know, Dennis Banks, uhm a great leader, uhm you know, a mentor. Uhm and we're losing so many that's walked away from that Disco Day or had that Disco Day put out. Uhm but we do have that connection to PBS. We do have those other bands out there that we're lodge friends with. You know, and uh Sam George, he don't believe in this gaming bit at all. And the Onondaga and the Longhouse, you know. And right now, I'm over mind uh McCaslin versus McCaslin and Manistee County there, whatever they do. You know, about taking my land or taking our land or what's this or what's that? You know, it doesn't, it does matter when it starts talking about your treaty

rights. And it does matter, you know, to keep our traditional values and our people awake. Because, you know, when we go back into the old business, that's 2020. I've been listening to that even when I was there presently in the chambers there. 2019, I was there uh this last year, that whole year, that cycle, you know, an honored vet. And then uh seeing the whole town of Manistee get locked down. Uh June, you know, 17th, 2023. Uhm, you know, and what part is the tribe holding on that? That whole bit, that uh that dysfunction, you know. And I just wanted to uh give thanks and my deepest condolence to Carol Ann. Miigwech.

Speaker Burmeister: Thank you. Next in the queue is Jolene. Go ahead, please.

Jolene O'Signac: Yes, I just wanted to say Miigwech to Julie for her beautiful prayer. To Lee and uhm Councilor Wittenberg for their kind words. And I greatly appreciated Sara's brave and eloquent words and tribute she laid down for my beloved cousin, Carol Ann Chabot. She was an important part of our tribe, and our tribe was a huge part of her life. I just want to thank everyone for their condolences and good thoughts. And let you know that Carol Ann's uhm services will be this Friday at 2 o'clock at the Lakeshore Cemetery in Benton Harbor, Michigan. Anyone that wishes or can attend, please feel free. The family would love to have you. Miigwech.

Speaker Burmeister: Thank you, Jolene, for that information. uhm go ahead, Councilor Crampton.

Councilor Crampton: Thank you. I have a couple of things. Well, first off, I want to just mention the best.

Speaker Burmeister: Councilor Crampton, you're fading in and out. Just so you know.

Councilor Crampton: I know. I'm trying to get my words. I'm sorry.

Speaker Burmeister: Okay.

Councilor Crampton: Uhm Carol Ann was an elder that I first met. She was the first person that I formed a relationship with down there in 2005. She supported everything I said. We just had a talk a few days before she passed. She supports everything I do. She wants this tribe cleaned up. She wants an enrollment audit. She wants the lies to the membership to stop. I'm committed to that. It's taken me a couple of days, and it affects me like this when to lose people like Roberta Tate, Fran Pitts, Theresa Baker, Aunt Judy. I have to just be by myself for a couple of days. But those days are over, and I'm committed to everything that I promised Carol Ann. This enrollment audit needs to come forward. Council has information that our 4/4<sup>th</sup> is not constitutional. Never has been, never will be. There's an immediate need for an enrollment audit. Now, I understand Mr. Romanelli does not like being called a liar, but when you lie, that's what you are. When he told me that I would have those escrow numbers that day, we have still not gotten them. I understand that. I'm pretty sure that Ted Bundy didn't want to be called a murderer either, but that's what he was. And when you tell me you're going to give me

the numbers from the escrow account and you don't, that's a liar. Now, you may uhm talk about your employees across the street. I don't expect those guys to come in here and tell me a load of bull. If they were professional employees, when they said three times, oh, y'all send them right over, have them that day. We have still yet to receive them. That's 6 million dollars. She's a liar. Mr. Romanelli is a liar. I don't care if they like being called it or not. That's what they are. Thank you.

Speaker Burmeister: Thank you. Are there any other public comments that people would like to speak, Matt? And then I have you, Boo, after Matt. Okay.

Matthew Chandler: Matthew Chandler, (Anishinaabe), 1687. Uhm first, I'd like to thank Elder Wittenberg. Uhm each week, I've been noticing that he's been giving us all a lesson. And that lesson is silence. And the strength of silence. Of not letting your emotions come out when you're angry or you disagree. You sit there, and you listen, and you be silent. And you let those words in so that you can digest them. Rather than react to them. So, I'd like to say a huge Miigwech to Elder Wittenberg for giving us that lesson. Uhm my question deals with policy and procedures. And I know we have a lot of policies and procedures and a lot of uhm stuff that uhm and I'm hoping they're all passed by ordinance or something like that. Do you, as elected officials, and I'm talking council. Do you, as elected officials, have to follow those policies and procedures? Or, because you are an elected official, you can kind of deviate from it? Uhm and I'll just kind of leave it at that. Miigwech.

Speaker Burmeister: Thank you. Boo, you are next in the queue.

Boo Battice: Boo Battice, 2644. Fisherman since at least 2001. I'm still looking for help. (21:09) I couldn't even get batteries probably two, three years ago. Got some help now, 2017. Or, 07, which would be 17 years ago. Or, very close. Uhm My boat needs a lot of work, probably refurbished and everything. A brand-new boat. She was built in 1948. So, I'm just here to say I'm looking for some assistance on getting my boat back up to par. And after that, getting back on the water properly with a place to take our fish so we're not charged with want and waste and things like that. Uhm, we need an ice machine. We need a place to park the boat. We, as in there are other fishermen. And we need to all be able to utilize something like that. Other tribes have fishing organizations that's got fishing operations that everybody gets to utilize. Uhm Instead of spending all the Great Lakes money on, you know, police tires. Can we get me back on the boat so I can uh feed the people? And I'll never get the understanding of paying back a gift. If it's a gift, it's a gift. A grant is a gift by definition. Uhm So, for me to pay back something that I'm going to gift the fish to tribal members because the gift should be passed along. It's not for me. It's for all of us. As I've once said and I've always said, the Eagle is the name of my boat. Our boat. Excuse me as I'm trying to get rid of my I's you because we need to get us and we in there. Uhm, we need to get the Eagle back out there flying again. She needs a paint job and everything. She's not looking good on the tribe as a whole. And they did dig up all of our forefathers when they put that place in there. All our wise men from all three fires were carried to that sacred hill. You could see Baldwin. They cut a third of that hill down. It wasn't that low. It was taller. They had to fit the size of the

reservoir in there. And when they did, they dug up hundreds of our forefathers that were standing tall. We didn't bury them laying down. But it wasn't just wise men from right here. It was from the Grand River to Canada. All three fires met right there at that power hill. It was a power hill to us too. And it still is. And the power should go back to the people. And that's by feeding them so they're not so hungry. They got that monkey on their back every month for a little bit of energy that was stolen. I'd like to feed them some energy so they can get some energy. And there's a red road by Grant's, which I said is a gift. So hopefully I can sit down. I would like to thank Julie for handing me her card before I got up here. And gave me a little bit of words of wisdom on the we's. And we can work together. So hopefully uhm I can talk with her later. But I would like to talk with all of you. Because tomorrow's the future and yesterday is already gone. And I don't want to see the Eagle drowned. You know It's a bird. It's a high-flying bird. But she hasn't been able to catch her fish. Kind of hungry and wants to feed her children. Thank you very much.

Speaker Burmeister: Thank you. Chelsea, you are next in the queue. Go ahead, please.

Chelsea Densmore: uhm thank you, Madam Speaker. I saw a resolution online that I can't find on the website. And I was just wondering if anybody had any information. So, it's resolution 24-0403-062. And it was talking about councilors being in person. But it's not on the website. And I thought maybe it had been rescinded. But I wasn't sure. Does anybody have any information on that? Or was it maybe just missed and not posted on the website?

Speaker Burmeister: Chelsea, that resolution hasn't been rescinded. But I'm not sure uhm about the website. Because of the transition of going to the new website. Why that wouldn't be on there?

Chelsea Densmore: Okay. I just I noticed all the other ones were up through like June. But I didn't see that one. So, I thought maybe it had gotten pulled back. So, I wasn't sure. So uhm

Speaker Burmeister: I'll follow up on that.

Chelsea Densmore: Okay.

Speaker Burmeister: Did you want a uhm did you want me to send you that by email?

Chelsea Densmore: That would be amazing. Thank you.

Speaker Burmeister: I will do that.
