Products marketed by the EDC are now being sold at Little River Casino Resort. We are very proud that the Resort is celebrating its 20th Anniversary this year! 

Brief descriptions of our subsidiaries

Little River Health Technologies (formerly Aya Ventures)

Little River Health Technologies is the parent company for InTerra Nutraceuticals and Advanced Protein Solutions.

InTerra is our nutraceutical division, offering therapeutic lotions and serums made with our patented formulation that utilizes tart cherry concentrate, Omegas 3-6-9, and Emu oil. We currently offer three scents of hand lotion, our Head & Body Serum, best-selling Joint & Muscle Lotion, and our new product, Hi-Tech Hemp Nano-gel. Kateri Ceplina said, "I want to be Miss Little River because it is a lifelong dream. I have always looked up to our princesses and wanted to be them. As I grew older I realized what a good role model and what good examples these young ladies had on me. I know that becoming princess would also make my friends and family proud and that is always a good feeling and becoming princess I would do that."



When **Angelica Hinmon Sanchez** was asked why she wanted to be princess and what she hoped to accomplish, she said, **"I hope to become the next Miss Little River to represent my Tribe and show how strong our people and culture are, I hope that I can be as good and honorable as the previous princesses have been. I look forward to the opportunity to meet other princesses and learn more of my culture. If I win, I hope that I can represent in the best way for the Little River Band of Ottawa Indians in the upcoming year."** The essay was sent in with their application.

When they arrived at the powwow and Grand Entry was over, they participated in the public speaking portion of the contest, where they introduced themselves in front of all present at the powwow. Immediately following the introduction portion of the princess contest, they competed in the dance portion. Finally, they were interviewed and asked questions to determine their knowledge and ability to relay their tribal traditions. "Hello my name is Angelica Hinmon Sanchez. I live in Mt. Pleasant, Michigan with my parents, Kim Hinmon and Miguel Sanchez my two brothers, Benjamin and Nijiji, and grandparents, Vera and Bruce. I am 13 years old and in the 8th grade at Shepherd Middle School. Growing up, I learned stories about how many of our traditional ways came to be. I enjoy learning about my culture, and will continue to learn more. In my spare time, I like to read, draw, sing, and bead. Basically, I like to do things that keep me busy. I play soccer and softball. I am active in girl scouts, scouts BSA and project venture. I also participate in a mentoring program called Zaagatee. I'm not the best in school but I study hard and try to keep my grades up. My favorite classes are choir and reading."

Family Services Director, Jason Cross, is Recognized as a Champion for Children

Advocating for children and families has intrinsic motivation; for example, the satisfaction of knowing that you are making a difference in the lives of families. Though advocacy has its inherent rewards, it is often emotionally draining work. It takes a special person to push through the stress that accompanies social work; a special person like the Director of Family Services, Jason Cross.

Jason was nominated for the Children's Advocacy Centers of Michigan (CACMI) Champion of Advocacy award. This award recognizes an individual or an organization that has been an exemplary partner to a Children's Advocacy Center by demonstrating extraordinary leadership and dedication in the role of serving children and families impacted by abuse. This champion is a person or an organization that has helped make connections where there were few; creating empowerment and access to services for survivors and their allies.

In his role of LRBOI's Family Services Director, Jason oversees five departments; the Next Generation Learning Center (NGLC), Member's Assistance, the Victim Services Program (VSP), Family Services, and Be Da Bin Behavioral Health.

During his time in service to the Tribe, Jason was instrumental in moving the NGLC from a dream to reality. Recently incorporated into the NGLC is the Great Start Readiness Program and Head Start which both extend opportunities to area children, some of whom come from abusive homes. In addition to his involvement with NGLC, Jason works closely with families who are impacted by neglect or abuse. Jason is careful to assure that the families served by LRBOI's Family Services Department have access to essential resources like housing, food, therapy and other needed services.

Jason's nomination boasted about his activities outside of his position as the Director of Family Services. He serves as the co-chair of the MDHHS Tribal State Partnership, and he is a member of the Tribal Court Relations Committee for the Court Improvement Program Statewide Task Force. Additionally, Jason is a qualified expert witness for Indian child welfare, having testified in over 100 cases to advocate for the best interest of LRBOI children. He also testified at a state level regarding best practices in the state child welfare arena. Lastly, always the children's champion, thanks to Jason's advocacy, the Manistee County Child Advocacy Center, located next to the NGLC, is in a better position to provide services they might not otherwise be able to provide.

On June 28th, Jason attended CACMI's inaugural Champion for Children event in Grand Rapids where he was presented with the Champion for Advocacy award for which he was nominated. Michael Christy, the Executive Director of CACMI, expressed to Jason, "CACMI submitted nominations to an external committee not affiliated with CACMI. The committee selected your nomination as best representing the award category. We wholeheartedly agree with their selection."

LRBOI is fortunate to have a children's champion like Jason at the helm of the Family Services Department.

FAMILY SERVICES DEPARTMENT

Department Overview

To provide an accessible, effective and diversified Social Services Program that will enhance and maximize individual Tribal Citizen's capabilities for greater self-sufficiency and wellbeing. In addition, it is our focus to maintain the preservation and reunification of Indian families by providing direct service, referral and case management of services for Indian children and families in compliance with the Indian Child Welfare Act and the Michigan Indian Family Preservation Act.

Our Goals

To target demonstrated needs to Tribal Citizens to fill gaps in services provided by Federal, State, and local agencies. To maintain the preservation of Native American families and communities by providing direct services, referral, and case management services to Little River Band of Ottawa Indians Citizens and their families.

Services:

Indian Child Welfare Intervention & Reunification

Intervention in State court proceedings as per the Indian Child Welfare Act (ICWA) and the Michigan Indian Family Preservation Act (MIFPA). Foster Care monitoring, adoption and Case Management services. Service Plan development to accomplish specific goals. The department works in conjunction with the Binojeeuk Commission (Child Welfare Commission) who make independent recommendations on a case by case basis. The Department also provides Expert Witness testimony as required by the ICWA and MIFPA. Eligibility is limited to children under 18 years of age, who are verified Tribal citizens or are eligible for enrollment who are currently involved with Child Protective Services (CPS) in either a Tribal or State court case.

Victim Services

Victim Services program serves to provide support and education services to survivors of domestic violence, sexual assault, dating violence, and stalking. Specific services may include: cultural advocacy, emergency shelter, and outreach services. Eligibility requires verification of Tribal enrollment in a Federally Recognized Tribe and a residence within the nine county service area.

Zoongaadiziwin Self-Sufficiency Program

A holistic program that builds on the strengths of an individual to create independence and accomplish future goals. Through case management and system navigation, individuals will be able to access Tribal and non-Tribal programs that will assist their journey to self-sufficiency. Eligibility requires verification of Tribal enrollment and residency in the nine county service area. Financial assistance may require proof of income level.

Elder Support Services

Providing assistance with Tribal and non-Tribal programs including case management services, advocacy, and referrals. Utilizing the Elder's Circle of Care these services give individuals the ability to live in their own home or community safely, independently, and comfortably regardless of age, income, or ability level as long as possible. Family Services also collaborates with Adult Protective Services (APS) to protect Elders in abusive situations. We also assist Elders with questions and concerns when accessing programs on Federal and State levels. Eligibility requires verification of Tribal enrollment.

Family & Individual Counseling

Counseling assistance to individuals and families directed at basic problem solving, intra-family relationships, and child parenting issues. Eligibility requires verification of Tribal enrollment.



I have drawn a picture on an original 1889 ledger page from a Missouri court house. The drawing tells the story of Hummingbird helping Women gather Medicines.

The story goes that when the Creator was giving characteristics and features to all the animals, he asked them what they wanted most. The Owl said he wanted to see at night, so the Creator gave him eyes that could see in the dark. The Mountain Lion wanted long claws so he could catch his prey. The Bear wanted strength, the Peacock wanted colorful feathers and the Beaver wanted strong teeth to chew on poplar trees. Each of these animals received their gifts from a large pile of parts that lay next to the Creator. As the day became night, the last little bird came to the Creator. He was very shy, and said the only thing he wanted was to help the People. He didn't want anything for himself. He wanted to serve the Anishinaabe People. The Creator looked down at the pile that had dwindled and saw that all that was left was a long bird beak and tiny wings that could fly backwards. He quickly and skillfully put these on the tiny Hummingbird. The little bird was very thankful and asked once again for a job or purpose to help the Anishinaabe People. The Creator thought long on this request, and wondered who such a small bird could help. Then he remembered the Women Medicine Gatherers talking about how tired they became while hunting and gathering Herbs. He told the Hummingbird to ride on the braid of the Women and help collect the Plants to Heal the People. This pleased the Hummingbird and that is why he is so important to the Healers.

I donated this ledger, "Gathering Medicine" to the Little River Clinic. You can view it there. The Clinic has always been very helpful to me, and I wanted to give something back to them for their service. I designed this piece especially for the Clinic. - **Shirley Brauker**
