A clearinghouse is an electronic data service that transmits medical claims to insurance companies. It is a necessary component for DT Trak, and LRBOI staff down the road, to complete medical billing. InfinEDI is recommended by DT Trak, and they can seamlessly begin using this clearinghouse. Other clearinghouses have longer implantation time. InfinEDI is experienced with Tribal Health Clinic clients. Recommendation is to use InfiEDI for a year and re-evaluate if it continues to be a good fit at that time.
