# OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on, October 25, 2023. Following are the minutes of that meeting.

Speaker Burmeister: Good morning, everyone, it is Wednesday October 25, 2023. We are here for our regularly scheduled Tribal Council meeting and we will start with an opening prayer; from Councilor Metzger, so if your able to stand please stand.

# 1. Opening Prayer

Al Metzger, Tribal Elder, offered the Opening Prayer in Anishinaabemowin and Shagnaash Interpretation to English:

I ask the Creator to have pity on me, as I speak this foreign language. Uh, what I would like to do is uh, my granddaughter shared a story; it's how miigi's saved the world; and I would like to share that with my people. Back in the days, there was so much turmoil, conflict among the Anishinabek, that the Creator was sadden by how his people were acting. They were being deceitful and um egotistic and a lot of arrogance going around. So, Creator told miigis, I am going to start over again with different beings, cause the Anishinabek don't follow my teachings. Miigis looked at the Creator and petition him, give him four days to find a Anishinaabe that is still offering that sema to Anishinaabemowin. First three days Miigis flew around, didn't see any smoke coming, it was on the dawn of the fourth morning, Milgis took his final flight and happened to see that little boy kneeing by the Anishinaabemowin that fire, with his sema in his hand; petition the Creator to live in harmony, to have goodness, was that little boy that miigis saw offering his sema. So Miigis flew straight up to the Creator and with that loud screech that milgis had stopped the sun from rising, and petition the Creator there again, I have found one, one young one that is still offering his sema, still wishing to live in harmony with the Creator. So, with that story, I say chi Milgwech, chi Milgwech, chi Milgwech to that young man. Say chi Milgwech to milgis for stepping in for mankind, the Anishinabek and I say chi Miigwech to Anishinaabemowin for giving us another chance. Chi Miigwech, Miigwech, Miigwech,

1. Addendum to Master Agreement for service with Conservation Resource Alliance for Pere Marquette River Habitat Restoration

and Protection Ogema Romanelli and Archic Martell are the ones bringing this forward so Archie the floor is yours.

Martell: Well, thank you, um yeah, I am here to request this ah addendum to the Master service agreement to extend ah the contract for the project until completed. Umm there's just been some delays and permitting thee project and getting the contractor in place and that stuff has been completed. Um, construction should be starting here in the next couple of weeks for the instream work. Um, which puts us over the work um puts us over the um work that I had previously for the time period that I had as the planting and revegetation of this stream um enhancement project, improvement project won't be completed until next spring. So, this was approved last year to work with them, it's a collaborate project to work with the Conservation Resource Alliance and the overall concept of this project is to protect and enhance thee um Pere Marquette River, um next to a degrading um railroad grade. Ya know we don't want to have a catastrophic failure and an derailment into the river because of you know degradation of the stream bank into the railroad bed. Which also protects our custard property which is downstream from this location.

Recorder Johnson: Um yeah, so this is just um cleanup it is um the MB and resolution numbers have been used prior, so just to make it clean um for the membership is to just go back through and um bring them forward on the floor to um clean them up give them their own number vs a used number. Um so that way they have their own number and identified as such so not using a duplicating number as such. I guess to put in simple terms. So, if you, I don't know any way to put it. Um, any questions?

Speaker Burmeister: Will there be any councilors abstaining from this item? Any Councilors with questions, any citiz... oh go ahead Councilor Crampton.

Councilor Crampton: So, the only changes to the document are the ones identified by the um the recorder. Is that right.

Recorder Johnson: Uh no they were um are um are attorney looked at them as well. He said and he said he had agreed that we could just change the numbers to make them but to make them clean and um to make it on the record, that it was cleaner to do it this a way so it's clean and doesn't look suspicious to do them on the floor.

Councilor Crampton: The question was about cleanness the question was there any changes other than the ones you identified.

Recorder Johnson: Correct, that's the only duplication is like the resolution number or an MB number that would that's it.

Councilor Crampton: Thank you

Speaker Burmeister: Any further questions from councilors. Go ahead um go ahead Councilor Metzger.

Councilor Metzger: Um yes, I'm kinda concern about the original resolution number they have some type of factor in that, so we are not rescinding two resolutions.

Recorder Johnson: Um when you um, I see what you're saying, um when you look at it what's attached to the paperwork um like the this one particular one um what it has to it the behind is... is he resolution that's actually attached to it is actually like that the second one the has the elders has attached to the amounts everything, like that descriptive one has everything and that's actually, being attached to um of course obviously the second one you can see its referencing the one before it. So those kinda cross check each other there.

Councilor Metzger: Yes, my concern is uh I don't want to rescind the original reason why we used that one 55 already thank you.

Recorder Johnson: You're not, it's...it's the packet is the ones you're actually redoing by the title.

Speaker Burmeister: Any other questions by councilors, any tribal citizens with questions, any further questions from councilors. Go ahead Councilor Crampton.

Councilor Crampton: Yes, again is it possible to have, I don't want to keep doing this every single time, um is it possible to read the title of the resolution that is being rescinded? I have to bring this up, I have never ever seen a council where the speaker just sits there and watches other people answer questions. Thank you.

Low murmurs

Speaker Burmeister: Go ahead Councilor DiPiazza

Councilor DiPiazza: He's more than welcome to bring that resolution forward

Councilor Crampton: Again, my response, I have never seen a speaker just sit there and watch other people answer questions.

Low Murmurs not sure what is said

Speaker Burmeister: So, we write it on this prior one

Recorder Johnson: Yeah, but that's the same resolution. We're rescinding the incorrect one

Councilor Crampton: Forgive, but it's a fairly simple process, the title of the resolution that your rescinding, that's probably should be read to the membership.

Councilor DiPiazza: I have it, evidently, he doesn't have any information

Recorder Johnson: Ok, go ahead.

Councilor DiPiazza: I'll make the Motion I guess since he won't do it.

Recorder Johnson: Thank you

Councilor Crampton: Yeah, you should be, knowing what you're doing.

Councilor DiPiazza: Then please do it yourself, bring it forward

Councilor Crampton: I'm not the one doing it, you're doing it

Councilor DiPiazza: I have the floor

Councilor Crampton: You haven't been rec..

Speaker Burmeister: Councilor Crampton, Councilor Crampton, please. Let Councilor DiPiazza

Councilor Crampton: Yeah but

Speaker Burmeister: He brought forward the motion

Councilor Crampton: You recognized him, when did you recognized him. You haven't.

Councilor DiPiazza: Let him go

Speaker Burmeister: Ok Councilor Crampton

Councilor Crampton: You haven't recognized Councilor DiPiazza, you haven't recognized anybody but again your taking bias. All I'm asking you to do, is read the resolution title you're rescinding. That should have been prepared and ready by the person who submitted the packet or the councilor who is making the motion. Trying to dump it off on someone else cause you don't know what you're doing that's not protocol. Thank you.

Speaker Burmeister: Thank you for your derogatory comments. Councilor DiPiazza, you have raised your hand to make a motion can you read that please.

Councilor DiPiazza: I withdraw, cause I think Mr. Crampton was making the motion wasn't he, so it's done proper since we're all, evidently we don't know what we're doing.

Speaker Burmeister: Ok, so you're not making the motion

Councilor DiPiazza: Not this time, no

Speaker Burmeister: K. Councilor Crampton go ahead please

Councilor Crampton: Thank you, Speaker, again I would appreciate the speaker would not show her bias so blatantly to the membership. I did not say anything derogatory; I'm simply asking you to read once more time, the speaker to read the resolution that you're rescinding. This is something at every speaker. A speaker directs the meeting as the speaker should know what's going on in the meeting. A speaker should know everything going on today. I have never ever seen a speaker that has not known anything and sits there and looks like somebody, caught in the headlights of a truck every time them questions ask.

Speaker Burmeister: Do you really have to dog me out?

Councilor Crampton: Yes, no I'm not doggin you out, I'm listen you're trying to turn this into something so you can throw me out.

Speaker Burmeister: No, I'm not I'm just stating a fact. Go ahead Ogema Romanelli

Councilor Crampton: You're interrupting me again and I'm trying to clear, I'm simply

Ogema Romanelli: I have the floor. Time

Speaker Burmeister: Councilor Crampton, Please

Councilor Crampton: No, you don't, I was recognized and you're trying I'm just trying

Speaker Burmeister: Councilor Crampton, second warning, if you keep...

Councilor Crampton: So, you're taking me out of the queue?

Speaker Burmeister: You're going to be asked to be removed

Councilor Crampton: I am only asking you to read the resolution

Ogema Romanelli: Um I have the floor, he keeps talking

Speaker Burmeister: Go ahead Ogema Romanelli.

Ogema Romanelli: Thank you, at which of the seven grandfathers' teachings, tells one admonish the speaker, in a open session. This is getting ridiculous, in my opinion and he's had two warnings now and I would encourage the speaker to do what was said at the beginning of the meeting. We have uh prayer that was said in the morning before the meeting and it seems like

after the prayer it just goes south. Those are nice words but if they're not followed by humility and everything else then why do we even say it. Thank you.

O'Signac: I just wanted to reaffirm that Councilor Shannon Crampton is simply trying to keep the meeting flowing in the order that it should and for him to be admonished for doing the job of the speaker, I think is unacceptable. I think the courteous needs to be extended and listen. Because he is simply bringing forth past practices and what is required of council to do their job correctly. Thank you.

And this is done through the National Resource Center on Native American Aging and what this does, I sent a copy to you guys, it lets us know how our Elders are doing all the facts on where we can improve and it would eventually allow us to apply for more grants through Title VI to help support our Elders; and this requires a resolution in order to give us thee um results from our surveys. And as far as I know, I talked to the issuers of this survey and I don't think we ever turned in last time, so we really need to get them done.

Speaker Burmeister: Thank you, Victoria. Any councilors that will be abstaining from this item. Any councilors with questions, go, um go ahead Jolene

O'Signac: Yes, um my question, I guess to Victoria, will these questionnaires or surveys be sent out to all Elders?

Wells: They are to be sent out to all elders in our nine-county service area, if you are not in the service area, I can't issue them to you just because our grant funds only allow me to service those in the nine-county area. It's my hope to be able to issue during the Elders Conference as well, it's coming up next weekend. I believe its next weekend.

Speaker Burmeister: Jolene did you have a further question for Victoria?

O'Signac: Um it just seems out of balance that its only, I understand that service areas and certain things happen, but I think were um, negating a large population of our elders that live outside of the nine county, whose opinions do count and should be heard. Thank you.

Wells: I wish that I could offer services to those but since this is covered by title VI I can only survey only those that I can issue services too. I apologize for that.

Speaker Burmeister: Go ahead Councilor Metzger

Councilor Metzger: You know ahh. In the nine-county service area, how many elders do we have?

Wells: I'm waiting for Mary to get back from her trainings to get an accurate number on that, as soon as I do get that, I will gladly email you that number.

Councilor Metzger: Miigwech

Wells: The estimation was 1,526 was estimated but that doesn't sound right to me, so were waiting for Mary to get back.

Speaker Burmeister: Go ahead Karol Ann

Chabot: Jolene asked the question I was going to ask but, I like to know, this is for Victoria, if Victoria has looked at other grants that it would include all elders in the van um, I think the Outlying members are doing, disservice to them from not being included in these grants. I don't know if the grant people are looking for grants that accommodate all elders or all members instead of just the nine county. So that's my question. To Victoria.

Wells: I think the way Title VI, well I know for a fact the way Title VI works is, say if you're up somewhere by Traverse City, you should be able to access their Title VI program as well. As long as that tribe as has, because its flexible across the board. I think that's why the have the rules the way that they do. So that we're not double dipping by accident. I wish that I could find some other grants. I'm actively looking for more every day. I promise you cause I would like help everybody.

Chabot: Thank you. So, I need to contact and possibly the Pokagon Band to see if they have the same program and I can hook on theirs, is that correct?

Wells: Absolutely, because, we been working together Title VI and all of us that run our programs through them to include everybody who is a part of a federally recognize tribe as long as you're not actively double enrolled in their program. I would definitely look into it and the Pokagon's have a really good program going.

Chabot: They certainly do, they take care of their members. Much better than our Band does. Thank you.

Wells: You're welcome.

Speaker Burmeister: Go ahead Councilor Metzger

Councilor Metzger: ah yes, this is just a comment, I... I find it disheartening that are tribal elders would have to reach out to another nation to seek services that our own nation should be ahh willing, able to participate uh I just find it disheartening.

I'm still work... actively working on that too, but we try

Speaker Burmeister: Karol Ann did you have another question?

Chabot: No but I I agree with Councilor Metzger's um assessment. Down here in the lower part of the state to get um well and water assistance or we had to go through the Pokagon to get it done. Because our Band would not honor or do anything to help us so thank goodness for Pokagon they have done, they are very, very helpful. I'm able to get commodities through them, because I live in their um service area so they... they have helped me tremendously and I appreciated it. Thank you, Victoria.

Speaker Burmeister: I just want to say I talked with a couple tribal members um, this pass week and it was nice to get to know them, and I appreciated them calling with questions that they had um, so I want to thank Sara Agosa and Staci Cheney. Any other comments, questions for legislative. Ok moving down to

# C. Public Comment Period

Speaker Burmeister: Do we have any comments, questions from citizens. Go ahead Jolene

O'Signac: Yes, I have grave concern with this council not appearing to hear when information is given on voting clearing indicates that something should not pass there's kinda a core group that historically votes together; and inappropriately so I think you need to tune in to what's being presented, hear it, and vote accordingly. Thank you.

Speaker Burmeister: Thank you. Comments from other citizens. Go ahead Councilor Crampton

Councilor Crampton: Yes, thank you speaker, yeah, thank you Ms. O'Signac that is exactly my concern here. When your elected to office on the legislative body, the council, your elected to do the bidding and of the membership, your constituents. Ah you're not elected to be on the executive or to do the bidding of executive. And I think what we're having here is ah clear abuse of office. And ju just, an overhaul, throwing away the member of your duty. Um that's my opinion from what I've seen here. Um, you've seen here today, there is some that, there's a vote, a voting line like Jolene had identified. No matter if its right, or wrong or beneficial for the membership. If the Ogema says yes, that's the way its gonna go, that's not legislative

representative that's not a representative of the membership. That's not, that's a violation of your oath office. Thank you

Speaker Burmeister: Thank you. Go ahead Councilor DiPiazza

Councilor DiPiazza: I just want to say, we're all voted in here to do the best for the citizens, and that's every one of them. Lot of this, people get the packets, I don't know if they read them or don't um no idea. Sometimes I wonder. It's like voting down the commissioner um, yeah, so where do you want to draw the line as far as 4-5 vote. No, we don't do the bidding of the executive side. I don't give, care what you say. I have a mind I use it. So, you can say whatever you want. It doesn't really matter; I know where I need to be and what I need to do. I'm done.

Speaker Burmeister: Councilor Crampton your next go ahead please.

Councilor Crampton: Thank you, well just to remind everybody, nobody's needs any validation from Councilor DiPiazza do anything and I don't ask for it. and I never would. Um, we are legislative bidding, and I think the people are not as ignorant as some think they are. They can clearly see exactly what is going on here today and what's been going in the past. As I've stated before I have never seen a council like this where the investigations should of taken one or two days are taking four to five weeks. Council members have to basically set thee agenda, this has normally been done by the speaker in the past. Um, all the questions should be known by the speaker, here the speaker should be setting the table I have never seen anything like this in any council before in the past. Um, what I witnessed in, and the membership have witnessed it too and questions are asked of the council, the body, the leader the head of the body, should be answering those questions instead we get this stare and look around the room at everybody else for an answers. I, this is not uh this is not the body that the membership thinks it is. I want to make it clear so that they understand exactly what this is. From my perception, you have five council members trying their best to avoid every little low noise around them and do something their fiduciary duty be for the membership. Be fiscally responsible. There's another faction that doesn't care what you spend as long as you betterment for the people in Manistee and that's it. and that's what's going to happen. That's what I've witness, that's my opinion. Thank you very much.

Speaker Burmeister: Victoria, you were next in line please.

Wells: Morning again, um, I just kinda wanna go over that um, it's in your constitution what the official duties of the speaker, recorder are encase of you need to brush up on this sir. Um, yeah, I can read 'em but, speaker, speaker of the council shall preside at all meetings of the tribal council, calls special meetings when appropriate, receive reports from the committees or commissions and deliver reports as such to council, perform the duties of the tribal Ogema in absent or of due to inability of the Ogema to preform those duties. Recorder of council shall submit a record of all tribal council meetings and make sure report available to the membership of the tribe. Keep members informed as to status of council and all other matters that effecting the tribe and its members. Maintain and protect tribal seal, perform the duties of the speaker if the speaker is absent, or unable to full fill those, so that being said, kinda handy to have this um, I know I speak a lot, and sometimes I make little to no sense, but there's a section in here powers

of tribal council, so I wanted to bring up and remind you all of, which is section 7 part 2, which it says to promote, protect, and to provide for the public health, peace, moral, education and general welfare of the Little River Band and its members. Of which I have not seen a lot of outta certain members of this council; I'm not calling everybody out, I'm just saying, and that is what the membership being. I read, I read our Constitution, I read our policies and procedures, ordinances, I read it all of those. And it just hits still sad, ongoing sad, but it's getting kinda irritating, to see this constant bickering it's like two, it's like children. And and it's not bra, it's not sides, its branches. I would just like to remind people that, it's not sides, its branches. You have executive branch, and then legislative branch and then need to work together for the betterment of this tribe and the members of this tribe which includes outlying, and here. What all you see, not everything you see, not everything is what it seems. Little bit of wisdom, we could all use humility, and a lot more love out of our seven grandfathers, that is all that I have. Chi Miigwech.

Speaker Burmeister: Thank you, go ahead Councilor DiPiazza, you were next in the queue

Councilor DiPiazza: Nah, I'll refrain cause I know how the speaker and recorder should be doing these things. An, yeah, the constant bradge of somebody doing something wrong all the time. Yeah, I don't know where that falls, falls under some of them teachings but yeah, it hasn't changed in two years we haven't done anything except court battles, and internal fighting so am I tired of it, absolutely. I'm I going to just roll over, br, no, cause I always seem to be right when I quote the Constitution. Which some wanna, yea, I'm good. Right now.

Speaker Burmeister: Thank you, thank you, Councilor Metzger you are next.

Councilor Metzger: Ah yea, I just like to clarify why I voted no on the appointment today to the commission. He was asked to appear today, and uh where is he? I mean if people can't show up to an appointment, then are they gonna make it to the meeting. Um, an also, you know ah yes council has been dragged into courts, over the last twelve years, council has changed, what's consistent, and I say chi Miigwech to Ms. Wells for those kind words, that you shared. Miigwech.

Speaker Burmeister: Councilor Crampton you were next

Councilor Crampton: Ok, just to I don't agree with anything that was said by Miss Wells cause that's not factual the Constitution does read that, but it gives the power to constitute, Constitution to the council, to make its own rules. The mee, the membership needs to look at any procedure's ordinance and then uh, the administration ordinance procedures act. Cause those flow from the Constitution. Then you will see exactly what I'm talking about. Um no, Councilor DiPiazza, hasn't been right about Constitution, he keeps trying to say that, but we have week after week find out that he's wrong, wrong, wrong, wrong, wrong. The self-promotion is really outta place, when the facts don't back it up. Um, as far as seven grandfather teachings ever since member on this line right now, call all the local tribes around here and ask about Shannon Crampton, I think your have uh, going to find something surprising if you don't think I don't follow the seven grandfather teachings. Now, in comparison, when you call the same tribe, and ask them about

Little River, and I think you're going to find something out that I'm telling you the truth, and that those seven grandfather teachings aren't exactly in Little Rivers reputation. Thank you.

Speaker Burmeister: Thank you, go ahead Councilor Wittenberg

Councilor Wittenberg: Yeah, I want to say ah Chi Miigwech for er, for all, everything above me, everything with me, everything below me, and what is within. And we turn around sit here and talk about, bout ah, teachings, and then one ah, turn around and different ones pointing fingers ah, it starts when we get up in the morning and look in the mirror, that's where it starts at. According to the seven teachings outta us and our members turn around and didn't know about the teachings: but the new morale, good morale. Where you turn around and that even comes in with the teachings it's just that we're going by the teachings. So, when we turn around, and being respectful to one another, uh to love one another it goes on and on with this seven teachings, but it turns around that if your outta sync with one your outta sync with them all. And that's where we have not a little bit of this and little bit of that we need ah to put 100% in there. Turn around and look at different corporate cities, and if everything is going fine, then we're not in court when it doesn't go fine, we're in court, it's just put of what is going on. Yeah, different council people, turn around and look at different things that shouldn't be. Just not going with the roll. Roll with the tide. Ya, know sometimes one has to stand their ground. So those are the things that are uh to me, my opinion on these things. Ok, Miigwech.

Speaker Burmeister: Thank you, I also have a comment, is I treat everybody the same, with respect. I don't name call, I don't banter back and forth, I don't believe in it because it doesn't solve anything. We all have our differing opinions, and I believe every councilor sitting here votes the best that they can with what they feel for all citizens. Um, I read everything I my packet and based on the facts that are presented that is how I vote. I'm not influenced by anybody else, as it may be thrown out there that I may be on this side or that side. I'm not. I'm very open minded, and I look at what's the best for all citizens um yeah, I don't call, I don't call names, accuse people of things, I don't believe um that that should be done because it doesn't solve anything. And just to kinda clarify the whole investigation that keeps being brought up, that I haven't done this, or I haven't done that. In work sessions I have asked, um for, a motion to be made to move forward on things so when it's said that I'm procrastinating or I'm not doing it, I'm doing anything unless there's a motion that's brought forward and I have followed through on motions that have been brought forward. So, I just wanted to clarify that for the record, and that's all I have to say. Thank you. Go ahead Councilor Crampton

Councilor Crampton: Thank you, um well nope my statements are absolutely correct. The speaker is the one who is supposed to set the tone and agenda. For the council and ahh and preparing things for council to do. Keep the um work sessions flowing, keep the legislative moving. You just witness, she sets and waits for motions, this is what I've experienced and it's not the council table being set when you get there. Like, all of the speakers like all of the bodies there's a person sitting there waiting for you to suggest something to sit at the table. This is what I'm talking about when its different from all of the councils. Um, if you just go back and look at the recordings you'll see. Council Speakers have had the answers across the board. Cause they know the agenda, and then when it's said they know what's going on. Um, you can take it as personal as you want, I'm not mentioning any names, I'm just saying, the speaker position right

now is totally outta sync with everything else and like I said its lost and we have investigations that should of taken a day, they should of taken a day, council Wolfe, Council Metzger, Council Wittenberg, myself asked hey what happened to that four or five weeks ago. That was maybe three weeks ago. Now we're about seven or eight weeks out. And were still having this pity pat back and forth when there should be a hammer coming down and saying this is the law and this is what is written, and we want the information today! But we don't get that happening. What we get is a delay, delay, a delay. So, I in, ya know, I hate to put anyone on the spot like this, but I'm going to. Because I hear it all the time. I hear everybody going, we don't believe in Christianity in this we don't believe in the seven grandfather teachings. And then I say ok tell me about the messenger er the um child. The biggest look of silence, and confusion that comes across people's faces and their lost. Well, I believe in the seven grandfather teachings, ok then you should know all about them, the messenger and the child. But I... I believe in the seven grandfather teachings that's as far as it gets. So, I mean, when you're at, when people say that I would delve a little bit deeper or so, your making sure they're not just saying uh I know the seven grandfather teachings. Thank you.

Speaker Burmeister: Thank you, any further questions or comments. Go-ahead, go-ahead Corey.

C. Wells: Thank you, Speaker, um there's a bunch of stuff going on today, and I think I'm going to take time to digest what I've heard, and I will be in person next week and I'll have some comments to deliver. Until then um councilor um, Councilor Crampton said something about the Administration Procedures Act and Tribal Councils Procedure er Tribal Council Procedure Ordinance um on the tribes website the Administration procedures act is not there it's a 404 not found file so not sure if that's something tribal council can um fix or send out so members can read that administration Procedures Ordinance but ah, hard to argue with anything in it if you can't read it. Thank you.

Speaker Burmeister: Thank you Corey. You're referencing the legislative procedures ordinance, correct?

C. Wells: Under 100 Chapter in the ordinances oh title 7 Administration Procedures Act is not there. I don't see a legislative procedure ordinance

Councilor DiPiazza: Op, yup not found.

C. Wells: So, yea can't read it if it's not there.

Speaker Burmeister: Ok, we will... will look into that and see why ok Corey.

C. Wells: Thank you

Speaker Burmeister: Your welcome thank you, go ahead Councilor Crampton

Councilor Crampton: Are so just to restate nobody said legislative procedures accept Mr. Wells. The documents that I asked to be record recorded of the tribe is Tribal Council Procedure Ordinance, and the Administrative Procedures I don't know who made up legislative procedures

but don't think there is one. Um yea if that's missing from the website, that would be something to take up with the Executive side and IT. Last time it was there. Just another thing ah another thing missing under IT. Thank you

Speaker Burmeister: Thank you. Councilor DiPiazza go ahead please

Councilor DiPiazza: I have no comment, but I'd like to make a motion

Um, the courts eye, council not part of this. Just saying. It was given, who was given outside legal direction on this case. Council as a whole.

Councilor Crampton: Is the speaker gonna answer the record, you know you did.

Speaker Burmeister: I was waiting to let him finish

Councilor DiPiazza: Nah, I'm done go ahead

Speaker Burmeister: Well, when I was first asked, in um, at the hearing actually, I was on zoom. Judge Sherigan did ask me, and I did said um Mr. Pitchlynn. I'm not going to deny that I said it, I said it.

Councilor Crampton: What I'm talking about is

Speaker Burmeister: what you talking about

Councilor Crampton: The body sat here and ordered Mr. Mr. Pitchlynn came in and gave you... Is this groundhog's day? You guys can't blame me for saying this because this is crazy! Mr. Pitchlynn came in here and talked to all of us. No matter whose name is on it, it's against council. Council as a body voted to have him do this. What is going on here. This is insanity that you're allowing these two too keep rehashing this when you know that th their being insane! Council as a body gave Mr. Pitchlynn the order to do it. and you let him keep going without... when you going... Speaker for real, when are you going to address the fact that he keeps lying week after week. Trying to advance his theory on record, now on record this body knows that they already gave Mr. Pitchlynn the authority, but you're going to continuing let him tal, lie into the record, that's insanity. Thank you.

Speaker Burmeister: Go ahead, you're in the queue, go ahead Keegan.

Bordeaux: Yeah, just want to clarify, in a practical way, heard the language, per the resolution, but practically speaking, we had to break this down in layman's terms. For anyone to understand, what is the motion trying to accomplish? Cause there could be a couple different things here, so is one, one of them, is tribal council ordering Mr. Pitchlynn to stop representing Councilor Crampton, or is tribal council trying to enact some type of like a fine or something for Councilor Crampton. I'm not quite sure what the practical effect would be.

Councilor Wever: No, I just want him to pay the fee, he has spent thousands and thousands of dollars of the tribe's money um on legal fees and court

Councilor Metzger: I would like to call to question

Councilor Crampton: Council ordered it.

Councilor DiPiazza: mumbling something

Speaker Burmeister: Hmm

Councilor DiPiazza: mumbled some more, too low to pick up

Councilor Crampton: Who supported it?

Councilor DiPiazza: I didn't

Speaker Burmeister: Go ahead Keegan

Bordeaux: Yeah so, it might be best if I give advice in closed session. But there's potential legal problems comes with the language as its written.

Councilor Crampton: No let em' go... let em' let em go Keegan. Let em

Bordeaux: No, I'd be ah be ah not be doing a great job as your attorney if I didn't mention it. You're in open, so I have to be limited what I can say. Tribal Council might have serious enforcement with the language which as its written, as Councilor Wever stated on the record, the attention is for Councilor Crampton to pay um the legal fees that Tribal Council already approved and also paid for in the case. I'll leave it there in open but there's potential enforcement problems with the motion. Thank you

Speaker Burmeister: Councilor Metzger you...

Bordeaux: Thank you, Speaker Burmeister, it might help if council, if council when entertain a motion, it might help if you specified in the motion what you're doing, you're authorizing a release of records held in confidentiality or close

Councilor Metzger: I understand that that's why I said all pertinent information.

Speaker Burmeister: He said confidential though. You mean like closed work sessions

Bordeaux: Yes, so anything that you hold in close, whether its closed minutes, or video recordings or anything you could say something that you held confidentially. For instances my email to councilors are confidential records for example

Councilor Metzger: All pertinent confidential records and reports.

Councilor Wolfe: Still support

Speaker Burmeister: Any further discussion. Ok, Councilor DiPiazza

Recorder Johnson: What is that

Councilor Metzger: Federal authorities

Recorder Johnson: Ok, thank you

Councilor Metzger: yup

Councilor DiPiazza: I don't believe you can assign him that authority of the officers but that's their duty plus in Law and Order 11.400.3 ordinance 12.04 yeah, to move forward but be cautious. Ok, do what you're going to do.

Councilor Wolfe: I believe the speaker has the authority to delegate any of her duties to another councilor. No, prohibition against it.

Speaker Burmeister: Go ahead Keegan

Bordeaux: Thank you, Speaker Burmeister, technically what is happening right now if the motion passes, Tribal Council, the body is giving authority directly to Councilor Crampton even though the motion evokes the speakers name. What's happening is Tribal Councilor would be the one delegating, giving the authority.

Speaker Burmeister: Keegan I have a question for you, I want to make sure it gets done correctly, does it need to specify those 5 things that Councilor Crampton mentioned?

Bordeaux: For clarity, I think it would be good if you're authorizing him to release particular records, to define those particular records, that way there's no potential dispute later. Say, a month, year somewhere down the road about what exactly Tribal Council authorized him to

release just for clarity's sake, its usually best to point out specific records that you wish to release. That way there's no fights, arguments or anything down the road.

Speaker Burmeister: Thank you. Go ahead Councilor Crampton

Councilor Crampton: Yes, and I would argue it's the opposite, if you get too specific then that's where the argument is going to come into court. I like the motion as it is, it says all pertinent information. It's gonna be hard to argue in court what I give them on tapes, is not pertinent information. If you get too specific that's where the argument is going to come in so, this time I disagree with Mr. Bordeaux, and I like the motion as it is.

Speaker Burmeister: Thank you.

Councilor Crampton: Oh, and I just want to say again, I'm going to keep saying it, every time that we come up with that Mr., DiPiazza doesn't like, he tries to influence the council by stating law that he does not know. So, he is just trying to bluff you guys again, and he will do it again, and again, and again. You guys need to watch these tapes, it's like a comedy show, thank you.

Councilor Crampton: Well Thank you, before you two get to far in left field yes, Councilor Wittenberg is correct, exactly right, it still stands on the old motion so now instead of authorizing me it goes back to the Speaker, and I will be, we will be doing that when, I will be mentioning it every Wednesday, every work session, we need to be *(garbled)* now it just falls back onto the speaker. And the council has already taken a vote. So now the responsibility is on the speaker that should be done today. Now, I would like to make a second motion. My motion is to have the speaker, to have the public safety investigate the signing of the Dennis Swain check yesterday um I'm sorry Thursday after the Wednesday vote. That's my motion.

Recorder Johnson: What was that after the investigate the check signing?

Councilor Crampton: the two checks that were signed for Dennis Sw.. the two checks that were signed for Dennis Swain. Without a contract.

Recorder Johnson: Let me (could not make exactly what that was said)

Councilor Crampton: So have the Public ... the directive speaker that's the body directing the speaker to have the public safety investigate the signing of the two checks for ur for Dennis Swain and um by the two council members. Gary DiPiazza and Shi Shirley Wever

Recorder Johnson: Um... um, on what day?

Councilor Wolfe: He amended it. He didn't include a date, you amended it Shannon and didn't include a date, correct?

Councilor Crampton: Correct

Recorder Johnson: Ok, so, to investigate the signing of the checks for Dennis Swain how did you end that the signing of the checks for Dennis Swain

Councilor Crampton: By two council members; Councilor DiPiazza and Councilor Wever

Councilor Wolfe: Support

Speaker Burmeister: Councilor DiPiazza

Councilor DiPiazza: I have the floor?

Speaker Burmeister: Yes

Councilor DiPiazza: Since I'm being accused. You're accusing me of a crime, right? Are you accusing me of a crime?

Councilor Crampton: Um, one more time, to have the speaker investigate, investigate comes before any type of allegation, this is an investigation

Councilor DiPiazza: Yup, you're slurring your speech, besides that I have the floor

Recorder Johnson: Ok

Councilor DiPiazza: Anyway, I will revert to our law and order again 11-400-03 12.4 and 12.9, you're accusing me of a crime again.

Councilor Crampton: One more time, no one is accusing anyone, its investigation I'm asking for

Councilor DiPiazza: K, but technically you are.

Councilor Crampton: No, absolutely not

Councilor DiPiazza: I have the floor, but ok

Some chatter, just enough overlapping of voices not sure what was said

Councilor DiPiazza: Keep interrupting

Councilor Metzger: Once again, I would like to call to question

Speaker Burmeister: Recorder Johnson can you do roll call please. Read back the motion

Recorder Johnson: Ok, yeah, I...

Councilor Silvis: Um, I am going to abstain, thank you

Recorder Johnson: So, just to make sure I have this correct Shannon; um if you don't mind, to direct the speaker to have a public safety investigate the signing of checks for Dennis Swain by the two councilors DiPiazza and Wever that sound, correct?

Councilor Crampton: No, it doesn't, to have, one more time, I'm going to go slow have the speaker, the body is directing the speaker, to initiate an investigation with the public safety office, let me know when you got that.

Low chatter going on

Recorder Johnson: check signing...

Councilor Crampton: Of the Dennis Swain check or checks I would say check and checks by councilors DiPiazza and Wever

Recorder Johnson: Ok, let me write this over this looks horrible

Councilor Crampton: And it doesn't matter if Councilor Silvis did them a favor cause their both conflicted.

Recorder Johnson: So, the motion, to have the body to direct the speaker to have public safety office to initiate an investigation, the signing

Councilor Crampton: I didn't, listen, I didn't speak broken English like that what I said was I want the speaker

Recorder Johnson: I have it all chopped up, sorry

Councilor Crampton: Ok let's go in phases, phase 1. To have the speaker, that's phase 1 let me know when you got that.

Councilor Wittenberg: said something too low to get clearly

Recorder Johnson: No, no sarcastic sorry, my paper is scratching and arrows here and it just looks... ok... to have the speaker go ahead... Shan

Councilor Crampton: Contact public safety

Recorder Johnson: Ok

Councilor Crampton: to have them initiate

Recorder Johnson: Ok

Councilor Crampton: and an investigation

Recorder Johnson: Ok

Councilor Crampton: of the checks, signed

Recorder Johnson: Ok

Councilor Crampton: By Councilors DiPiazza and Wever

Recorder Johnson: Ok

Councilor Crampton: Or Dennis Swain or payable to Dennis Swain and I am going to make a motion right now since Councilor, well it's not a motion, but I am going to call it, calling for uh

Mrs. uhh Silvis has abstained that we have to do a vote now on if conflict of interest. I'm calling conflict of interest on both of them. Those two.

Councilor Wever: I have no conflict, no, no. I'm not ...

Councilor Crampton: Listen, Listen the body votes

(breaks into several councilors talking at once)

Councilor Crampton: wait, wait the body votes

Speaker Burmeister: Councilor Metzger already called a question

Councilor DiPiazza: It sucks to be you

(breaks out again with councilors)

Councilor Crampton: Oh my God, it doesn't matter

Councilor DiPiazza: uh-huh

Councilor Metzger: I would like to ask Council member Silvis why she's abstaining

Speaker Burmeister: We have to have a vote on that

Councilor Metzger: uh-huh

Recorder Johnson: Yes, we do.

Councilor Crampton: We got to vote on con, when I raised a conflict of interest, it doesn't matter

when it is. Look at your rules.

Speaker Burmeister: we have no rules

Councilor Crampton: We have to take a vote, on whether a conflict of interest or not.

Councilor Metzger: I'm more curious on Councilor member Silvis

Recorder Johnson: Yup

Councilor Crampton: Yes.

Speaker Burmeister: So how do we state that then? Do we, I meant, does it have to be

Councilor Metzger: I would like her to state her reason.

Speaker Burmeister: Ok we can just ask that. Councilor Silvis, can you state your reason for your abstention please.

Councilor Silvis: Yes, my reason for abstention is because there is not enough information, we just requested more information on how um it if that was to be um what's in the contract so without having all the information were supposed to get it tomorrow, I'm abstaining for that reason.

Speaker Burmeister: Soo Rec

Councilor DiPiazza: So, he called the question, let him...

Speaker Burmeister: That's right.

Councilor Crampton: No, no... no that's (multi councilors speaking) you're letting him call the

procedure

Councilor Metzger: Do we vote on her abstention

Recorder Johnson: Uh-huh

Speaker Burmeister: Yes

Councilor Crampton: And now we also vote on their conflict of interest after that.

Councilor DiPiazza: That's not how that works

Councilor Crampton: Yes, it is. It's in the meeting proce, you guys open up the meeting

procedures ordinance. Don't listen to him no more

Councilor DiPiazza: He called a question before

Councilor Crampton: Oh my god, there's no procedure for that, open up the meeting proce...

Councilor Metzger: She abstained, she abstained after I called the question, I'm questioning her

abstention.

Councilor DiPiazza: Your fine.

Councilor Metzger: I want to know what her conflict of interest is

Speaker Burmeister: Correct, she stated what it is, and now we vote on it.

Councilor Metzger: Yup

Councilor DiPiazza: Do we want to have a discussion on this or

Speaker Burmeister: No

Councilor DiPiazza: Or were, no. Ok, I remember a couple a few weeks ago there was uh

Councilor Crampton: Speaker! For real, is he, you're going to allow him to do this again?

Councilor Metzger: I believe what's up for a vote is uh... uh Mrs. Silvis er Council member

Silvis' abstention.

Speaker Burmeister: We vote on it.

Councilor Metzger: Thank you, Madam Speaker,

Speaker Burmeister: Your welcome.

Councilor Crampton: You vote on the abstention, and you also vote on the conflict of interest

Speaker Burmeister: Right. So, you have to read that

Councilor Crampton: First up is the abstention

Speaker Burmeister: Yes, must be majority vote yea, oh you're writing it.

Councilor Wolfe: Get a pad of paper.

Speaker Burmeister: Write it down for conflict, abstention, do we have to write down her

abstention?

Recorder Johnson: Her reason?

Speaker Burmeister: yeah. I don't that's why I'm asking.

Recorder Johnson: Um, (mumbling) she said I don't think I have too.

Councilor Metzger: Such member shall have to abstain from voting on that matter due to conflict

of interest and shall disclose the nature of the conflict. Constitution.

Speaker Burmeister: Yup, and that's what we're doing right now.

Councilor Metzger: yup. So, there's no discussing it. She already explained so... let's move on

Speaker Burmeister: yup I'm waiting for her to write all that down.

Councilor Metzger: Ok. Thank you

Recorder Johnson: Ok, I guess if you're ready.

Speaker Burmeister: Recorder Johnson, if you can do roll call on that please.

Recorder Johnson: Yup

Councilor Metzger: Ok so do I accept her... so no

Recorder Johnson: So, no.

Councilor Silvis: I can vote on it.

Councilor DiPiazza: People have before

Councilor Silvis: Oh Yes.

Councilor Crampton: I'm gonna need a point of clarification, what are we voting on?

Recorder Johnson: Her abstention

Councilor Crampton: Yeah ok, what voting on her abstention to what, to do with her abstention.

Councilor Metzger: Whether to accept it

Recorder Johnson: Yeah.

Councilor Crampton: Whether to accept it

Councilor Wittenberg: Yes, I accept it or no I don't.

Recorder Johnson: (said something, didn't catch it, Wittenberg was speaking too) Right.

Councilor Metzger: Yes, she can abstain, or no she can't

Recorder Johnson: Or no she can't

Councilor Crampton: Ok, oh yes, yes because you can't, never mind

Recorder Johnson: So, 3 in favor, 6 against her abstention failed.

Councilor DiPiazza: Constitutional, she can vote anyway she wants.

Councilor Crampton: Ahh in the Meeting Procedures Ordinance and in the Constitution, you can't compel her to vote, even though we took that vote. That's why I argued against it.

Councilor DiPiazza: Tell her to vote

Councilor Crampton: You can't

Councilor DiPiazza: No, but she can vote if she wants too.

Councilor Metzger: Now back to call to question ma'am

Councilor Wolfe: What about the two conflicts of interest by Shannon?

Councilor Metzger: What?

Councilor Crampton: Yeah, yeah that's the next thing to vote on whether they have a conflict of

interest.

Councilor Wolfe: The two that signed the check

Speaker Burmeister: Councilor DiPiazza

Councilor DiPiazza: I don't believe I do.

Councilor Wever: I don't believe I do either.

Councilor DiPiazza: I don't believe I have a conflict of interest on any of that.

Councilor Wever: I did what I was supposed to do.

Councilor Crampton: It's like an abstention, you need to look at the Meeting Procedures

Ordinance I've raised the issue now it needs to be voted on.

Speaker Burmeister: Voted on

Recorder Johnson: (something said) Abstentions?

Speaker Burmeister: Yup

Councilor Wolfe: It's not an abstention,

Speaker Burmeister: It's a conflict

Councilor Metzger: Conflict of interest

Recorder Johnson: Excuse me, (unsure of what I said)

Speaker Burmeister: I know

Bordeaux: Speaker

Speaker Burmeister: Go ahead Keegan.

Bordeaux: Speaker Burmeister, I'm happy to listen to uh folks that have been around longer and have had to deal with this more and interpret this these rules more, but my quick thinking of the Constitution suggests the vote on the abstention is taken only after someone invokes their own conflict of interest. So, if a councilor has not invoked a conflict of interest my understanding of the Constitution at least, doesn't require a vote to be taken on the existence of one. Only after someone invokes it; but then again, I'm just saying the council has had their own interpretations, in past practices of how it interprets its rules. Uh that's my quick reading of it.

Speaker Burmeister: Thank you, Keegan. Go ahead Councilor DiPiazza.

Councilor DiPiazza: I was gonna say, I think it was last week, there was an abstention on every item on the agenda and nobody called for a vote on that. Their abstained. So please follow the rules all the time not just part of the time. That's all I'm asking.

Speaker Burmeister: Go ahead Councilor Metzger

Councilor Metzger: Uh, I believe uh councilor Wolfe did give a statement she wasn't involved in uh work session and choice not to vote on the matter. Therefore, she wasn't properly informed.

Councilor Wolfe: I don't think were voting on abstentions, we're voting on Councilor Crampton called conflict of interest

Councilor Wittenberg said something to low and Councilor Wolfe was speaking at the time)

Councilor DiPiazza: Tell me something I don't, it's been voted on once before. It was voted I didn't...

Councilor Crampton: Why am I sitting in the queue? If he gets to talk when he wants.

Councilor DiPiazza: Cause I'm sitting here and you're accusing me of something which...

Councilor Crampton: There was a queue, Speaker please get to the queue

Councilor DiPiazza: Yes, you are, and I love it.

Speaker Burmeister: Gary, Gary

Councilor DiPiazza: I'm sorry

Speaker Burmeister: Um, go ahead Councilor Crampton

Councilor Crampton: Oh my god

Councilor DiPiazza: I'm sorry that was a snidely laugh

Speaker Burmeister: Gary

Councilor Crampton: You're like a small child.

Councilor DiPiazza: Yes

Councilor Crampton: Um, is there a way you can get him to stop. I mean throw in a romper,

romper or something.

Speaker Burmeister: Go ahead Councilor Crampton

Councilor DiPiazza: Said something... just low enough to not catch

Speaker Burmeister: Gary!

Councilor Wittenberg: Gary!

Councilor DiPiazza: I didn't hear, ya whatcha say?

Councilor Wittenberg: Gary!

Councilor DiPiazza: I can't hear ya cause I'm gonna own every...

Councilor Crampton: Speaker

Speaker Burmeister: Gary, stop

Councilor Crampton: Speaker please speaker please c'mon

Speaker Burmeister: Go ahead Councilor Crampton

Councilor Crampton: Your guy's comedy routine is getting boring. Um, yeah, uh... uh I'm sorry again but I'm gonna have to disagree with Mr. Bordeaux. There's a Tribal Council Meeting Procedures Ordinance and it's in the ordinance its and it states these are the rules for Tribal Council and if there is any rule lacking then you will look to Robert's Rules of Order. Roberts Rule says when there is a conflict of interest raised by any member, of the floor there does need to be a second, that there is a vote. And I appreciate Mr. Bordeaux listening to people who have

been around a lot longer cause that's how it's been handled. So, if you look to the meeting procedures ordinance the Constitution gives the council the ability to make its own rules and regulations. It made its own rules in the Tribal Council Meeting Procedures Ordinance flow from that constitution requirement. Um, er authority, sorry, um in the meeting procedures ordinance they said if there is a conflict of interest that they shall abstain and if and if there is anything missing in here and need further guidance you shall look to Roberts Rules. And Roberts Rules of Order there are many conflicts of interest, the only one in our Constitution is a mandate. That does not mean that there is only one conflict of interest that means that there is one cited in our Constitution as a mandate. So, if you follow what I'm saying, there is a constitutional authority given to council by the Constitution to the council to write its own authority. They did a the Meeting Procedures Ordinance. In their it says, if there is anything lacking in here you look to Roberts Rules. Once again, Roberts Rules states the most recent one 2023 that if there is a conflict of interest um uh raised it does need to be seconded and there is a vote. Whether that complicates this. Thank you

Speaker Burmeister: Um, gonna go ahead and let Sara go, I'm looking something up. Her hand has been raised for a very long time. So go ahead Sara

Agosa: Yeah, I just want to make sure that the rights of members can make comments is upheld and I tried to look up the Administrative Procedures Ordinance, I know it was brought up in council meeting today, I'm getting a 404 error so, I can't even look up the ordinance. But I'm really concern about the use of these abstentions. I just want to make sure that they're not overused and I even had a question about Misty Silvis's abstention, to me, I question if waiting to view the documentation is appropriate use of an abstention. I question that whether that is a conflict of interest. So, I'm just asking council please, become informed of the rules and do these the right way. Thank you, that is my comment.

Speaker Burmeister: Thank you Sara. Um, go ahead Councilor DiPiazza

Councilor DiPiazza: I was gonna say, the resolution number for that ordinance is 11-1109-379 in case you want to look that up, can find it better that way, since you're having an error 404. Trying to help you out.

Speaker Burmeister: Keegan, could you help me look that up? Where that would be in the Robert's Rule of Order

Bordeaux: Yeah, so I can, can point you to your own rules before we get there though.

Speaker Burmeister: Ok

Bordeaux: There's steps we got to do first.

Speaker Burmeister: Ok,

Bordeaux: We're lookin, I can read it out loud if that's ok.

Speaker Burmeister: Go, go right ahead.

Bordeaux: So, we're looking at section 7.04 the actions of the Tribal Council shall be interpreted, so that's where, it shall be interpreted in light of the processes set forth in the ordinance. In the event additional direction is necessary, the latest edition Roberts Rules procedure recognizes the National Association of Parliamentarians; shall govern that interpretation. Uh then it says provided that following that specific set of rules of order shall supersede Roberts Rule procedures. So, if we scroll down to B. below it, I don't know if anyone has it in front of them, but subsection B actually describes the action required for abstentions for voting that means that there are problems with that language. It uses the verb interpretation, lets even if we pretend it doesn't say interpret, and pretend it says incorporate we will incorporate Roberts Rules except for the following, and then it lists the process for abstentions for voting, so I'll read the abstention section Roberts Rules of Order definitely does not apply to abstentions cause of the way the Order is written.

Councilor Wolfe: How can we not have abstentions?

Councilor Metzger: I don't know.

Bordeaux: So, I can read it for Councilors; I know you probably don't have it in front of you.

Councilor Crampton: Ah listen, before, before you go to that trouble, the vote only abstention is over. This is on conflict of interest

Councilor Wolfe: Correct, that was my comment. I don't know why we're talking about abstentions

Bordeaux: So, what would a conflict-of-interest vote do then?

Councilor Crampton: The conflict of interest once its raised would vote whether that person has a conflict of interest. Not for that, ... we're on to something different Mr. Bordeaux, uh it the abstention was on Councilor Silvis, who wanted to abstain from the vote.

Councilor Wolfe: That failed

Councilor Crampton: I'm saying that the vote I put to a motion, to have the Speaker report the two council members. I am raising a point of order saying there is a conflict of interest on Councilor Wever and on councilor DiPiazza from voting on this issue, cause their conflicted

Bordeaux: So, in theory, what is actually happening here is that a councilor is making a motion that would band certain other councilors from voting on a matter

Councilor Crampton: No, it's well that's what the conflict of interest would do. Yes, it saying they have a conflict of interest. It doesn't band them, it puts the ownness on them.

Bordeaux: Ok, I'll keep reading, I haven't, I don't recall in your ordinance or Constitution that lets the body ban individuals from voting on topics, but I'll keep looking.

Councilor Crampton: I didn't say it was in our law, that's where it. You're talking about the abstentions it says in our ordinance it says Roberts Rules supersede except for and then you named abstentions. It doesn't name conflict of interest. So that's where we look at Roberts Rule of Order

Speaker Burmeister: Ok go ahead

Councilor DiPiazza: I have the floor

Speaker Burmeister: Yup, when he's done... go ahead Councilor

Councilor DiPiazza: You do know also when you call eh uh question it has to be voted on right. Roberts Rule 16.6/07. Also, he likes to place this conflict of interest cause he played that some years ago on Ron Pete and me because that is a removable offense, but I don't have a conflict so, of interest what's so ever. Cause I have no monetary value whatsoever (mumbled something). You guys keep doing what you're going to do.

Speaker Burmeister: Go ahead Councilor Crampton

Councilor Crampton: Ok, this is probably for membership consumption at this point uh um, it would be um amazing if somebody who is accused of a crime got to vote whether they were charged or not. How much sense does that make; that is absolutely absorbed this is my point. There is a conflict, one which is on you, no one would let Ted Bundy vote whether he is guilty or not. I don't see how nobody is not seeing a conflict here. You don't let somebody vote whether they're going to be prosecuted or not or if there is going to be an investigation on them. Cause of course

Councilor DiPiazza: Will you shut him up please.

Councilor Crampton: Speaker, you just recognized me in the queue. So, I'm...

Speaker Burmeister: So, keep going

Councilor Crampton: Alright, please stop, please stop him from interrupting ... alright thank you. Um, no, that's not, you don't let that happen I don't see how you guys don't see the conflict of interest. I mean, I know I use the words small child but at this point I think I'm insulting small children. I think that anybody can see a huge conflict of interest. You don't let somebody accused of something or investigation vote on whether or not they participate or not. Not whether it goes forward, that's called a conflict of interest. Thank you.

Councilor DiPiazza: Can I respond?

Speaker Burmeister: Um there's others in the queue

Councilor Crampton: I did not address him at all.

Councilor DiPiazza: That's addressing when you say my name and all those things

Speaker Burmeister: Just wait, I'll put you in the queue. Um, go ahead Sara

Agosa: Well first of all, I would really appreciate Gary to stop disrupting the meeting with all this chatter, its its very disruptive. And I personally would like to see both Councilor DiPiazza and Councilor Wever if this vote is regarding an alleged um action or questionable action that you recuse yourself and I would feel more comfortable if you left the room. And I think that is our of respect for members and the tribe thank you that is my comment.

Councilor Wolfe: Shirley wants to be in the queue.

Speaker Burmeister: Um Shirley, I will put you in after Gary and Misty

Councilor Silvis: Thank you, I would just like to um state as of right now there is nothing that is showing that they are doing anything illegal and this is why I wanted to wait till there was more information, so now we're doing a vote on something when there is no information on so until you know, I don't see a conflict of interest if there is no information brought forward. It's not coming in until tomorrow, and this vote should of waited but Councilor Crampton brought it forward now anyways, so I guess we need to take a vote, when there's nothing at this point.

Councilor Wever: Thank you Misty.

Councilor DiPiazza: Do I have the floor

Speaker Burmeister: Gary's next, go-ahead Councilor DiPiazza, and then I have you next

Councilor Wever: Well, Misty said that

Speaker Burmeister: Oh, so you don't want to be in the queue?

Councilor Wever: No, I don't need to now

Speaker Burmeister: Ok,

Councilor DiPiazza: Yeah

Councilor Wever: I'd assume not say anything

Councilor DiPiazza: I...

Councilor Wever: I did not do anything

Councilor DiPiazza: If there's uh... you're accusing me, I don't know you need to make up your mind. Whether you're accusing me of a crime or not. Cause you just kinda said I was

Councilor Wolfe: We're not accusing you

Councilor DiPiazza: That's not what he said, he said on the record that's recorded. I'm sorry.

Councilor Wolfe: That's not the motion

Councilor DiPiazza: I'm Sorry!

Councilor Wolfe: Not accusing you of a crime

Councilor DiPiazza: He said, it doesn't matter. I love this recorded stuff. I'm just saying. I don't have a conflict, and he called a question, under Roberts Rule, you gotta vote on it also; and last week even want to vote on stuff, you don't want to vote on stuff. Vote on this I don't care. Because again, I'm just telling ya law and order 1100-403 12.4 and 12.9 you better google it, that's all I can tell ya.

Speaker Burmeister: Are you done? Councilor Crampton and then I have you Councilor Metzger

Councilor Crampton: Uh, thank you, um well this is to have an investigation done, we have um the information already. Everyone was already pretty much privy that there was no contract voted on in open, in open on Wednesday there should have been no check signed on Thursday I don't know what Councilor Silvis is contemplating about, the membership can understand that's pretty much black and white. So, I don't know how much more investigation you need.

Mumbling at the table

Councilor Metzger: Go ahead Shannon

Councilor Crampton: Hey Speaker

Speaker Burmeister: Go ahead Shannon

Councilor Crampton: And I wanted to say eh, uh you keep allowing the confusion to go on. Councilor Metzger called a question on the abstention of Councilor Silvis, that had nothing to do with the other one on the table right now and you called the vote when question. Now, again you're having some trying to shake their head and confuse the table. What we're on right now is my motion and I call, I'm saying they have a conflict of interest. Now, you can look at Roberts Rules of Order, I haven't heard from Mr. Bordeaux again he said that there was two things and I agree with that, that there is two things that supersede that and that involved the abstentions nothing in there that supersedes a conflict of interest. So, you do look to Roberts Rules of Order. And I can wait for Mr. Bordeaux to look that up, cause I'm absolutely correct. Now there needs to be a vote taken on whether they have a conflict of interest or not. You can't compel him or ban him it doesn't take away their vote. It just says the body says they have a conflict Thank you.

Speaker Burmeister: Go ahead Keegan

Bordeaux: Thank you, Speaker Burmeister, so just to clarify that I understand what Councilor Crampton is mentioning so he's not making a motion to decry of a vote he's making, sorta making a factual termination of some kind. And I have a follow up after that. Do I understand that correctly.

Speaker Burmeister: Go ahead Council...

Speaker Crampton: Yes

Bordeaux: Ok, so in my follow up I I haven't gotten the newest edition version of Roberts Rules of Order in front of me, so I won't be able to answer the question immediately right now. I'm sorry, its gonna take a little more research to whether or not Roberts Rules newest edition covers for a vote like this to cover a factual determination that Tribal Council decides whether these two councilors have a conflict of interest.

Councilor Crampton: Um, I apologize Speaker, for jumping in, just to avoid all this, I am going to withdraw my motion with having you initiate an investigation. I apologize to Councilor Wolfe and the Councilors. Just wait till tomorrow, Councilor Silvis, and wait till we get the information that we're waiting for tomorrow. And then I will, it only takes two to call an emergency meeting. Thank you, so I want to withdraw my motion at this time, so we can move on.

Speaker Burmeister: Um, go ahead Councilor Metzger

Councilor DiPiazza mumbled something

Councilor Metzger: He just withdrew his motion

Councilor DiPiazza: ok never mind, my apologizes

Councilor Metzger: My concern is there has been going on, from my point of view what other tribal members have been seeing corruptions since day one. So now you want to start crawling and dancing around jigaboo dadada. No ordinances were written illegally, meetings have been held illegally. For the last 20 add some years, has anybody ever called those into question? No, but no when it comes down to Courts decision, now everything has to be proper and primer uhuh we all know there has been illegal activity goin on up here. I'm here to stop that. I was voted in to stop that. I was voted in to get this tribe back on track going great. We are a bunch of sick adults sitting around doing pittly sh\*t. We were a great nation at one time. I want us to achieve that again. Thank you, ma'am. I'm done.

Speaker Burmeister: Thank you, Councilor Metzger. Lost track of where we were at. Councilor DiPiazza

Councilor DiPiazza: I'll make a motion to end second open

Councilor Wever: Support

Councilor Metzger: Your supposed to wait for the motion to be finished ma'am

Councilor Wever: Support

Speaker Burmeister: Let me know when you're ready, Recorder Johnson can you do roll call
