Meeting was called to order by Kathy Berentsen at 12:40 p.m. Roll Call: Kathy Berentsen, Jerry Koon, Margaret Chandler, Bonnie Kenny, Anne Avery. Absent: Marcella Leusby. Jerry Guenthardt proxy for Marcella Leusby. Bob Guenthardt will be one hour late.

Adoption of minutes with changes to add Ghost Supper. Christmas Party under Old Business, Tribal Logo.

Motion was made by Jerry Koon, seconded by Margaret Chandler to adopt the agenda with the changes to be adopted at October 22, 1996 meeting.

Financial Report. Mark will do a budget for Chris salary.

Staff Reports. Tammy and Diane working on ordering new phone system. System, need to check with AT&T for the less expensive one. Mark talked about getting office equipment from the Federal Surplus Warehouse.
