LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL MEETING NOVEMBER 12, 1995

Present: Bob, Margaret, Kathy, Marcella, Jerry, Bonnie. Absent: Annie. Staff: Mark. Guests: Bill Brooks, Jay Sam, and Dale Chandler.

Agenda changes made as such. Kathy moved, Margaret seconded, motioned carried.

Kathy suggested minutes to adopt from January '95 to September '95 for the old minutes to be discussed and approved at November 26 at next meeting. Table October minutes not done as of today.
