Resolution # 12-1003-261

*Approving a 2012 Operating Budget Modification MB-2012-37
Narrative Change for Tribal Council Program #1020-100-5802 and Rescinding
Resolution # 12-0926-256*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized to enact budgets and make changes to those budgets, subject to the Ogema's right to veto; and

WHEREAS, the Tribal Council was presented with an opportunity by the Kwewok Circle to host a visit to the Little River Band Reservation in October, by Miss Jessa Rae Growing Thunder, recently crowned Miss Indian World; and

WHEREAS, the Tribal Council supports efforts to bring positive role models to its Nation's Youth, and supports the request for the Tribe to pay Travel Costs associated with Ms. Growing Thunder's visit to the Little River Band Reservation.


WHEREAS, Resolution # 12-0926-256 did not reflect the correct program number.

NOW THEREFORE IT IS RESOLVED that the Tribal Council of the Little River Band of Ottawa Indians hereby approves an amendment to the Narrative for the Travel Budget of Tribal Council Program #1020-100-5802, to include the costs associated with travel and expenses for Jessa Rae Growing Thunder, 2012-13 Miss Indian World, for an amount not to exceed \$1,500.00.


NOW THEREFORE IT IS FINALLY RESOLVED THAT Resolution # 12-0926-256 be rescinded.



Presentation of Resolution Budget Modification to Tribal Ogema:


