The fourth quarter was very busy having the Ghost Supper and the Language Conference in Muskegon both events went very well. Also, the Veteran's Pow Wow and Feast were very successful. Memberto thanked the Council members who came and helped.

Over 350 young people came to the storytelling, there were 12 excellent speakers. Onekama, Kaleva-Norman Dickson and Manistee Public Schools participated in the storytelling day. Memberto would like to have Council encourage the Education Department to be more active with the Cultural Preservation Committee.

Sam stated background checks have been completed for new members of the Education Committee. Memberto stated, he believes, if parents were asked they would volunteer for this committee.

Parsons stated he would like to have Tribal Council do an annual report to the membership.

Fisher stated two Executive Orders were taken, by Director Bussey, to the Ogema, the Executive Orders related to adopting the Michigan 2000 residential codes for Elder housing and Walking Shield. Sam stated, in her opinion, it was outside the Ogema's authority to act on Executive Orders pertaining to residential codes. Sam asked to send a memo to Housing Commission, with copy to Bob Guenthardt and Helen Ann Yunis citing the reference made in the Minutes of 10/30/01 of two executive orders. Sam noted under the Tribal Consitution, residential codes are Legislative in nature and should be adopted by Tribal Council. Therefore, it was beyond the scope of authority for the Ogema to excute Executive Orders regarding residential codes.

Bennett questioned the payment to Goslin in the amount of \$1,180. The October 22, 2001 Minutes listed an amount different from \$1,180.. Parsons stated it appeared the Housing Commission authorized two different payments. Porter stated, in her opinion, the Tribal Council needed to accept the minutes of October 30, 2001 with the understanding the discrepancy will be reviewed.

Bennett stated according to the Minutes, Eljean Kizer had a contract, however, not sure if it was for current position. Parsons stated the status of Kizer's contract would be addressed in Sam's letter to the Housing Commission.

#### A. Construction Management Team

A duplication of the November Minutes was presented in error. Bids for the pump house were addressed. Six bids for the pump were requested, however, only two were returned. There has not been a third bidder for the pump house. A case was made to go forward with only two bidders for the pump house. The purchase of a Hydropneumatic tank will be on the next Tribal Council agenda. The SBR bid package was sent to a number of prospective bidders, however, due to problems with the drawings the bids were recalled.

Kleeman asked about November's Cunningham-Limp's Minutes. Fisher stated there were two issues that had taken more time than originally planned. The first, the community water system, which was addressed and approved by the Council earlier and the second, the art work for the Casino logo. Fisher stated community water system and the art work for the Casino logo have both reached a solution stage.

A comprehensive report from Cunningham-Limp was presented. Sam stated, in her opinion, the most important component of the report was the section addressing the original contract, net change orders, total contract, percent of completion to date and current payment due. Kleeman stated she appreciated the report.

Parsons queried as to the projected completion dates for the Casino. Fisher stated no concrete date has been projected for completion of the Casino at this time.
