Resolution # 13-1106-338

Approval to rescind Resolution #13-0731-227 and approve purchase of 2013 Transit Connect to be used by Custodians and Mail Staff.

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the 2014 Transit cannot be delivered prior to the Tribe's fiscal year cutoff date of December 31st 2013; and
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council hereby rescinds Resolution #13-0731-227, and
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council hereby approves the purchase of a 2013 Ford Transit Connect in the amount of \$10,253.47 with additional safety features of a backup camera and a hands free mobile devise.
