### Resolution #16-0525-157

*Approval of Expenditure for the purchase of a Vactor Jetter Vehicle for the Utility Department to provide needed Sewer Maintenance Services to the Tribe and Manistee Township*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

IT IS RESOLVED, that it is in the best interest of the Little River Band of Ottawa Indians to provide for maintenance needs of the Sewer Collection System and the Septage Receiving Station;

IT IS ALSO RESOLVED, that the Vactor Jetter Vehicle is equipped with standard length hose and the Utility Department will purchase extra hose included in this price along with shipping,

IT IS FURTHER RESOLVED, that the funding is available in the Fiscal Year 2016 Utility Budget for the purchase of the Vactor Jetter Truck,


