Resolution #16-0824-244

Amending the Schedule of Regular Meetings for the Tribal Council for Calendar Year 2016 by the Cancellation of the September 14, 2016 Tribal Council Meeting

WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council is required under Article IV, Section 6(a) to set a schedule of meetings for the next calendar year which was done by approval of Resolution #15-1216-379 and amended by Resolution # 16-0427-122; and

WHEREAS, it is required in section 4.01(c)(1) of the Tribal Council Meeting Procedures Ordinance, that regular meetings be cancelled by action in the form of a resolution.

WHEREAS, the Tribal Council wishes to cancel the meeting scheduled for September 14, 2016.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby amends the schedule adopted by Resolution #15-1216-379 and amended by Resolution #16-0427-122 and cancels the regular meeting scheduled for September 14, 2016.

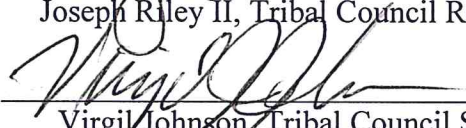
