Approval of Membership to National Republican Congressional Committee by Tribal Council and Tribal Ogema

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Strategic Gaming Reserve does set aside funds for endeavors that are important to the Little River Band of Ottawa Indians; and

WHEREAS, the Tribe hereby appoints the following persons as Delegates and Alternates to fulfill their responsibilities as Federal Legislative Liaisons on behalf of Little River Band of Ottawa Indians.

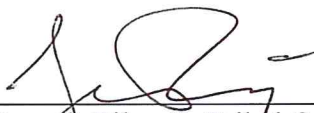

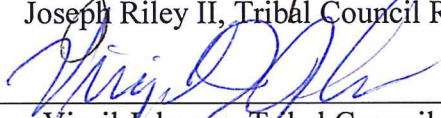
WHEREAS, the Tribal Ogema and Tribal Council agree that a \$32,400 membership fee to the National Republican Congressional Committee is appropriate.

NOW THEREFORE IT IS RESOLVED THAT that The Tribal Council approves the membership fee to National Republican Congressional Committee in the amount of \$32,400 from the Strategic Gaming Reserve #8300-000-5302.
