### Resolution #17-0208-052

## Release Restriction of Commodities Renovation Reserve

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Tribal Council approved Resolution #14-1210-395, Creation of a Restricted Account for the Commodities Renovation for purpose of renovation to the Casino Resort Warehouse for the Commodities Program; and
- WHEREAS, the Tribal Council authorized funding in the amount of \$130,000.00 to be placed in the restricted account; and
- WHEREAS, the Tribal Council acknowledges that all renovation to the Casino Resort Warehouse has been completed; and

WHEREAS, the remaining unused balance in Commodities Restricted Account is \$10,995.38;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby releases the restriction of the Commodities Renovation Reserve restricted account unused balance in the amount of \$10,995.38.
