**Resolution #17-0807-269**

*Amending the Schedule of Regular Meetings for the Tribal Council for Calendar Year 2017 by the Cancellation of the Saturday, August 12, 2017 Tribal Council Meeting*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council is required under Article IV, Section 6(a) to set a schedule of meetings for the next calendar year which was done by approval of Resolution #16-1221-400; and

WHEREAS, it is required in section 4.01(c)(1) of the Tribal Council Meeting Procedures Ordinance, that regular meetings be cancelled by action in the form of a resolution.

WHEREAS, the Tribal Council wishes to cancel the meeting scheduled for Saturday, August 12, 2017 due to lack of quorum being able to be present.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby amends the schedule adopted by Resolution #16-1221-400 and cancels the regular meeting scheduled for Saturday, August 12, 2017.

IT IS FINALLY RESOLVED THAT the Tribal Council Recorder shall post notice of cancellation in all Tribal Government buildings as well as posting notice to the Tribal Government Website.
