Resolution #17-1025-371

Authorization of employment contract for Prosecutor thereby confirming the appointment of the Ogema's nominee for Prosecutor.

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which, became effective upon approval by the Assistant Secretary-Indian Affairs on May 3, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council established the Office of the Prosecutor through the adoption of Ordinance #11-400-09, and
- WHEREAS, the Tribal Ogema is authorized under Article VIII, Section 8.02 of the Office of the Prosecutor Ordinance, to nominate an individual for the position of Prosecutor subject to confirmation by Tribal Council Resolution, and
- WHEREAS, the Tribal Ogema is authorized under Article VI, Section 5(a) to negotiate and execute contracts on behalf of the Tribe, provided such contracts are approved and ratified by the Tribal Council; and

Moved to

WHEREAS, the Tribal Ogema's is requesting the approval of the employment contract for 06/20/18

Prosecutor and the confirmation of the Appointment of the Ogema's nominee; and

WHEREAS, the appropriation of funds for the Prosecutor is included in the annual budget; and

WHEREAS, the Legal Department has reviewed the employment contract; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby ratifies the employment contract and appointment of the Tribal Ogema's nominee for Prosecutor. This appointment begins immediately at the expiration of the previous Prosecutor's term.

IT IS FURTHER RESOLVED THAT this employment contract sets the Prosecutor's compensation as required under Ordinance #11-400-09

IT IS FINALLY RESOLVED THAT nothing in this Resolution shall be considered a waiver of the Tribe's sovereign immunity.
