*Authorization of transfer of Little River Trading Post from Little River Tribal
Government to Little River Casino Resort*

WHEREAS, the status of the *Gaá Čhíng Zilbi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indians Affairs on August 24, 2016; and


WHEREAS, the Tribe recognizes that the Little River Trading Post located on Loon Drive, Manistee, is a recorded fixed asset of Little River Tribal Government; and

WHEREAS, the Tribe has recognized the value of transferring the Little River Trading Post asset at the estimated Net Book Value on 1/1/18, subject to final audit and determination by tribal and resort CFOs/auditors, at \$1,127,888.09 to the Little River Casino Resort; and


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the transfer the Little River Trading Post, and all assets/liabilities affiliated with same, as of 1/1/2018, to the Little River Casino Resort at aforesaid estimated and finally determined Net Book Value.

CERTIFICATE OF ADOPTION
