Resolution #17-1129-416

Adopting the Fiscal Year 2018 Tribal Government Operations Budget

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(i)(1) to approve the annual budget presented by the Tribal Ogema; and

WHEREAS, the Tribal Council met with department directors and Executive staff to review individual budgets; and

WHEREAS, the Tribal Council has received Certification of Availability of Funds, #2017-025, #2017-026, and #2017-027 from the Accounting Department signed by the Chief Financial Officer related to the estimated Tribal Supplements to the 2018 Tribal Government Operations Budget.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council hereby approves the Fiscal Year 2018 Tribal Government Operations Budget in the amount of **\$37,358,923**, with a Gaming Distribution estimated at **\$24,000,000**, and an estimated Tribal Supplement of **\$2,235,828**.

Presentation of Resolution Adopting Fiscal Year 2018 Tribal Government Operations Budget to Tribal Ogema:


