Resolution #18-0207-046

Authorizing the Donation of \$2,000 for the Polar Plunge at Little River Casino Resort to benefit Special Olympics Michigan

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Indian Gaming Regulatory Act (IGRA) requires that Indian Tribes that operate gaming operations commit gaming dollars to charitable donations, and the Little River Band's Per Capita Plan has adopted an allocation of gaming dollars to be used as donated funds; and

WHEREAS, the Tribal Council is responsible for determining the recipients of donations for one half of the donated fund reserves, and the Tribal Ogema is responsible for selecting the remainder of recipients, based on the Tribe's approved Budget for FY 2018; and

WHEREAS, the Tribal Leadership has determined that donations to organizations which contribute to our community are appropriate for the purposes established by the Revenue Allocation Plan and the restrictions imposed by IGRA; and

WHEREAS, the Tribal Council gives permission for the Little River Casino Resort and Special Olympics Michigan to use a modified version of the Tribal Logo for this event to use for posters and on the trophy that will be given.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Ogema and Tribal Council approve the donation of \$2,000 to the Special Olympics Michigan from the donation line:

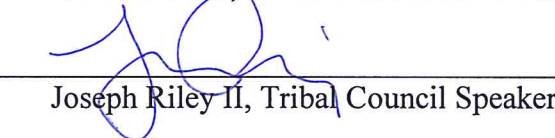
