Resolution #18-1114-338

*Approval of Supplemental Appropriation 2018-15-4th QTR to fund
expenses associated with the Election Board Attorney Contract
in the amount of \$50,000*

WHEREAS, the status of the *Gaá Čhíng Ziibi Dadwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribal Council has received a Certification of Availability of Funds, #2018-017, from the Accounting Department signed by the Chief Financial Officer; and

WHEREAS, the appropriation of funds from the will require a modification of the Operating Budget for Fiscal Year 2018, which was approved on November 29, 2017; and

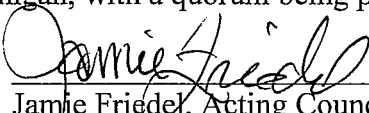
NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2018 to include an appropriation of \$50,000 from the Unrestricted Fund Balance to fund expenses associated with Election Board Attorney Contract.

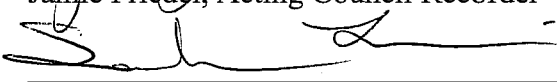
IT IS FURTHER RESOLVED THAT this supplemental appropriation shall be allocated in the 4th quarter. Funds shall be allocated as follows:

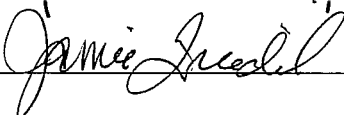

Presentation of Resolution for Budget Modification to Tribal Ogema:

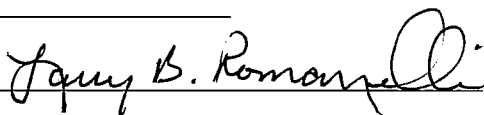
