2. Acceptance of contract funds from the U.S. Department of Interior-Bureau of Indian Affairs and approving a modification to the Operating Budget MB-2023-13 in the amount of \$222,961

Tribal Ogema B. Willis

Willis: Thank you. additionally, this money is part of our 2023 self-governance contract with Bureau of Indian Affairs. This money is specifically dedicated to our rights protection, our Consent Decree activities. \$133,977 is the base for Great Lakes enforcement and Great Lakes assessment. The balance of the money is split between Inland Rights Protection Activities \$44,592 going to BIA Inland Natural Resource and the other \$44.592 is being dedicated to Inland enforcement. Again, we just have to accept the money into our operating budget.

Speaker: Thank you, Are there any questions for Mr. Willis from council?

Recorder: Mr. Israel Stone had his hand up.

Speaker: Oh Mr. Stone, go ahead

Stone: Israel Stone #1735. Um, I guess I'm trying to get clarification from Mr. Willis as to where the dollars from this grant are applied to. Is that the 1836 ceded territory uh and the '55 and '36 treaty designated historic lands?

Willis: Anyone can correct me if I'm wrong, but I believe these funds are specifically for the 1836 Treaty area under the Consent Decree.

Stone: my second question is for Tribal Council. Uh In accordance with our constitution and we are described an initially by the 1836 ceded territory boundaries which goes halfway across Lake Michigan, up through the U.P. and curves over a little bit toward Marquette there. And I have a concern. I would ask the Council to consider doing a quorum call, because I believe we have council members participating in this meeting living outside that ceded territory where we are not governed nor do we authority. And so, I am asking Council for a Quorum call. Thank you.

Recorder: That would be back to the Speaker on that, asking for a Quorum call on that Israel

Stone: you want me to clarify that?

Recorder: Yeah, if you don't mind because I have to write this all down...

Stone: And I'm not trying to be difficult, I think that our Constitution strictly regulates us, uh, within our reservation, or uh historic ceded territory boundaries. And the legality is where I have a question is because if we're taking actions as a legislative body then we have people participating from outside of that jurisdiction. uh We have no authority at that point to enforce or regulate those uh individuals in their activities and so uh, um it comes into question whether or not this was or is a legal action. Are we actually taking legal actions with people participating outside those ceded territory or the reservation boundaries. Last I knew we were um governed by that '36 ceded territory and so anything outside of that, I mean I'm not a lawyer, um we would lose the ability to have sovereign immunity, um and even to invoke certain privileges the tribe is able to invoke under Tribal and Federal law um under those immunity privileges. So, if something were to take place that would say, uh a violation of our constitutional laws, any of those things, right? Um we have no standing at that point to go into tribal court or Federal court and invoke sovereign immunity. So, we're essentially waiving our immunity, in my opinion, if people aren't participating in those meetings within those boundaries.

Speaker: well, I'm just gonna jump in here because the agenda item is the adoption of this item here before us, brought forward by Mr. Willis, and what you're, I'm so glad you added your opinion because I'm following some things that are not <u>Quite</u> of my opinion. But then again, we're both not legal attorneys. The allegations you're making are just basically that, allegations. So, it has not been legally vetted. So, before any action or anything is taken on that we would have to have a legal review of that. So, I don't think getting up here in front of members and citing things which you're not even sure of is something you shouldn't be doing. When you get up here and use the false misnomer that you're not trying to confuse things. We're trying to get through the agenda. You have no legal add in for your premise. Do you have a legal review of that Mr. Stone?

Stone. I'm not asking for you to do anything other than check your quorum. Do a quorum call. Several torts claims and laws are very clear. No I'm not an attorney, but I'm....

Speaker: *interrupts* - Mr. Stone you're trying to initiate an action from Council, that's something that you are not an expert at.

Stone: But sir, the grant that's being applied for, the reason that I got up to say at this point, is because this grant covers the ceded territory, much like our constitution does. I just have concerns over...

Speaker: *interrupts*, I know, and I know your concerns and I've heard your concerns and I understand them fully. What I'm asking you for is if you have any legal backing for your allegation?

Stone: I, I'm not asking, I'm not giving a legal opinion, I'm asking council to do their constitutional responsibility and check into...*interrupted*

Voice: can we have a legal opinion?

Speaker: Based on this yes. Can we get a legal opinion on this? I mean this is ridiculous. And Mr. Stone, please, you're not fooling anyone with what you're trying to do. *Ms. Frias, please go.*

Stone: Thank you sir, I appreciate your commentary.

Frias: I apologize Mr. Stone, I'm not really clear. I think I understand where you're coming from but I'm not really clear on it, but I don't see anything in the constitution, that, that your concern is not having sovereign immunity? Because of action taken by Council members that may be outside of the original territory. I don't see anything in the constitution that speaks to that. I, I would need a little more time to, you know, really look through everything, but from my reading before and also the Tribal Council procedures, I really don't see anything that says that you know. And just as general principles of Indian law, I, there's no option being taken that would waive immunity, specifically and put the tribe at risk by taking these actions. So, I think we're okay, um, I really don't see any action being taken putting anyone at risk, especially the tribe, so I'll continue looking at it as we're moving along, but at this point I don't see any problems.

Speaker: Thank you Ms. Frias, we're going to continue with the agenda now. Does anybody have any questions for Mr. Willis? Does anybody from the membership have questions? is there anything further from council. Please do a roll call.

Champagne: Can I ask something- does this apply to tribal fishing? Mr. Stones up there.

Speaker: alright, you asked your question. But listen, let's not exasperate the issue, let's please move on with the agenda.

Lewis: you need a motion first.

Speaker: I thought there was a motion by you supported by councilor Johnson

Lewis: No, that was the last one.

Speaker: Sorry, I will entertain a motion.

I'm hearing little bits and pieces. It doesn't sound like she has a good connection.

Speaker: Okay, before I proceed, I'm going to try to get Mrs. Grantsynn one more time. Harriette, can you hear us? Ms. Grantsynn? Okay we're going to move forward we'll try to grab her at public comment.

Speaker: That's Mr. Willis:

Willis: These funds as well are part of our 2023 self-governance compact with the Department of Interior Bureau of Indian Affairs. These funds are all dedicated to base funding. So again, we just need to accept the money and authorize the amendment of the operating budget.

Speaker: Does anyone have any questions of Mr. Willis at this time? Recorder: Israel Stone has his hand up.

Speaker: Mr. Stone, please, no more of the last thing. Please go ahead.

Stone: Okay, I was gonna ask who was it that was speaking on the constitution... Champagne interrupts: Excuse me, Israel has already had his five minutes.

Speaker: I know but let's not go back and forth. That's our attorney Mr. Stone.

Stone: That was your attorney? Okay, because I was confused by the response, um but a couple of things...

Speaker: Listen Mr. Stone, we're on an agenda item. We're not going to go into debate on something else.

Stone: I would agree, you're on an agenda item.

Speaker: and the agenda item is the acceptance of Interior Bureau of...cut off

Speaking out over Speaker - Champagne: Let's call this to order.

Speaker: Mrs., please Mrs. Champagne. I don't want this to go back between. I know what he is trying to do, I don't think he's fooling the membership either. Now this needs to stop. So, Mr. Stone please state your uh

Stone: This is on this item and the relationship to the item is um the grants you're accepting right now specifically are dollars that cover the tribes' jurisdiction. That's why I'm asking the question. It's directly related to the item.

Speaker: Mr. Stone do you have any legal premise that there is a prohibition... that does anything to... back up anything illegal that you're saying.

Stone: If you allow me, I will tell you where I am reading that at.

Speaker: I have that same information you do. I'm talking about the allegations that you're trying to very loosely reach for and link together.

Stone: I'm not trying to reach for anything. I simply asked for a uh Quorum Call based upon Art.1 of the constitution- Territory. Very specifically describes what the territory of the tribe is.

Speaking out -Champagne: I asked that this be called to order.

Speaker: I know Ms. I'm trying to get this into order. And uh, Part of the order Ms. Champagne would be if you would not interrupt. Okay that's making the situation worse, and like I said I don't think anyone's being fooled by what Mr. Stone is attempting to do here and I will give you about a couple more minutes Mr. Stone. Please proceed. But please I mean c'mon. Let's just be adults here an let's have a little professional respect for the council and for this body. We all know what you want, please make your allegation or I'm going to stop.

Stone: Again, I'm not making an allegation.

Speaker: Okay then do what you're gonna do and hurry up.

Stone: Okay so, I want to point you to Civil Rights Art. 3 of the constitution because of being interrupted several times through this. I'm trying to say what I'm trying to say but when I have council members stepping on me in the que and even you, cutting me off, and I'm not trying to be disrespectful of you, Shannon, but the Civil Right Clause, Article 3 of the Constitution says that- *The Little River Band in exercising the powers of self-government shall not: make or enforce any law prohibiting the free exercise of religion, or abridging freedom speech, or press, or of the right of the people to peaceably assemble...*

Speaker: What law are we passing today that would do that to you Mr. Stone?

Stone: NO. By stopping me from exercising my free speech...

Speaker: *interrupts* That's not it. That's not passing a law designate, that's calling order to a meeting.

Stone: Okay...But...Okay, I'm not going to debate that, I am asking...

Speaker: Interrupts. There's no debate there. It's...(voice trails off)

Stone: We'll find out from the courts on that. I am asking Council to understand that we have a territorial jurisdiction in our Constitution. That is the supreme law of the land. It doesn't matter what laws you write, it can not abridge this constitution.

Speaker: What you're trying to do is influence the Council (other voices).. by, by apprehension.

Stone: I'm not trying anything but ask council to uphold the Constitution. Unless...

Speaker: Okay and they're not breaking the Constitution, you're making the allegation that they are. You have nothing to support this.

Stone: Okay. Yield, sir.

Speaker: Thank you. Ms. Frias

Frias: No, I just was going to respond but I'll just let it go...

Speaker: Yes, please...um okay, then we have...this on the floor. Is there anything else from Council? If not please do roll call.

Recorder: We need a motion, please.

Speaker: Sorry this just keeps.. this won't happen again. I'll entertain a motion on the item:

Professional Fees for Outside Counsel That Provide Supplemental Legal Services, Including but Not Limited to, Treaty Right Negotiations and Land Trust. Speaker: That is the Ogema and Elise McGowan.

- McGowan-Cuellar: Good morning. *Inaudible* Everyone. So today I'm asking for a supplemental appropriation. This was the prescribed plan for asking for professional services for the executive legal branch. My professional service fees are going to be used for um law firms that represent us in Treaty Rights and Land to Trust projects. At least those are the two that I've been billed so far um and then probably with our um Federal outside council, which would be Hobbes Strauss. So, those are the three that I'm currently aware of and I'm hoping this is a quarterly appropriation where I won't need anymore this quarter, but I will be back per Tribal Councils instruction if I need more. So that is it. Thank you.
- Speaker: Does Council have any questions at this time for Ms. McGowen? If not then I will go to membership, Sara Agosa.
- Agosa: my question is... the tribe is paying salary for an in-house attorney um, plus these consultant fees. So, if it's \$50,000 for one quarter then that would be um, \$200,000 a year, if it's needed every quarter and my question to council is- How is this cost effective?
- Speaker: Okay, I guess I'll take that on. That's the way council wanted to do it to watch the bills and, like she, Elise said, she's asking for this in the 1st quarter. Some of this is past bills, and uh, um what she said she hopes it doesn't get to this much in the future and I don't think that it probably would get to that much in the future, But I would take it to legal uh, take it to legal fees of other tribes. We, I, I was worried about ours being excessive. There are some areas that are excessive and some areas that we are totally behind other tribes in their spending area. This is when the Tribe, I have a feeling Tribal Council will be watching which is why we put it the way it is. I'm not sure if that answers your question but this is the best I've got at this time.

Ms. Agosa: I'm good thank you.

Ogema: I have nothing to report.

Speaker: Anyone have anything for:

C. Legislative Affairs Update

Recorder: Yes, I do. I was looking on the laptop this morning and according to the State of Michigan there were 6,547 new cases with 89 deaths and I'm sharing that also to let all know that's still going on out there, just to let people know. (*Soft voice*-covid?) yes, covid. So, we want to watch ourselves where we're at. I'm done, thank you.

Speaker: Thank you I just want to add on to that. It's a corona virus and it's going to act just like the influenza does. It's going to have its season, but I think when everybody starts to recognize the season then we'll deal with this a lot better than we are. It's almost like ...,I was at the hospital recently talking to doctors about it. It's like Hamburger Helper, if you have an existing condition this thing just exasperates that condition. Um, but thank you Mr. Wittenberg.

D. Public Comment Period

Speaker: Now go on to Public Comment and I will try once again to pick up Mrs. Grantsynn. Mrs. Grantsynn go ahead.

Recorder: Is there someone else's hand up? Mr. Stone has his hand up out here.

Speaker: Alright, Mr. Stone go ahead

Stone: Is Ms. Grantsynn not on?

Speaker: She may be having some technical difficulties on her end.

Stone: Israel Stone 1735. Thank you for allowing me to speak before the Tribal Council. Uh, I want to speak on a couple of items. One is Article 3, of the Constitution. Constitutional Rights: "Make or enforce any law prohibiting the free exercise of religion, abridging the freedom of speech, or of the press, of the right of the people peaceably to assemble" and" The Second thing is Powers of Tribal Council Rules of Tribal Council-(e). "Tribal council shall determine its own rules of procedure for meetings, subject to any limitations imposed in this Constitution. Such rules and procedures shall provide for an opportunity for the General Membership to be heard on any question under consideration by Tribal council." It's not a five-minute limitation, it's any question. I would also point you to, yet again, back to jurisdiction. The reason why I'm bringing these things up is not to "stir the pot". The reason I bring these things up is because they're genuine concerns for us as a tribe and us as citizens. And I'm sorry in my very limited knowledge of this tribe's history and constitution that I don't have a law degree. Never claimed to have a law degree. But what I will claim is, I've questioned the constitution a couple of times, and lo and behold, I've been right, every time. I firmly believe that this tribe has no foundation to stand on if they're not following the most basic principle of our own structure. And our structure is the constitution. It's not even legislation it's not executive order. Those things matter, they're important. But we have to

follow this. (Holding up the Book of Constitution) And when we don't follow this it leads to a lot of problems or potential issues for us down the road. I wish I could phone my attorney right now, get him on the phone and ask him to give a legal opinion. Unfortunately, not all of us have that same authority. But in my opinion as it relates to the basic principles or the foundation of the Tribe, every person sitting up there at that table, every person that we hire into our law services, every person that works in our organization should be aware of the laws of our Tribe, the supreme law, which is the Constitution.

And so when I ask these questions its not because I'm going to a truck pull, it's not because I'm ignorant, or a dumb hillbilly as its made out to be. It's because I have questions and concerns and as citizens, we have that right to ask questions and have concerns. That's what leads to fruitful discussions and hopefully, get out (*bumps?*) When that's oppressed it leads to frustration and I understand, in somebodies' story somewhere they're out slaying dragons and you know, doing away with evil in the tribe through the power of control that happens in this room. But that's not how the constitution was written. The Constitution was written in, it was in more than one article. Meaning the authors of this Constitution thought it was important enough to give the citizens the right to speak before this council that they put it in there more than once. In more than one way. And to me, when that's cut off, we're losing valuable discussion that will lead to get out counts. Or lead, at least to a minimum to understanding. Nobody should ever be chastised for coming in before their elected body, who we elect, to serve us, and asking questions. That should never happen. We shouldn't be shot down because we have maybe a different understanding. See that's what's wrong with this world..

Speaker interrupts: Mr. Stone, you keep using words like we and stuff. You do not, my family does not share your opinion at <u>all</u> so please speak for yourself.

Stone: This is MY public comment you don't get to cut me off.

Speaker: Yes, we do, after 5 minutes we will cut you off. You're filler-busting. You're fillerbusting. You're not gonna do it. So, you're out of order. (Stone talking) you're not gonna have more than 5 minutes so please continue.

Stone: You just took 2 of my minutes. Thank you for that, Sir.

Speaker: Well, you don't speak for my family, so please do not do that again.

Other background voices

Stone: You don't speak for mine either Mr. Crampton. But you know what? There's a lot more people in this Tribe that have questions than just your family.

Speaker: Mumm, yes, they do, then your family too, Mr. Stone.

Stone: Again. Mr. Recorder, I am trying to exercise my rights to free speech before this tribal council.

Speaker: when his 5 minutes are up, let me know. Mr. Recorder.

Stone: to point to the body and ask questions. My time is being used up by somebody talking over me. How is that not out of order? Just because you write the laws doesn't mean you're above the laws. That's needs to stop. It's a lack of respect. She asked me to stop earlier, I stopped. I shouldn't have to continue to put up with that I'm sorry my five minutes are up. Thankful to Mr. Speaker for using three minutes of those. Once again violating my constitutional right to free speech.

Recorder: It was 20 seconds to be honest with you. Miigwetch

Speaker: Thank you Mr. Stone., Terry,.. I'm sorry Chelsea you were next but I'm gonna try and get Harriette one more time because she's been on it for a long time then I'll go to you. Mrs. Grantsynn

Recorder: We do have another one now Teresa is it? She had her hand up.

Speaker: I'll get her after Laura and Chelsea, Chelsea had her hand up. Chelsea go ahead.

Densmore: Chelsea Densmore, #3225. Just for Mrs. Grantsynn, she doesn't actually have the mic uh image next to her and that means that she doesn't actually have her mic on, so she cannot hear you guys. Um I don't know if anybody had noticed that, but I don't think that she can respond at all, unfortunately. Um Because I don't think that she can hear it. But I could be wrong. Anyway, I just wanted to ask about the Round Dance this weekend. I know that you guys have had some water, and then I heard Councilor Wittenberg talking about, you know, with Covid and everything. I was just wondering if somebody could give an update about the Round Dance, if it's still going on or um if you guys could potentially be changing it because of the weather or anything like that. Miigwetch.

DiPiazza: I can answer that, I had my hand up to but, uh it's still on. It's still a go for Saturday the 25th. Starting at uh—I don't have that flyer in front of me, but

Wever: 5,

DiPiazza: 5, five o'clock at the Casino in the Resort Center. Be safe if you're out and about. I almost turned around an went home the roads were so bad this morning.

Echelbarger: Thank you. I just want to say its very hard to hear on Zoom when everyone is talking over each other. So, if we could allow each other to speak so that those of us on Zoom can hear that would be greatly appreciated. Thank you.

Speaker: Um and now are you done Mrs. Echelbarger?

Echelbarger: Yup.

Speaker: Okay I'm sorry, I just didn't want to interrupt you. Um Mrs., you said you have somebody there- Teresa? Just approach the podium and give your number.

Callis: Teresa Callis #399. I just had a question as far as Commissioners being able to attend through Zoom. Um is there any um means for them to have to at least attend once or twice a year for that. Um I just don't see that this Zoom working out as far as the Commission that I'm on. We've not had the power in two years to have that set up and in place. We have a Commissioner that's out of Grand Rapids. Recorder: Shannon, Councilor Johnson had her hand up here

Speaker: Okay. I'm sorry. For Public Comment Go ahead Ms. Johnson

Johnson: So, I'm in a disagreement. Our members should be able to speak freely to them. It does actually go against their freedom to speak that we have in our Constitution. That's against their civil liberties, quite frankly. If they want to speak, they should be able to speak. Because how often have you let them speak multi times? It shouldn't be we're just now going to put a hold on them because maybe they're saying something we disagree with. I mean, we've all done that. We've all disagreed with somebody that had been speaking, but we still let them have the floor evenly. And even if, regardless, and to have a second time, maybe they, something they thought of a second time. Teresa's one.no offense Teresa, that um Teresa I haven't seen before. So, I mean I've seen her on Zoom and stuff. She's actually here in person. She should be able to speak a second time. If um Darlene wants to give her minutes or has something to say she should be able to have that liberty. Yes, well, no, Israel can like talk forever, and a lifetime. But in the same token he should be able to, if he thinks of something new, he, should still be able to speak. We would do the same for anybody online. And its, are you going to also withhold them- also wanting to speak a second time? Because we've done that on multi occasions. And to now start it seems unfair because it just, especially since it was not putout there in the beginning, that you only get one time to speak, which is really unfair to our membership. They have a right to speak. That's it.

Speaker: Okay. Thank you. Is there anybody that you have a personal opinion against that you don't want to speak? Because there's nothing like that in my mind, other than you trying to make that paint that picture. Is there somebody you had a disagreement with?

Johnson: It was just an example of each one should be able to speak freely when it is their turn to speak. They should be able to speak as often as they want

Johnson...to they can only speak one time. They should be able to speak. They're our constituents. They should be able to speak if they have something to say. Freedom of Speech after all. Should be able to speak freely.

Metzger: uh, going back to speaking and public comment, This has been an ongoing issue for quite a while. Uh, I believe, I can remember it going back to when Virgil Johnson was speaker. We were allowed five minutes. And uh, I mean I applaud the people who are standing up for Constitutional Rights, But I want to remind that a former Ogema, and Council member, Lee Sprague, Constitutional Rights were violated when he was escorted out of a meet & greet meeting that the Ogema hosted with Tribal Funds. So, if you really want to start talking Constitutional Rights, let sit down in a public forum, face to face, and we'll go over that Constitution. Miigwetch.

Speaker: if it, let's see now. I appreciate the words, but I don't want to do anything that's gonna exasperate this. And if we could just avoid. We've had a good meeting here today, I can see some people wanted terrible on a political platform. But we've had a good meeting, we've accomplished some things. Now we're going to be moving into closed session.

The purpose of closed session is to discuss business matters considered privileged or confidential involving consideration of bids/contracts, pending legal issues, and/or personnel matters.

And with that I will entertain a motion to end first open session.
