Ratification of the EQIP Funds from USDA-NRCS for the Custer Project Program
Contract

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is vested with the authority, under Article IV, Section 7(b), to ratify and authorize agreements to be entered into by the Tribe with federal governments; and
- WHEREAS, the Tribal Council has received a contract from the Natural Resource Department to make improvements to the Tribe's Custer 80 property; and
- WHEREAS, the contract has been reviewed by the Unified Legal Department; and

WHEREAS, reducing non-point source pollution, increased sedimentation and establishing fish habitat will protect the Pine River, and all life that utilize the river system; and

- WHEREAS, reducing non-point source pollution, increased sedimentation, and establishing fish habitat will promote a healthy fishery for the Tribe to exercise their hunting, fishing and gathering rights under the 1836 Treaty of Washington; and
- WHEREAS, the Tribal Council has received a contract from the Natural Resource Department to assist in remediation of the Pine River Bank Stabilization; and
- WHEREAS, the contract has been reviewed by the Unified Legal Department; and
- WHEREAS, nothing in this Contract shall be construed to be a waiver of the sovereign immunity of the Little River Band of Ottawa Indians or any of its subordinate enterprises or entities and

NOW THEREFORE IT IS RESOLVED that the Tribal Council authorizes the Ogema to ratify the USDA-NRCS EQIP Program Contract for funds for the Pine River stream bank stabilization project.
