- Acceptance of the Little River Band of Ottawa Indians Internal Audit Summary for the Human Resources 2000-401 Department Budget.
- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council adopted, in accordance with Article IV, Section 7(a) of the Constitution, and the <u>Government Business and Accounting Act of 2010</u> which identifies how internal audits are conducted and reported; and
- WHEREAS, the Comptroller General has performed internal audits of the 2023 Human Resources 2000-401 Department Budget; and
- WHEREAS, the Comptroller General has prepared and presented the audit summary and any necessary supporting documents to the Tribal Council and Ogema on October 28 and March 11, 2025, and in work session on February 13, 2025 and March 13, 2025; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby accepts the internal audit summary for 2023 Human Resources 2000-401 Department Budget dated March 11, 2025, and any respective Corrective Action Plans and authorizes their dissemination to individuals as deemed appropriate by the Comptroller General and or Tribal Council.
