Resolution #26-0211-011

Amending the Schedule of Regular Meetings for the Tribal Council for Calendar Year 2026

WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016, which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 6(a) of the Constitution is required to meet in regular session at least once every month at a time and place to be set by the Tribal Council; and

WHEREAS, the Constitution provides that the “schedule of meetings for regular sessions of the Tribal Council for [each succeeding] calendar year shall be set by resolution of the Tribal Council at the last regular session of each calendar year” and that such schedule “shall be published and made available to the General Membership;” and

WHEREAS, the Tribal Council desires to have the greatest input from the General Membership in all considerations of government action such that meetings should be regularly scheduled that allow for the comment and discussion with the General Membership; and

WHEREAS, the Tribal Council approved Resolution #25-1217-294, approving the Meeting Schedule for the Year 2026; and

WHEREAS, Tribal Council needs to make amendments to the Meeting Schedule for the Year 2026.

NOW THEREFORE IT IS RESOLVED, that the Tribal Council of the Little River Band of Ottawa Indians hereby approves the amendments to the schedule of regular meetings of the Tribal Council for the Calendar Year of 2026, per the attached amended schedule.


IT IS FURTHER RESOLVED, that the Tribal Council will add March 4, 2026, to their Meeting Schedule for the Year 2026 and will remove March 18, 2026, from their Meeting Schedule.
