Procedures for Establishing Candidacy

Any Tribal Member who is running for elected offices must obtain, complete, and submit a *"Declaration of Candidacy packet"* during the period listed in the Election Calendar below.

The Special Election shall be by secret mail ballot only. The homes of registered voters shall be designated as the polling place for voting purposes. All Tribal Members who turn 18 years old by the date of the Special Election are automatically signed up to be a Registered Voter and will receive a ballot.

Ballot counting will begin at 12:30 pm. The ballot counting will take place in the Lodge at the Tribes Government Center, 2608 Government Center Drive, Manistee, MI.

If a candidate wishes to have their photograph and biography included in the Tribal Currents, the candidate must include the photograph and biography in their "*Declaration of Candidate packet.*"

If a Tribal Member wants to receive a ballot and vote in the Special Election, it will be your responsibility to have a current mailing address on file with the Enrollment Department.
