The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on April 17, 2019. Following are the minutes of that meeting.

1. Acceptance of contract funds from the Department of Health and Human Services-Indian Health Services and approving a modification to the Operating Budget MB-2019-__ in the amount of \$293,641

The contract funds are awarded as part of the 2019 Self-Governance Compact.

Pro Tempore Speaker Shannon Crampton asked Bill Willis if he was the one representing that.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said this item represents Modification #4 to the 2019 Self-Governance Compact with Indian Health Services. Willis said year to date this brings them up to \$1,777,230, which represents approximately 64% of what they estimated they were going to receive. Willis said \$270,000 of this appropriation is for Contract Support Costs.

2. Approval of Supplemental Appropriation 2019-__-2nd QTR to fund Data Management Software in the amount of \$50,000.00 The Tribal Council has received a Certification of Availability of Funds #2019-003 from the Accounting Department signed by the Chief Financial Officer.

Pro Tempore Speaker Shannon Crampton said he thinks Mr. Le Vasseur is representing this.

George Le Vasseur, IT Director, represented this agenda item. Le Vasseur said good morning. Le Vasseur said what this item before them is something that was discussed late last year when they started the process of updating the website. Le Vasseur said in order to make the website much more efficient and to reduce their costs of data storage they will bring the data in-house and manage that data with the Data Management Software. Le Vasseur said this will also allow them to provide data management and document management for the Unified Legal Department and all of their documents and the contract flows that they have to deal with. Le Vasseur said it will also allow them to make Tribal Council resolutions, ordinances, and regulations much more easy to access, search, and give them the ability to do key word searches for Tribal Council Resolutions.

Pro Tempore Speaker Shannon Crampton recognized Councilor Pete.

Councilor Pete thanked Pro Tempore Speaker Shannon Crampton. Pete said if there are no....if there isn't any discussion he is prepared to make a motion on this.

Pro Tempore Speaker Shannon Crampton asked is there any other discussion. Crampton recognized Pro Tempore Recorder Di Piazza.

Pro Tempore Recorder Di Piazza said he just has one he wanted to deeply appreciate to the IT and Public Affairs for getting the Bear and Elk Permits online to be filled out and submitted right to the department right through the website. Di Piazza said it is extremely exciting. Di Piazza said Miigwech very much to their departments in getting that taken care of.

George Le Vasseur thanked Pro Tempore Recorder Di Piazza.

Pro Tempore Recorder Di Piazza said other than that.

Councilor Friedel said that had nothing to do with the data.

Pro Tempore Speaker Shannon Crampton asked Councilor Corey if he had something.

Councilor Corey said yeah, how much money is this saving the Tribe by doing this.

George Le Vasseur said over the long run they are basically going to reduce their costs for the website by about 50% so about \$20,000 a year. Le Vasseur said plus the maintenance costs is going to be less than the storage costs that they pay for

the data storage. Le Vasseur said the maintenance costs for this yearly is about \$4-5,000. Le Vasseur said what they have been paying in data storage fees every year is between \$5-7,000.

Councilor Corey said okay and thanked George Le Vasseur.

Pro Tempore Speaker Shannon Crampton recognized Councilor Friedel.

Councilor Friedel said plus it is going to be going paperless as well, correct.

George Le Vasseur said paperless, yes, it puts them in a position where they can even do more paperless than they have been so this is an advancement that they have been trying to do for quite some time. Le Vasseur said they are now in the position where they can actually do it. Le Vasseur said Lyle Dorr brought this company in and they are very.....the last Document Management System they looked at was well over a million dollars and this one is very affordable, very flexible and meets their needs.

Pro Tempore Speaker Shannon Crampton recognized Councilor Friedel.

Councilor Friedel asked is that a local company.

George Le Vasseur said it is. Le Vasseur said it a state company, local here in Michigan.

Pro Tempore Speaker Shannon Crampton said if that is it for the questions. Crampton recognized Councilor Pete.

Councilor Pete thanked Pro Tempore Speaker Shannon Crampton. Pete said just for the record when George Le Vasseur was giving his presentation and he said that company is in Grand Haven.

George Le Vasseur said he believed it is.

Councilor Pete said he will tell them this he own nothing of that company and he has no percentages in that company. Pete said he hasn't lent them a dollar or anything. Pete said with that said he is prepared to make this motion.

Willis said so other than that once again these are just kind of trying to clean up the document in its entirety. Willis said this has been approved by the Gaming Commission on April 2nd so it is coming forward for Council approval.

Ogema Romanelli thanked them very much. Romanelli said what he will do is have it drafted and then they can have it signed off by....it might not hurt to have all Councilpersons, Judge and Ogema. Romanelli said okay and thanked them. Romanelli said he received a call this morning from Chairman Swartz from the Keweenaw Bay Indian Community. Romanelli said maybe they could have the discussion with Unified Legal because he knows they prepared actually a very good letter so he will do that as well. Romanelli said he also just received a call from Wenona Singel who is the Native American Representative for Governor Witmer and his understanding is that their planning on.....the Governor is planning on having...holding a meeting on Line 5 with the Enbridge and they are willing to discuss the tunnel and other options is what he understands. Romanelli said she asked if Little River would be interested in continuing talks and he obviously gave that yes on behalf of Little River so. Romanelli said just so they are aware of it he didn't get any information on dates or anything or other information but if he does he will pass it onto Unified Legal and Council. Romanelli said other than that he thinks that is all he has today. Romanelli asked so if there are any questions.

Pro Tempore Speaker Shannon Crampton asked is there any questions for the Ogema.

Ogema Romanelli thanked them very much.

Pro Tempore Speaker Shannon Crampton recognized Councilor Corey.
