The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on April 24, 2019. Following are the minutes of that meeting.

Recorder Lewis said to Speaker Riley that the recorder is on.

The Tribe has received a modification.

Speaker Riley said they have Jason Cross and Bill Willis both representing this item. Riley said they have the floor.

Bill Willis, Budget Coordinator, and Jason Cross, Director of Family Services represented this agenda item. Willis said he is going to let Jason Cross answer any questions but this is a new award through Inter-Tribal Council. Willis said they just need to accept the money and amend the Operating Budget.

Speaker Riley said okay does anybody have any questions. Riley recognized Ron Pete.

Councilor Pete said to Jason Cross just so for public record would he please explain this like he did on Monday during Agenda Review please.

Jason Cross said yeah this is an increase of the \$121,030 to the existing Head Start Budget for this year. Cross said what it will do is it funds positions covered for the whole year instead of just the school year so now this will be a full year Head Start. Cross said so it fully funds five employees including benefits and partially funds another employee so the whole \$121,030 should come back to the bottom line for this grant.

Councilor Pete said super. Pete said Joe Riley.

Speaker Riley recognized Ron Pete.

Councilor Pete said to Speaker Riley then if there are no other questions he is prepared to make that motion.

Speaker Riley said to Bill Willis that they will hand it over to him again.

Bill Willis, Budget Coordinator, and Jason Cross, Director of Family Services represented this agenda item. Willis said this is also a new award through Inter-Tribal Council and is also managed by the Family Services Department.

Speaker Riley said okay. Riley recognized Ron Pete.

Councilor Pete said to Jason Cross excuse him, sorry, he knows he explained this on Monday but just for the record for Tribal citizens can he please explain this again.

Jason Cross said yeah this is a grant from Inter-Tribal Council that will support an employee, a Parent Educator. Cross said it supports their salary, benefits and any equipment they need computers anything it is fully funded. Cross said this person will go into the homes of Tribal members with children five and under including those who may be expecting. Cross said using the Family Spirit Tribal Parenting curriculum and they will do that in the homes.

Councilor Pete said okay.

Speaker Riley recognized Ron Pete.

Councilor Pete said to Speaker Riley okay and thanked him. Pete said he is prepared to make that motion.

Cross said they are going to try to put out materials maybe in the Currents or online so that this new program is.....people can be aware of it.

Councilor Lonn thanked Jason Cross.

Speaker Riley recognized Jamie Friedel.

Councilor Friedel said again is this a one-time thing or is this going to be an annual award.

Jason Cross said this is an annual award and it has a fairly long history with Inter-Tribal Council so there is no current concern about the funding being cut but that position is contingent on the grant being there so if the grant were to end the Tribe wouldn't be on the hook for paying that person.

Speaker Riley recognized Diane Lonn.

Councilor Lonn said she forgot to ask and she is thinking about it. Lonn asked Jason Cross when they do the home visiting stuff can he maybe come and visit them and explain to them what exactly they are going to do, what kind of questions or what are they going to do when they go in these homes.

Jason Cross said sure he can send the material but if Council would like a work session to be more specific, they can do that if they would like to.....

Councilor Lonn said she would like to have a work session just for him to tell her what they are going to do and everything so she has an idea.

Jason Cross said sure, if they would like to schedule one he would be more than happy to do that.

Councilor Lonn thanked Jason Cross.

Unite Three Fires Against Violence is encouraging Tribes to Designate May 5th as a day of awareness.

Speaker Riley said this is represented by Jamie Friedel.

Councilor Friedel explained yes actually they have been working with the United Three Fires of Michigan. Friedel said they sent down.....sent out to all the Tribes their doing the resolution to claim May 5th as the day of awareness and they are going to push it for the State as well. Friedel said he knows Nikki Nelson is doing a Red Dress thing on Sunday May 5th. Friedel said all this is is pretty much bringing light to all the missing and murdered Native women and girls. Friedel said it is a good thing for everybody to be aware of not just outside of their Reservation it is everywhere so.

Speaker Riley said okay. Riley recognized Ron Pete.

Councilor Pete said support. Pete said sorry, did he bring the thing forward he may be ____.

Councilor Lonn said no.

Speaker Riley said no he didn't make a motion.

Councilor Pete said sorry about that he thought he was going to make the motion.

Councilor Friedel said if there is no further questions, he will make the motion.

Speaker Riley said okay.

Councilor Crampton said yeah just to say that this is building off a resolution that was passed or brought forward by Jefferson Kiel of the National Congress of American Indians. Crampton said the resolution that they himself and Councilor Lewis and Councilor Wittenberg were in Washington when they adopted the first one and this is bridging off that. Crampton said all the Tribes are taking it up but the lead is the National Congress of American Indians.

Speaker Riley said okay and thanked Councilor Crampton. Riley recognized Mr. Wittenberg.

Councilor Wittenberg said yeah and to his understanding is there also including the men and boys also.

Councilor Friedel said yes.

Councilor Crampton said eight different Tribes he thinks.

Councilor Wittenberg said it is a big thing and it is not being recognized also. Wittenberg said he says there is more to his understanding with the male end than what there is with women but they both need to be acknowledged he feels together.

Speaker Riley said okay. Riley asked is there any other discussion. Riley asked Nikki Nelson if she had anything to add.

Nikki Nelson said no.

Speaker Riley said he was just wondering since he was mentioning she was helping out with it so. Riley said okay, all right. Riley asked Recorder Lewis to do a roll call.

Romanelli said this would be an appointment by the Governor someone who has knowledge of the resources, etc. Romanelli said so that is what they are looking for and he can give them the number. Romanelli said as a matter of fact he will pass this down but let him write it for himself. Romanelli said there they go and there is a g-mail on there also so.

Recorder Lewis said she will just.....right there.

Speaker Riley said all right. Riley asked are there any questions. Riley said okay and thanked Ogema Romanelli.

Ogema Romanelli thanked them.

Speaker Riley said oh, Shannon Crampton.

Councilor Crampton said he will defer if somebody else is going to talk.

Councilor Pete said no he didn't.....

Speaker Riley said he was just directing him to Shannon Crampton.....

Councilor Pete said.....he was just pointing to Shannon Crampton because he had his hand up.

Speaker Riley said.....because he looked down there he saw him moving so he pointed him to Shannon Crampton.

Councilor Crampton said well he wanted to address something.....this is nothing against him Mr. Pete he just wanted to explain this. Crampton said something happened at the Membership Meeting and it has sort of been upheld on.....he saw comments on Face Book and members have asked him about it. Crampton said that would be Mr. Pete being on.....on....in Muskegon on Fridays.

Councilor Pete said um.

Councilor Crampton said well it has been said that the Speaker said that he could but the Speaker does not control anybody up there he just officiates the meetings. Crampton said so basically he is just not coming in on Friday just like if somebody else would not come to the office because the ____ is here and Council is here. Crampton said there is no business in Muskegon other than being in Muskegon.

Councilor Pete asked can he comment back on that.

Speaker Riley said yes he will let him respond and let's not get too deep into this....

Councilor Pete said no he is not.

Speaker Riley said.....because he doesn't want a lot of problems.

Councilor Crampton said it is not argumentative he just wanted to clarify it.

Speaker Riley said yeah, yeah.

Councilor Pete said yeah.

Councilor Crampton asked Speaker Riley if he can give permission for any of them to.....

Speaker Riley said no he cannot. Riley said he is not Council's boss.

Councilor Pete said get permission for.....

Councilor Lonn said to go somewhere.

Speaker Riley said all...

Councilor Pete said okay he....he....he knows what he thinks he is right. Pete said he is not going to get into a comment on that he.....he does have meetings in fact he a Mus.....he has a meeting in Muskegon this Friday with the Speaker at 9:00 over Tribal business and he also really....when he informed the Speaker he

really don't ask permission because he knows he is not the bos.....he means they are all separate Councilors. Pete said when he informed the Speaker that he is going to be somewhere it is out of a courtesy so that he knows that he is not going to be here on Fridays so that is what really.....he guessed he misstated that.

Councilor Crampton said yeah.

Councilor Pete said so wha.....he informed him only so that he knows. Pete said it is just like if he is leaving and the Recorder is still here he is quite sure that Sandy Lewis will tell him he always comes to see her and say "*Sandy I'm going to be leaving the office now.*"

Councilor Crampton said yes.

Councilor Pete said so that she knows. Pete said it is more of an information thing.

Councilor Crampton said he.....he....he.....

Councilor Pete said.....than it is an asking for permission thing. Pete said he is just trying to ____ straight man.

Councilor Crampton said he understands but the inclusion of it on their calendar.....their Council Calendar gives out the wrong impression plus it....why isn't the rest of Council on there saying this person is in Traverse or this person is over here at the Sugar Shack and this person is over here why are they including that on the calendar.

Councilor Pete said okay he just has one comment then he is done. Pete said he.....very simple he would love to ask Kathleen Bowers to say.....tell her please take that off the calendar that.....

Councilor Crampton whispered something but it wasn't picked up on the tape recording.

Councilor Pete said.....that he is in Muskegon and she'll know and the rest of the Council know that generally unless there is something that he really.....there is meetings here scheduled for Friday he will still be in Muskegon but she doesn't have to put it on their weekly calendar. Pete said he will let her know that.

Councilor Crampton thanked Councilor Pete.

Councilor Pete said he is welcome.

Speaker Riley said okay. Riley recognized Gary Di Piazza.

Councilor Di Piazza said he thinks Boo Battice had his hand up. Di Piazza asked no?

Boo Battice said questions like he said.....*and was speaking from the audience and the rest was not picked up on the tape recording.*

Speaker Riley said um.....

Councilor Di Piazza said well he.....

Councilor Crampton said maybe he must of missed the queue.

Councilor Di Piazza said he doesn't know. Di Piazza said anyways he was just going to remind members the Fall Fire that was to take place during the Membership Meeting is May 3rd and 5th Sunrise is at the Lodge if the weather is prevailing it might be moved to Aki possibly depending on the weather.

Councilor Corey said it is the Spring Fire.

Speaker Riley said yeah it is the Spring Fire.

Councilor Di Piazza said Fall, Spring yeah.

Speaker Riley said um.....

Councilor Di Piazza said this time of year he doesn't know.

Speaker Riley said just for clarification will there be like breakfast served, will there be beverages available.....

Councilor Di Piazza said always.

Speaker Riley said.....if they need to bring things.

Councilor Di Piazza said usually there is a breakfast and lunch.

Councilor Pete said um-hum.

Councilor Di Piazza said that he doesn't know the flyer still hasn't been presented all they had was an agenda and he doesn't have it in front of him right now.

Speaker Riley said okay. Riley asked does he know off the top of his head who is going to be presenting.

Councilor Di Piazza said oh, Pumpkin, George Martin, and who else was....

Councilor Wittenberg said Dave Shannequet.

Councilor Di Piazza said yup.

Speaker Riley asked who was the other guy.....Johnny.....

Councilor Wittenberg said Donny Dowd.

Speaker Riley said yeah, all right, yeah.

Recorder Lewis asked isn't Brian Loney coming up.

Councilor Di Piazza said yup, Brian Loney.


