The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on April 27, 2016. Following are the minutes of that meeting.

I. Opening Prayer

Chuck Fisher, Tribal Warrior, offered the Open Prayer.

Chuck Fisher said before they actually begin the prayer he would like to let everybody know that they had a kind of special language session last week in their Language Class was devoted to praying and how tradition enters into that along with what normally gets taken into account in that frame of mind. Fisher said one of the most important things that he learned from that was being or having a sense of gratitude for everything.

Creator, thank you, thank you for this day.

Thank you for this life.

Help me appreciate both the day and life.

Help us all do the same.

We believe that this life force is in everything around us and that is kind of a traditional belief.

Help us remember this.

Help us remember that Mother Earth is alive, everything on the Earth is alive, life is all around us and it is not always seen. That spirit of life though is undeniable when you really stop and think about it. I want to just really say thank you for that and thank you for letting me see that. I hope everybody can take that to heart and kind of walk in that appreciation.

Thank you. Miigwech.

Wheeler said the amount is \$109,690 and this represents the third year of funding for the Elders Meal Program.

Speaker Johnson said to Gary Lewis that what he will ask him to do is give them a quick update what this is all about so their membership will fully understand it. Johnson said he knows that Gary Lewis is a soft speaker so he will ask him very politely to speak up into the microphone.

Gary Lewis, Utilities Department Director, represented this agenda item. Lewis tested the microphone and asked if it was alright. Lewis asked if it was good.

Speaker Johnson replied beautiful.

Gary Lewis said at a work session with Manistee Township and Tribal Council it was decided that they would waive the initial tap fee for a certain timeframe for anyone who wished to connect to the Sewer Line along US-31 and this resolution sets that timeframe.

Recorder Riley represented this agenda item for Tribal Councilor. Riley said what they did here is they had a meeting scheduled on Reaffirmation Day so they cancelled that and right after Memorial Day they had one meeting but there are five Wednesdays in June so they opted to have the week of Memorial Day with no meeting because it is a short week then have one on the fifth Wednesday. Riley further explained then they cancelled two Wednesday Meetings and moved them to Saturday, one the day of the Ogema's Budget Meeting and the Elder Meeting for August and one to coincide with the Annual Elders Conference in November.

Speaker Johnson said he would like to add onto that the two Saturday Meetings typically what they have done is they only have open meeting and do not do closed unless there is a real special need for it they will still continue on that route. Johnson said if there is something coming up that they are required to act on an emergency basis or a high priority basis they will go into closed but otherwise they normally just do open on Saturdays.

Councilor Di Piazza represented this agenda item on behalf of CORA. Di Piazza said this is just a resolution of support for the CORA Tribes for funding for, no cost to them, and is BIA money for Dockside Inspection and Training which there is a need to see what kind of fish and how many are coming out of the Great Lakes. Di Piazza believed that this is going to improve that situation and they are not supporting with any monies and it is all BIA Funds.

- B. Ogema Weekly Status and Business Update

Ogema Romanelli said as was mentioned earlier the Annual Budget Meeting that the Ogema and the Executive Branch puts out will be August 6th he believes and that is in conjunction with the Elders Meeting so that they can make it easier for them to attend as they have been doing every year. Romanelli said they are going to be hosting within the next month the U.S Attorney General and the......which includes other Law Enforcement Agencies such as the FBI and they do this on a regular annual basis as well. Romanelli said they have been doing it in the fall but they want to change it back to the spring time which is when they normally do that. Romanelli said they are going to be hosting that over at the Resort and working on that. Romanelli said what else do they have. Romanelli said

tomorrow there are a couple of them leaving for Washington, D.C and thinks it would be the Speaker and himself will be heading out. Romanelli said it is just going to be a quick one or two day trip and back for the weekend if all things go right but if all things go wrong they will probably be coming back in the middle of the weekend which is what they have known to do. Romanelli said something about he thinks it is probably the Speaker's bad luck because they have problems when they travel together. Romanelli said he will blame it on the Speaker anyway. Romanelli said what else is going on. Romanelli said they have been getting......have they noticed that they are getting a lot of donations this year.

Speaker Johnson replied yes.

Ogema Romanelli said it is really starting to spread thin because they are either going to give more donations and less money or they are going to have to really look and not give to so many. Romanelli said he knows that he is getting hit up all the time for them and they are requesting more and more money it seems so he is going to be probably telling them if they give a donation it is going to be less this year on several of these. Romanelli said he knows he sent a few over to the Council within the last week but they can only do so much and they have a limited amount that they give so. Romanelli said he thinks that is it and he can't think of anything else.

Speaker Johnson said he has.....

Ogema Romanelli said one more thing, the United Tribes, they are going to the United Tribes first part of mid next week and he will be travelling he thinks with Councilor Di Piazza also.

Councilor Di Piazza said he is not bad luck.

Ogema Romanelli said he is not bad luck alright and he is not travelling with him anyway and they will be going to the same destination but different vehicles.

Speaker Johnson said he would just like to add to the Ogema's Business Update. Johnson said he just received word yesterday that they received a grant for \$357,000 to improve the intersection between US-31, M-22 and Loon Road. Johnson said that is a huge, huge step forward. Johnson said now how it takes them to get the money from them but again he wanted to recognize both Steve Fisher......Chuck Fisher and Steve Parsons for all the hard they did to move forward in getting this grant approved.

Ogema Romanelli agreed.

Speaker Johnson said he really appreciates the work that the Ogema's Staff did on this and it is going to help them both the Resort and Government Building and even the C-Store for access to their facility and making it a much safer intersection when they are done.

Recorder Riley said the light is still out of the question, right.

Speaker Johnson confirmed that the light is still out of the question, correct.

Recorder Riley said they will be stacking lanes.

Speaker Johnson said again he wanted to say "kudos" to the staff.

Ogema Romanelli said yes.

Speaker Johnson said he saw Darleen Martin's hand and is sure she wants to talk about this issue also.

Darleen Martin, Tribal #0575, asked if the street light now is going to be put up.

Speaker Johnson said no.

Darleen Martin reiterated no. Martin asked what are the improvement plans for that.

Speaker Johnson said that Steve Parsons and what they are going to do is they are going to first of all as they approach US-31 on M-22 they are going to have a sign better identified so they don't get into the merge lane too soon where people are pulling into the casino. Johnson reiterated they are going to have a sign there first of all. Johnson said the other thing is that the merge line as they are heading south on US-31 they are going to make that into three lanes so it is easier for people on M-22 to access onto US-31 and makes it much more efficient and faster. Johnson said they are going to have double lanes with there so those are some of the things and he can't get all of them but that is at least two of them that he understands.

Darleen Martin said that sounds good and thanked him.

C. Legislative Affairs Update

Speaker Johnson asked if there was anything under Legislative Updates. Johnson said the Ogema already shared about their visit in Washington, D.C however they did also meet with the Units of Government last week and it was very productive. Johnson said as a matter of fact Filer Township joined in and one of the things that they are talking with the City is about the overflows with the water on rainy days. Johnson said they are working jointly with them on how to resolve that problem and it is working out very well at least with the discussions they are having. Johnson said also on the next meeting they will be happy to announce

about the improvement on M-22 to US-31. Johnson said he is sure they are going to be happy to hear that also. Johnson said that is all he has for Legislative Affairs. Johnson said of course the other two people, Councilors Burger and Crampton, he is sure would have some input on the federal level on some updates with what is going on but they are not here.

D. Public Comment Period

Bridget Cole said they move fast now, it's like geez, she just stepped outside and by the time she caught up with her glasses they are done. Cole said Tribal #1110, just came and is just visiting and came into town. Cole said she had a few questions that she kind of was, they know, with media and stuff talking with Councilor Crampton about and she is kind of interested. Cole said there is a lot of hoopla going on around this new legislation that they had passed about some...their preference or last week and they are all looking at her like they don't know what she is talking about.

Speaker Johnson apologized and said he didn't hear the question about what again.

Bridget Cole said about the preference.

Speaker Johnson asked about the Preference Ordinance.

Bridget Cole said on some new legislation that has just been.....her intentions were to get here early enough to look at.....she heard that it was posted this week. Cole said she just had some comments for that and is kind of concerned that they are kind of getting to the point where they are becoming a punishing people and they are not a punishing people. Cole said she would hope they can understand like when they are making these laws and writing them down they putting them in their history and they leaving them for their children so when.....20 years down the line after they are done with this whole thing and they are gone their grandkids are going to be reading this stuff. Cole said they are going to wonder that they needed laws to.....like this for to govern themselves and that is the kind of expectations that they are putting for their generations to come. Cole said it is not for her to......she has an opinion about it and she is not agreeance with how that thing came out but they were elected by their peers so they know but she does have a right to say that she thinks it's wrong and think that if they are worrying too much about punishing a very few people instead of taking care of those few people that are causing the problem and writing laws to everybody's history that they can't......it is not easily taken away. Cole said she guessed that is all she has to say.

Speaker Johnson asked if there was any other discussions or comments.

Brian Gibson, Tribal #1812, said he had a concern about the......somebody had mentioned to him and he doesn't know if it is true or not but is just asking them to check in on it. Gibson said the Forestry Red Pine that they took down that they lost \$20,000 on the sale because they waited so long to take the......get the contract done and everything done to get the wood sold. Gibson reiterated that he is just asking them to check into that and/or maybe they can answer it right now if anybody knows if that is true or not true. Gibson said it is getting really concerning to him that it's frustrating because they are cutting Budgets and doing this or have cut Budgets in the past and everything. Gibson said to lose \$20,000 is not a drop in the bucket and is quite a bit of money to him anyways.

Councilor Medacco said as one Council member sitting up there he has not yet seen a contract come in front of him for any kind of sale for any kind of wood.

Brian Gibson said if that doesn't go through he heard by May that they might be paying for it to get chipped up so that is \$45,000 and he is doesn't if there is an emergency way to get this done to get the contract pushed through or anything like that or if this is true. Gibson said he is not for sure that it is true so.

Ogema Romanelli said to Brian Gibson just so he heard him right and what is being said is they lost \$20,000 in the sale of the Red Pine because of a delay in the handling of the contracts.

Brian Gibson explained that when the wood dries out he was told that the price of it goes down and it is drying out and the Forestry or the Mill Yard said that if they wait any longer it or much longer that it is going to be chipped. Gibson said they would be paying for somebody to chip it. Gibson said that is what he was told so he just wanted to check in and see if they would check into it and make sure something happens and take care of it.

Ogema Romanelli said he will send out an e-mail this afternoon and send it to Tribal Council as well, cc Tribal Council on it. Romanelli said to Brian Gibson that he can probably cc him on it too depending on what it is. Romanelli said if it is contractual he may not be able to cc him on it.

Brian Gibson said to the Ogema if he says he is going to take care of it he will take his word on it and that he will look into it. Gibson said that is all he just wants somebody to look into it and if that is the case that is......he doesn't know.

Ogema Romanelli said they wouldn't want to lose \$20,000.

Speaker Johnson asked Councilor Di Piazza if he saw his hand.

Councilor Di Piazza answered no that Councilor Medacco answered because they just haven't seen a contract come in front of them.

Speaker Johnson said he just wanted to add on Public Comment that the C-Store has moved forward on their ability to get the computer upgraded and that. Johnson said it looks wonderful and he talked to the Manager there and they said they are working on getting the card reader done. Johnson said they were hoping to have that done today or in the next day or so. Johnson said they thought they were going to be done all day yesterday but they are working very hard at getting this thing up and running and as a matter of fact they opened up for business earlier than anticipated so that was wonderful.

Ogema Romanelli said that was nice.

Speaker Johnson said they are moving in the right direction and he wanted to thank the C-Store for making this big step forward because he thinks it is only going to help out the customers but the Tribal members who are customers also. Johnson said it is going to be a win, win.

Ogema Romanelli said it should make the process easier and less intrusive on other customers.

Speaker Johnson agreed.

The purpose of closed session is to discuss business matters considered privileged or confidential involving consideration of bids/contracts, pending legal issues, and/or personnel matters.
