OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on August 28, 2024. Following are the minutes of that meeting.

Speaker Burmeister: Good morning, everyone. We are here for a regular scheduled tribal council meeting for Wednesday, August the 28th, 2024. Um I just want to apologize to everybody. We were having computer issues, so those have been resolved. So, we will begin our meeting uhm with an opening prayer. I have asked Councilor DiPiazza if he could say the prayer. So, if you're able to stand, please stand.

Councilor DiPiazza: (Prayer in Anishinaabemowin) what I said is I prayed all creation. We can all work together for the betterment of all of our people and give them all better way of life. With that being said Miigwech, Miigwech, Miigwech.

Speaker Burmeister: Thank you councilor DiPiazza. Okay next, um we will move down

Councilor Wever: Oh gee. Support.

Ogema Romanelli: Thank you. I just wanted to address closed session number VII. C.1, it has been postponed that has to do with the economic development corporation funding in the amount of \$2,062,495. Uh the reason I'm bringing it up is because it lists the tribal Ogema as the presenter. Uh I sent the EDC board uh and the council a concern on that because my understanding is that there was under agenda review. Uh it was said that Frank Lewis, who is the chairperson, was not in attendance, nor was the Ogema. I'm not sure why the Ogema is listed as a presenter. I believe this would be under uh the EDC board. Frank Lewis as a chair, and we understand that the EDC board is under the Tribal Council. So, I just want to make note of that. I did try to get on the meeting. Uh I got on about 20 minutes after the meeting started, and I couldn't get in. Uh I waited for about 10 minutes, and then I contacted the recorder. Uh but I just wanted to make that note because I believe that would be Frank Lewis should be the presenter. Thank you.

Speaker Burmeister: Go ahead, councilor Wolfe.

Councilor Wolfe: Well, I can explain why the Ogema is on the agenda, and I was the one that did ask for Frank Lewis just because of the reasons he stated. But the agenda request came from the Tribal Ogema, and Larry, you signed it on 8-15. So.

Ogema Romanelli: Okay.

Councilor Wolfe: If your. I agree with you, what you're saying should be Frank Lewis, and Frank Lewis should resubmit the item with the agenda request. But that's why your name is put onto it. Thank you.

Ogema Romanelli: Right. And that goes back to the concern that we've had, or I've had for a while, is that I've asked the Tribal Council and the EDC board and the Ogema to get together because we really need to make sure we each understand our duties and responsibilities within that document. And I think sometimes it gets a little skewed.

B. Budget Modifications

1. Approval of Budget Modification MB2024-__; authorizing the Reduction of funding from Health and Human Services-Low-Income Home Energy Assistance (LIHEAP) in the amount of \$10,074. Ogema Romanelli and Jessica Steinberg have brought this item forward. So, Jessica the floor is yours.

Jessica Steinberg: Thank you, Madam Speaker. This is um funding that was unobligated through a series of several awards um prior to my joining the administration. And whenever we have an unobligated fund balance for the program, um at the conclusion of the time periods that the awards funding period um is designated, then we would send them back to the agency. So that's what this is.

Speaker Burmeister: Thank you. Will there be any councilors that are going to abstain from this item? Any councilors with questions? Go ahead, Councilor Metzger.

Councilor Metzger: Thank you, Madam Speaker. Uh returning these funds, are they going to uh give us a negative impact on receiving additional funds in the future?

Jessica Steinberg: That's a good question, Councilor Metzger. Uh no, it should not. These were funds that were additional funds awarded to the tribe under the CARES Act and ARPA programs. So, it was actually a surplus of funding. Um it shouldn't reduce the initial or the original award or the award going forward.

Lee Ivinson: Thank you. Um question for Jess. Was the designation for the additional funding for the LIHEAP in the era of ARPA, um was there a specific scope that those dollars were to be expensed to?

Jessica Steinberg: They were expensed under two different pieces of legislation. Was a supplemental. Um those were just additional funds to support the objectives of the program grant and then under the infrastructure um legislation. And those were mostly dedicated to um weatherization type assistance. And as you know, during COVID, there were probably um not as many of those types of activities going on. But it shouldn't, because they were awarded under those two separate legislative pieces, it shouldn't have any impact on the normal LIHEAP funding going forward.

Lee Ivinson: Thank you.

Speaker Burmeister: Thank you. Any other tribal citizens with questions? Back to Tribal Council? Okay. With no further questions, I'd like to entertain a motion, please.

Councilor Wolfe: Sorry Tammy I didn't get my hand up fast.

Councilor Wolfe: Um were we eligible to apply for an extension to keep those funding dollars? I know most ARPA dollars uh didn't uh expire for tribes.

Jessica Steinberg: Unfortunately, no, we were not eligible to ask for an extension to expend the funding. Um part of that reason was because when I came into this position, we had um to go back through and look at all of the expenses. And some of those expenses that were um put into the LIHEAP program actually needed to be moved into the members program. They were expensed to the wrong account under the previous administration. So that's the end result was this funding were expen were um originally expensed to an incorrect account. So, it created the surplus. And because the surplus was not eligible for an extension, um we weren't able to re-obligate it.

Councilor Wolfe: Okay, I was just wondering because I know housing got ARPA dollars and those were expended pretty fast on their emergency program. So didn't know if there was any on those that would have been eligible, but there's was repair. So just just a question. Thank you for your answer.

Jessica Steinberg: Yep, You're welcome.

V. New Business

ADD: A. Acceptance for filing the revised Gaming Commission Regulation #R400-04: GC-06- chapter 6 Gaming Vendor Licensing.

Councilor Wolfe has brought this item forward. So, councilor Wolfe the floor is yours.

Councilor Wolfe: Okay thank you. Let me pull up the item that I have. Um so, what this is is Gaming Commission Ordinance 04-400-04 requires all Gaming Commission Regulations to be adopted by the Gaming Commission by written resolution and filed with the Tribal Council Recorder, which then shall be placed on Tribal Council Agenda for acceptance. So, we did update the Gaming Commission Regulation um through the NIGC, and these are just following suit to adopt those new uh regulations. Um this will be the same for all three items. One, what are they? A, B, and C? Anyways, the next three items. Um the regulations are updated to provide clarity and detail to assist in a consistent and fair implementation of the Gaming Ordinance. There were. Due to the new rules issued by the NIGC, um and we're on Chapter 6, so that's all I have on that one, and they were adopted by the Gaming Commission Resolution. This will allow them to be um put into practice by the resort. Thank you.

Speaker Burmeister: Thank you. Will there be any Councilors that are going to abstain from this item? Any Councilors with questions? Go ahead, Councilor Metzger.

Councilor Metzger: Thank you, Madam Speaker. I'm uh looking at the reports or the uh agenda paperwork that was submitted, and I actually don't see a resolution in here from Council. Is that acceptable if we just uh submit the Gaming Commission Resolution, or do we need a resolution from Council to push this forward? Thank you.

The tribe is the host this year for their annual conference, so it's um the Food Distribution Program, and all of their staff is here. And I'm participating um to support that today and tomorrow. Um and then the second one that I have, what I wanted to share, um on August 24, 2023, Judge Mahoney of the United States District Court for the Western District of Michigan approved and ordered implementation of the Great Lakes Consensus Decree. So Little River along with the other core tribe's um and the State of Michigan and the federal government have been negotiating for more than five years to come to agreement that ensures preservation and protection of treaty rights of signatories to March 28, 1836, Treaty of Washington and the Great Lakes. So that has been accepted. It does look like over the next few months; they'll continue to update on the regulations. And then um I believe the Ogema is going to be making an announcement when there is the official

signing of the decree. So just wanted to share that. Thank you. Oh, and the holiday for September 2, I believe it is.

Sara Agosa: I have some questions. And since I can't get back in the queue, I just want to make sure that nothing is ignored or glossed over. And I'm at least given a response of how to follow up. My first question is on the financial report work sessions. I'd like a status update on the financial reports. The last time I attended the financial work session, the Ogema nor his staff showed up, um which inconvenienced us as tribal members. We were waiting for the meeting to start, and it never started. So, I'd like an update on these work sessions. First of all, has the April financial report work session occurred? I can't access a calendar right now. So, I wanted to get a status update on that particular work session. And then what is tribal council's plan to make sure this does not happen and that if work sessions are scheduled, staff show up. And that's out of respect for our tribal community. That's my first question. My second question is regarding the membership meetings and the Budget and Appropriations Act work sessions. Will those be scheduled next week? Those are really important. So that's my second question. My third question is I scheduled a work session on closed sessions and the outcome of the session was to get a legal review. And I just wanted an update if a legal review has happened and when my work session will be scheduled to go over the legal review. My final question is about the currents. I scheduled a work session on our newsletter, The Currents, and I submitted an information request and it's been a couple weeks. And I'd like to know when my information request will be filled. Those are my questions. Thank you.

Recorder Johnson: I can start answering them. Um so your first question about the ah financials, it is rescheduled for tomorrow. Um I have not heard um if it needs to be rescheduled or not at this time. I'm waiting to actually hear from her. Um I did send her an email, um but it is rescheduled for tomorrow at 9:30, I believe. Um your second question, yes. Um what was the third question?

Speaker Burmeister: Was she going to hear about the membership meeting and the budget and appropriations.

Recorder Johnson: Oh, um we just got the legal review back um yesterday. So, on that, on waiting for the legal review. So, we did just get that. The other problem we have, or part is that during these work sessions, I've allowed my staff or yeah, allowed my staff not to attend in person. I think we've had this discussion before. Because what happens with work sessions is we send the information that's required or requested. And at the work sessions, there's been some pretty rough uh discussions that have happened. And I don't think that I should subject uh staff to that type of behavior. So, they can call in or they can send the information. And but I'm not requiring them to attend in person. So, I hope that answers the questions. Thank you.

Speaker Burmeister: Thank you. Councilor Wolfe, you are next in the queue. Did you,

Councilor Wolfe: So, we did receive an invite and it was scheduled on our calendar and it was sent to the Ogema and the CFO and neither one of them have responded to the Outlook invite at this time.

Lee McCaslin: Um this is for the recorder. And uh uh so that we all get in the same page one day. Um the Northwestern Territory of July 13, 1787. And why do we have to educate our first graders? And this goes to the line of uh my comment on the Filer City

biomass carbon removal and storage. You know, and the net negative study. 98 steps to make it like Palestine or Palestine. Right? And we got 11 counties that are wanting to use this facility of the Niagaran shelf or the Niagaran Reef. And the uh Northwestern Territory gives us free informative prior consent of uh putting our data into it. And within the study, I see 98 steps, but I don't see this happening in Filer City. Um you know, and when we have to educate a first grader on the Northwestern Territory, and it gives us that free informative and prior consent and within the study, I'll give you the number. The project number is DEFE0032262. That's the biggest disaster that will ever have and to Manistee. And it going out on rails, Um is it going to replace the water that we're entrusted with 21% of the world's water right there. In my experience, when I was down working in that oil field in that area, it's nothing but a basin of salt. You have H2S along that route. You have 11 counties connected. You know that 26 uh feet pipeline to get piped into Filer City. You know, you have all those components, but then you have pressure. Uh our children shouldn't be subject to earthquakes and clean drinking water. And that's exactly what's going to take part right here. If we don't see the Northwest Territory in that date and getting something intimated and giving it back to them on the table, you know, I give it to the recorder. You know, we're we're a nation built on trust. And this trust right here is being taken away from us. Our legal right, our inherited right to this earth, our clean water. And in that basin, there's nothing more exciting when those alarms goes off and you're working in a non-livable atmosphere and you're trying to control that situation. I understand all that from basic training. You know, we need to implement some of these rights of nature or the RONS ordinance, you know, the rights of nature. Everything has a right to clean water, clean soil, clean air. And right now, with Filer City coming in, which most of the members don't even know about, 97 uh 98 different steps to take us out. But uh I just want to say to the recorder that we should get this information out. Our uh geologists, uh our self-determination of education, Uh Dr. um Tony Ingraffea from Cornell University, retired, fishing in Alaska right now. But I would trust any one of his students with this. You know, we need another, that's 11, 11 counties of nothing but pure raw crude coming at you. You're being the hub. Nothing to breach the Great Lakes is right there. Take it out on rails. Yeah, carbon capture. I understand that. We have Sandra Strangraver. Now, trust anyone that those science and the education is talking, not this uh northern star clean energy. You know, we got to take that and hear it right.

Speaker Burmeister: Lee your time is up.

Lee McCaslin: Okay Miigwech.

Speaker Burmeister: Thank you. Next in the queue is Mark. Go ahead, please.

Mark Huddleston: Miigwech. I have two things, one question and one comment. Uh my question is the uh tribal council strategic plan for 2024 or five. And uh I read on something on um online gaming. It says some experts believe that the market could face a correction due to factors like market saturation, regulatory changes and economic shifts. That's all I have.

After that, the Ogema then sent emails that he was no longer going to allow his people to attend our emails or our work sessions and we have that down to the date of the emails, but the membership was in on that work session.
