The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on August 2, 2017. Following are the minutes of that meeting.

Acting Recorder Di Piazza said to Acting Speaker Lewis that the recorder is on.

Acting Speaker Lewis Aanii, miino kiiak. Lewis said welcome to the Wednesday, August 2nd, Tribal Council Meeting. Lewis said Acting Recorder Di Piazza has asked Grace Hendler to say an Opening Prayer for them.

Willis said this is the annual IHS Well & Septic Program funding that the Tribe has received on a regular basis each and every year. Willis said the money is going to install wells and septics for Tribal members. Willis said they just need to accept the money and amend the Operating Budget.

Jason Cross said it depends on which one. Cross said they have three active right now and the oldest serves 16 and the next oldest serves 23. Cross said the one that they are talking about serves 15 Tribal members so far.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said this item represents Modification #9 to the 2017 Self-Governance Compact with the Bureau of Indian Affairs. Willis said these funds are specifically earmarked for Contract Support Costs. Willis said they originally estimated they were going to receive or projected they were going to receive \$300,000 for the entire year. Willis said year to date they have received \$679,893 in Contract Support Costs. Willis said it is good news is what he is trying to say.

The contract funds are awarded as part of the 2017 Self-Governance Compact.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said this item represents Modification #10 to the 2017 Self-Governance Compact with the Bureau of Indian Affairs. Willis said the funding is appropriated between Public Safety \$185,061 and Great Lakes Restoration Initiative in the amount of \$195,000. Willis said year to date that brings them up to \$779,796 more than they projected. Willis said once again good news.

Acting Recorder Di Piazza asked Bill Willis if he could repeat the number for overage again.

Bill Willis said \$779,796.

Acting Recorder Di Piazza said wonderful.

Acting Speaker Lewis asked if there are any other questions on this item. Lewis recognized Councilor Friedel.

Councilor Friedel asked if Public Safety will be able to purchase like new cars and equipment by the end of the year.

Bill Willis said they are hoping to. Willis said he knows he met with the Director of Public Safety in the fall of last year and they talked about putting together a

plan to replace some of the vehicles. Willis said they met with him again a couple of weeks ago regarding his 2018 Budget and once again they had a conversation about putting forward a plan to Council to cycle out some of the vehicles so there is a plan in motion.

Councilor Friedel thanked Bill Willis.

Acting Speaker Lewis asked if there are any other questions. Lewis recognized Councilor Crampton.

Councilor Crampton said well he knows the years when they have done this most of the police cars they traded in for the price off and he has always asked if they could make those available to members for the same price deal. Crampton said not making it more of losing money giving them to Tribal members but offering them to Tribal members who can pay first so they don't lose the deal. Crampton said providing them to members first.

Bill Willis said he will definitely recommend that to the Ogema, yeah.

Acting Speaker Lewis recognized Councilor Friedel.

Councilor Friedel said he thinks when the public.....the.....when ____ was still here he thinks the conversation took place that the reason why they didn't do that was because in case something was wrong with the car, they had an accident, they couldn't come back on the Tribe or something like that. Friedel said he thinks that was back when Mary Velikan was still here because he had asked the same question.

Councilor Crampton said well so long as it is sold as is there is no problem.

Councilor Medacco said they have clarification.

Acting Speaker Lewis recognized Rebecca Liebing. Lewis asked Rebecca Liebing if she wanted to come up and speak on this item.

Rebecca Liebing, Unified Legal Department Attorney, said so the changes in the Land Use actually reflect all of the resolutions and laws that are already out there. Liebing said so the ordinance as it currently stands is.....would need to be changed and that is kind of why it is in front of them. Liebing reiterated what is reflected in the changes is actually reflective of the resolutions Tribal Council has passed since that ordinance was passed a very long time ago and the Natural

Resource Regulations which also has some kind of governance over land use as well. Liebing said she understands their concerns but actually this correction addresses their concerns.

Councilor Medacco thanked Rebecca Liebing.
