# A. Grants & Contracts

1. Approving the Submission of a Grant Application to the U.S. Department of Health and Human Services (HHS)-Child Care Development Fund (CCDF) to help fund the Next Generation Learning Center Operations for 3 years (FY 2020-2022) There are no matching dollar requirements.

Acting Speaker Di Piazza said Jason Cross is here to represent that. Di Piazza said to Jason Cross that he has the floor.

Jason Cross, Director of Family Services, represented this agenda item. Cross said good morning. Cross said this is a three-year grant from the United States Department of Health and Human Services Child Care Development Fund. Cross said this grant is for like he said three years and there is no match. Cross said this grant will be used to offset expenses, so most...just about all this grant will go to the bottom line.

Acting Speaker Di Piazza asked is there any questions for Jason Cross at all. Di Piazza asked any discussion. Di Piazza asked is anybody going to abstain. Di Piazza asked can he get a motion on this item. Di Piazza recognized Sandy Lewis.

Councilor Lewis said she would like to make a motion.

Acting Speaker Di Piazza asked is there any discussion on the item. Di Piazza asked again is anybody going to abstain. Di Piazza said with that being said. Di Piazza asked Acting Recorder Lonn to do a roll call.....oops he is sorry. Di Piazza recognized Cindy Champagne.

Councilor Champagne said she is sorry she should have asked this question earlier. Champagne asked Jason Cross he said this is to supplement the Child Care Center.

Jason Cross said yes.

Councilor Champagne said okay. Champagne asked how many Tribal children are enrolled over there.

Jason Cross said he doesn't have an exact number. Cross said it is 38% of the children over there are Tribal affiliated which means they are either enrolled members, descendants or employee children.

Councilor Champagne said isn't it true that the age group to enroll is 0 to 5 or is it higher.

Jason Cross asked for the center.

Councilor Champagne said yes.

Jason Cross said 12 and under.

Councilor Champagne asked 12 and under. Champagne said okay according to their stats they only have 33 Tribal children in Manistee from zero to 10.

Jason Cross said okay.

Councilor Champagne said so she guessed she is wondering how this is benefitting their population as a whole.

Jason Cross asked the center itself or this grant specifically.

Councilor Champagne said no the center itself because this is going to be used towards the center.

Jason Cross said well the center itself is Long-Term Economic Development. Cross said their community depends on the children of the future to be their employees. Cross said only 10% of the casino's employees are members. Cross said most of those are community members. Cross said those are children that they are teaching. Cross said only about 60% of this building employees are members so that is about 40% that they need from the community. Cross said that also provides employers better employees, which improves the economic situation of this county. Cross said economic situation of its community members, which could eventually equal more disposable income, which helps the casino. Cross reiterated it is a Long-Term Economic Development Plan that is what it is. Cross said he believes the children are their future. Cross said they teach culture to every children....every child there whether they are Tribal or non-Tribal. Cross said that helps with hopefully long-term communication between Tribal members and non-Tribal members in this community. Cross said he thinks he means he could go on about what he thinks the benefits of the center are to the community but that is just his opinion.

Councilor Champagne thanked Jason Cross.

Acting Speaker Di Piazza asked Cindy Champagne if she was all set.

Councilor Champagne said yes and thanked Acting Speaker Di Piazza.

Willis said this is the fourth and final year of this particular grant award. Willis said year to date including this \$50,000 they have received \$175,000 so this runs through September 30<sup>th</sup> of next year.

Willis said it appears to be the last year of this particular grant but anyway this grant is also administered by Jason Cross and his department. Willis said so if Council should have any specific questions.

Acting Speaker Di Piazza asked does anybody have any questions for Bill Willis or Jason Cross. Di Piazza said with that being said he looks for a motion on this item.

3. Acceptance of contract funds from the U.S. Department of Interior-Bureau of Indian Affairs and approving a modification to the Operating Budget MB-2019-\_\_ in the amount of \$40,265

The contract funds are awarded as part of the 2018 Self-Governance Compact.

Acting Speaker Di Piazza said to Bill Willis that he has the floor.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said as he represented in Agenda Review Monday these are actually funds from 2018 that the Tribe is receiving. Willis said if they look at the letter that he has attached from the Department of Interior it basically says to be eligible to receive a one-time or base funding increase under the BIA OJS which is the Office of Justice Programs Tribes must have submitted their monthly Crime Stats and Drug Reports each month from the prior......from the entire previous year. Willis said so that is obviously the result of them receiving this additional money so they know he guessed great work by the Public Safety Department. Willis said so just need to accept the money and amend the Operating Budget.

Acting Speaker Di Piazza said okay. Di Piazza asked is there any questions for Bill Willis on this item. Di Piazza recognized Cindy Champagne.

Councilor Champagne said to Bill Willis as she asked him in their work session what does that S-GOIP 2 Years the amount of money \$2,873,899 what is that used for. Champagne asked is that the Tribal Police's salaries or what is it.

Bill Willis said in this particular case this is just a one-time non-reoccurring amount but......

Councilor Champagne said she understands that part. Champagne said it is the other amount that she was questioning.

Bill Willis said um, as he, he thinks he mentioned Monday the Self-Governance Compact with the Bureau is made up of a number of programs Education, Family Services, Public Safety, Natural Resources and in some cases Tribal Court so that money is allocated to those programs based on allowable expenses which salaries and fringes would be one. Willis said so because the Tribe is Self-Governance the Tribe can determine what expenses they want to spend the Federal money on verses Tribal money so he did bring that up, her request, he guessed if they will to both Steve Wheeler and Jay Sam. Willis said Jay Sam said he would recommend that if she hadn't already looked at the Self-Governance Compact, the Funding Agreement that the Tribe recently authorized or approved. Willis said that kind of outlines the programs that are included it may not necessarily show her exactly what programs they are receiving or what funding but he can follow-up with Tammy Burmeister and see if he can get an additional report. Willis said he doesn't know if one exists but anyway those are primarily the programs.

Councilor Champagne said okay and thanked Bill Willis.

Bill Willis thanked them.

Acting Speaker Di Piazza said with that being said if there is no further questions. Di Piazza said oh, he is sorry, recognized Shannon Crampton.

Councilor Crampton said so he was confused by that answer so what is the money exactly used for.

Bill Willis said it is used for allowable expenses, which they know, depends. Willis said it could be vehicles.....

Councilor Crampton said so he doesn't know.

Bill Willis said.....could be fuel it could mileage....he means it depends on the program expenses. Willis said he doesn't do the reports Tammy Burmeister does the reports on all grants and contracts so she would be the one to supply Council with any specific reports that may not already be included in the Financials. Willis said so he does believe in the Financials Revenue and Expenditure Reports are included which show at the top the revenue that has been received for that particular program whether it be Tribal Revenue, Grant Revenue, Program Revenues so that may give Council some indication of how the money is kind of flowing through the Accounting Systems so but he will still follow-up and see if he can get Cindy Champagne something.

Councilor Champagne said she would appreciate it.

Bill Willis said she is welcome. Willis said to Shannon Crampton he doesn't know if that helps but.....

Councilor Crampton said not really.

Acting Speaker Di Piazza said okay. Di Piazza said he is looking for a motion on this item.

Councilor Guenthardt said he will make a motion.

# A. Approval of Right-of-Way Documents for the Public Safety Parking Lot Construction Project

The Bureau of Indian Affairs needs a resolution approved by Tribal Council in order to convey Right-of-Way and Easement Rights to the Tribe for road construction on the Public Safety Parking Lot Project.

Acting Speaker Di Piazza said to Steve Parsons that he had the floor.

Steve Parsons, Planning Department Coordinator, represented this agenda item. Parsons said good morning. Parsons said one of the BIA Road Construction Projects they have planned for this year is the reconstruction resurfacing of the Public Safety Parking.....well it is actually the Justice Center Parking Lot but it is called the Police Department Parking Lot on their inventory is what they called it so that is the name that it goes by. Parsons said in any event that project is scheduled for this year but the building, the parking lot; all of the facilities up there sit on a parcel that is currently in trust. Parsons said in order to proceed with this project they need to get a Right-of-Way approval from the Bureau of Indian Affairs. Parsons said in order for that to happen the Tribal Council has to approve a resolution authorizing them to approve and submit the Right-of-Way back to them. Parsons said he knows it is a little convoluted but that is the way it works in those cases. Parsons said so what this is a resolution for Tribal Council to authorize and approve that they can send to the Bureau of Indian Affairs in order for them to process the Right-of-Way Application and get it sent back to them. Parsons said once they have done that then they can proceed with the project.
