Position: Brownfield Specialist - Natural Resources Department (Full Time – Regular) (1) – Grant Funded Position.

Summary: This position will be responsible for the administration of the Tribal Brownfield Program – evaluate and monitor the assessment, remediation, and redevelopment of Brownfield sites within Tribal Territories

Employment Qualifications:

Minimum Necessary Qualification:

- Bachelor's Degree in Environmental Sciences or closely related field.
- Knowledge of State and Federal Brownfield laws, statutes, and programs.
- A valid Michigan Operator's License with the ability to be insured under Tribe's insurance policy.
- Intermediate computer skills in Microsoft Office applications.
- Strong verbal communication, written communication, organizational, project management, interpersonal and teamwork skills.
- Heightened attention to detail and accuracy; and
- Commitment to confidentiality.
- The ability to obtain and maintain one of the following for international travel to Canada: a valid passport, a valid passport card, valid State of Michigan Enhanced Driver's License within 90 days of employment.
- Superior performance in the selection process as determined at the sole discretion of the LRBOI Hiring Manager, including but not limited to all of the following: any pre-employment interviews, skills testing, credentialing, drug screening, background investigations, reference checks and previous work history, passing a pre-employment drug test and background investigation, possession of a valid Driver's License throughout employment and being insurable under the Tribe's insurance policy.
