Position: Cafeteria Worker – Elder Meals Program – (1 – FT, 1 – PT) Grant Funded 100% – One Year positions

Summary: The position is responsible for preparing and serving food and maintaining a safe and sanitary environment in support of the Elder Meals Program.

Employment Qualifications: Minimum Necessary Qualifications -

A qualified candidate offers:

- High School Diploma or GED; and
- Six months experience of cooking and food preparation in a restaurant or cafeteria setting; and
- SERV Safe Food Handler certification or must obtain within 90 days of employment; and
- Needs the manual dexterity and ability to operate kitchen equipment, knives, utensils and to routinely carry work-related materials up to twenty-five (25) pounds and occasionally lift up to fifty (50) pounds; and
- Must be able to help teach classes on safety protocols in this new Post Covid environment with a
 focus on how to keep safe in public and precautions on preparedness for if Covid is contracted;

- Must be able to help present classes on food safety/nutrition/cooking; and
- Superior performance in the selection process as determined at the sole discretion of the LRBOI Hiring Manager, including but not limited to all of the following: any pre-employment interviews, skills testing, credentialing, drug screening, background investigations, reference checks and previous work history, passing a pre-employment drug test and background investigation, possession of a valid Driver's License throughout employment and being insurable under the Tribe's insurance Policy.
