There is one proposed change that is correcting a typographical error from the last time Council adopted proposed amendments to this regulation.

Figgels said they have a notification period of 30 days and in another place 20 days. Figgels said it was intended in this notification to be 20 days verses the 30.

Frank Figgels asked do they want to make it all 30, okay. Figgels said that was what was original. Figgels said that is what he understood. Figgels said so that is what it is just a notification period is all it is.

Johnson said he encourages their Tribal members to look at this regulation and give input so when they take it down from posting they have their feelings in regards to this. B. Ogema Weekly Status and Business Update

Speaker Johnson said the Ogema is not here but just for the record he would want to make sure that the Ogema......

Councilor Medacco said there he is.

Speaker Johnson said aah, he is here. Johnson said let it be known that the Ogema joined them at 10:14. Johnson said to the Ogema that they are right now at the Ogema's Weekly Status & Business Update and he has the floor.

Ogema Romanelli said he has the floor but he doesn't have any notes right now. Romanelli apologies. Romanelli said he just got off the phone. Romanelli said they are just moving ahead with different things.

Recorder Riley said to the Ogema that they just passed his item.

Speaker Johnson said yes.

Ogema Romanelli asked which was.

Recorder Riley replied the Employee Incentive.

Ogema Romanelli said oh okay. Romanelli said they have obviously started the construction on the 300 houses or the first phase of that down in Muskegon. Romanelli said they are aware of that. Romanelli said he thinks that is about it. Romanelli said he doesn't really have anything and apologized because he doesn't have any notes for them this morning.

Speaker Johnson said they also started construction for the Daycare Center or Child Development Center. Johnson said so that is moving along too.

Ogema Romanelli agreed. Romanelli said that is moving along too and they are hoping that the weather doesn't interfere too much with the housing underground work, etc. Romanelli said it is moving along pretty good though.

Speaker Johnson said there were two issues that they were concerned about, Council is, it was brought to their attention and he wanted to bring it to his attention. Johnson said it is that the vacancies for Binojeeuk. Johnson said they are down to only two members sitting on that commission and they have an Elected Official helping them through the process for voting and so forth on issues in regards to their children. Johnson said it is imperative that they get somebody on there so they have a more.......diversity.....to help on the decisions for their children so that is one area. Johnson said the other one is they want to know where the Election Board is during the......for the re-appointment for one of the people that had stepped down.

Ogema Romanelli said he is not sure on the Election Board and thinks they are looking at both positions. Romanelli said he thinks they have a name for the Binojeeuk that needs a background check but the Election Board he is not sure what they have. Romanelli said they will update them.

Speaker Johnson said they will revisit this probably next Wednesday just to ask again to make sure they keep this moving forward. Johnson said especially the Binojeeuk that is so important for their children that are at risk.

Ogema Romanelli agreed.

Speaker Johnson asked if there was anything else in the Business Update.

C. Legislative Affairs Update

Councilor Crampton said just that Standing Rock issue is now headed to Federal Court and the pipeline is actually losing \$20 million a week and they are urging for the judge to make a decision in that case but he has indicated that he will not and their contracts run out in January 1st, he believed. Crampton said David Archibald from the Standing Rock Tribe issued a statement asking everyone because of the weather not to come out there but instead to stay home and take action in their local communities.

Speaker Johnson asked if there was anything else in Legislative Affairs Updates.

Councilor Medacco said last week he was out in Palm Springs for.....he was out there for three separate conferences and he gave testimony in front of the Department of Justice on Domestic Violence. Medacco said once that testimony

gets published he will bring a copy back for Council so they can review it to see what he was out there when he represented the Tribe out there on that issue.

Speaker Johnson asked if there was anything else. Johnson said he knows that they have the Units of Government Meeting coming up tomorrow. Johnson said they will be talking about issues impacting Little River with the Local Units of Government. Johnson said they also did a ceremony of the check, the 2%, to the Units of Government or to the Township and the Revenue Sharing Board last week so. Johnson said that is what they have in regards to Legislative Affairs Updates. Johnson asked if there was anything else.

D. Public Comment Period

Speaker Johnson said he invites any Tribal member to come forward with their I.D. and share their comments with Council.
