The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on December 7, 2022. Following are the minutes of that meeting.

Recorder Wittenberg said Speaker Crampton the recorder is on.

Speaker Crampton thanked him. Crampton said welcome everybody to the December 7, 2002....2022 ah, Council Meeting for Little River Band of Ottawa Indians. Crampton said at this time have they done a roll call on the members.... for identification.

Someone in the background on the ZOOM recording whispered, "roll call."

Speaker Crampton said that is Melissa Waitner.

session.

Melissa Waitner, Members Assistance Coordinator, represented this agenda item. Waitner said good morning Council. Waitner said um, this is the grant that operates their Elders Congregate Meals and Nutrition Program. Waitner said they have had this funding since 2010 when the program was initiated. Waitner said this application um, if approved from um, the Administration on Aging will fund the program with um, no expense to the Tribe at this point there is no match. Waitner said they have not put any Tribal dollars into this program to date um, they will be funded for the next three years. Waitner said um, they are submitting it today um, so that was kind of the rush that they had to get this moved through and have the resolution for today as well so. Waitner said the average amounts she will say um, the last three years each year's worth of funding was approximately \$125,000 per year so that is for the three-year funding cycle. Waitner said \$374 on estimate.

Speaker Crampton said okay. Crampton thanked her. Crampton asked do they have any questions from Council. Crampton said he has one and that is um, he knows she is new to the position but in the past um, if there was any indication on um, turnaround time. Crampton said he knows they are just applying today but.....

Melissa Waitner said she is sorry, turnaround time for when they will get approval for the grant.

Speaker Crampton said yes, yes.

Melissa Waitner said um, they know, she can't give a specific date um, essentially if they submit this and this is what she had been told by the Funding Agency and this is how it kind of worked in the past is that once they get it submitted because it's a formula grant the only way they cannot get this funding is number one not submitting or number two not being in compliance with the funding um, they know, for every year that they operated it at least in the past three years. Waitner said so it will be submitted once they approve the resolution today and they are in compliance thus far.

Speaker Crampton said okay. Crampton thanked her. Crampton asked is any there any further....

Melissa Waitner said she means the turnaround time should not be very long.

Speaker Crampton thanked her. Crampton asked is there any further questions from Council. Crampton asked anything from the membership. Crampton said ah, okay, he will entertain a motion on this.

Waitner said at this point it is ages 55 and up.

A. Adopting the Fiscal Year 2023 Tribal Government Operations Budget Adopting the Fiscal Year 2023 Tribal Government Operations Budget.

Speaker Crampton said they pretty much beat this to death. Crampton said they went over it and over it at several meetings. Crampton said Mr. Pringle if there was anything he would like to say.

Brad Pringle, Comptroller General, represented this agenda item. Pringle said he was just going to read the portions of the resolution that may be appropriate.

Speaker Crampton said please proceed.

Brad Pringle said at the very bottom of the resolution:

WHEREAS the Tribal Council has authorized Section IV, Section VII, I 1 to approve the annual Budget presented by the Tribal Ogema; and

WHEREAS Tribal Council has authorized under Article V, 1.2.c of the Budget & Appropriations Act to adjust Budget proposals by Line Item increases, deductions, deletions, and additions; and

WHEREAS Tribal Council has held multiple public work sessions to discuss the Budget and proposed Budget proposals; and

NOW THEREFORE IT IS RESOLVED Tribal Council hereby approves Fiscal Year 2023 Tribal Government Operations Budget in the amount of \$41,579,940 with a Gaming Distribution of \$24,000,500.

Speaker Crampton said okay. Crampton asked are there any questions from the Council. Crampton asked any questions from the membership. Crampton said he will entertain a motion.

Recorder Wittenberg said Gary Di Piazza has his hand up.

Speaker Crampton said he is sorry, Gary, he can't see him, go ahead.

Councilor Di Piazza said well the narrative on the bottom saying that the grant funds can be moved around to Public Safety and Government Building. Di Piazza said um, if its grant funding from the Next Gen or whatever that may be them grant funds usually have designated what their attached to. Di Piazza said so that may be a problem people thinking they can move grant funding around like that so.

Speaker Crampton was trying to make a comment in the background on the ZOOM recording but it didn't come through clearly.

Brad Pringle said that is in a question format it says if any can be moved.

Councilor Di Piazza said it shouldn't even be a question but so be it.

Speaker Crampton said no that is the second version that was Pam's concern and they fixed that concern so. Crampton said if Mr. Pringle wants to explain that.

Brad Pringle said sure, the original conversations were around ah, were concerning grant dollars being moved from the Next Generation Learning Center to a Public Safety Legal Fees and the Grant Department removed all that particular proposal one wording. Pringle said they are no longer moving Next Generation Learning Center dollars into other departments. Pringle said it would just be removed from the Budget.

Speaker Crampton said yeah, that is kind of interesting he didn't see that in the report since it was removed. Crampton said ah, okay. Crampton asked are there any other questions from Council. Crampton said he will entertain a motion.

Councilor Lewis said she will make a motion.

Romanelli said he was travelling to different departments. Romanelli said he will have a more full report later after he collect his wits. Romanelli said he travelled and in fact he went

to....for the last few days to the State Summit and that was up in Sault Ste. Marie. Romanelli said so he has been on a little bit of travel to get back in the saddle trying to figure out ah, trying to pick up where he left off. Romanelli said there is a lot of things going on but other than that he can't think of anything else. Romanelli thanked them.

Speaker Crampton said okay, he has a question from Sara Agosa.

Sara Agosa said her question is for the Ogema. Agosa asked um, she is just wondering why they are not informed of travel plans in advance.....

Councilor Wever said she thought they were.

Sara Agosa continued.....and only hear about it afterwards. Agosa said this also happened with the Indian Boarding School event when the Ogema did not attend the Budget Work Sess.....or the Budget Meeting.

Speaker Crampton said he is pretty sure he notified them before he left in a meeting. Crampton said that is how he was notified. Crampton said go ahead Sara.

Sara Agosa asked was just Tribal Council notified or is that given to.....

Speaker Crampton said it was in a public forum just like this.

Sara Agosa said she doesn't recall ever receiving that information and she does try to follow the issues.

Speaker Crampton said okay. Crampton said yeah, it was in a public forum. Crampton said he told them in a public forum in a meeting just like this. Crampton said um, Staci Cheney.

Staci Cheney said um, Speaker Crampton she did want to ask um, um, if he could ask the Ogema um, about.....and this isn't political its about but its just bringing up the question um, about the Muskegon Project because it was in the bio. Cheney said she was curious about um, where.....what is the update on that because she knows that it was published in the Muskegon um, News Press and she is just curious um, if he could help them get an update on that from um, the Ogema.

Speaker Crampton said well looking over the ordinance he thinks that any statements should come directly from the Shoreline Task Force. Crampton said he was going to hold a work session on the Shoreline Task Force just to see what they are going to do with it coming up but he thinks any statement can be ref....that has anything to do with the ah, Muskegon Property, like he said come from the Shoreline Task Force.

Staci Cheney said okay. Cheney said so there will be a work session on that.

Speaker Crampton said he was just.....he is bringing forward something on the works.....work session just to discuss the neness.....necessity for it but if the Ogema wants to answer her question.

Ogema Romanelli said he can answer it in part.

Speaker Crampton said go ahead.

Ogema Romanelli said well that was part of the State Summit that happened and he spoke to the Governor yesterday about their Muskegon Project. Romanelli said that it is not dead yet and is still on-going and there is still some discussions that still has to be had. Romanelli said one of them was held yesterday. Romanelli said he had a 15 Minute Meeting with the Governor directly about the project and about a couple of other issues. Romanelli said so the project is still on-going and he can update the ah, ____ whenever they want. Romanelli said whenever they get together so.

Speaker Crampton said well they need to have that update very quickly then because um, the application they submitted is moot and done and over with. Crampton said they can submit a new one. Crampton said he just wanted to make sure the membership has the right information.

Ogema Romanelli said right. Romanelli said the options for Muskegon Casino are still on the table. Romanelli said that is correct that the first application is dead in the water it did not happen. Romanelli said that doesn't mean there isn't an option for a second application which the Governor is fully informed of.

Speaker Crampton said ____ they can file a new one at any time. Crampton said Staci Cheney.

Staci Cheney said oh, she is sorry she will take her hand down. Cheney thanked them.

Speaker Crampton said okay. Crampton asked are there any further questions. Crampton said if not they are going to move onto Legislative Affairs.

C. Legislative Affairs Update

Speaker Crampton asked is there anybody that has anything for Legislative Affairs. Crampton said he does um, he just asks that members be patient. Crampton said he knows that their Members Assistance is doing a wonderful job with getting the checks out. Crampton said their Accounting Staff has been helping out um, everyone down there....Angela, Laura they have all been helping out everybody's been doing a good job just please be patient. Crampton said as

far as Legislative Affairs he just wanted to point out that um, the other day the Governor did appoint the first Native American Justice to the Michigan ah, Appeals Court and that was Judge Ally Maldonado. Crampton said she was actually a Visiting Justice in their courtroom.

Ogema Romanelli said yes, at the Summit yesterday as well. Romanelli said Judge Maldonado also recognized Little River that she has worked for the Tribe in the past as well. Romanelli said she has been working for the Little Traverse Bay Band. Romanelli said the Governor personally signed it yesterday ah, at the Summit.

Councilor Guenthardt left the Lodge Room at 10:41 a.m.

Speaker Crampton asked is there anything else for Legislative Affairs. Crampton said if not they are going to be moving down to Public Comment.

D. Public Comment Period

Speaker Crampton asked is there anything for Public Comment. Crampton said he is not seeing any hands. Crampton said so if they don't have any Public Comment they are going to be going into Closed Session. Crampton read the following statement:

The purpose of closed session is to discuss business matters considered privileged or confidential involving consideration of bids/contracts, pending legal issues, and/or personnel matters.

Speaker Crampton said he will entertain a motion to Close First at 10:44.

Councilor Lewis said so moved.

Sandy Mezeske said what a disgrace.

Councilor Wever said oh, support. Wever started laughing at this point.

Speaker Crampton said oh, excuse him was that an employee because he knows they have a Personnel Policy around here. Crampton asked was that really an employee that he just heard say that. Crampton said well they will pick this up later.
