#### **REPORTS:**

Chuck Fisher reported out that the Michigan Indian Elders Association (MIEA) is seeking to regain 501(c)3 non-profit sthatus; it was lost during Covid shut down. The organization has lost member tribes and having challenges maintaining participation. MIEA is seeking a sponsor for the April 2025 meeting.

Motion for LRBOI to host the MIEA executive board and delegates only meeting in April 2025, by Marcella Leusby, second Jessica Steinberg. Voice vote from floor: Ayes – majority affirmation — Nays – none. Motion carried.

Chairperson Steinberg wanted to address the concerns by creating opportunity for persons who had traveled to attend the conference, and were in attendance at the regular meeting, to seek nomination for representation to the committee. Chairperson Steinberg then informed the group she would entertain nominations from the floor for the Chairperson's seat, or all seats if that be the pleasure of the group.
