The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on February 19, 2025. Following are the minutes of that meeting.

That was a restricted account, and all activity in that account should have done by resolution or motion, and none had happened outside of that. So, um that's why it's postponed because it says zero dollars in there. We're still figuring out that information, and we'll have an immediate the work session to discuss it further on Friday. I don't know if it's been said on that yet or not, Pam.

Um and as long as we follow and abide by those rates, um we can um forgo they're basically snooping around, hunting around, making sure that we are um being accurate with our reporting. So, it's kind of an agreement that we set these amounts, which are normal and average throughout the industry. Um as long as we stay within those ranges, then we don't have to worry about them coming in and looking around. Is that?

Councilor Wolfe: I have one more question. There's no um financial obligation to the tribe or the resort with this agreement, correct?

Michael Schrader: No, nothing, nope.

Annie Perry: No, I don't have one.

Councilor Crampton: Then that's fine. I mean, I thought that, well, you're correct.

Councilor Wolfe: Yeah, this resolution was reviewed by the attorney. I believe Attorney Pitchlynn was the one that said there's nothing in here that would be unconstitutional or invalid.

Councilor Crampton: Can we postpone that till second open and review that email? I want to make sure so there's no court cases that come up and try and knock this out.

Councilor Wolfe: Sure

Councilor Crampton: But I'll amend my motion to make a, or I'm sorry, who made the motion?

Acting Speaker Johnson: You did.

Councilor Crampton: Make a motion to postpone till second open till we can confirm uh what Councilor Wolfe has just stated.

Acting Speaker Johnson: As Councilor Silvis, I think you had supported the, or yeah, his support. Okay, you're still supporting.

Councilor Silvis: Okay.

Acting Speaker Johnson: Uh any discussion on the postponement of this item? Recorder DiPiazza, do you have a comment?

Pro Temp Recorder DiPiazza: Well, on the item, I guess, but there was a complete 100% audit done in 2017. So, if you want to catch up with the 10-year audit, I'm all in favor to go back and spend all that money again. I won't be in favor in second open either. So that resolution 17-0503-163 was a complete 100% audit in 2017 on all members. So.

Acting Speaker Johnson: Councilor Crampton, do you have your hand up?

Councilor Crampton: Yes, thank you. It's been explained to Councilor DiPiazza, but he doesn't seem to get it. Um the piece of paper that has been adopted in Council from since 2005 is a piece of paper. Uh the problem here at Little River, and I've already identified it through um the strategic plan, through the Budget and Appropriations Act, is that we have things that are written, and then we have instituted policy that we just do. Um adopting a piece of paper in second does not meet the law that is written. The law that is written says a qualified role. A qualified role shall contain for each person a role identification number, name, address, sex, date of birth, date of death, degree of Indian blood, and degree of Grand River, Ottawa, Michigan, Ottawa blood. Upon conclusion of the initial file review and every five years after, the Enrollment Department shall submit to the Enrollment Commission and Tribal Council in closed session a qualified role. I've just described to you what that entails. What Council has is a piece of paper, a resolution, no qualified role. I went back and checked the minutes. No, there's none in there, and we haven't had video closed session. Every time there's just a piece of paper, there's no qualified role being brought. Not once. Only a piece of paper resolution. But you can all look it up for yourself. It's 7.03. It describes a qualified role and that shall contain all that criteria. Never been brought.

Acting Speaker Johnson: Uh Councilor DiPiazza, you were next with your hand. I'll get you once we get to.

Pro Temp Recorder DiPiazza: Yeah, you can look up the minutes for- for May 3rd, 2017. That item wasn't closed and was moved to open. You were on Council at the time, so I can't recall if it was presented to us or not at that point in time. 17 was a few days ago. But Council did vote and accepted a qualified role in 17 of a 100% audit.

Acting Speaker Johnson: Councilor Crampton

Councilor Crampton: Um I think Councilor DiPiazza just said it himself. It was moved to open. There's no way that everybody's files that were presented in closed could be moved to open. What was moved to open was what was presented in closed. What was presented in closed and moved to open was a single sheet of paper. Oh, maybe it was two pieces that said the resolution. So no, again, he just contradicted himself with his own words. So, if what was brought in closed on the 17th or 2017 was moved to open, there's no way that could happen if that was a qualified role. Thank you.

Acting Speaker Johnson: Okay. So, I just want to say this is just to postpone, guys. Let's not go back and forth.

Diane Lonn: Diane Lonn, 194. Uh Mr. Crampton is very right. In 96, was the first one. And since then, we've had numerous ones. Everyone was uh shown in closed session. Everything that he is stating, and the books are sealed. They're down in the basement. And I went down there today to confirm there is an audit for 2017 or 16. What that was done. And it has everything that Mr. Crampton is saying. And I remember numerous times that I presented it in closed session only. They never were brought out in open. Um there hasn't been one since 2016. Um I found information and paperwork where Jessica Wissner brought forward in 221, which would have been 220, uh to do an audit. And it was stopped by Mr. Champagne and Ms. Wolfe. So there has not been one since 2016. Thank you.

Acting Speaker Johnson: Okay, Uh I have Councilor. Councilor Crampton, go ahead.

Councilor Crampton: So, uh for the record, because this is a legal record now, um you're stating that you presented those in closed session?

Diane Lonn: Yes, sir

Councilor Crampton: Okay, thank you. Because there's no record of a video on them.

Diane Lonn: But I did. And everyone, so these papers.

Councilor Crampton: There is a record of you coming in and bringing a resolution. There's no role. So, thank you.

Acting Speaker Johnson: Lets uh I will put you in queue DiPiazza

Diane Lonn: Um there is. And I presented it to you guys, uh whether you were there or not. Um they looked at it and they said that's when they made the resolution that it was uh to be sealed and put away.

Acting Speaker Johnson: Councilor Wolfe, you're next.

Councilor Wolfe: Well, I want clarification for the record. That is an incorrect statement by Ms. Lonn that in 2021 that I did something. That was an action of the body of Tribal Council. I may have sponsored the item, but it was not me individually that stopped your audit. And you had an and anyone in that position had the opportunity to bring it forward to be in compliance with the law. You're still out of compliance of the law, no matter how the resolution was adopted or unapplied and not followed through with. But it was an action of Tribal Council, not me as an individual with Mr. Champagne. And I support 100% audit fully. And I've told everybody numerous times it's for the integrity and accuracy of our roles for the next generations, for all the people to come, not just all of us here today. And I don't need a comment or response from you. I'm clearing the information because you inaccurately said I did an action. I didn't. Thank you.

Acting Speaker Johnson: Councilor DiPiazza, you're next.

Pro Temp Recorder DiPiazza: Well, I'm going to say in 17, we didn't have Zoom. So, it's kind of hard to find that video.

Acting Speaker Johnson: Councilor Crampton.

Councilor Crampton: Um Zoom, uh there's been video recordings of the Council meetings. There's need to be Zoom so people can participate. And I'm glad Mrs. Lonn made that statement because there's no record of any of what I just said, the detailed list of qualified role. Absolutely not. The only thing you're going to find in the Closed sessions is a resolution that's adopted. Nothing even coming close to what the law states as a qualified role. And we can easily go back and produce this. And I also want to, um this is perjury. We got a Councilor sitting up here saying that this happened in 2017. It's very easy to go back and look at these records. Very easy to go back and look at what Council adopted on that date. So, I want that investigated because that's a lie.

Acting Speaker Johnson: Councilor Silvis

Councilor Silvis: I actually just wanted to thank Ms. Lonn for coming forward and stating her truths on this. And I think that, um yeah, we need to come back into being in compliance. But I think that doesn't need to go back any farther than 2017. It should be in the Enrollment Department's hands like they've always had. And I'm in support of keeping it in the Enrollment Department's hands. And if you were a true tribal leader, you wouldn't be trying to divide this tribe. You would be trying to unite it. Thank you.

Acting Speaker Johnson: Councilor Metzger.

Councilor Metzger: Thank you. Uh I looked at the 2017 resolution. And the question I had was there's six or seven dates prior to that. So back in 2017, did Council take it upon themselves to backdate other audits? Because if you look at that resolution, that's what it looks like to me. We made a resolution to approve five different audits in one setting, going back to 04, or actually 96. So, did Council back in 17 backdate for 30 years? Because if you look at that resolution in 17, that's what it looks like to me. Thank you.

Acting Speaker Johnson: Thank you. Councilor Crampton.

Councilor Crampton: Yeah. Um I'll out uh just a few weeks ago, we had a Councilor travel out to Washington, D.C. I called a friend of mine who's a real leader and asked him to um point out some things for our Councilor that was coming into D.C. to kind of give him some headway since we hadn't had any orientation on the issue. So, uh Mr. Payment got ahold of Mr. Metzger and gave him some. That's a real leader. Real leaders ain't got anything to hide from the membership. If you're setting up, you're calling yourself a leader, and you're trying to hide things from the membership. You're not a leader. Thank you.

Acting Speaker Johnson: Okay. Any other comments from membership? Go ahead.

Ken Metzger: Uh Ken Metzger, 889, Tribal Elder and a member. This is well overdue. Supposed to be done every four to five years, and we ain't had an audit supposedly since 17. Uh there's a lot of cover up there, and there's reasons why they don't want it. And uh I believe 100% audit is what we need here. No questions. Thank you. Chi Miigwech

Acting Speaker Johnson: Ogema Romanelli, you're next.

Ogema Romanelli: Thank you. Uh I take exception, again, when people say that leaders are trying to hide information. Again, as this Council knows, uh I asked for an informational meeting with the Council and the Ogema sitting right here to answer questions. Uh the first one that refused to participate was Councilor Crampton. He said it would be a dog and pony show, as he usually does when we try to get real information. So, I take exception to that. I don't think he pointed it directly at me. Could have been at anybody. But after some of the comments, uh I take it personally. We also know that this, he says that you go back to the minutes and see for yourself. That's

impossible to do because there are minutes that are missing. We know that. Not accounted for. Going back to the time when Ryan Champagne was here. And I'm not sure who was uh Speaker or Recorder. But there are missing minutes. We've been asking for them for several years now. So, during some of this time, the minutes aren't there to record. I'm not going to get into the whole thing. Uh but the problem we have here is if you go into second open now, I'll probably be on the road because I have to attend a United Tribes meeting. What I'm asking is that this uh council give the membership as much notice as they can that they're going into Closed or going into second open. We never know exactly when that's going to be. And if we could get like 30 minutes notice so that uh could be uh people could attend would be very helpful. And I'll try and get on. I'll pull off the road if I have to, to be on the call during second open. But I would really ask that you give at least 30 minutes notice if you can. So that because this is of interest. I mean, it's, it's big enough that Councilor Crampton showed up in the offices today. So, thank you.

Acting Speaker Johnson: Hey, hey, hey, hey, hey, hey, stop.

Acting Speaker Johnson: Right...To your corners, gentlemen. I have you in queue. Don't

worry. Councilor DiPiazza. Hey. No, we are not.

Councilor Metzger: Call 5-0

Acting Speaker Johnson: Hey. Stop guys

Councilor Wolfe: Recess.

Pro Temp Recorder DiPiazza: Call to order

Acting Speaker Johnson: Stop it.

Acting Speaker Johnson: Hey c'mon guys.

Councilor Metzger: stated something but unclear

Acting Speaker Johnson: We are not helping the matter, guys. Councilor DiPiazza, you're next.

Pro Temp Recorder DiPiazza: That resolution I quoted, them are the years that audits were completed. 2019, 2004, 2008, 2010, 2012, 2014, 2016. So, it's not covering anything up. And then if you go back and look at them resolutions from them years, there's been more than just one complete audit up to that point. I'm in all in favor of going and getting this cleaned up for the 10 years that are, should have been done. Council stopped that in 2021. Whether there was a memo, an email, I can't recall. But council stopped that because it was brought forward to do the five year. So, I'm in full support of getting, doing the 10 year and getting us caught up. Other than that, I'm not in favor of digging up bones.

Acting Speaker Johnson: Okay, Councilor Crampton, you're next.

Councilor Crampton: Yeah, my comments were for Councilor Silvis, who's the one that first said about leadership. That I don't know why Mr. Romanelli keeps jumping at people. He just jumped at a member and threatened him again. Uh this is getting ridiculous. This is over something that should have been done a long time ago. If you got nothing to hide, then you got nothing to hide. I'll be number one. I'll hold your hand if you're scared. But this is what other tribes do all the time. Nobody should be scared. But there's a reason they're scared. And I just like to point out something to you in here. Um when you're reading through 7.3, um the purpose of this was to give direction and to create a commission and to give them guidance and uh I think what they did was they kind of strayed away from the Constitution and tried to stray away from the criteria. And you can see how I think maybe I almost envision an attorney being involved. The way they did it was to take the ordinance itself and to walk it away from the Constitution. And the ordinance itself then says that uh the commission shall make rules and regulations to ensure the integrity of the records. If you look at compliance, that's not what they did. Absolutely not. And this is in our ordinance. I want to read this to you. There's constitutional criteria for to be a member in this tribe. This is what they wrote in the ordinance. Upon adoption of the Tribal uh by the tribal council of the qualified role, that's described in here that was never brought to council, the enrollment application process shall require only proof of family relationship to a person listed on the qualified role. You can look at this. You can get it yourself. Um is your uh in-laws related to you? Are your cousins who are not native related to you? That's only what's required. That's what they wrote. And I'm holding a work session to explain this further next week. And the actual attorney who came in and helped us find most of this stuff, holy cow, um the council kind of stalled it off. It was taken off the record. We should have had it about two or three weeks ago. But it was something they were scared of, like the election ordinance. So, they stopped it. But this one was just taken off the calendar and never put back on. So, I put it back on. That will identify for all you guys, all the problems that we have here and why this is sorely needed. When you're talking about protecting our culture, if you have a culture that comes in fraudulently and takes over your tribe to about, I don't know, they could gain voter status. And where's your culture at? If they got the majority of the voters, where's your culture? What's happening to your culture? Whose culture, is it? Not this one. I've been totally confused when I came down here. I've been through, uh like I said, I'm friends with most of the leaders. I can call them up any day of time and talk to them. When I came to Little River, things are absolutely different. Absolutely different than any other tribe, any other nation, and they're in leadership. And looking at this, I can see why. We have a tribe where most of the leaders are getting shoved to the back. And I don't know, I'll leave it at that. But I can show you some employment status too. Thank you.

Acting Speaker Johnson: Thank you. uh I have a comment myself that I um about this and some huge concerns about this. If what you're saying is true.

Councilor Crampton: That's right there in front of you.

Acting Speaker Johnson: Aye.

Pro Temp Recorder DiPiazza: mumbled something but was unclear

Acting Speaker Johnson: Aye. But then we come to a point where you look at different resolutions. Last week, I had read a resolution from 11 as well that covered and had stated that it went back to, whoops. Uh it did everyone's files up until then. I can't remember offhand what the number is. I can get it though uh when we go to break. But if that is the case, and different resolutions I've seen have stated that those files remain with enrollment department. Which, so council would not have those in their files at all. Any of those that they look at them only in closed. If that is the case of what you're stating, then that none of those qualified roles had been seen. Then we have several years of resolutions, our own laws then that are incorrect.

Councilor Crampton: Mm hmm

Acting Speaker Johnson: Because otherwise by those resolutions in 11, I would suggest that we go back from 11 from when the last qualified role was done. And I have you down. Um

Councilor Crampton: Well, you were saying something to my response. I'd like to respond

Acting Speaker Johnson: So, Um I'm going back from that role and looking at it. Because each one of those roles that is mentioned in the 11 resolution, every one of those files can

stand on their own. And I have a problem with if we're looking at, they were shown in closed and yet it really didn't happen. And majority of those votes, the resolution was accepted for what was in those roles. For the qualified role that was taken back to enrollment. So that is a huge issue. Then that's saying past councils for the past 20 years have all been lying. And...and that's a huge issue. Because when you look at our documentation, our qualified roles and everything have been done. They've been completed as they should have been done. We've had over 4,000 member, 4,000 and something, whatever uh it was at the time had been done. And that's a problem because I like to go through and research stuff like there's and look at it and find those things for myself. People give resolution numbers, and I will look them up and look at them and look at other things. And when you find those that says it's been done, there's no need to go back because we have resolutions, which is supposedly part of our laws. I gotcha. Um so that becomes an issue for me because now it has to be proven otherwise that that actually did not happen um without a doubt. And until that is, I... I would say by those resolutions that say it has been done on everybody from the resolution of 2011, that we would only have to go back that far. That's my opinion and my thought on it. And next we have uh Diana, if you want to come up and then I have you.

Councilor Crampton: Oh, you were responding to me. You had-

Acting Speaker Johnson: I was actually on the list.

Councilor Crampton: Okay. Okay

Acting Speaker Johnson: I was next on the list

Councilor Crampton: I'll remember what you said, so.

Acting Speaker Johnson: Good deal.

Diane Lonn: Diane Lonn, 194. Mr. Crampton, I don't understand what you even said at the last time you talked about culture. That has nothing when we're to do with um enrolling people. The Constitution says that anybody that submits an application will bring original paperwork, and I will make a copy and certify it on the back that I've seen the original. Then it says that that it will have a paper trail from that person that applied for a job or an application, a paper trail going back all the way to the Durant role. And that is in every single file. If you look at your file, you'll see your name and it'll go every pay your birth certificate, your marriage license, everything right to the Durant role. I was uh enrollment director before and every time we completed the 96, the 2008, those were brought before council in closed session, and they looked them over. They asked me questions. Um, you may shake your head all you want, sir, but they're down in the uh lock area downstairs. Um and they are the roles up till 2017. And that is down there as well. And it says going back from day one, 1996, all the way through everybody is in that book. So, they've been audited three times now. And I don't feel it personally that they have to go back again. You may say that there's mistakes made. I don't think so. We've had three different auditors come in and audit them. So, this is the same auditor. So, I

don't understand what your purpose is and wanting to go back from day one. I've also heard that you say there's 150 people that don't belong. How do you know? How do you know? Don't shake- I've got the paperwork that shows it that you said it on Facebook. How do you know there's 150 people? I'm asking you.

Councilor Crampton: Oh, she's asking me a question.

Acting Speaker Johnson: No, you can wait your turn.

Diane Lonn: Okay. Anyway, it says

Acting Speaker Johnson: One please

Diane Lonn: He says there's 150 people that shouldn't be here. I want to know how he knew that how he got the information. Because once that person is uh enrolled, no one sees those records. So, I question that. Thank you.

Acting Speaker Johnson: Thank you. Councilor Crampton, you're next.

Councilor Crampton: Um well, just looking at that, I wanted to get to the for the membership, just to point out the obvious here. If you go back and look at the tape, you're going to see Mrs. Lonn saying that uh enrollment audit hadn't been done since from 2016. Now she just changed it to 2017 to match Mr. DiPiazza's claims. Because when she first got up, that would prove everything that I'm saying. She just got up and said 2016. And he is trying to sell you a resolution from 2017 that couldn't possibly be accurate. Um just going back and watching the statements. And people might want to question, everybody knows here, but Mrs. Lonn was removed before from the enrollment department. Why was that Mrs. Lonn?

Sandy Mezeske: That's uncalled for.

Councilor Crampton: No, I'm just asking why were you removed from the enrollment department, Mrs. Lonn? Wasn't it for enrolling people fraudulently? Thank you.

Acting Speaker Johnson: Uh next up is Councilor Metzger

Councilor Metzger: Thank you, ma'am. Resolution 17-0503-163. That's what we're talking about right now. I'm going to read the resolution. And I want you to catch the numbers. Because we say we're supposed to have a qualified role every five years. Listen to the numbers. Adopting a qualified role of tribal members who files were subject to and confirmed by audits conducted in 1996, 2004, 2008, 2010, 2012, 2014, 2016. Those aren't five years apart, are they? As submitted by the enrollment department with a total of 4184 living tribal members and 336 record of deceased. Now, page two. Now, therefore, it is resolved that tribal council of the Little River Band, Ottawa Indians, hereby adopts a qualified role of tribal members who files were subject to and confirmed by audits conducted by the enrollment department in 96, 04, 08, 010, 012, 014,

016. There's four audits that were conducted in two-year periods. Why? When by law they should be conducted every five years. We've had six audits. One, two, three, four, five audits in a 10-year period. But yet we can't get one for the last 10 years? Think about this, people. Pull up this resolution yourself. Look at it. Look at the dates. I am all support of new business continuing on with the audit. Thank you.

Acting Speaker Johnson: Ken, you're next. Okay. Councilor Silvis?

Councilor Wolfe: Do you have me on the list?

Acting Speaker Johnson: I will add you

Councilor Wolfe: I was way up when Shannon was talking.

Acting Speaker Johnson: I missed your hand

Councilor Wolfe: Courtesy, I should be next, not after everybody.

Councilor Silvis: Anyways, I was just going to make a comment that I'm not sure when the enrollment ordinance was actually took into effect when the five years needed to be. I don't think it started back in 96 but. And on top of that, um it says in the ordinance a minimum of five years. Doesn't state a maximum of five years. So, it can be probably happened at any point because it states a minimum of five years. Thank you.

Acting Speaker Johnson: Councilor DiPiazza?

Pro Temp Recorder DiPiazza: Well, enrollment was closed in 2016. The membership voted on that constitutional change. That's when it went to five years. That's why it's been two years or so beforehand. So, there's no hanky-panky here. Oh, my God. Like I said, if you want to go back to when it was presented in 21, council said, stop, don't do it. And every time I believe it was kind of brought forward, it's like, oh, no, stop. Because we want this 100% audit. You don't need to do a five-year audit. So that's why we're at 10 years. And I probably could find the email someplace where it said stop, cease and desist. So yeah, you want to go back and pick up where we left off and go forward? I'm all in support of that. You want to go back day one? I'm not going to spend a half a million or whatever it's going to cost us. Yeah, I'm good.

Acting Speaker Johnson: Okay. Uh Councilor Crampton, you're next.

Councilor Crampton: Mumbled something in the background

Acting Speaker Johnson: okay. Councilor Wolfe

Councilor Wolfe: So, we always get to this point, should we, or shouldn't we? Every other thing that this tribe participates in, we have audits on. Whether we do them for a specified purpose, we have six, seven audits on this agenda that we're going to review

today and accept. But we can't do one for our enrollment at 100%. We did ask them, hey, let's not spend the money on the five-year audit and let's use that money that we want for the five-year audit just to this 100% complete audit. So, I don't know why that's such a big discussion. And after it was repealed, there's been no action by the department to bring forward and rectify incoming compliance with the law. So, I applaud Councilor Crampton for bringing it to the forefront and bringing it again for another...another vote on it. The department's failing. We um, you know, it's a funny thing if we look back in history. We adopted that in 2021 for 100% complete audit. It stalled. It failed. Everyone disregarded the legislation of the Tribal Council. What was past legislation, which was law. But you know what happened? We did that in December. Our enrollment coordinator quit in January. And then it was vacant for a time. And then we got an enrollment coordinator. And then she quit again. And then it was vacant for a long time. And all we've heard since Ms. Lonn has been back in the department, understaffed, unutilized, overwhelmed, don't have time to do anything. Files were everywhere, all over the floor. I couldn't complete applications. Pending membership applications were in violation of the law. They had 120 days to review. We have a newborn baby that is almost 18 months old that's just getting their provisional letter. Why do I know that? Because the member had confidence in their Tribal Council and their legislator to act, advocate for them and told me that information. The member themselves advocating for themselves, advocating for their new child enrolled member. So, there's all kinds of problems with the un enrollment office and the audit. I get enrollments been closed since 2016. You had an audit at 2017. I don't see the problem. And we always say it's about the money or it's this or it's that. You know, every time something gets brought to this body, you know what 90% of the justification is? Well, we have the money. It's told to us. Shouldn't be about being responsible or advocating or making sure resources are equally. We have the money so we should just do it. But this one, when it comes to the financial cost of it, we can't do it. We don't want to do it. We don't want to give that benefit to our people. We're talking about all this division. At the end of the day, you know what? We're going to have a paper that's going to say, here's your audit results. When this member or that member comes to me and says, well, I don't think this one should be enrolled. I can say in 2025, here's the audit result. There was no finding on that person. Don't come to me with it. I don't have to support or advocate for you. That's what's going to uh stop all this division. But for some reason, we use it as a ploy. Let's divide everybody. Let's want it. Let's not want it. It's just craziness. I've said from the beginning in 2021, this is integrity and accuracy. Ms. Lonn says, from document 1, 2, 3, 4, 5. Okay, we had 1, 2, 3, 4, 5 enrollment coordinators looking and accepting those documents at different times. We've had a plethora of commissioners looking at those documents at one time. When this started, it was to have one professional service look at every file from beginning to end to make sure all documents, all signatures, all verification was there. Look at the administration of the federal government right now. Stopping the funding, looking at that, treating like an Andrew Jackson Indian extermination. Wouldn't we want the protection of this audit for our tribe and for our tribal members and for all generations to say, we've done this. You don't have any holes in ours. But we're not looking at it that way. We're looking at it as a witch hunt. We want to disenroll. I can't speak to how Councilor Crampton thinks and what he thinks. But I have a whole different mindset of why I support the audit. And it's always every time I

say my point, I always get this question. What's the end game? The end game for me is integrity, accuracy, completeness of our role. So, there's no more questions to be asked. From an individual tribal member all the way up to the federal government. That's what this 100% complete. And it's not even 100% audit right now. I think it's proposed as a comprehensive and complete audit. I support it 100%. And I have the documentation to show this is a legitimate resolution. So, I will provide that, and we can move on to second open. You know, this, the Enrollment Commission, they prove minutes 2-16-24. They didn't meet the entire year until December 16 on an unscheduled meeting. There's problems in your enrollment. We have a secretary that signed this, submitted a resignation letter, and then got begged to stay. How does that happen? And then she signed this document, and it submits us for us to accept. Inappropriate, unprofessional. Those are my comments. Thank you.

Acting Speaker Johnson: Councilor Crampton

Councilor Crampton: Thank you. Yes, and uh there's a lot of problems. And uh people uh know that what happened prior, and Ms. Lonn was the enrollment director at the time, or coordinator, whatever you want to call that position. She was in that position. There was people being fraudulently enrolled here against the criteria. That's what sparked all of this. So, to bring the person back that was faulted right before, and this is, members need to understand, go back and watch the tape when she said 2016, and he's trying to pass a resolution to tell you that it was started in 2017. Not even possible. Not even possible. That isn't close to possible. Now, my endgame is to make sure that these, our records are integrable, and that the people who are here are supposed to be here, so that our culture is the one that survives, that moves on. Not an invasive one that takes over, and then starts employing all their people, and giving all of our benefits and resources to theirs. That's what leaders should be watching out for. We have what we have, because our people have been held back for so long. This is a way to give them an advantage, to let them move forward. What is going on here is disgraceful. And if it wasn't, if there wasn't something wrong, there would be nobody here fighting against it. Think about the action, you, guys. What would be the problem of somebody looking at your records, and um saying, yeah, that persons supposed to be here? What is the problem? There is no problem if you're really supposed to be here. The only problem would be if you're not. And every time this comes forward, the same group of people come forward freaking out. Absolutely freaking out. But you guys should go through the enrollment ordinance and look at how poorly this was written. Um I think counc- the Recorder, I'm sorry, the Speaker, the acting Speaker for today, pointed out that these were done in the past, and would that be wrong? Would the council back then be wrong? Yes, the council would be wrong back then, because like I pointed out to the judges and the executive, bring you forth the strategic plan. This hasn't been followed since it was written. The strategic plan, I think, was written in 2010. Implemented 2013, 2014, 2010? 13, okay. It hadn't been followed since it was created for the Budget and Appropriations Act. None of this is being followed in this ordinance, the enrollment ordinance. There is a way that has been comfortably instituted down here that people do things. Then there's the way that we have in the law that the membership expects. That's where the problem comes in, you guys. And that's what needs to be rectified. We either need to be compliant with our laws, Page 36 of 78 Regular Meeting February 19, 2025

or we need to codify what we are actually doing. But right now, we're out of compliance. And here's another fun fact for you. You just had the enrollment coordinators come up here and say that it hadn't been done since 2016. How do you verify a voter list? Yeah, see, there's some huge problems here. There're some real huge problems. Thank you.

Acting Speaker Johnson: Diane, you're next. Okay. Uh James, you're next. Nope. James, you're next. Chuck is after you. We're getting there.

James Dame: James Dame, 1189. We're on uh E, correct?

Acting Speaker Johnson: Yes.

James Dame: And uh so, Councilor Crampton, you asked for this to be-

Councilor Crampton: postponed.

James Dame: Postponed and we've been here doing this because somebody just wants to have the last word. Is that what we're doing? Because I have an appointment with our comptroller to take care of some business. Can we just, can we, like, can I have the last word? Or maybe this gentleman have the last word so we can move on? I'm all for an audit. I'm 100% about that. I really, it doesn't bother me one bit. Heck I can go ahead and throw out names right now for my family all the way back to great, great grandparents. It doesn't bother me one bit. But we don't, I mean, we're just, this was already asked to be postponed. Let's just go and get this done, this meeting and go to our second one. Thank you.

Councilor Crampton: Can we call the question?

Now it therefore resolved that the Tribal Council of Little River Band of Ottawa Indians hereby accepts the internal audit summary for the 2023 planning 1070-147 department budget dated October 1st of 2024. In the uh audit findings, we found that

there was overspending in the 5,000 salaries and wages and in the 5110 workmen's comp premiums. And other than that, that's the only finding in the internal audit.

Whereas the Comptroller General has performed internal audit of the 2023 Gaming Commission Surveillance Department Budget. And whereas the Comptroller General has prepared and presented the audit summary and necessary supporting documents to Tribal Council and the Ogema on October 1st of 2024 and in a work session on February 11th of 2025. Now it therefore resolved that the Tribal Council of the Little River Band of Ottawa Indians hereby accepts the internal audit summary for the 2023 Gaming Commission Surveillance, 1030-120 department budget dated October 1st of 2024. And I found there was no audit findings at all in their internal audit for their budget. No overspend, no over-budgeting.

Acting Speaker Johnson: Thank you. Will anybody be abstaining from this item? Councilor Wolfe, you'll be abstaining? Okay, uh go ahead then for discussion.

Councilor Wolfe: And then for that, most of that savings was in because we did a supplemental appropriation with grant dollars to fund their upgrade in their surveillance system.

Brad Pringle: Yep, after it after a review of the accounting department and a summarization by the accounting department is supposed to be earmarked for future assets or membership services. That's correct

Councilor Wolfe: And this particular um fund isn't going into a restricted or heading to those programs.

Brad Pringle: Nope

B. Pringle

Brad, you have the floor.

Brad Pringle: Once again, looking for resolution approval for the appropriation of funds for expenditures during the second quarter of fiscal year 2025. Whereas section 5.7 of the Budget Appropriations Act of 2013 requires the Tribal Council appropriation of funds for expenditures for the following years uh the following fiscal year by March 1st, June 1st, September 1st, and December 1st of each fiscal year. Now it therefore resolved that the Tribal Council of Little River Band of Ottawa Indians hereby appropriates the amount of \$5,672,228.25 for expenditures during the second quarter beginning April 1st of 2025. This consists of quarter gaming distribution at \$2,836,114.12 and quarter gaming per cap of \$2,836,114.13.

Acting Speaker Johnson: Thank you. Would there be anybody abstaining on the item? Any discussion from Council? Councilor Wolfe?

Councilor Wolfe: So, for me, this is an item I can't support. We had a financial report due on this uh agenda and it wasn't submitted. We haven't had a closeout. We haven't had a financial report since May of 2024. We don't know what our budget looks like. We can't get accurate information from the CFO. So, to appropriate funds, I think would be irresponsible at this time. I think there needs to be a mandate. The last information we received, we had to subpoena. How can we appropriate funding appropriately if we have no knowledge of what it is? This doesn't have to be due until March 1st. There's plenty of time to get that information from the executive to get those reports caught up. It's important. We haven't completed uh our annual audit yet. It's important. So is this funding. We don't- I don't want the government to shut down. I know they need this appropriation, but it would be totally irresponsible of me not to consider the facts on the table and approve an expenditure for \$5 million, over \$5 million. I don't know what our books look like. And this information that was provided on December 12th sure tells me there's problems. So, I can't support this item. It would be irresponsible. I understand there's a court order and we're mandated and it's our, what's the word they like to

use? Ministerial duty to complete some of these laws, but we have time. We should be holding the executive accountable to give us accurate information before we just continue to make expenditures. And this is appropriation for quarter two. So, at this time, I can't support the item. Thank you.

Councilor Wittenberg: Yeah, Miigwech. I uh totally agree with Councilor Wolfe. We got a pot that's out and we keep taking, taking, taking, and then we want to put in, put in, and we don't even know what is in there, what ain't in it. And that's the shameful part about it. So, I totally uh agree with Councilor Wolfe, Miigwech.

Acting Speaker Johnson: Okay. Any other councilor would like to make a Councilor Silvis.

Councilor Silvis: I would just like to state that even though we're not getting our financials from the executive side, we are still getting our financials from the casino where the money does come from. And we do see that coming over. So, I would just like that to be made clear. And I would not like to see the government shut down because we are seeing funding coming from them. Thank you.

Acting Speaker Johnson: Councilor oh uh Wever, go ahead. Or Wolfe, sorry, Councilor Wolfe, sorry, my apologies there.

Councilor Wolfe: Yes, that is uh true. We do get financials from the resort, but that's only 50% of our budget. 50% of that gets allocated to government expenditures. There's grant revenue, there's uh general fund revenue, there's um income generated from departments. All of that we have no knowledge of. Since May of 2024, nine months ago, it would be irresponsible for anyone to support moving this forward. Thank you

Acting Speaker Johnson: Councilor Crampton, did you want to say something or? Okay

Councilor Crampton: Yes, well, see, that's the distinction for the membership to understand. There's a certain view. We see it coming over as distribution. We don't know what's how it's being treated after it gets broken down and goes to department. So, you have a layman's view saying, yeah, we get this, but the upper management mind should be thinking, yeah, how is that broken down and how is that getting delivered? Of course, we see the big package coming across the street, but it's really amateurish to say that we know where it's going since we see it coming in the door. It's kind of, I just want to make that appearance of membership, thank you.

Ogema Romanelli: Thank you very much. I think I have two items today that I want to bring forth. Uh the regarding the external financial audits, uh we did receive late yesterday a letter from the BIA that states that no sanctions will be going forward. So, they kind of rescinded that. So that's been a big issue for a long time. Uh it's been kind of

thrown out there in all kinds of ways. But we did receive a letter, I think it was about 4:15 yesterday. So, I will be forwarding that to the Tribal Council as well. But to ease everyone's minds, uh there are no sanctions going forward. I think there will be some findings as were uh the legislative and executive are both aware of. Uh there we will find that out, I think, at a later date and uh go from there. So that's a big relief for many people. I want to thank the staff that put so many hard hours of work into getting it done. Uh even though it wasn't timely, uh it was a lot of work. There's a lot of extra things that go on. My understanding is that there may be even a few other tribes in the same situation because you now have cova- COVID, and you have ARPA, and you have opioid and all of that plays into it. In our case, we were understaffed. We also have some missing records, both from the executive and the legislative that play into this. So, uh the good news is the sanctions are not going to go forward. We did, uh by the way, we did submit a letter um of appeal, and I don't know that that even had to play into it. So, uh with the appeal process, I think that just ends now. Uh that's the good news. Uh the second thing is uh financial reports. Now that we've submitted and been and that's why the sanctions have been lifted is because the financial audit has been submitted and received. But now that that's happened, we're going to go back and uh catch up the financial reports. We couldn't do both at the same time. Uh and hopefully within the next month, month and a half, we'll have those caught up. We really do, really do need to get those minutes caught up. And again, we're going back three years. Uh were we have missing minutes; I believe from 2021. Um I'm not sure about 2022. We have 2023, 2024, and 2025 that also need minutes. And it's really hard to get financial and approve it. And that's what the auditor said is that those minutes are very necessary to uh understand what has been brought in and what has been gone out. So, I'll leave it at that. The last thing that I have to say is that the item with the \$894,000 uh by going through the audit and completing the audit, we realized that those numbers are incorrect. I think we sent that to the tribal council before, and I'm not sure why it's still showing up as that amount of money. Uh it could be even zero. And I have some concerns here. Now that we have the audit done, the financial audit done, I think that I'm going to give uh you know take a break from it for a couple of weeks until these people can catch their breath. But I want to go back in there on a deeper dive because what we found out was not only this last audit, but the one before, there were some things that were, I think, inconsistent. And I want to make sure that this doesn't happen again. I believe that the comptroller on the legislative side should have been involved more at this one and at past ones, but I would like to invite the comptroller to also be a part of this, because I think there are some things that may have happened in the past that we need to make sure are correct and that it doesn't go on. So, with that, I'm I think that's the end of my report. Thank you.

Councilor Wolfe: Yeah, I had a question for the Ogema. Can you give an update on the Binojeeuk Commission application for the commissioner?

Ogema Romanelli: Yes, I believe uh we did that last week, didn't we?

Councilor Wolfe: Nothing's been brought forward for that person to be appointed.

Uh there's been a lot of federal layoffs that are gonna impact some of our programming. Um Indian Health Services provides direct healthcare. They're looking at, by this update, um uh more than estimated under the Indian Health Services, 850 federal employees were laid off. Some of those happened on February uh 14th, Valentine's Day. And then under the Department of Interior, um the department reported laying off 2,300 employees by some of the executive orders written by um the Trump administration. So just um note for membership, we are watching that and taking that into concern and looking at that. Uh one that hits close to my heart and why I've been following it is um Haskell's Indian uh University, Indians Nation University out in Kansas. They had a huge federal layoff in some of their, um it was over 30 or 40 uh faculty that were laid off and they were looking at um possibly closing that um BIA-funded university. Um I think it's been stopped and put on a pause at this point. But you know just if we can think about all them and lift those people up in prayer because it's you know devastating, life-changing when you lose your job. So, um just think about those. Thank you.

Councilor Metzger: Thank you. I have a couple items. Uh first, uh last week I was absent, I was out in Washington. Uh is on. Hello? Yeah, last week I was out in Washington at a meeting that was a subdivision of uh Native American uh Congresses, uh... uh the Executive Council of uh Native Americans Winter Session. Uh for me, I found it very informative and also put a lot of my worries at ease. I came away feeling that there was solidarity in that meeting, that the tribes were coming together as a concerned front. Because a lot of this discussion with this uh current administration that we have in Washington, a lot of concern, is there's a thing called DEI, diverse equity, diversity, equity and inclusion. A lot of tribal leaders were at first taken back by that. But there's a thing called nation to nation and treaty obligations. As I said about two, three weeks ago, our treaties go back to the 1600s before this country was even established. We've had treaties with the Dutch. Our ancestors, the Anishinaabe, had treaties with the Dutch. If you know our migration story, I felt I felt good that we aren't being targeted because of our race. We are on a government-to-government association, government to government dialogue. And that's what I got out of there. You know it's a lot of information that was handed out and I got pamphlets and flyers to go with that. But like I said, I found it very informative. I met quite a few different leaders from around the country, uh got quite a few different ideas popping around in my head. And it was just an awesome, awesome feeling to see so many natives in that position that they were holding as leaders. But, the other thing I want to talk about is a state Senate Bill 41. It's sponsored by uh John D'Amos, Committee's Transportation and Infrastructure. The bill is entitled Michigan Memorial Highway Act. The people of state of Michigan enact section 108, a portion of Highway 22 in Leelanau County, beginning at the intersection of Highway M-22 and

North Stallman Road and continue north to the intersection of Highway M-22 and North Putman Road shall be known as Company K Indian Veterans First Michigan Sharpshooter Civil War Memorial Highway. This one means a lot to me because of my great-grandfather, Wawa Chinodan, who happened to uh... uh spend some time down at Fort Southerner. Uh the Confederates didn't take care of him too well. He was POW back in the Union War. He was one of the lucky ones that made it home. A lot of our tribal members didn't make it home. That war was ended in 1865. Anishinaabe have been fighting either for America or against America at one time or another. Since the war of 1812, we've basically been fighting for America, even though we were not considered Americans until I believe it was uh 1928. So, I am very happy that the state is finally recognizing Company K.

Um and I found it kind of ironic that one of the committee members first words were, I know this seems like Groundhog Day. And uh I just thought that was kind of strange. But uh not to go on to all that, but uh I really do appreciate what you what you said about our warriors, tribal warriors. And I think we got citizenship in 1924, if I if I'm correct. And I am on the Warrior Society, and a member of our Warrior Society. I'm an honorary... honorary honorably discharged Army veteran. Um I served during peacetime in the 70s. Not to talk about me. Now, while Mr. X, I'm sorry. While Mr. Metzger, Al, if I may say that, was away, Corey I from Natural Resources, I think, is now taking over uh as the leader of the Warrior Society for our tribe. And they need a liaison for them to open up funding to be able to do anything. And I'm asking you, Al.

Mark Huddleston: Excuse me, to step up and do that, please.

Councilor Metzger: Is he done?

You know, uh that... that reference about Groundhog Day, it uh I believe he was talking about a movie that was uh done out with Dan Ackroyd, I believe it was, or it's a comedy, it's called Groundhog Day. And in that movie, it's a repetitive day after day. He wakes up, does the same thing when he goes to sleep. When he wakes up, it's Groundhog Day all over again. And he has to change different things during that day so he can continue on until the next day. I believe the reference was, here we go again, standing up for Native rights. Here we go again, standing up for treaty obligations. We gave over 2 billion acres for the formation of this country. 1491, there was over a hundred million Native Americans on this continent that the creator blessed us with. So, I will do you as you asked, Mr. Huddleston, and I will be calling you. Uh... uh... uh I'll get in touch with you somehow and we can exchange phone numbers. But uh I also wanna say, chi-Miigwech for your service. Aho Miigwech, Miigwech, Miigwech, Miigwech, Miigwech, Miigwech, Miigwech.

So, when they bring it forward, there'll be easy to knock it down. Thank you.

Acting Speaker Johnson: Uh I don't know probably, well, depending on how fast we get through here, I would say probably uh we'll break for lunch. So, we'll be back um 1, 1:15, depending what time we get done here. And then um after that, it'll prob it'll probably be about two. I'm going to say if somewhere around there.

Chuck Fisher: Thank you

Acting Speaker Johnson: Roughly. Councilor Wolfe, go ahead.

Councilor Wolfe: Um so, I just wanted to um make one comment in public comment and um see if we can get some support and assistance. Um last week, it was talked about that boat that sank um in Ludington that was owned by a tribal member. Um reached out to some people and looking for some assistance. And um what we're hoping or working towards is having a fundraiser here in the government center on March 5th, the day that we have tribal council meeting. Uh just have to get some of the paperwork filled out and filed. But that's what we're looking at. A group of women, Kwewok in the community, are looking at that and supporting and um having a bake sale auction fundraiser type uh event here on um March 5th in the government center down in the cafeteria. So, we can support that tribal member uh to get some assistance. So just um kind of giving a FYI about that so people can be looking for the information on that. And um at this time, I'm also accepting the donations if you have an item that you'd like to donate for the fundraiser. So uh that's all I have right now. Thank you.

Acting Speaker Johnson: Thank you. Mark, go ahead.

Mark Huddleston: I um I want to start by thanking uh Pam, sorry, first name, councilor, um for letting us know that the Speaker is ill. And I'd like to uh let her know that I hope she gets well soon. Um I also want to say I was informed that we had a councilor with a birthday that I wasn't aware of. And I want to wish Ron a belated birthday, a happy belated birthday. Um uh let's see, I had to write down some notes today. Uh let's see, I know there's no one there from National Resources, but I'm curious about the grant for our um solar power that we were supposed to save some money for the uh the casino on the solar array. And uh I know there was three employees that were supposed to be hired, and the grant would pay for them for three years. And then we would end up having to

pay them to continue working. Um and I don't know if maybe somebody could work on that somehow and find out where that grant's at or is that grant being used now for our uh power company or I think, what is it was NACU. Um and then, uh excuse me just a moment. Uh I'm going to leave that one out. Um I heard today about consistency, and I heard, and I understand that our tribal leaders are held to a higher standard by members. And I do realize how few members are in attendance here. So, I would like to see tribal council follow their own policy and stop these sidebars, stop the interruptions of the queues or yes. And uh actually, follow those policies. I mean, it just goes on and on. People interrupting and interrupting and oh, let's stop this and stop that. I... I don't know the exact wording of what you got your procedures are supposed to be following. But I don't know, we got to have warnings and one, two, your you need to be removed. I, I...I it's unprofessional and I don't want to point fingers. I just want, I'm asking for me and the rest of the members follow the policies, please. And I'll leave it at that. Thank you

Acting Speaker Johnson: Thank you uh Councilor Crampton, go ahead.

Councilor Crampton: Um yeah, I had the same concern. So, I went back, and I was looking through some uh videos that are, um some are missing, but there's a lot that are there. If you look at the councils that I ran and the councils that Mr. Kelsey ran and the councils that were run prior to that, this seems to be unique that this one got totally out of control. And if you go back and you watch, you'll see that in the initial, the initial violations, I had mentioned several times that this Speaker was letting uh a member named Councilor or Sandy Mezeske stand. Every time I said something, either say asshole or something like that, there was all kinds of profanity. And I kept pointing it out and there was only a blank response, or they would smile. And if you still go back even two weeks ago, you'll see it happening. And when the Speaker's told about it, it's that's where it gets out of control. If you go back, like I said, and watch the other Speakers that was not allowed, this has been the only council that's allowed that and it's because of family um inclusion. Thank you.

Acting Speaker Johnson: Councilor Wittenberg.

Councilor Wittenberg: Yes. And I want to say uh Miigwech to the Speaker today to turn around and get it under the control and zap it uh as fast as possible. So, I say Chi Miigwech for that because it could have still been in that same circle. At least we got something done and it's uh we're not going to two o'clock talking about the same thing. So, I do say, uh Speaker Johnson, Chi Miigwech.

Acting Speaker Johnson: Uh Councilor Wever, you are next.

Councilor Wever: Well, I disagree what um Shannon just said. Um most of the time, I thought our speaker was rude to uh Sandy Mezeske for speaking up. She told her not to be talking that way or she'd be removed from our meetings. It's um Shannon Crampton that would go on and on and on and bullying all of us. And that's where I uh have the

problem with how he calls us names day after day, uh meeting after meeting. It's the bullying that I don't like. That should have been stopped from the get-go. Thank you.

Acting Speaker Johnson: Councilor Crampton, you're next.

Councilor Crampton: I really won't get into that. I just want the members to get back and watch the tape and you'll see exactly what I'm talking about. Watch when I was a speaker, watch when uh Virgil Johnson was a speaker, watch when Joe Riley was the speaker. In fact, the one tape I had to watch when I was a speaker, I think there were people attacking the Ogema at the time and I stopped them and said, no, that's not gonna happen here, even though we're not on the best terms. That's how professional meetings are run. So, and despite what Councilor Wever keeps trying to insinuate, the facts are there on video. So, if you go back and watch the video, you'll see that's exactly what happened and what exactly inspired this one. And I told everybody, and go back and watch the tape, I think it was in, uh I wanna say it was right around this time, February of last year, that I set up and said that this Council is out of control and these are the worst two speaker, the speaker that we've ever had and quick to run to their defense was the Ogema. So, if you watch tapes, it's all there. I'm not gonna rely on he said, she said, I want you to look at it and make a judgment for yourself. Thank you.

Acting Speaker Johnson: Sandy, go ahead.

Sandy Mezeske: I can't laugh like Crampton does, but anyway, um he's a hypocrite. Uh Mr. Crampton, can you prove I'm a drunk?

Acting Speaker Johnson: Sandy.

Sandy Mezeske: No, five times, five times, but you know, it's okay for him

Sandy Mezeske: To interrupt, say what he wants to say. He wants people to go back. Um Mr. Crampton, I stand at my word of what I said, you know, no apologies from this old lady, let me tell you, you know, but you uh totally call the kettle black all the time. But oh my God, the speaker, you know, Tammy's a good speaker. Tammy's wonderful at her job, you know, because if it was me sitting there, you wouldn't get out of control. You'd be kicked out in a heartbeat, but and Pam, you do a great job too. Uh you know, it's...it's the membership needs to know it's one councilor's opinion, not nine, but one. And if the rest of you feel the way he does, speak up, speak up, no, you don't, because you follow. I'm done, yeah he's not worth it.

And if they did, can you hand me the constitution for a minute so I can read this to the members? Pam. Thank you.

When elect a tribal council shall establish ordinances governing membership including that but not limited to enrollment and disenrollment provided that the tribal council should not have the power to change or change or establish substantial requirements for memberships in addition to those established in this article. So council is the only people who have the right to look at the whole files. If you're so worried about that look at the enrollment ordinance where the director can delegate, her authority and that means all of her authority to anybody in that department. If they hire somebody to put trash in the waste can she can delegate that the way the ordinance is written. So, I wouldn't be too worried about council looking at your files when they're constitutionally delegated to or authorized to. But the uh enrollment department can delegate the janitor to take a look at your files. Uh no thank you. I'm good.

Um Tribal council finds it essential for the well-being of the tribe and all tribal members for the tribal council to select an experienced and competent audit to conduct a comprehensive and complete enrollment audit of membership files thereby ensuring compliance with our constitution promoting the peace morale and general welfare of the Little River Band of Ottawa Indians. This resolution mandates that Tribal Council of Little River Band of Ottawa Indians hereby mandates the issuance of a request for proposal for conducting a comprehensive and complete audit enrollment audit of active tribal member files and file where an individual has been admitted to membership. Then it also goes further to resolve that the Ogema on receipt of one or more responses from the RFP the Ogema negotiate the terms of the agreement for the desired services and then that the work the Ogema negotiates said contract within 30 days. None of this talks about enrollment commission removal. None of about who's looking at the files. This is the first step in the process to issue the RFP and get the audit in way and bring the enrollment back into compliance. So, all this discussion of who's going to look and what's going to look at and the comments relevant to the commission being removed or not is not up for discussion in this resolution or on the table. So, let's move on with the motion Councilor Metzger making.

Councilor Metzger: Thank you

Councilor Wolfe: that's my comment.

Acting Speaker Johnson: Councilor Silvis

Acting Speaker Johnson: Okay um so I just want to make a comment on this tidbit um as well. Um in relation to the comment, I made earlier, if our past resolutions were done in a false manner, then we need to prove that. I think it needs to be proved that it really didn't happen and there was no qualified roles that were shown. That's... thats where I'm at with these is I see resolutions that say that we had qualified roles all 4,000 members at the time. It had been done. Um so, I'm not totally agreeable to this. I would like to see something postponed or this just because we do have those previous resolutions that says the qualified roles and how do we know those that are sitting here, how do we know now those actually didn't happen? And that's the hard part I am having with it is that what proof do we have besides somebody's hearsay that it didn't actually happen, and those resolutions were done for giggles? Um that's kind of where I'm at. I see resolutions that say they were done all 4,000 and something at the time and I would like to see some sort of proof that says otherwise um for me. Um I see you have your hand up, but I did say I was going to go to the three.

Councilor Crampton: You asked for the proof, and I have the proof

Acting Speaker Johnson: Okay.

Councilor Wolfe: He can make the motion and go to discussion again

Acting Speaker Johnson: So, um let me take the three members and then I'll let him do his motion then you can come back with your proof. Sound fair? Okay. So, Chuck you were first.

Chuck Fisher: Um I guess in away this has gotten very politicized and if it was straight business. You know that would be one thing but it's on social media. It's being brought around, and um it does not have to be a political statement or anything. That's what it is and thank you very much. Um even the resolution or the agenda says severe issues identified in the LRBOI enrollment and the audit to ensure the accuracy of our files and to avoid irreparable harm to the tribe. Now that what severe issues are we talking about? What irreparable harm are we talking about? Because of the irreparable harm that I see is a result of doing the audit and subjecting membership to um unintended consequences that you know found from the audit. Where you know their membership criteria is questioned. So, what happens after that? What happens after that?

Councilor Crampton: Do you really want to answer?

And I also want to say now that I've been listening to this for five years and all I heard was people being targeted. The Ogema. Gary. Continuously. Gary called a white boy and everything else and then now I'm seeing people laughing. Laughing and this angers me more than you know. And now how many people have passed? Does anybody have any kind of a number since 2011 when one of your council members that was a former member of the Little River Band of Ottawa Indians stated in a comment that we need to take our tribe back. Okay. So how many people have died thinking that their children and their grandchildren may not be members in this tribe? How much grief have you put on them? You put people in their graves because of this as far as I'm concerned. And here you want to do an audit? Start with me. Can you see it? Can you read any of that on the bottom there? Start with me.

Councilor Crampton: Stated something but not clear through zoom

Acting Speaker Johnson: Thanks Mark. Sandy go ahead.

Sandy Mezeske: I'd like to go back probably months ago um when Mr. Pitchlynn was, I believe it was a work session because he was on view at that time. He was on Zoom, and he made a comment that he had read... read everything, the ordinance, the bylaws from the Enrollment Commission and he found nothing wrong with it. He said it was well written. Who from council and was there a vote to contact Mr. Pitchlynn because Mr. Pitchlynn did say if you have any other issues I'll take it under advisement. Was there a vote from council the whole council to say hey here's the issues let's send them to Pitchlynn? And I think council seems to forget too way back then you're the ones that stopped the Enrollment Commission and now you're on the bandwagon oh they're out of compliance, they're out of this, they're out of that. Did you forget that you discussed all that? That you were going to stop them? You're going to stop and work on the ordinance? You're going to talk to them and do the bylaws? What happened to that? Where's that at? You're the ones that stopped that commission and now you want to remove them. Yeah, Chuck you're there, you're on the hit list.

Councilor Crampton: *Speaking in the background but unclear*.

Sandy Mezeske: I sent my papers in for the Enrollment Commission. Am I going to get votes to sit on it?

Councilor Crampton: *Speaking in the background but unclear*.

So no, there isn't a division on here, and I just like to say to the members again, why would you be concerned? The only people that would be affected are people who don't meet the criteria. So, think about that when you hear all these excuses and all these things about dividing things, you're not dividing anybody. If somebody comes into your house and steals your stuff, you don't go, hey, let's have a party. You call the cops. This is ridiculous. I've never seen a tribe this scared before in my life. And that's why um I already felt Turtle Talk. I want to find out, they want to find out about the outcome of this, and I'm totally going to send it to them, because I'd like to have everybody find out about this too, all our nations. This is ridiculous. This is absolutely ridiculous. And our ancestors, if you look back there land was stolen from us, from non-members, we have

claims about that. So that's what our ancestors felt about, non-members. And if you look at our treaties, our headman had to be bribed to take anybody who's half-blooded. So no, they do not, that's not our ancestors' wishes. Anybody trying to bend that is a lie. And those books, I think it's Kaplan, or Kaplan is the guy's name, all of our treaties are in there. Take a look at that book by Kaplan. At the front of it, you're going to find out that they didn't even want half-bloods. So no, they weren't all, hey, everybody come on in and call yourself Indian and take all the resources. That was not their intent. So yeah, just when you're speaking out of fear, please do not disperse our elders. There's a lot of them that wanted this to happen. Thank you

Acting Speaker Johnson: Councilor DiPiazza you were next

Pro Tempore Recorder DiPiazza: Well, a lot of them get a hold of me too. There's a lot that don't want to do this because it is a witch hunt. And you just pretty well said it was. We're taking resources and we're stealing the resources. So, who's stealing the resources? And nobody's running scared. We had a complete audit in 16. The resolutions dated 17. Like I said, we're going to do it with a five-year and 21. And I believe there's an email. There's something on that order to the enroll or the enrollment department to not do it. Because that 100% audit was on the table. So, I can't support it. If you want to go with it, get caught up with the 10-year, yippie I yo. Full support. Go back and dig everybody up. Can't do it. I'm done

Acting Speaker Johnson: Councilor Wittenberg

Councilor Wittenberg: Yeah, I say Miigwech for this and I understand some views. And I can understand other views. Uh this is just for it to go through turn around and have an audit done and people say well those who ain't. But I do know that the... that there are some unenrolled. And there are that are enrolled. And I know uh different ones uh that are up on top that turnaround and basically said the same thing. And that will put people in a frenzy. They try to unnaturally say it's political and things like that. And well, I guess maybe if my adopted sister was Native then I would be, oh, no, you can't do that. But my adopted sister was probably the same name. And you turn around and look back as in many things and I turn around and understand. And to me, it's just saying what is exactly going on. The BIA says I can't do nothing. You have to bring it forward. And that's what you're scared of is what the BIA would say. Because I'm enrolled with the BIA. And this and that. But the BIA actually ain't involved with this here deal. That's where I'm at. So, I can be like the gentleman here earlier, turned around and say, for me, first in line and I'm not. And I had no problem then myself being put first in line. The sad thing about it is that even though when they had individual audit names came up, the same names come up that they know that they're Why didn't they go through names? Oh, well, this name come up. We had that one already. Let's go reshuffle and put in who hasn't been on there. But so, yeah, it's questions like that that turned around and turn around and bring up the same family name. And then, well, we're good. We're clear. No, that's wrong. I'd like the same person having the same, bringing up a lotto number and they turn around and keep having the same person that wins. Instead of nope this person won already, so back in. But those are my thoughts. I think, and feel, even along with all this, I think for

Trump, if he has his way, we all are going to be cashing in our cards. And this Little River casino out there, I'm sure, Trump Casino, they'll be going across the lane on me. So be happy with what you got today. So, this, even though this is coming up now, I don't think we, this ain't nothing compared to what I think and feel possibly could come up in uh the past time goes and say in the next four years. He might be so many billionaires, but to think of all these casinos that turn around and go up underneath his name of and add to those billions. So no, I'm not scared of this. And like I say, if I say, well, Ron, you're not, then I'm sorry. Okay, here's my card. Journey was nice. Miigwech. But that's who I am.

Acting Speaker Johnson: Councilor Crampton

Councilor Crampton: Yeah. Um when I say something, I just want everybody to understand. Councilor DiPiazza is trying to redirect my answers that the childish, childish, childish thing that goes on in kindergarten. Um what I say is what I say. He takes it and tries to turn it around and spin it to a scare tactic. I fear nothing. I'll be second if Councilor Wittenberg wants to be first. But no, nothing he says represents me. Thank you.

Acting Speaker Johnson: Uh any other councilors? Councilor Metzger, go ahead.

Councilor Metzger: Yeah, I think uh I think all tribal members need to read Chicago 1836, Article 6. Specifically, Article 6. That's all I'm going to say on that. Thank you

Acting Speaker Johnson: Any other, go ahead, Councilor Wever.

Councilor Wever: I just want to say, if you start removing people that shouldn't be on the enrollment, what are we going to do? Go to court? We're going to be in court with all these people.

Acting Speaker Johnson: I gotcha

Councilor Wever: Then what do we do? How many years will that take to even remove those people? Because they're going to be in court with us. Thank you.

Acting Speaker Johnson: Councilor Crampton

Councilor Crampton: Tribal Council doesn't remove anybody. Theres a process within the Constitution and with the rules. All Council would do is be giving back the outcome of the report. Council has no power to remove anybody but the Golden Law. So that statement, I want members to understand it's a false statement. There's no way we can do what Councilor Wever is talking about. Thank you.

Acting Speaker Johnson: Any other councilors? Okay, moving on to uh tribal membership. Um Delia, you were first. Go ahead

Secondly, as an elder, I'm sure I'm speaking for some elders and not all, I don't see what the problem is. I've been kicked out the tribe. My whole family was kicked out. All hundred of us were kicked out the tribe. We had to prove who we were. Nobody cared at that time that they kicked the whole family out, took away the kids' money, our kids' money, supposed to be put in a trust because we appealed us being put out. Nobody cared. And did they ever get their money back? No, because nobody knows what happened to it. That was way back in the 90s. And yes, we did go to court. We had to get a lawyer. We had to do all of that. We had to come up there and make that trip because we do not live in Michigan. And we had to do all of that to prove that we were who we said we were. And in the end, we ended up having to get DNA tests. So, you know, okay, kick us out, do what you can, but we know who we are. And you told us to prove it, so we did. I really don't see what the issue is, why people don't want to do this audit. If you're who you say you are, then prove it like I had to. It's not a problem. If you know who you are, then we need to do the audit. If you don't want to do this audit, then there's something wrong. What is it that you're afraid of? There should be no fear from anyone in doing a 100% audit if, in fact, you are who you say you are. And I guess that's kind of where my problem is because I've been through it personally. And, like I said, we were kicked out. Prove who you are. We did. We're back in. So, you know, not wanting to do the 100% audit causes me and I'm sure other tribal members to wonder, why don't you want to do this? It's been five years. We're out of compliance. Just do what you need to do and let's get over and done with this. We've been arguing about this for how many years now? How many years have we been doing this? We've been going through this for some time now. As an elder and getting older by the day here, I'm kind of getting tired of this same argument for years. It makes no sense. None whatsoever. I listened this morning to the meeting where they're talking about all the files are in the basement. Then you take yourselves down there. Get those files out of the basement and show us. Show us. Prove to us that the people have been certified. It's so easy to do. So very easy. Thank you. That's all I have to say for now.
