So, Kathleen, the floor is yours.

Kathleen Bowers: Thank you. Um you did receive, hopefully, an updated uh resolution. Um there was an error. That was my error um for the dental. So, what's going into contract health is \$1,013,223. In the clinic operations, \$1,391,207. In behavioral health, \$82,606, for a total of \$2,487,036. Um and Councilor Wolfe had a question about what OEHD stands for, and that is the Office of Environmental Health and

Engineering. Uh and that is providing optimum availability of functional, well-maintained health care facilities.

Speaker Burmeister: Thank you, Kathleen. Will there be any Tribal Councilors that are going to abstain from this item? Councilors with questions? Go ahead, Councilor Wolfe.

Councilor Wolfe: So, Kathleen, I had asked about it in the work session, the um just over about the \$18,000 going into dental under the clinic, and we have no dental facilities?

Kathleen Bowers: Yeah, I clarified that. I thought in the resolution, um that was an error on my part. That was supposed to go into 4104 not 4103. It was supposed to go into 4103, not 4104. So, that has been updated on the resolution on where those monies are going. That is for contract health.

Councilor Wolfe: Okay, because it was really hard to hear you, so I didn't understand everything that you had said and noticing that change. So

Kathleen Bowers: sorry about that.

Councilor Wolfe: Yeah, it's kind of echoey for you. That was my only question. I had those two, and I believe you fixed it. So, thank you.

2. Approval of supplemental appropriations **Tribal Ogema** 2025- 1st QTR to fund the Elders Meal Program in the amount of \$13.885.

V. Sam

So, Vicki, the floor is yours.

Vicki Sam: Good morning. This is just asking for you guys, for the tribe to help supplement our program with \$12,000 under client services so that we can continue feeding the elders until our new grant funding comes in in April. The food prices have gone up significantly. And this also, since we're losing our full-time employee as she was a grant-funded position, and that grant is running out and it's not a renewable grant, this bumps up my part-timer up to the full allotment of hours we can give her. And it's also \$1,000 for tribal activities, just so we can keep doing activities with our elders, which totals \$13,885.

Speaker Burmeister: Okay. Thank you. Will there be any councilors that are going to abstain from this item? Councilors with questions? Recorder Johnson, go ahead, please.

Recorder Johnson: Um how, um wondering, how much have you spent to date on food services?

Vicki Sam: I do have the last since November, November through January, if that helps. And from November to January, for food alone, it was \$13,454.40.

Recorder Johnson: 13,454?

Vicki Sam: Yep.

Recorder Johnson: Okay. Um and you're only asking for 13?

Vicki Sam: That is correct. That was what I was authorized to ask for.

Recorder Johnson: Okay. So, um we had gotten, just received our budgets, or the May, excuse me, June um monthly report for last year. And this is still putting you, in comparison, because you're asking for June, that would put you at a total of what you've already spent and what you're asking for at \$27,339. When you look at the June monthly report, you're still a good \$5,000 off from...uh from June of last year. And you're like \$2,000 above what you spent in 23. Um why didn't you at least ask to match last year's?

Vicki Sam: I was authorized to ask for up till April. And this is in hopes that the federal government gets a budget approved so that our grant funding's released in April.

Recorder Johnson: How many members are you feeding right now?

Vicki Sam: Right now, November through January, our numbers for homebound deliveries and grab and goes were 1,361. And for congregate meals, November through Page 9 of 47 Regular Meeting February 26, 2025

January was 448. And then there was 30 congregate meals served at Hackley and 41 takeouts.

Recorder Johnson: How many? 30 what?

Vicki Sam: 30 congregate in person and 41 takeout. Our numbers are starting to grow down there.

Recorder Johnson: Cool um, I don't know about everybody on...on here, but I would think we should add an extra \$5,000 to this budget to at least match what she had last year. But by looking at June's budget to be able to feed and with the cost of everything, to at least get her through till June. We know everything's on hold. I don't know what everybody else's thought is.

Speaker Burmeister: Go ahead, Councilor Wolfe.

Councilor Wolfe: Well, I'm not in disagreement with adding more funding so that our elders can continue to receive the elders' meals from the elders' meals program. But what she's asking for Pam is first quarter that only goes till April.

Recorder Johnson: Mm hmm

Councilor Wolfe: So, she would have to come back after April or in second quarter for more funding to take her through July. But that brings me to my original question. Have you? But you're throwing me off because it's 2025. And you're reporting December and November and December until all your numbers and accurate what you're asking for us. And we're only January and we're right at the end of February. So that would be the two months instead of the four how you're reporting it the way you're asking for the funding because November and December already closed, they would be in the 2024 budget.

Vicki Sam: I did do-

Councilor Wolfe: So that 13,000 or whatever you reported for that, we take two months away from that moving forward. And then would are you have you expended some of this \$12,000 for January and February and you're bringing this to us now because it's not there. There are grant dollars to cover it. So just from March to April 1, one month, you're going to be \$13,000 short on food.

Vicki Sam: No, I came to you guys before I ran out of funding. I just used the last of my purchase orders this last week. And I believe I have about \$1,000 left in one of my other accounts for food and then that is it. And then I have nothing more to purchase with. And for January, I do have the food tally number for January, which was \$4,153. I guess for me, my grant year is different from our budget year. So it's-

Councilor Wolfe: Okay, that's what I wasn't understanding.

Vicki Sam: my budget

Councilor Wolfe: Recording these numbers and I was like

Vicki Sam: my grant year goes from April till March.

Councilor Wolfe: Okay, that makes sense to me. I don't have any more questions.

Vicki Sam: It gets confusing on my end to

Speaker Burmeister: Does any other? Oh, go ahead councilor DiPiazza.

Councilor DiPiazza: Well, I say at this time, this is what's in front of us to get... get you going. And then come April, the government last year approved the budget. So, I think a lot of that funding still going to flow through could be wrong, but next year may be a different issue. But right now, I think this will get you through and if you need more than we'll address it at that time.

Vicki Sam: My budgeting money for 2025 is going to be released in April. And that can only be released if the budget for 2025 on a federal level gets accepted in right now, they have not come to an agreement on a federal level, they're still very much trying to get it pushed through. And they are actually looking at a government shutdown on March 14. And my grant keeps me informed of this. And that's what they told me because I emailed them and asked them about, hey, is there any promise of our funding coming through in April? And they said until a budget gets approved in Congress? No. If that helps. And what I have left in this funding covers my part timers in uh my part timers pay, and then my pay and everything to do with that. With our pay her and me. That's the rest of my funding. I can keep borrowing from there. But then if it goes on any longer than we're in a real big, real big boat of trouble.

Speaker Burmeister: Councilor DiPiazza, did you have your hand up?

Councilor DiPiazza: Yeah, I'm just the same comment. This is in front of us, I suggest we do this. And if a dilemma arises before April, or if they don't approve it within that timeframe, we can deal with it.

Speaker Burmeister: Mm hmm

Councilor DiPiazza: Deal with it then. Not saying you don't need funding to keep it going. But right now, you know, just never know what's going to happen on the federal level.

Vicki Sam: Plan for the worst and hope for the best.

Speaker Burmeister: Go ahead, Councilor Silvis.

Councilor Silvis: I just wanted to say that yesterday, the house did um vote for approving the budget. But again, I agree with Councilor DiPiazza, because this is here and you're running out of funds, I think it needs to be pushed right now. If something else comes up, don't hesitate to come back in my view to ask for more funding. Thank you.

Vicki Sam: I appreciate that. Thank you.

Speaker Burmeister: Any other comments from Councilors? Okay. Um Tara, you have your hand up.

Tara Bailey: Just a clarification. Um if she receives this funding, um is she eligible to hold on to this and say use all of it up? Um so that her funding that she gets in April could hold her over for next fall or next. The last quarter?

Councilor Wolfe: Yeah were-

Tara Bailey: First quarter of our fiscal year, next year? You know what I'm saying? Or would she if she doesn't use it all up by April 1st? So, she have to refund it back to the tribe back to the general fund? Or could she hold on to it and use it? Hold it on to more of her grant dollars to extend to hold her over until April of next year?

Councilor Wolfe: I don't I don't think it would be available, Tara, because our budget cycle closes, and we would be closed out by February 20.

Tara Bailey: Right, but that's what I'm saying. You could use this up until it's used up, and then start using her grant dollars, even if she gets it in April.

Councilor Wolfe: Oh, I think that would be her individual discretion to do that. Because when we appropriate it, it's in the line item for expenditures.

Tara Bailey: Okay, I just wanted to know if she had to give it back if she didn't use it by April 1st. I just wanted to use that as a clarification.

Councilor Wolfe: No, because these will be general fund dollars. That's what she's requesting.

Tara Bailey: Okay

Speaker Burmeister: Okay, thank you. Go ahead, Councilor DiPiazza.

Councilor DiPiazza: The only thing is, if you don't expend them, then they go back into the general fund at the end of the year so.

Vicki Sam: I have no doubt we will definitely.

Councilor DiPiazza: Absolutely.

Vicki Sam: Uh and one more thing I wanted to throw out there too. A lot most of the last three years, in fact, last year was the first year this happened, our NSIP funding, our Nutritional Supplemental Incentive Program funding that we get through Title VI, it went from \$10,000 and \$11,000 a year down to \$2,500. Title III received so many cuts last year to their budget that they couldn't afford to give us any more money. And how that works is that because they utilize our tribal elders' numbers in their censuses and everything in their data, then our kickback is that little bit of money they send back to us for allowing them to use those numbers. And so, this actually lines up to how much I'm short of because every year that's what we used in this in-between grant periods was that NSIP money. So that was painful.

Speaker Burmeister: Thank you, Vicki. Councilor have. Any councilors have any further questions? All right. Um I'd like to entertain a motion for this item, please. Councilor Wolfe, go ahead.

3. Approval of Supplemental Appropriation to fund the Catastrophic Disaster Relief Assistance Program in the amount of \$45,000.00

J. Wolfe

So, Councilor Wolfe, the floor is yours.

Councilor Wolfe: Thank you. Um Tribal Council established the Catastrophic Disaster Relief Assistance by Resolution 24-1211-243. Um we need a budget modification because in the 2025 um budget passed, this program was unfunded. We've had it in place now for um just over three months. We were waiting on getting um program application and regulations accepted by Tribal Council, and if I could ask the Ogema for an update on those. Um but for this \$45,000, it would be coming from the Unrestricted General Fund Balance to fund the fiscal year 2025 Catastrophic Disaster Relief Assistance. This would be going into the Members Assistance Fund under Client Services to fund that program. Um this would cover 15 Tribal members to access the program. So just that update, if the Ogema can provide one, where the regulations, program application, and guidelines are.

Speaker Burmeister: Ogema do you have an update on that?

Ogema Romanelli: What was the question, or what were you looking for?

Councilor Wolfe: So, we passed the program amendment to the Membership Assistance Ordinance in December. It was left on to the Executive to create the application, program regulations, and guidelines for it. That's why it was unfunded in the 2025 budget.

Ogema Romanelli: Okay

Councilor Wolfe: We're looking for an update on how close we are to having those documents ready so the program can be fully implemented with this funding.

Ogema Romanelli: Okay, I asked for the CEO to be on today to answer questions like that, so is she on? Okay, maybe she could assist.

Councilor Wolfe: So, it would be program regulations. The last I heard from the coordinator before they left the position was that it was forwarded to the Ogema's office in legal review from the Executive.

Ogema Romanelli: Okay, and I'm not sure I can ask with, uh probably forwarded to Elise. I'll check with Elise.

Councilor Wolfe: Okay

Ogema Romanelli: Thank you

Councilor Wolfe: So, if he's willing to check on that and get those updated and stuff, I don't have a problem funding the program. It would be just one step less that we have to do once they are adopted. The money would sit there in the line item of client services until the program is ready to be fully implemented by the Executive. So, I'm just asking full support of Tribal Council to get this benefit in the line item so membership can access it.

This uh resolution, looking for resolution approval for the appropriation of funds for expenditures during the second quarter of FY 2025, whereas section 5.7 of the Budget Appropriations Act of 2013 requires Tribal Council appropriating funds for expenditures for the following fiscal quarters by March 1st, June 1st, September 1st, and December 1st of each fiscal year, whereas the comptroller held work session on February 18th um for Tribal Council to review and discuss. Now, it, therefore, resolved that the Tribal Council, of Little River Band of Ottawa Indians, hereby appropriates the amount of \$5,672,228.25 for expenditures during the second quarter beginning April 1st of 2025. This consists of quarter gaming distribution at \$2,836,114.12 and quarter gaming per cap at \$2,836,114.13.

Speaker Burmeister: Thank you, Brad. Will there be any councilors that are going to abstain from this item? Any councilors with questions? Councilor Wolfe, go ahead.

Councilor Wolfe: I just have the same concerns that I noted last week. We are um nine months behind in financials. We haven't closed out fiscal year 2024. We did get some communication from the executive side that the reports, um they're working on July of 2024 and soon we would receive June 2024 and not till the end of March will it catch up the other August through December, but that still doesn't address this quarter in the year that we're in with budgetary items because there's no timeline or date for January or February, but this time I can't support appropriating this fund's expenditure. Thank you.

I did go through all the numbers based on all the information that was provided by the CFO, um came up with this dollar amount. We did have um information provided on December 9th that showed this dollar amount of \$894,287.94 available. Um we did have a proposal that came forward with an emergency meeting called by the Ogema on December 31st that asked for \$884,200. Out of this same account, the ARPA dollars are restricted. Um and then, as recently, we started in after the program passed for the supplemental payment. In January, the Speaker started communication with the CFO to get a certification of funds and a dollar amount in there. We weren't able to receive one until we subpoenaed the item. We got a certification of funds, and it tells us that there are zero dollars unobligated in the ARPA fund as of December 31st, 2024. To me, that cannot be correct because we did not pass all the resolutions to allocate and unrestrict the money and apply for expenditures. So, um Tribal Council has been working diligently on this and having work sessions. There is an upcoming meeting for some discussions to get better information or clarification between the legislative and executive attorneys. So, at this time, I want to make a motion to postpone this item.

Councilor DiPiazza: Support

Um I've included a copy of the Colorado sales tax and withholding account application that has been completed with the necessary information on LRBOI. I ask that you approve and allow the Ogema to sign this document so it can be submitted to the state of Colorado. We will receive an account number allowing us to submit funds withheld from Annie Perry on a quarterly basis. This is a one-time application and does not need to be completed any other time. Once we receive the confirmation from the state of Colorado, in the event Annie Perry is no longer employed with LRBOI, we will complete the final return and at that time we'll inform the state of Colorado Department of Revenue that it is our last return.

A. Approval of Revised Gaming Commission Regulation #R400-04: GC-06-Chapter 6-Gaming Vendor Licensing

J. Wolfe

So, Councilor Wolfe, you have the floor.

Councilor Wolfe: Thank you. Um bringing this forward on behalf of the Gaming Commission as the liaison for the Gaming Commission, um specifically what it is, Gaming Commission ordinance requires all Gaming Commission regulations to be adopted by the Gaming Commission by written resolution and filed with the Tribal Council Recorder. So, what we do have is the substantive changes to the Gaming Vendor Licensing Regulation is in um page 7, section 9.1, and page 8, section 10.4. What we're doing is we're going from an annual renewal to a biannual every two years. Um we've had a work session on this. Um what it does is streamline the process for improving efficiency and reduce the cost, um plus man hour and material cost, and it should provide a savings of \$26,585.33 based on um past history. Vendors and their control person have continuing ongoing duty to report any material changes to their application, including acquisitions, legal proceedings, structural changes, disciplinary action, arrests, and change in personal information. Gaming vendors are vetted in hundreds of jurisdictions, state and tribal, and sometimes both. Many jurisdictions use a repository and may renewal every two years and some less frequent. Um if there's some questions or concerns that come up with the vendor, we always have the responsibility and authority to investigate. The Gaming Commission does. That's the- we I'm saying in that comment. Um so just bringing it forward for acceptance by Tribal Council.

Speaker Burmeister: Thank you. Will there be any councilors that are going to abstain from this item? Councilors with questions or comments? Go ahead Councilor Metzger.

Whereas the Gaming Commission has determined revisions were necessary to better serve the regulatory function of the Gaming Commission and specifically moving forward the renewal processes for vendors from annually to every two years. Uh the Gaming Commission Regulation Chapter 6 Gaming Vendor License was approved by the Gaming Commission on February 4, 2025, by Gaming Commission Resolution what you see in your packet GC-2502-400-01. Whereas the Gaming Commission Regulation Chapter 6 Gaming Vendor License is now being forwarded to Tribal Council for the filing in accordance with the Gaming Commission Ordinance R400-04-Section 6.04. And then the final now therefore it's resolved that the Gaming Commission Regulation R400-04-GC06 Chapter 6 Gaming Vendor Licensing is hereby accepted for filing by the Little River Band of Ottawa Indians Tribal Council.

DeAhna Underwood: Thank you and good morning. Grand Valley Automation designed and installed the government center's smart building automated system also known as the BAS. The BAS operates and monitors the HVAC system. The current agreement expires at the end of the month. This is a sole source contract and a 2025 budgeted expense and will be budgeted in the 2026 budget expense. Sorry. Um I received this contract on February 3rd and the legal review was conducted on February 5th and the work session was held on February 20th. Grand Valley will provide on-site biannual preventative maintenance services in the spring and in the fall. These services are designed to extend the operating life of the building's automated system. The PM tasks are on the proposal under the preventative maintenance plan. The contract will auto renew at the end of year one when pricing changes are required beyond the inflationary 3%. A notice of price changes will be presented 75 days prior to renewal. Year one and year two annual total amounts are \$10,540.85. The estimated two-year total amount is \$21,081.70. Thank you.

Alexis DeGabriele: Thank you. I'm Alexis DiGabriele. I'm the aquatic biologist wetlands and I'm representing the Natural Resources Department. We were asking for Tribal Council's approval to submit a grant application to NOAA for the amount of \$1,120,000. This would be for a Tribal Fish Passage grant. Um this would be for the Maple River, which is a branch of the Muskegon River. It was formerly uh flowed out of the Muskegon and back into the Muskegon, and it was cut off during the logging era. And since then, um its impeded fish passage, as well as um there's a very important manuman wild rice stand there. And this project that we're proposing would be a feasibility study and some baseline monitoring for us to evaluate um the reconnection and to put everything in place that if the reconnection were to happen, we would have all the design in place. I'm happy to answer any questions. Thank you.

Speaker Burmeister: Will there be any councilors that are going to abstain from this item? Councilors with questions? Go ahead, Councilor Metzger.

Um, it was passed mostly along the party lines, with every Democratic voting against a measure, one Republican voting nay, so that is, um, this is the Medicare spending and cuts that's being, um, that passed, so voted, so that will be, um, affecting the children, families, people with disabilities, um, hospitals and nursing homes, all of those have an effect in that with this funding, um, passage and, um, following the Trump administration's plan. Um, the other one, I wanted to talk briefly about the Michigan Court of Appeals upholds Enbridge Line 5 tunnel plan, which that means the Court of Appeals has upheld the permit for Enbridge energy plan to bury oil pipeline beneath the, um, Straits of Mackinac, so it looks there's going to be more action, and I know tribes are not done fighting, but currently right now the three-judge panel voted for um Enbridge to move forward with their tunnel. Um, and then a few other updates, um, just a reminder again, government offices will be closed tomorrow, Thursday, February 27th, um, notice out I had said about the, um, Easter egg hunt that's happening at the housing, um, pavilion at Aki maadiziwin on Saturday, April 12th, that's for youth and elders, registrations beginning at 10:30, um, and then the egg hunt itself is starting at 11, and then we are just about 25 days away from our annual round dance, we have that scheduled for March 22nd at 5:30, with the doors opening at 5:30, fees to follow that, so, um, everyone's welcome to attend that, and we still are looking for volunteers that we may need that evening, um, and I think we are moving forward, we do have, um, save the date flyer being prepared, and our annual Jiingtamok. will be 4th of July weekend, we're having that on the 5th and 6th of July, so that should be out too, so just put in a reminder for save your date, we were unable to secure any discounts for tribal members that weekend, um, versus the casino policy, but we're still looking into

Councilor Wolfe, go ahead.

Councilor Wolfe: Thank you. Um I announced this last week, I want to announce it again. Um we're having a silent auction bake sale fundraiser to recover the vessel the Eagle. That's happening March 5th from 11 to 2 in the lunchroom here at the Government Center. Proceeds will be used to assist the retrieval of the sunken tug vessel the Eagle out of the Pier Marquette Lake. On 11 2-11-25 our tribal member fisherman Boo Batiste's vessel sunk and now needs to be recovered from the bottom of the lake. Boo used this vessel to feed his family and many members of the community. If you would like to make donations, any items to the auction or baked goods, they can be dropped off in the lunchroom on Wednesday 3-5 at 8:30 in the morning. This is being sponsored by Quaywook of the Little River Band of Ottawa Indians. And also, if you would like to make a cash donation, there is a bank account that has been opened at Filer Credit Union for this fundraiser. That's what I wanted to share. Thank you.

Speaker Burmeister: Thank you. Any other public comments? Go ahead Councilor Crampton.

Councilor Crampton: Yeah, just given the recent stories and the political um BS that's being tried, Um I don't think it was too long ago everybody wanted me to be here. I'm here. Since I walked in the door, I've had things tried left and right, so I leave quick as possible. That's the only reason that they uh wanted me here was to try stuff like you saw today. But it's not going to happen. I'm going to do my job for the people. They can play the political games they want. And I do not mean Councilor Metzger, Councilor Wolfe and Councilor Wittenberg. Thank you.

Speaker Burmeister: Thank you. Go ahead Staci. You are next in the queue.

Staci Cheney: Thank you. I actually want to thank Gary DiPiazza for the warning regarding the viruses that are out there. I um got one on my work email, so they are real. And thank you for the warning. Um I wanted to also say Miigwech to Pam because you're doing a great job getting those videos up their um for us to be able to see the Council meetings if we miss them. And then I wanted to say um Shirley that I think that was a completely inappropriate time. I don't know if you understand um what the legislative review is, but it's not for you to tattle on people. But um yeah, that was inappropriate. And then I um also was hoping that um the speaker could give us an update because I know last week we were told that the sanctions were lifted. But I did some research, and I was wondering, um does that mean there's no penalties to our tribe? Because after doing some research, I found out that sanctions can be lifted, but that

doesn't mean that our tribe has not been penalized with the funding. So, I was just wondering if you could answer that question for us. Thank you.

Speaker Burmeister: Thank you. Ogema did you want to respond to that?

Ogema Romanelli: Sure. And then I also want to be in the queue about the other issue. Want me to speak now?

Speaker Burmeister: I have you written down in the queue. So, I'll go to, we had a tribal citizen with their hand up in the audience.

Ogema Romanelli: Okay

Speaker Burmeister: So, I'll get her first and then I have you.

Ogema Romanelli: Okay. thank you.

Speaker Burmeister: Diana, do you still have a question or comment? Okay.

Diana Harris: Diana Harris, 2404. Um going back to Shirley's comment, I just wanted to ask her a question. If she feels in fear of her life, that's all I have to ask.

Councilor Wever: Well, I don't want to be alone when Shannon Crampton's around. That's all. Thank you.

Diana Harris: Okay. So, um can we have an escort for her when she leaves the building? And um also, when she comes in, maybe she can call ahead of time. But if it's giving her emotional issues, then we should take note. Don't let our councilors um be treated in an incorrect way. We're here to be peaceful and we all have to get along. And that's what we need to do. Miigwech.

Speaker Burmeister: Thank you. Ogema Romanelli, you are next in the queue.

Ogema Romanelli: Thank you. I'll answer the tribal members on the calls question. The uh fact that we are not going to be sanctioned is one thing. There will be findings. And depending on what those findings are, uh there could be some kind of uh steps taken to rectify that. As we know, there are some things that are still pending. And uh so, we'll have to wait and watch. But basically, the sanctions are off. Now, when we go into situations like this, it can affect future grants. I think they take a look at things like that. So, um are there some things that could still happen? Yes, I believe so. And I think we have to look at what those what those um what those findings come down to. And I think both the executive and legislative need to work together, as I stated, uh both the CFO and the uh comptroller specifically should be working together. And I'm not sure that happened in this last one, but let's hope it does going forward. As to the councilors comments earlier, this uh some of the actions that happened, you know, after the meeting, I'm not aware of. But that gets back to some of our employees hear some of the things

going on. So, I can only take it as rumor. Uh but some of the actions that happened within the Tribal Council meetings, whether it be second open or first open, cause uh concerns for employees. I'm left in a bad situation because Tribal Council wants staff to appear in person, they want them to come to the uh the podium, they want to have them come to work sessions, etc. Many times, when they come to these places, they feel intimidated, threatened, etc. They do. So, I'm left to say now what do we do? I don't think anybody should uh feel as uh Councilor Wever does. And I get complaints from my staff on a regular basis as to having to appear. Now, nothing in the Constitution that I see requires us to be attending work sessions. What it requires is if that we have something on the agenda, that we submit the information. We submit it in a timely manner, usually by Tuesday at five o'clock, so that the council has time to review. If they have a question or concern at that time, they're free to email the director or the person that's involved and get the questions answered. The way it's done now, we submit the information and then we're requested to attend a work session or two or three and then attend the um agenda review and then still get questions once they get here. Some of those questions are inappropriate. They just are. Some of them are legitimate, but that should have been worked out at the work session. When you get here, it's my belief that much of that stuff should have already been worked out. There's no need to intimidate, threaten, humiliate, or anything else our staff. And so now I'm faced with, because of the latest thing, what do I do? I've already, and it was misreported, that I told people to hold back financial information. I did not tell them that. I told them they do not have to attend work sessions if they feel uncomfortable. And I'll continue that going forward. So, and attending in person. You see, there are times where they don't want to attend in person, and I don't mandate that they attend in person either. I think that over the years, from what I see, these uh council meetings have gotten down to a very low point as far as uh respect. And we say the prayer before the meeting, and we talk about working together. We talk about the seven grandfathers' teachings, but little do I see of that. It doesn't take five minutes to get into a situation where we're laughing, smirking, uh all the different things that go on here on a regular basis. That's not to mention the things that happen outside on Facebook. So, I'll make a decision on where I'm going uh with the staff. We have 170 staff members in this building and in other buildings, and it's my opinion that they submit the information. Uh they do it thoroughly. They submit it to council. Council has a problem. I think that council can then uh do an email exchange back and forth, and uh we'll go from there and see what we need to do. Now, it's been talked about that if I do not have them attend work sessions, that they will pull each item from the agenda, which has happened in the past. Excuse me, I'm still speaking, and that's another thing that happens. Constant interruptions, depending on who it is. I've been interrupted. Okay, I am done. I'm telling you that I will not put up with this for me or my staff, and it's the same people that are offensive every time. Thank you. Have a good day. Chi Miigwech

Speaker Burmeister: Next in the queue is Councilor Crampton. Go ahead, please.

Councilor Crampton: Well, I'd just like to point out that the person who tried to attack a tribal member last week was Ogema Romanelli. So, when we're talking about violence in these meetings, I think that's where it comes from. Um I went back, and I tracked the emails. This whole thing about employees not coming to a work session happened right

after Angela Rabb stood up and said that the Ogema told her to illegally move money, and then all of a sudden, we started getting his uh reports of abuse from tribal council. Absolutely not. Uh when I first came down here, I made a police report to the police about Shirley Wever. If she's truly a scared uh afraid of me, why do you come up to me and tell me you like me and try to hit on me?

Councilor Wever: Stated something but not clear on zoom

Councilor Crampton: No, I'm in the queue.

Speaker Burmeister: Can we please not get, let's not get personal.

Councilor Crampton: You just let-

Speaker Burmeister: I know.

Councilor Crampton: You just let it happen.

Councilor Wolfe: Just like everything else

Councilor Crampton: You just let it happen. I'm responding. I'm responding. So, after there was a report of her hitting on me, now she comes back up with this. I think that's the fear around here. If we're going to have stuff like that, I think we have sexual I think we have sexual abuse and harassment as one of our main things around here.

Councilor Wever: Stated something but not clear on zoom

Councilor Crampton: Speaker, could you please? Anyway, sexual harassment is one of our biggest things around here. I filed that. Now, she's saying all these things after I filed that. Like I said, if you're really scared of me, don't come up and try to hit on me. Councilor Wolfe was right there and saw the whole thing. So, I really don't like coming down here because this is what I have to deal with. I would like to do the professional thing and there's nothing you can't do on the internet that we don't do here. But what happens here is that you get here and then you get the um political things like Mr. Romanelli come up saying after Angela Rabb told us that he illegally moved money and told her not to say anything. Now, we get him come up here and saying, well, my employees can't meet with you. They're being abused. They're being asked questions. No, they're saying things that he hasn't approved is what's happening. And the whole political thing with Ms. Wever, I wish I never had to see her ever again. That's not somebody that would even be at my dinner table. My friends and I wouldn't even let her close to us. That's not my social circle. I don't slum. Thank you.

Speaker Burmeister: Thank you. Recorder Johnson, you're next in the queue.

Recorder Johnson: Um so, uh Councilor Wolfe, uh on your comment that you made about having um with a fundraiser next week and the account at Filer, um could you do

something up or get with Joe and have something so we can have that post online to be able to share? So, people want to because it's easier or whatever... whatever maybe they have to do to partake in that in a different um way without um having to come in or whatever. They can just make a donation to that account or something. So that way, um members can see that regardless of where they're at, if they want to help support that with... with Joe. Just wondering, it was a thought that the more I got thinking about it that that would be a good thing to post to have out there for um the different members and whatnot. Thank you.

Speaker Burmeister: Thank you. Councilor Wolfe, you are next in the queue.

Councilor Wolfe: Okay, I'll address. I don't know. I'll address the Ogema's first. You know, he said, employees are intimidated and this and that and my staff, you know what, this is Little River Band, Ottawa Indians, and we're a three-part government. That staff is managed or overseen by Larry. It's not his staff. It's the people staff. We work for the people. We as legislators sit up here and serve in a role as legislators for the people. The court works here for the people. For them saying we can't come to a meeting, we can't this or that. Where's the court case that files were hostile Tribal Council members? Where's the court case that says we're not doing our jobs? Councilor Crampton said it right away. He doesn't like what's being said to Tribal Council. Did you hear a person at the podium? This is all I was authorized for. Not what I need. This is what I was authorized. There's fear and intimidation. We all know it happens. And for him to say, my employees, my employees, we're one nation. We're Little River Band. We're a tripart government. He manages and oversees employees, but those are shared employees that have a duty and obligation to this Tribal Council. So, for him to go on with that, yeah, I get like, what's going on here? Why are you allowed to say everything you want to say with no regard to actual facts? I present facts. When I'm here and I'm representing, I have a lot of facts. I have a lot of reasons behind me. And I ask the hard questions. And when you don't want to hear them, or you don't want to answer them, it doesn't stop me. I treat you the same when I see you in the lobby or in the kitchen or, you know, uh when you come back for your office. A lot of times I'll ask the hard questions. The camera will go off. We'll be laughing and joking because it's not personal for me. It's about the best goals for the tribe. And I operate that way. Um so, I wanted to answer Councilor Johnson. I can give the information to um Joe for an update. And it would be nice when it was originally posted on the website, the government Facebook page. It didn't have the account information to it. But since I've added in an updated that, so I'll resend out the flyer with the account. It will just be on the post, not actual. I won't update the flyer, but reposting and then we can share it back out again. And I'm all set. Thank you.

Speaker Burmeister: Thank you. Councilor Wittenberg, you are next in the queue. Go ahead, please.

Councilor Wittenberg: Yeah, Miigwech. Talking about um I can go back to uh when we first got going and I talk about particular one council member where the council member, this is supposed to be behind our sacred area. And any time one comes back here, you're in our areas. And how many times as uh the Ogema turned around and made that

approach? Oh, no, I don't want to say nothing. I want to point fingers. But nothing is addressed that way. Now we got turn around and we got citizens that are turn around and do the same thing. But they turned around. Oh, no, it's councils. And would that scale ain't balanced at all. Oh, I forgot. Somebody is going to say it's election season. So, we're going to turn around and shoot this way and shoot from the hip. You turned around, you cried the blues because it wasn't here. And he turns around and comes in. You're still crying the blues. Still crying the blues, wah, wah, wah. No, some of you uh don't know what you want. You talk about the seven grandfathers. What about the twelve commandments? Because when I go to ceremony, I only see a handful of people there. So, it must be either the one uh seven grandfathers or the twelve commandments or just plain old respect. You don't need none of them. Respect. No, we got our own agenda. And, uh you know, that's where I see it. So, let's look at the real deal. There's no balance. No balance at all. So those are my uh words on that. Miigwech.

Speaker Burmeister: Thank you. Ken, I have you next in the queue. I'll put you in the queue, Boo.

Ken Metzger: Ken Metzger, uh 0889. Um first of all, I'd like to say uh thanks for the Housing Commission putting a cap on the houses here on the tribe. Um that was one of my biggest pet peeves when I moved around here. I didn't find this out until about a year ago because uh I had a lot of other issues dealing with divorce and losing job and a lot of money and stuff. But I'm glad that we got a cap on it. But it's not enough, you know, because we got elders that only get like five hundred dollars a month and then they get penalized when they get their per cap. Instead of being a gift from the tribe, our payments allocated as per caps. Um I'd love to see that change someday so they don't get penalized every time they make a little extra money. And then uh feeling threatened and intimidated. I don't know if anyone was here last week, but I was, you know, when Larry blew up at me for chuckling. And I wasn't laughing out loud. I just, but he seemed to point at me for some odd reason. I don't know. And then he doesn't stick around to the end of the meetings like usual. You know, he either hears what he wants, leaves, and if you don't hear what he wants, he'll leave anyways. He never sticks out the full meeting. So, when people are talking online and that, he's already gone. Yeah. And then there's another thing with the EDC getting blended in with uh Little River Holdings, you know. Sounds like their Little River Holdings gonna leave us holding a bag when they pack up and leave us. How much money have they received from our tribe since their conception? I can't even get a roundabout estimate. But uh we got him and another uh council member that seemed to be running EDC, and uh now they deny it. But as you can see, when the Constitution was changed in 04, we should have had a tribal audit before then. I feel that every time the Constitution been changed ever since, it was illegal because it was illegal people changing it. Now, you know, target people wobbling their heads and huffing. I see it when I come here, you know. Um pretty pathetic as grown adults, but uh when we're talking millions of dollars, not just 100,000, not 400,000 for a tribal audit, which would be pennies compared to the people that are illegally on our tribal roll. And I know they're illegally on our tribal roll because we haven't had an audit in over 20 years. And there's people that do not want to see an audit here because they know they're part of the situation. Yes, there is going to be a lot of people. There's going

to be relatives that are going to probably be dismissed. But if you're illegally, if you illegally got on tribal roll, how come we can't legally kick them off? It's plain and simple. There's got to be, we got to have an audit, tribal audit, blood quantum, because I feel a lot of injustices that's happened here in Manistee County. The worst thing that I have seen here is the buying and selling of ancestral properties and rebuying and selling them again. It's a monopoly and it's been going on for a long time. Thank you.

Speaker Burmeister: Thank you. Okay, next in the queue, um Roy, I did have you, but I know you lowered your hand. Do you still have a comment?

Roy Vanas: Uh kind of, you know, I see people uh making threats online and one of them just left the podium and I hear the... the ridiculousness of someone sexually assaulting uh someone who's just smarmy. It's just uh I can understand someone being afraid of someone and yeah, they should, you know, be careful because no matter how much a snake smiles at you, it still will bite you. That's about all I got to say. The rest of its kind of a moot point.

Speaker Burmeister: Thank you. Council Wever, I do have you next in the queue. Do you still have a question or comment?

Councilor Wever: I don't know where to begin. Um I won't lower myself to call names, but I sure would like to. I just want to say that I would never lower myself to Shannon Crampton's, um I don't know what you want to call him, but he can continue calling me a liar and I had forgotten all about that he had pressed charges against me. I hope he pays \$60 every time he runs over there because that's what it should be. I'd like to see that he does pay his um fee, but I just want to say if I were to make up a lie, which I'm not a person that lies and I think that's what gets me into trouble all the time, is because I don't lie, but I could come up with maybe a better story than him telling me he hates me the most and I'm stealing from his kids. And for him to say I'm lying, now I know for a fact that he does say that all the time. They're lying, they're lying about me. And like I said, I just thought everything was okay and safe until I walked by his office and that still bothers me. And I think it will for a long time. And for him to say we all want him down here; I get along with all these people here. I love them. I love coming to work and seeing Ron, Al, Julie and Tammy and Pam and Gary and Misty. They have a lot of respect for me and for all of you. But that one on the end, no. And for him to say we want him here, it's just like the rest of us. We're all here, aren't we, Julie? Well, shouldn't he be here? But he causes trouble. So, you know what? I don't want to say anything about the election, but if he doesn't get elected, wow, we're going to uh we're going to go to the election board. We're going to sue them. And maybe I'll be here for a little longer. Who knows? Thank you.

Speaker Burmeister: Thank you. Councilor DiPiazza, I have you next in the queue. Go ahead, please.

Councilor DiPiazza: All I can say is after the camera went off in second open last week, it was very disheartening to hear what was coming out of some people's mouths and what

they were actually up to. Because poor Chuck never hurt a fly. Everybody needs to watch that video. The disrespect that was at the table after the camera was off. The snide laughing or whatever that was. Yeah.

Staci Cheney: Speaker it's actually on camera.

Councilor DiPiazza: I have the floor, but I guess that doesn't matter anyways. Anyways, I'll revert to people to resolution 17-0503-163. That was the audit for the 2000 2016, which was a 100% audit of them newly enrolled citizens. Pull that resolution up because it hasn't been 20 years. We're five years behind on an audit. The next one's not due. Next five years due in 26. So no, and I'm really hoping that charges get filed on some of these that transpired last week because there was a citizen out here hearing it all. It might even be in a body camera. Hmm that would suck, wouldn't it, for some. Other than that, it's, yeah, I'm good.

Speaker Burmeister: Okay. Thank you. Boo, I have you next in the queue. Yeah, I have him next. After Boo.

Boo Battice: Boo Battice 2644. Yeah, I'd like to say uh the eagle did go underwater, still underwater. I'd like to get it back up and breathing again. Um It's a lifestyle. These kinds of things do happen. Um It takes weeks to get the equipment that we don't have to recover this kind of vessel. So please have an understanding that it might take another week or two as we're trying to figure things out. Um I'm not really apologizing as these things happen and the speediness of fixing it. I apologize and I wish things could have happened a little bit faster. We had more of a foundation. Um I would like to thank Julie especially for helping out. Any help is possible. Anyone who wants to donate to what Julie set up. It's going to go towards the better of all the fishery because I don't plan on leaving anywhere. Um I plan on making that boat float. Everybody's heard the phrase, you know, repair the holes in your ship. I mean, that reason's around for a reason. It can be easily repaired. Um I just don't have all the equipment for that, but I've got a lot of help coming in and we're doing it as fast as possible. And it is a lot of heat, and I respect you guys for taking all the same kind of heat. As I'm not bragging about any certain or other, but the other guy about got hit in his ear because of the positions you guys play. Some people, our president, he's flying this ship right now, but our president, you know, got shot at. And I respect all of you because that is what you guys are doing, getting shot at every time. As we're battling, we're shooting at each other. I like what Ron said where we need to find this balance to get on the same goal to work together as a whole. AS a whole we're never really getting ahead as a whole because we're too busy doing the divide and conquer thing, the Gregorian thing, the Roman thing, the old, you know, we should learn from our mistakes and try to fix it and keep moving forward. I'd like to thank everybody for having an understanding that I'm still pursuing fishing and that's a lifestyle and that's just a thing that happened. I'd like to thank Julie and all of you for participating. Hopefully some donations can help out. And then I would like to say thank you, Shannon, for bringing up something for people with no credit for the housing thing because as fishermen and being part of the food industry, there's hard building those establishment taxes and different things because it's a food and it's a farm. It's considered fish farming. So, to be able to build these credits, I've never been able to have the ability to even build these credits because I can't claim it the same under the as a fisherman. So even if I was fishing fully, I would still have to build it without the fishing thing a little bit because it's grants and fish and food and farming. So, the credits don't ever really come. So, it's hard to build credit even if you have all the money. You still got to have credit to get things. You can have a whole bunch of money, and they'll say, well, what do you have for? And you know, just my abilities and things. So, thank you, Shannon, for bringing that up because there is people out there that really need the help and just can't get it. And when they do try to get it, it takes five years, three to five years to even because you got to create EIN numbers and have these different regulations. You got to follow regulations and rules that's just been in place. And it's really hard for us as a whole. Um I hope everybody's surviving the turn up of the of the frequency. I know I've seen a lot of people getting... getting the lung congestion. I hope everybody's recover and handling it fine. But we are going to 589 the color of light so they can laser us. It's not going to be just radio waves. Um yes, I'm asking for any help and all to get the eagle up. And I'm still pursuing the same dream. And hopefully we can ...we can uh move forward and make it look better for all of us. Thank you all very much. And hopefully everybody recovers well from the... the turn up. Have a great day.

Speaker Burmeister: Thank you. You also. Next in the queue is Councilor Wittenberg. Go ahead, please.

Councilor Wittenberg: Yeah, Miigwech uh I just want to retract my statement. I said the 12 commandments and I didn't realize there's only 10. So don't take me to the cross and nail me up because uh I seen the book, but I'm not too familiar with it, but I am familiar with the teachings. But the bottom line, it's all connected if one chooses one another. And it goes back to uh different views. We can all sit in here and watch the corner and turn around and see an accident and uh more than half of us will see something different. And that's uh what it's all about. So, since the one shared what he saw, I'll share what I seen where that gentleman could have just kept on going or come out this door and not even gone out in the back. That person is the one that stopped. And I seen the look on that person's face where I turned around and I seen something that wasn't right. And I was definitely right about that because you can tell look on somebody's face what is going on. But we don't want to say that. So, look at the camera. Oh, no, it was after the meeting. So, it was uh deleted as most things. So those are the things you people want to turn around and point, point, point, point. Well, then how come we lost this video or didn't do this or do that with the video? Think about it. That's all I got to say. And oh, yeah, I forgot we got cameras out there. Whether they work or not, I don't know because I know even across the street, a lot of their cameras don't work. And so, what is and what ain't is working here. There's a lot of things that people have turned around and look at it with an open mind. You know. So that's all I got to say. I'm ready for a cinnamon roll. Miigwech.

Speaker Burmeister: Thank you. Susan, you did have your hand up. Do you still have a question or a comment? Okay, she dropped. All right. Councilor Crampton, you are next. Go ahead, please.

Councilor Crampton: Well, I'd like to thank Councilor Wittenberg and uh all the members that recognize the pathetic up political ploys that keep getting put forward up here every week because they are pathetic. Um right now, if you go over the agendas, you're going to find that Councilor Wolfe and myself are the most productive council members on this council. You're going to find that Councilor Wever and most of the others that support her, absolutely nothing in four years, not one work product. And you're paying how much annually for nothing that you get up here and do pathetic political ploys. Those are on your agendas. That's not he said, she said. That's something you can look up at what council members put what things on agendas. Like I said, not one thing in four years. So, when you think you're getting used and you look at what you paid for four years, you paid for four years of nothing. That's not he said, she said. That's factual. And there's whole bunch of them sitting up here that do the same thing for two years now. And I can show you on the agenda for two years, not doing anything, but they get off a mouthy on a Wednesday. And all they have is political ploys and lies. Like I said, you've all seen my wife. Do you think that I would do anything like that? Absolutely not. I don't eat dog food when I have filet mignon at home thank you.

Speaker Burmeister: Okay, Councilor Wolfe, you are next in the queue.

Councilor Wever: Trash

Councilor Wolfe: Thank you. This goes to the citizen that came up. I think it was a few weeks ago he came up and you said I want to know what how much EDC is had and what the profitability is. I'll start with the profitability. Never a profit always operating the red. The last time they gave us their presentation when it was time of their five-year autonomy to be up, and they had to start developing their dividend plan and pay dividends to the tribe so we can support more tribal services. \$95,000 in the red after five years of autonomy. I got seven resolutions here. I went and looked them up for you. Didn't calculate the numbers because I've been kind of busy finding other numbers for the stimulus payment. But in 17 enabling resolution, estimated quick review 7.5 million in assets and properties and uh infrastructure, governmental investing, old and old infrastructure, all of these things, 7.5 in 2017. And they're enabling res, I'm gonna give you these. Uh then also in the same resolution, we authorize them a \$5 billion line of credit. How much of it they used, how much do they owe? This was in 17. Okay, next resolution is an 18. We transferred two more properties at 135,800, 2019, we give them their supplement, they got a distribution for economic development out of the casino revenue, 2019, we gave them \$1,130,791, 2020, we gave them that same funding \$1,336,183. Plus, they asked for \$413,333, which was budgeted in the Commerce Department. We haven't had a Commerce Department since 2020. Okay, here's another resolution from 17. Transfer of Little River Trading Post, \$1,127,888.09. Another resolution, 2018, authorization transfer 215-acre golf course property. Subject to final auto determined by CFO, \$600,000 was estimated that property. In 2019, confirmation existent need and role of the uh entity as a nation is the last resolution. That doesn't have a dollar amount in it, but it talks about how they came to be. So, I got these seven resolutions. I pulled them all offline. These are all open in public documents that are

listed under resolution. But I pulled them off and printed because you wanted to know. So, I did that for you because that's how important one citizen is to me. Thank you.

Speaker Burmeister: Thank you. Councilor Metzger, I have, no, okay. Um Sara, you are next in the queue. Go ahead, please.

Sara Agosa: My comment is about, sorry, I've been recently sick. My comment is about cybersecurity. I want to go back to the recent hack at the Sault Ste. Marie tribe. I checked the tribal website and there are numerous job postings and for our end IT. The positions that are open, help desk technician, operations engineer, system security administrator and technician. So, my question is, has Mr. Romanelli come forward with a plan to avoid a risk like this in light of this recent hack? That's my question. Thank you.

Speaker Burmeister: Well, I can answer that. No, he has not. He hasn't come forward with a plan. You have an answer to go ahead Councilor Crampton

Councilor Crampton: I got to back up the Speaker. I don't think he's brought forward the forward, but I know that the last time I think it was George LaVassar and I think that it was kept up to subscription. Our uh we are subscribed with Sophos, which is what the federal government uses for their uh internet protection. I think it costs \$10,000 a year for the subscription. So, we're in pretty good hands. Thank you.

Speaker Burmeister: Thank you. Go ahead, Councilor DiPiazza.

Councilor DiPiazza: I'm going to say some of the resolutions she brought up. The C-Store that transferred to the resort along with the property, the golf course. So, they haven't been funded in the last three years, two years, three years since 21. So, they've been, they've been holding their own, the EDC. So, yeah. And that 5 million was

Councilor Wolfe: Went bankrupt

Councilor DiPiazza: 5 million line of credit was never, never used.
