The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on February 26, 2020. Following are the minutes of that meeting. The tape recording was skipping through the following minutes and some of the comments were not picked up and were taken from memory or the Roll Call Record.

1. Acceptance of contract funds from the Department of Health and Human Services-Indian Health Service and approving a modification to the Operating Budget MB-2020-__ in the amount of \$1,728,541

The contract funds are awarded as part of the 2020 Self-Governance Compact.

Speaker Pete asked Bill Willis if he was here to represent this.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said yes and thanked Speaker Pete. Willis said this item represents Modification #2 to the 2020 Self-Governance Compact with IHS. Willis said year to date this brings them up to \$2,812,008. Willis said they projected to receive \$2,935,000 so they are well on their way. Willis said this represents about 96% of what they estimated they would receive so. Willis said they are confident they will receive, they know, the \$2.9 million and potentially more.

Speaker Pete thanked Bill Willis. Pete said that is what he was going to say because they.....when some of the.....this is some of the earliest they received that much money.....

Bill Willis said yes.

Speaker Pete continued......from the Federal Government and that is a good sign. Pete thanked Bill Willis. Pete recognized Diane Lonn.

The Tribe received this grant last year for a total funding amount of \$216,000 and is a 3-year grant.

Jason Cross, Family Services Director, represented this agenda item. Cross said yeah, good morning. Cross said this is a resolution approving year two of a three year grant funding for their Resident Opportunity Self-Sufficiency Program. Cross said this is a grant from HUD that supports their residents who live in public housing or NAHASDA Housing helping them with self-sufficiency.

Speaker Pete said okay. Pete asked they know what he asks the same question every time that this is grant funds, right.

Jason Cross said this is a grant, year two.

Speaker Pete said absolutely. Pete thanked Jason Cross. Pete asked is there any.....can he get a resolution or any further discussion. Pete recognized Sandy Lewis.

Councilor Lewis said she would like to make a motion.

Bill Willis, Budget Coordinator, represented this agenda item. Willis thanked Speaker Pete. Willis said he did confirm with the Housing Director, Tara Bailey, who is here in the audience that this modification is in it's entirety designed to provide funds to renovate one of the existing bathrooms in the Elders Complex to install a commercial washer and a commercial dryer for the use by the residents. Willis said should they have any further questions Tara Bailey is available to answer those.

Speaker Pete said okay. Pete asked is there anyone that has further questions. Pete recognized Diane Lonn.

Councilor Lonn asked Bill Willis this is just for one washer and one dryer right.

Bill Willis said he believed so.

Councilor Lonn said the complex holds how many people....how many units are in that complex.

Bill Willis answered there is ten units currently.

Tara Bailey, Housing Director, said it is just for a large size commercial size washer and dryer so that the residents have the availability to wash like comforters or sheets. Bailey said large items like that they cannot currently wash and dry in their units.

Councilor Lonn asked if they needed to add is there room to add in that bathroom they are making.....

Tara Bailey said she believed um-hum.

Councilor Lonn said 30.....okay. Lonn thanked Tara Bailey.

Speaker Pete recognized Ron Wittenberg.

Councilor Wittenberg said no, he is good.

Speaker Pete asked he is good.

Councilor Wittenberg said yeah.
