Councilor Corey said to Boo Battice, yeah, it's about hemp and food production for Tribal members. Corey said the Farm Bill has....there is almost \$142 Billion available and it's to help promote farming in indigenous communities so if they get people into cattle, hemp and sustainable practices so they could provide a living for their family. Corey said there is people from all over that are there sharing what they do in their communities to help get farming in....back in Native American...back in their hands and on their land. Corey said look it up on the internet.

Acting Speaker Di Piazza asked Dave Corey if he was all set. Di Piazza recognized Shannon Crampton.

Councilor Crampton said oh, he was going to say he supports this too and if they look it up on the internet it is the White Earth Tribes putting it on. Crampton said there is a whole page about it. Crampton said so if they wanted to look it up it is just off the title of the page. Crampton said to Dave Corey when he does come back tell them where the hell this place is at because he never heard of Calloway, Minnesota.

The Tribal Council has drafted amendments to clarify permit process by adding definition of ordinary repairs, to allow for approved vendors for inspections, and to fix formatting.

Rebecca Liebing asked Steve Parsons if he wanted her to do it.

Acting Speaker Di Piazza said either or that would be fine.

Steve Parsons, Planning Department, said good morning. Parsons said he is going to defer to Rebecca Liebing because she is the one that actually made the changes in the ordinance itself. Parsons said he is certainly here to answer any questions that they may have in terms of why it was necessary and some of the things that they did. Parsons said if she doesn't mind.

Acting Speaker Di Piazza thanked Steve Parsons. Di Piazza recognized Rebecca Liebing.

Rebecca Liebing, Unified Legal Department Attorney, said the Building Ordinance was posted for 30-day comment period, they did not see....receive any comments from the membership on the amendments that were proposed. Liebing said the amendments that were proposed were initiated from across the Resort regarding clarification. Liebing said the ordinance was changed about two years ago to include commercial buildings as well before it was previously just for residential construction and building plans. Liebing said so with the addition of commercial properties the Resort is now subject to certain permitting and the Building Code requirements and as they were working through the process they asked for a few changes exceptions to permits and how that process could be addressed. Liebing said grandfathering in equipment from previous construction and clarification of definitions like ordinary repairs so when they made the changes they went to Council and they basically looked at what the Michigan Code does with LARA. Liebing said they followed their guidelines with some advice from both Steve Parsons and their Building Inspector that they contract with.

Romanelli said one of the Elders mentioned to him this discussion whether it be descendants or 1/8 bloods or whatever the talk is the fact that their Tribe needs to do some long-term thinking as to how they go forward to the future. Romanelli said again, it isn't stating that they are going to go to 1/8 blood or anything but it is to look at the future of the Tribe. Romanelli said now that they closed enrollment there is this issue that their Tribe will diminish in numbers, numerically so just to look at it. Romanelli said it is not promising or anything like that it is just to look at it. Romanelli said Elder, Marcella Leusby, said that if a committee was put together she would be welcome to sit on it. Romanelli said so he is just passing that onto the Council who sets up their committees and commissions so. Romanelli said that is it.

### C. Legislative Affairs Update

Councilor Crampton said yeah, Oklahoma's Governor, Kevin Stitt, just keeps on with this argument. Crampton said what he is trying to do is he is trying to shut down \_\_\_ gaming. Crampton said if he can do it in Oklahoma. Crampton said Oklahoma was the first state to declare Indian Territory. Crampton said this is a very dangerous action that he is taking but it is going to fail. Crampton said he has already been looking over the case and he is headed for failure but it is something they should stress when they are out in Washington very much. Crampton said he kind of thinks that is probably going to be a hot button issue.
