Position: Fisheries Biologist - Inland - Natural Resources Dept. (FT – Regular) (1)

Summary: This position is responsible for the implementation of the Tribe's Inland Fisheries Program. This position will include extensive fieldwork, technical report writing, data analysis and assisting in creating management recommendations to protect the Tribes sovereign right to hunt, fish, and gather within the 1836 Ceded Territory.

Employment Qualifications: A qualified candidate offers:

Minimum Necessary Qualifications -

- Bachelor's Degree in Biology, Fisheries Biology, or closely related field; and
- Two (2) years' work experience in the fisheries biology field involving fisheries and aquatic sampling techniques, fish species identification, and research and study design; and
- A valid Michigan Operator's License with the ability to be insured under Tribe's policy; and
- Intermediate computer skills with Microsoft Office Applications, and statistical software; and
- Strong verbal communication, written communication, organizational, project management, interpersonal and teamwork skills; and
- Heightened attention to detail and accuracy; and
- Commitment to confidentiality; and
- Superior performance in the selection process as determined at the sole discretion of the LRBOI Hiring Manager, including but not limited to all of the following: any pre-employment interviews, skills testing, credentialing, drug screening, background investigations, reference checks and previous work history, passing a pre-employment drug test and background investigation, possession of a valid Driver's License throughout employment and being insurable under the Tribe's insurance policy.

- Five (5) years' work experience in the fisheries biology field involving fisheries and aquatic sampling techniques, fish species identification, and research and study design.
