# Gaming Commission Order #GC24-0206-01

Prohibiting Little River Casino Resort from Conducting Business with ReelMetrics BV

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C.§ 1300k et seq.); and
- WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7 (a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7 (j) to take action, not inconsistent with the Constitution or Federal law, which is necessary and proper to carry out the sovereign powers of the Tribe; and
- WHEREAS, the Tribal Council has in Gaming Commission Ordinance #04-400-04, created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Tribe and to enforce all Tribal, federal, and applicable state laws governing the conduct of gaming conducted on the Tribe's reservation; and
- WHEREAS, in Section 6.01 of Gaming Commission Ordinance, the Gaming Commission is authorized to enact and enforce such regulations consistent with the Gaming

> Commission Ordinance regarding its activities as the Commission may deem necessary and proper to effectuate the powers granted by the Ordinance and duties imposed by applicable law(s); and

- WHEREAS, Chapter 6 Section 3-1 of the Gaming Commission approved regulations states that every person supplying any gaming services or concessions gaming equipment, gaming devices or supplies must obtain a Gaming Vendor License; and
- WHEREAS, Chapter 6 Section 4-3 of the Gaming Commission approved regulations states that the gaming enterprise must initiate the renewal process by forwarding a Notice of Intent to Conduct Business Form to the Gaming Commission at least 120 calendar days prior to the vendor's license expiration date.
- WHEREAS, the Gaming Commission received the Notice of Intent to Conduct Business Form for ReelMetrics BV from the gaming enterprise on September 14, 2023 which specified that the gaming enterprise was no longer using the vendor.

NOW THEREFORE IT IS ORDERED that the Little River Casino Resort shall cease conducting business with ReelMetrics BV effective February 6, 2024, or until such time that they are licensed as a Gaming Vendor.

## Approval of Maintenance Service Contract Renewal with HID Global Corporation in the Amount of \$1,413.00

WHEREAS, the Tribe's status as a federally-recognized Indian Tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C.§ 1300k et seq.); and

WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016, which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council has, pursuant to Gaming Commission Ordinance # 04-400-04 which created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Tribe and to enforce all Tribal and federal laws governing the conduct of Tribally licensed gaming activities; and

WHEREAS, pursuant to the Gaming Commission By-Laws all contracts require Gaming Commission approval by resolution and pursuant to the Constitution – Article IV – Section 7 (b), all contracts/agreements require Tribal Council authorization and ratification; and

WHEREAS, the Tribal Council adopted Gaming Commission Ordinance #04-400-04 which created a Gaming Commission and delegated to such Commission the authority to regulate all gaming activities authorized by the Tribe and to enforce all Tribal and federal laws governing the conduct of Tribally licensed gaming activities; and Gaming Commission Resolution #GC24-1210-15 Approval of Maintenance Service Contract Renewal with HID Global Corporation in the Amount of \$1,413.00 Page Two

WHEREAS, Gaming Ordinance #10-400-01 - Section 10.03 (r) provides that all applications for licensure, fingerprints shall be taken by the regulatory agency and forwarded to the NIGC for processing through the Federal Bureau of Investigation (FBI) and the National Criminal Information Center to determine the applicant's criminal history, if any; and

WHEREAS, the livescan fingerprint scanner system requires maintenance, software upgrades, and technical support to operate efficiently, and our previous maintenance service contract expired on December 1, 2024; and

WHEREAS, the Gaming Commission Department budget does include funds to support this expenditure in the amount of \$1,413.00

NOW THEREFORE IT IS RESOLVED THAT the Gaming Commission hereby approves the renewal contract contingent on Tribal Council ratification of the contract.

IT IS FINALLY RESOLVED THAT the maintenance service contract renewal will be forwarded to the Tribal Council of the Little River Band of Ottawa Indians requesting ratification of the contract.
