Name, Purpose, Officers:

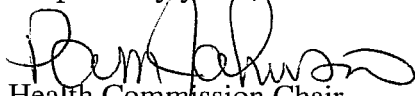
1. This report is from the Health Commission

 - Update on a few by-laws and ordinances.

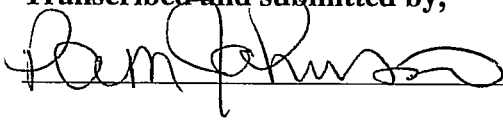
Motion to adjourn by Johnson Seconded by Patricio, all in favor. Meeting adjourned at 6:00 pm.
