- **E. Law Enforcement update:** Bobby Robose was present and informed the commission that there has been a lot of training since the last meeting. So they have been very busy doing that.
- **F. Natural Resource update:** Frank Beaver stated that at the last CORA meeting it was decided that All trap nets must be closed (tied off) by Nov.6th and must be removed from the water by noon Nov. 20th each year. They may be returned to the water Nov. 29th each year.
- **G. Legal Department:** Shayne was welcomed back. Shayne then stated that council will be having a work session about CORA regs. on Friday May 12, 2017 at 10:00 am.
- H. Natural Resource Business: (no hearings scheduled)
- I. New Business: Note-Review and revise commercial fishing application and permit. At that point legal presented a copy of the old fishing permit/application and the new application and permit with the changes. It was added to the application a probationary period and also to acknowledge that the applicant is physically fit to perform the job. Acknowledge that Tribal court has jurisdiction. Acknowledge that the natural resource commission can take any action against the permit, including suspension and revocation. Also certify that the permit holder will have all the proper equipment and safety gear required to commercially fish.

Motion to approve: Motion to approve Great Lakes commercial fishing permit application with the following corrections; under "if yes" chub net permit needs to be changed to small mesh permit, Fishing zone requested add choose one, under fishing operation choose 1, under number 2 states- I certify that I have all gear required to fish commercially, under number 10 states- I release the tribe from any claim or injury, loss, damage, financial or other use resulting from any claim while utilizing fishing activities authorized under this issued permit. Number 11 states- I understand the Natural resource commission shall impose a probationary period in accordance with application regulation.
