## Little River Band, casino make donation for Onekama class trip

ONEKAMA —Each school year, the eighth grade class at Onekama Consolidated Schools works diligently to fundraise in order to support a class trip to Chicago at the end of the school year.

This trip is more than a sightseeing tour. For many students in the class, it will be their first time leaving the state. The class trip is an opportunity for students to broaden their experience and understanding of the world.

However, as prices for travel have gone up and the median family income of students in Manistee County has gone down, the cost of this trip has become nearly unobtainable. This year, the students turned to caring community members and organizations to help them realize their fundraising goals.

Fortunately, they found a great partner in the Little River Band of Ottawa Indians. Thanks to a donation of \$2,500 by the Little River Casino Resort, and a \$1,500 donation by the Little River Band Tribal Council and the Tribal Ogema – for a combined donation of \$4,000 – the Onekama Schools eighth grade students are nearing the finish line in their fundraising efforts.

On Tuesday afternoon officials Little River Band of Ottawa Indians Ogema Larry Romanelli, tribal council members, Little River Casino Resort General Manager Andrew Gentile presented Onekama Consolidated Schools eighth grade class officers Mairin McCarthy (president) Elizabeth Sidor (vice president) Madison Antal (representative) The Little River Band of Ottawa Indians Tribal Council and Casino Resort donated \$4,000 to the Onekama Consolidated Schools eighth grade class for their trip to Chicago in the spring. The trip will allow the students to meet up with students from St. Sylvester School in Chicago who worked with their Onekama counterparts on a project titled "The Common Ground Project." In September, each class worked to create and share a video to describe their communities and daily lives. (Ken Grabowski/News Advocate)



with a check for \$4,000.

"This year, we have planned a more comprehensive visit to Chicago by connecting with an urban school in downtown Chicago," explains eighth grade class advisor (and Onekama teacher) Megan McCarthy. "This opportunity will allow our students to have meaningful interaction with students from backgrounds different from their own."

The partnership between Onekama School and St. Sylvester School in Chicago has been titled "The Common Ground Project." In September, each class worked to create and share a video to describe their communities and daily lives. In October, the classes participated in a live video conference to meet one another, respond to the student-created videos, compare life experiences, and ask questions.

"During the course of the year, we will engage in meaningful academic exchanges to help the students learn more about one another," said McCarthy. "Students will read the same texts and share insights through FlipGrid, Google Hangouts, Padlet, and other digital applications.

"It has already been incredible to see these students interact. They ask thoughtful questions and give provoking responses. The students are incredibly respectful and open with one another. I couldn't be more pleased."

The culmination of the

Common Ground Project will be when the students meet their new friends face-to-face when the Onekama class travels to Chicago for a three-day trip in May. Together, the two classes will participate in a joint service project.

It is an adventure that students are anxiously awaiting – and one that is being made possible in part due to the generosity of the Little River Band of Ottawa Indians.

"We are so grateful to the Little River Casino and to the Tribal Council and Tribal Ogema for supporting our students," said McCarthy.

## Letter from the Ogema

Aanii.

The Tribe has been very busy over the past few months as there is a lot going on.

Not in any particular order, LRBOI has established an Economic Development Corporation (EDC) for the first time in its history. This board will oversee several of our enterprises/businesses with the exception of the Little River Casino Resort. The board of directors is put in place to begin the first of January 2018 and will include the Ogema, two tribal councilors, and four other positions.

Our Muskegon casino project still inches along and we are putting on a push to keep it moving in the right direction. Recent actions and work on the project have been beneficial. The Odeno, 282 homes to be built in Fruitport is moving along better than expected because of the unexpected warm weather in November. Basements have been started on several lots. It is exciting to see this project progress.

Ayaa continues to make contacts and establish itself with new names and products coming out in recent months.

The Little River Trading Post C-Store will now be placed and run under the LRCR starting January 1st 2018. We are in the process of making those adjustments and thank the Resort staff for their assistance.

With a few hiccups to resolve, the Gathering Grounds area improvements are mostly completed. There are still some issues with electrical services that need to be worked through and hopefully bath house improvements in the near future.

The Next Generation Learning Center continues to grow its number of children served and adjust to the needs of our employees and the community.

Our Pharmacy is now in service. Again, we are working through some details. It is important to know that at this time, there are no changes to your prescription services. There are some misconceptions that are simply not true. There will be a Work Session with Tribal Council sometime after the holidays to address the concerns.

Our downtown Bank Building is now completely leased as are most of our other rental

properties thanks to the work within our Commerce Department.

We are now working on changes to the Currents and the Rapid River News to make them easier to access for members.

I am hoping to give a State of the Tribe report shortly after the first of the new year which could be put on the website. I know some members, including myself, have been having difficulties logging on to the website in which , when you try to log on , the system does not seem to remember your password making access almost impossible. I believe we are coming up with a better system in 2018. Prayers for those tribal members we've lost in 2017 and for their



families. Please pray for those who are going through some serious health issues.

To everyone, please have a safe and peaceful Christmas and New Year.

future of our county's children along with support from individuals who have stepped forward to sponsor one or more students' costs toward the trip is a signal to Onekama's students that their community believes in them and is willing to support efforts designed to enrich their lives."

Litttle River Band of Ottawa Indians Ogema Larry Romanelli said they are always happy to support the children of this area.

"We appreciate being able to do that and of course the local community is part of our community," said Romanelli. "If we can work together both ways it can work so well. Children of course are so important. To watch this happen where they are moving ahead and learning is so important and we are always happy to help."

Manistee Little River Casino Resort General Manager Andrew Gentile said after hearing the classes story they wanted to assist in making the students dream come true for a trip to Chicago.

"When we got the letter and they said they weren't able to go last year we wanted to help," he said. "We have a lot of our team members at the casino where their kids go to Onekama Schools, so it was really important to give back and help the school. It's an important trip and they just told us how much they enjoy communicating with the peer school. The fact that a lot of them haven't ever got out of their community before makes a trip like this important and it would be a big shame if they couldn't make it."




### Accepting bids for a General Maintenance Contractor



#### **Three Sisters Legend**

A long time ago 3 sisters lived together in a field. The sisters were very different in size, shape and appearance. The youngest wore velvet green with beautiful ribbons. She was only able to crawl but with the help of her two older sisters she was able to stand up. The second sister wore bright yellow and loved to run across the fields when the sun was shining. The third sister had silky hair and worn a green shawl. She stood very tall and straight and always guarded her two younger sisters. As different as these girls were they were very close and knew they could not survive apart. Native legend has it that they were known at the sustainers of life.

One day a little boy came and played in the field. The sisters were intrigued by him as he ran around, jumping and yelling. They watched him all day but as evening came on he wandered off. The sisters wondered where he might have gone. One day later in the summer the youngest girl who couldn't stand up disappeared. The two sisters watched and waited for her but she never returned. They began to mourn the loss of their beloved sister.

Once more the little boy returned to the sister's field. Again the two watched as he played and got reeds from the river's edge. That night the middle sister, the one who worn the bright yellow, disappeared. The oldest sister who stood tall, prayed and prayed that one day her and her sisters would be reunited.

As winter grew closer the oldest sister's hair grew dull and her green shawl began to fade. She loved her sisters and knew her survival depended on her being together with her sisters.

One day late in the fall the boy returned to the field and heard the oldest sister crying. His heart ached because she sounded so sad. He picked her up and carried her to his home. There she found her missing two sisters!! Now that they were once again together they were able to sustain each other.

HOW TO GROW A "THREE SISTER" GARDEN:

- Buy the seeds. Make sure you buy pole beans. You also want to make sure the squash seeds are the trailing variety.
- 2. When to plant: Best time is when the evening temperature stays above 50 degrees, usually late May or early June.
- 3. Preparing the garden: Chose area the will get the most daylight, usually 8 hours at least. Work some compost into the soil. First make a mound about 4 feet around and 10-12 inches high. Make 4 holes, about 12 inches apart, plant 4-6 kernels in each hole about an inch deep. Cover kernels and water.
- 4. When corn reaches 4 inches plant the pole beans. Plant beans 6 inches from the mound, plant them 1 inch deep. Cover the beans and water.
- 5. One week after the beans sprout plant 6 squash seeds 1 foot away from the squash plants. Plant them in a hole 1 inch deep. Cover them and water.
- 6. Remember to weed plants so they can grow. Keep soil moist, water often.

After reviewing some general historical information relating to the involvement of indigenous peoples in commerce-related activities, a general review of tribal investments and their risk/reward rankings was made. Specific organizational documents relating to the EDC were also presented for the board to review prior to their first official meeting. Finally, Gary and Sandy Lewis blessed the ceremony with song and Judge Bailey swore in members of the board.

## **LRBOI** Phone Survey

This is an update on telephone survey by Michigan State University. If you see being conducted as we are getting close to completion. We have 36 more surveys to complete. If contacted to participate, please consider taking the survey.

The Little River Band of Ottawa Indians is conducting a personalized survey called the Behavioral Risk Factor Surveillance System (BRFSS) as part of the 2017 Native American BRFS Project. In the past, Native Americans, have been underrepresented in such surveys; this survey will give our tribe a more accurate and fair represen-

The benefits of your participation will be valuable to our Tribe. The data from the BRFSS will be very useful in applying for grants, requesting funds, starting new health programs, and to determine the effectiveness of existing programs. The BRFSS information will give our Tribe a better idea of the community smoking rates, diabetes rates, exercise, and nutrition habits and many other health risk behav-

This survey is sponsored by the Michigan Department of Health and Human Services Health Disparity Reduction and Minority Health and will be conducted a telephone number on your caller ID with a 517 area code, this may be the surveyor from Michigan State University. We hope that you will also help by agreeing to participate if you are called.

## **Food Distribution**

**USDA Income** 

Food Distribution Program (FDPIR) was created by congress in 1977 Food Stamp Act as an alternative to the Food Stamp Program for Indian Reservations. The program offers commodity to low income Native American households. No household may participate in both the Commodity Food Program and Snap Program, but eligible households can switch from one program to the other at the end of each month. Eligibility and participation for FDPIR are based on application and certification requiring tribal status, income and resources qualification, in determining who is eligible for the program. We are federally funded by the USDA and they set the regulations and guidelines for the Commodity Program.







#### **Training Opportunities Through LRBOI & Commerce/Workforce Development**

It is the goal of the Commerce/Workforce Development Program to work in collaboration with each department of Little River Band of Ottawa Indians to increase the productivity of each employee. We will work with any LRBOI department to determine training needs of an individual or a group through different resources available to us.

**Job Readiness Training** consists of resume and cover letter preparation, preparing for the interview, how to correctly fill out a job application, job searching strategy, and other training applications designed to prepare the individual for work and job retention. #### **Development & Training:**

Various training and services as needed for LRBOI Citizens not limited to the following: preemployment drug testing, pre-employment physicals, purchase of bus passes, procurement of drivers record, job interviewing skills, unmet college/university course fees and miscellaneous fees. The maximum amount per applicant that will be paid on their behalf to third party vendors is \$300.00 per calendar year. Access to funding in the Development & Training component is limited to 3 times per tribal member within a 5 year period (up to \$300.00 per calendar year which is 365 days from date of last service).

We will coordinate LRBOI program services with outside agency services to allow for the maximum benefit to the Tribal Citizen.

## Michigan's Arctic Grayling Initiative receives grant

LANSING — The Michigan Department of Natural Resources recently was awarded a \$10,000 grant from Rotary Charities of Traverse City to facilitate a fund development strategy in support of Michigan's Arctic Grayling Initiative.

This initiative, a statewide partnership effort focused on restoring self-sustaining populations of this native fish, was founded by the DNR and the Little River Band of Ottawa Indians in June 2016. The partnership includes more than 40 organizations.

The \$10,000 grant will support grant research and writing by NorthSky Non-profit Network, a management support organization administered through Rotary Charities. The project will include a fund development strategy matching public and private funding sources with project phases and the development of the initial grant applications to secure funding for initial phases of the Arctic Grayling reintroduction.

"This is a tremendous opportunity for our organizations to be a catalyst for



what we hope will be the historic return of the grayling to northern Michigan streams," said Marsha Smith, executive director of Rotary Charities. "We are impressed by the scale of this partnership. This kind of collaboration is exactly what will generate important solutions for our region and all of Michigan." The first stage of Michigan's Arctic Grayling Initiative is expected to take five years of research project development, acquisition of fertilized eggs from Montana and/or Alaska, raising fry (small fish) in a controlled environment, and research to assess acclimation, mortality and other factors.

"Securing this grant will lay the foundation for developing funds from the public and private sources this project requires to move forward," said DNR Fisheries Division Chief Jim Dexter. "This is an effort that needs to be owned by many organizations if it is to achieve its intended historic results."

This is the second of two grants awarded to support the reintroduction of Arctic grayling. The first came from the Consumers Energy Foundation in the amount of \$117,000 to support identifying prime northern Michigan streams for this work.

#### Tribal Member Assistance Information

I have heard and noticed Tribal citizens from outside the 9 County say that you do not matter if you live outside of the 9 County. And that you are not eligible for assistance from the tribe. I will be the first one to say that this is not the case. We have a great Members Assistance team who goes above and beyond trying to help our citizens. Yet, I feel it is either miscommunication or merely given the wrong information that leads people to believe this. So I have decided to take it upon myself to try and find the answers that people need that will assist them in utilizing these programs. I gave gotten in touch with many people who are involved in our Assistance program, be it Food Assistance, or educational, etc. I would like to explain the differences between these programs. When it comes to getting assistance from the Tribe it is basically based on two different categories, you have your Members Assistance Department which is funded through the Tribe, i.e., Emergency Transportation Assistance, Elders Chores Assistance, Food Assistance, etc. These as well as other programs are supported by the Tribe, therefore, everyone is eligible to apply for these programs regardless of where you live. The Education department also has assistance programs available to everyone regardless of where you live. This includes clothing allowance for children, as well as Scholarships assistance. Nine County or not, these programs are open to all Tribal citizens. I believe I need to clear up some misunderstanding when it comes to the Michigan Indian Tuition Waiver. This is a program that is open to all citizens, however, they too have their own stipulations and they are:

- You must be at least 1/4 Native American from a federally recognized Tribe.
- 2. You must reside in Michigan the previous 12 months.
- 3. The School must be a public institution
- 4. And the school must be in Michigan.

Now on the other hand, you have your assistance programs that are from the National Level (Federal). These are usually grants and funds that are provided to Tribes from the federal level and they have regulations to them. One of the regulations being, you must reside in the 9 County. And unfortunately if we do not follow the regulations that come with these funds, we could lose them altogether. This is the difference between the two

assistance programs. I would encourage anyone who is seeking any assistance to contact the Members Assistance Department, Mrs. Linda Wissner. There is nobody more knowledgeable in this area than her. She is always willing to assist you and help you with any misconceptions you may have. If you have any questions regarding Education, then you would want to contact Ms. Yvonne Parsons. She too is an asset that is knowledgeable in the Education area.

I hope this little piece has cleared up any misconceptions that you may have had. I would encourage anyone to utilize these programs that is what they are there for. If you are ever in doubt, just ask. There is no such thing as a dumb question.

# Enbridge Energy, Limited Partnership Integrity Management Program – Line 5 Straits of Mackinac 2017 Coating Inspection at Support Anchor Location Status Update Nov. 13, 2017

As the 2017 safe working season on the water is coming to an end, the following report provides an update of the completion status and findings related to the 2017 coating investigation project being conducted at all of the support anchors along the Line 5 dual pipelines across the Straits of Mackinac. The work has been completed without incident to worker or public safety, crews will soon begin demobilizing for the season, and plans will be developed for continuing the work in 2018.

The core integrity management program encompasses a range of continual inspections, diagnostics and analytics involving a variety of in-line inspection devices, underwater scans, geotechnical evaluations, and monitoring of all operating conditions. As part of the core program in 2017, the dual pipelines were also hydro-tested to the same test level as when the line was originally constructed. The results of any of these comprehensive examinations and safety confirmations from the core program have been previously shared with the State and can be resubmitted if desired in addition to this report.

#### **Coating Inspection**

Crews were mobilized in August 2017 to inspect the pipeline coating on Line 5 using work barges, divers, support teams, and remotely operated cameras (ROV) which provided live feed/recording to technicians on-board the barges. The scope of the project is to examine the condition of the coating at all 128 previously installed pipeline support anchor locations. In 2017, all of these locations have been inspected by the ROV. Subsequently, a total of 48 of the locations have been examined by divers

to gather further data in addition to the ROV inspections.

Of the support anchor sites investigated by the divers, bare metal was discovered at 3 locations (E-10, E-13, W-3 as listed in Table 1). The total cumulative area of bare metal at these locations was 0.831 ft. It was confirmed that corrosion had not occurred at any of these locations.

In addition, at various of the anchor inspection locations as shown in Table 1, calcareous deposits were observed. Calcareous deposits are known in our industry and other industries to be a typical byproduct of the cathodic protection of steel surfaces in marine environments. The deposits are a demonstration that the cathodic protection current is effectively protecting the steel and as it builds up, serves as an additional protective layer on the steel. It is not typical practice to remove calcareous deposits but, as shown on Table 1, some were removed to confirm the conditions of the pipe beneath them and gather samples to study the deposit chemistry. At all locations where the deposit was removed, bare pipe was revealed and it was confirmed that no corrosion had occurred. Calcareous deposits are not considered fully equivalent to a coating system but the risk of corrosion is till effectively managed between the deposits, the cathodic protection system and regular in-line-inspections. As confirmed by cathodic protection reading, the cathodic protection system is working to continually protect the pipe and our plan is to catalogue all calcareous deposits and develop a plan to manage them over the winter. Once again, corrosion has not occurred at any of the locations.

Any bare spots found or intentionally

created through removal of the deposits have been or will be recoated. All but 0.330 ft. of bare area at anchor locations is anticipated to be recoated prior to winter weather in 2017, the time at which work crews will no longer be able to safely access the work site. As previously communicated to the State regarding the Biota Study, which is an examination of the aquatic biota (mussels), the coating has also been investigated at all biota investigation sites. From the biota investigation sites, there were 8 sites in total where either a small area of bare pipe was found or where the pipe was made bare because of intentional removal of calcareous deposit. Of these 8, all but one is expected to be repaired prior to removal of lake bed soil from around the bottom of the pipe prior to recoating. The area of this bare spot is 1.64 ft. and will be protected with cathodic protection and recoated in 2018 once the permit is granted.

The next key step involves the collation and organizing of all data gathered from the ROV and diver inspections. The data will be assessed by both in-house and by third party scientists. The information gathered in this investigation will be incorporated alongside other information gathered from the other core integrity program activities. The evaluation will examine the observations regarding any bare spots and calcareous deposits and assess their relationship to operating conditions, existence of mussels, historic maintenance activities, or other factors that are identified. Beyond this summary update, further reporting will be provided to the State.

Prior to remobilization in 2018, a high resolution in-line inspection (ILI) tool will be launched into both of the dual pipelines

in order to measure for corrosion. The inspection device will provide a millimeter by millimeter full scan of the pipes and will do so for both the external and internal surfaces. The report will be provided to the state.

#### Summary

Coating inspections have been conducted at all 128 support anchor installations. At all locations, the ROV inspection has been completed. Diver inspection has been completed at 48 of 128 support anchor locations. All bare area, either as-found or intentionally created as part of the support anchor investigation as well as the Biota Study, has been recoated except for a cumulative total area that is less than 2 ft. which will be recoated when work resumes in 2018. Of this remaining area, approximately 83 % related to the one biota investigation location where a permit will be required in order to dig the soil at the base of the pipe to apply the coating, No corrosion has occurred at any of the examined locations.



#### Invasive Species Alert - New Zealand Mudsnail



The New Zealand mudsnail is an invasive species that comes to the Great Lakes Region from Europe (Zarakno et al. 1997). It is often found in shallow areas of lakes and slow moving streams with soft mud bottoms and plant growth. However, it is able to stand high flow environments by burrowing into the bottom of streams. The mudsnail is able to outcompete native snails and other macroinvertebrates (e.g., aquatic insects, snails, and mussels), which native fish depend on for food (Benson et al. 2017). A single snail can produce a colony of up to 40 million snails and its shell protects it from being digested by birds and fish. The mudsnail can completely seal its shell, allowing it to survive out of water for several weeks in cool and damp conditions (USFWS). To prevent spreading of the New Zealand mudsnail please clean and dry boating and fishing equipment after use.





The shell of the mudsnail is 1/8-1/4 inch long, has right-handed coiling, and has 5 to 6 spirals separated by deep grooves.

Please report possible sightings of this snail to the LRBOI Natural Resources Department at sbarnett@Irboi-nsn.gov. If possible bring the snail in a small container to the NRD at 310 Ninth St Manistee MI. If not possible include photos, location, time, and date of observation.
