The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on Tuesday, January 28, 2025. Following are the minutes of that meeting.

Speaker Burmeister: Good morning, everyone. We are here this morning for a um emergency open meeting of Tribal Council that has been called by the Tribal Ogema and Recorder Johnson. Um first of all, I'll read in accordance with Article 4, Section 6C of the Tribal Constitution, the business to be transacted at this emergency. It says closed meeting, but it's actually open meeting shall be limited to the specific purposes stated... stated below.
