The contract funds are awarded as part of the 2017 Self-Governance Compact and are for the Rights Protection Implementation Programs.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said this as he mentioned to Council in Agenda Review is actually money from 2017 the Self-Governance Compact with the Bureau. Willis said this money is specific to Rights Protection and Implementation Funding. Willis said part of it is base funding for Great Lakes and the other base funding for Inland Activities under the same Rights Protection category. Willis said they just need to accept the money and amend the Operating Budget. Willis said Tammy Burmeister and he have been working with Frank Beaver to figure out how they are going to spend these funds given the fact that in 2017 they had some Deferred Revenue from 2016 that hadn't been spent. Willis said he sure they will spend the money at some point.

Speaker Riley said to Ogema Romanelli that he had the floor.

Ogema Romanelli thanked him. Romanelli said the first thing he wants to mention is the Cultural Group that he is going to call it that they are looking at. Council and Ogema, looking to re-establish, which he thinks is a good idea, the purpose of the group is his understanding to try and get some more cultural activities regenerated or moving forward. Romanelli said the first one being the Snow snake and the Round Dance so he appreciates the Council in their efforts in that area he thinks is a good thing. Romanelli said once they do that they have to then relook at some departments which he is also doing anyway and that would be Historic Preservation. Romanelli said they have a few of them but that is going to change the dynamics there so if and when this is established they....he will go back and look at the departments to see what they need to do there. Romanelli said he is also having meetings this week on providing clarity of the Next Generation Learning Center and the Pharmacy because while they have them started there is some tweaking that needs to go on as to, for example, snowplowing. Romanelli said who takes care of the snowplowing and who pays for it at their Next Generation Learning Center when they have several different departments or entities in the building so they have to hammer that out. Romanelli said if there is a plumbing problem who pays for it and where does it go or where does it come from. Romanelli said rent and all that stuff has to be worked out. Romanelli said with the Pharmacy there is still a lot of questions as to who it can serve and how it serves the people. Romanelli said again they have to tweak a lot of that so they are working on it. Romanelli said they have meetings set up and as a matter of fact in just a little while he has his first

meeting. Romanelli said he had meetings yesterday with the Leads and then he will have another just go on for the rest of the week trying to figure that out. Romanelli said once they get that a little more sorted out he will get back with Council and maybe need some help from them to understand what the intent was on those two entities. Romanelli said he thinks....he believes it was their intent to make them stand alone to be separate from the government eventually and he knows that they put some money in for both of them to get them started. Romanelli said what the intent is he thinks was to have them be an enterprise or to stand alone. Romanelli said the reason they need to get that squared away is because they have the EDC now so where are they going and try to help them get moving in the right direction. Romanelli said he thinks that is it.

Speaker Riley thanked the Ogema. Riley asked is there any discussion or questions on the Weekly Status & Business Update.

# C. Legislative Affairs Update

Speaker Riley said onto Legislative Affairs. Riley said at this point he just wanted to let everybody know that Councilor Wittenberg is actually out this week on Bereavement, his brother he believed walked on so please keep him and his family in their thoughts and prayers. Riley asked does anybody have anything for Legislative Affairs. Riley recognized Councilor Pete.

Councilor Pete said yes, something very important to Indian Country happened this week. Pete said the Tribal Labor Sovereignty Act did pass the House and it is moving on its way to the Senate. Pete said he believe it has a reasonably good chance of getting to the Senate and no matter how their politics stack up he believes that this President once it gets to his desk will sign it and move forward. Pete said so that is some great news for Indian Country that has at least cleared one hurtle. Pete said it has a couple to go but it is better than losing that hurtle. Pete said that is all he has and thanked them.

Speaker Riley said just to piggy-back onto that. Riley said right now based on a couple of straw polls and asking around that they are about four votes shy of the 60 needed for \_\_\_\_\_. Riley said two that are ones that their people in Michigan have some clout with are Senator Peters and Senator Stabenow. Riley said he would encourage anybody that lives in Michigan to write to their Senators and encourage them and they know, obviously as Democrats they are not going to vote because it has been turned into an anti-union issue which it is not at all but just to convince them to vote so it can go up for a vote. Riley said they know, they don't have to vote yes at that point or whatever just so it has its chance to run through the Democratic Process and not to block it. Riley asked is there anything else for Legislative Affairs. Riley recognized Councilor Crampton.

Councilor Crampton said this is for he think it would be more fitting under EDC but the House of Natural Resources Subcommittee is holding a hearing on HR

4506 and that is the Native American Jobs Act. Crampton said it would provide grants plus funding for a Native American Incubators.

Councilor Pete said wow.

Speaker Riley said okay. Riley said it looks like that is it for Legislative Affairs.
