## Chi Ishobak, Inc. Strengthens Relationship with the Little River Band of Ottawa Indians Chi Ishobak, Inc. Closes First Loan In Manistee, Michigan.

December 22, 2016

**Dowagiac, MI** – Chi Ishobak serves as the Community Development Financial Institution (CDFI) for the Little River Band of Ottawa Indians (LRBOI) as recognized by a Memorandum of Understanding signed by both parties last year.

Chi Ishobak is excited to announce that the first loan has been closed under this agreement. Krystal Davis is officially the first recipient of financing through Chi Ishobak's loan program. Chi Ishobak was able to assist Krystal not only with a necessary repair to her vehicle, but with re-financing that lowered her interest rate and shortened her loan term. "When I found their (Chi Ishobak's) brochure in the lobby of LRBOI, I wasn't expecting them to get me a lower interest rate, affordable payments, and a shorter repayment duration, but you did!" mentioned Krystal Davis. "The loan process was hassle free, professional, and genuine."

Chi Ishobak provides financing for tribal citizens for automobile purchase, repair, re-financing, and credit building efforts. A Commercial Loan Program assists tribal entrepreneurs with capital for small-business start-up and expansion. Technical assistance for personal financial wellness and small-business development supplement

these programs for added benefit. "It is the vision of Chi Ishobak to equip tribal citizens with the necessary resources, skills, and information as to position themselves for financial success," said Sean Winters, Executive Director. "We want strengthen our respective nations one citizen at a time."

Chi Ishobak is a Certified Native Community Development Financial Institution (CDFI) and Michigan 501(c) (3) non-profit organization. It is the mission of Chi Ishobak to provide access to affordable capital for tribal citizens for the purposes of business loans and individual financial development through collaborative and education-oriented lending services while practicing responsible lending to ensure loan capital for future generations of tribal citizens. Chi Ishobak currently provides commercial and consumer loan products for enrolled citizens of the Pokagon Band of Potawatomi Indians and Little River Band of Ottawa Indians. It is the goal of Chi Ishobak to work with every tribe within the State of Michigan.

"Chi Ishobak would love to create this type of relationship with other Michigan Tribes," added Winters. "We are all family and the greater number of tribal citizens we can help will accelerate the benefit across Indian Country."

## Victim Services

### **NEW VICTIM SERVICES PROGRAM**

Recently the Domestic Violence (DV) Program has transitioned to Victim Services (VS) Program located in LRBOI's Family Service Department. In October the tribe was awarded the Violence Against Crime Act (VOCA) funding. This allowed the DV Program to expand services outside of intimate partnership violence to all victims of crime. This funding has also allowed the VS Program to hire two additional full-time Victim Advocates, so both tribal offices will be fully staffed.

The Victim Services Program provides advocacy to a nine county service area which includes: Manistee, Wexford, Lake, Mason, Oceana, Newaygo, Muskegon, Ottawa, and Kent. The program focuses on providing support services that may include; crisis intervention, legal advocacy, accessing local and tribal resources, filing judicial paperwork, transportation, safety planning, filing for assistance through the Crime Victim's Compensation Funds, personal advocacy, and possible financial assistance.

### LRBOI's VS Program has three full-time staff and they are:



Shanaviah Canales is our Domestic Violence Program Coordinator and has been employed in this position since April 2015. She oversees the day in and day out activities with the VS Program and continues to provide services to all nine counties and work

between both the Muskegon and Manistee offices.

Ms. Canales is an enrolled member of the Eastern Band of Cherokee Indians. She has over sixteen years of experience working in criminal justice and social service fields providing services to victims of crime. She has worked in state courts family services, juvenile court, child welfare system, and mental health services. Ms. Canales has her Bachelor's in Criminal Justice and Master's in Human Behavior. She is grateful to LRBOI for giving her the opportunity to expand victim services and provide a more effective and efficient program. Ms. Canales is focused on improving services to the tribal community and collaborating with our neighboring counties.



Melissa Sharlow has transitioned from Intake Specialist to Victim Advocate as of 11/28/16. She will continue to provide services out of the Muskegon office and will be providing advocacy services to victims in the Muskegon, Newaygo, Ottawa,

and Kent counties.

Ms. Sharlow is a member of the Lac Courte Oreilles tribe of Wisconsin, however, she feels like LRBOI and its members have become like her family. She hopes to graduate with a Master's Degree in Social Work in June 2017, and would like to thank the tribe and members for being patient with her sometimes crazy work schedule. Ms. Sharlow is excited to begin her new position and is passionate in the cause to end violence in our communities.



Melissa Holden is our new Victim Advocate for the Manistee office. She started on 11/28/16 and will be providing advocacy services to victims located in Manistee, Wexford, Oceana, Mason, and Lake.

Ms. Holden has a Bachelor's Degree from Central Michigan University in Family Science and Sociology, along with Graduate courses in Human Services through Concordia University. Melissa has worked with individuals and families, assisting them with gaining self-sufficiency, education, and other forms of support for 20 years. She looks forward to supporting crime victims on their path to recovery and healing.



LRBOI's Domestic Violence Task Force are members comprised of LRBOI employees: Laurie Willis (Deputy Court Clerk), Brandi Johnson-Cook (Public Safety Office Supervisor), Spring Medacco (Paralegal), Shanaviah Canales (DV Program Coordinator), Robert Medacco (Public Safety Director), Bill Gregory (Tribal Prosecutor), Jim Grabowski (Detective Sergeant), Mary Witkop (Members Legal Asst. Attorney) and missing from the photo is Matthew Umlauf (Conversation Officer) and Melissa Holden (Victim Advocate).

The DV Task Force is currently transitioning to Victim Services Task Force. We meet every second Tuesday of the month at 9am at the Justice Center. Our goal is to review grant expectations, current victim laws, codes, and ordinances to make sure they are applicable to the current procedures and laws. The task force mission statement is:

To uphold the sovereignty of Native families that have been victimized by providing a coordinated community response to meet the needs of persons affected by crime, promoting effective intervention, enhancing victim safety, ensuring offender accountability, and educating the community to promote understanding of victims of crime.

## **Food Distribution**



Food Distribution Program (FDPIR) was created by congress in 1977 Food Stamp Act as an alternative to the Food Stamp Program for Indian Reservations. The program offers commodity to low income Native American households. No household may participate in both the Commodity Food Program and Snap Program, but eligible households can switch from one program to the other at the end of each month. Eligibility and participation for FDPIR are based on application and certification requiring tribal status, income and resources qualification, in determining who is eligible for the program. We are federally funded by the USDA and they set the regulations and guidelines for the Commodity Program.



### The Legend of Sleeping Bear As Told by Kenny Pheasant

Long, long ago, in a time before the coming of the white man in his ships and sails there was a land of great woods with the tallest of pine trees. This land was near a giant and powerful lake. The land and water had no names then and now we know them as Wisconsin and Lake Michigan. In the woods and along the waters lived many birds, animals, insects and fish. Among them was a bear the Odawa people called Kchi Makwa. One spring Kchi Makwa gave birth to two cubs. The cubs played, found food and grew strong in the woods. When they were thirsty they would drink from the great lake.

But this was a summer like Kchi Makwa had never seen before. The suns seemed closer to the earth, no clouds were in the sky. Each day was hot. Hotter than the one before, and soon the forest became dry. Then one night, powerful winds came, then thunder and lightning from the sky. The lightning struck the dry forest. And immediately a terrible fire began. By morning, Kchi Makwa had gathered her cubs and

took them to the great lake as the fires chased her. But once in the water they felt safe. The land was on fire and the wise mother knew her Forest was no more. Fires would remain for many days and there would be no food for her cubs. But she knew of land across the great waters, much like this with forest and food for all animals.

Kchi Makwa did not know how far away the land was but she knew they must go. So together they swam for two days and nights. The cubs grew weary but still they saw no land. Kchi Makwa urged her cubs to follow but they fell behind. And on the third night, another storm struck and waves stood tall. Kchi Makwa was separated from her cubs. She too was very tired as she seached for her cubs. Finally, she moved on hoping that she would find them on the shores of the Great Lake.

It was the fourth day when Kchi Makwa finally saw the sands in the forest on the land ahead. But her cubs were not with her. She was sad. Kchi Makwa dragged herself on the sands of the beach and shook the water from her fur. She was so weary; she wanted to sleep yet she searched the shore for her lost cubs. When she could not find them she rested, always watching the vast waters but she would not, could not eat. She waited for many days. Her cubs did not come, but still she remained.

Finally one day as the faithful mother waited, the Great Spirit, Manidoo, who is wise and created all things, took pity on her. The Manidoo joined Kchi Makwa and her lost cubs in the spirit world and again the mother and her cubs were happy. The spirit, Manidoo, was so moved by the love and faithfulness he saw, that he raised the two cubs out of the deep waters and made them islands which he named after himself. In honor of Kchi Makwa who waited so patiently, he covered the places where she lay with mounds of sand so that forever all peoples and animals would know the greatness of the sleeping bear.

These islands, sands and waters are homes to people of many cultures, home to insects, the animals, the birds and the fish. Life in the earth, on the earth, in the air and in the water,. And all those who know the story of Kchi Makwa and her cubs know that life is blessed because of her faithfulness and her love.



### MICHIGAN INDIAN ELDERS ASSOCIATION 2017 SCHOLARSHIP NOTICE

The Michigan Indian Elders
Association (MIEA) is pleased to
announce that it will make available
(4) \$1000 scholarships and (6) \$500
scholarships. The scholarships will
be awarded to at least nine qualified
students with the \$1000 scholarships
being awarded to the top 3 qualified
students, as determined by committee
review and lottery, if necessary. Each
student must be currently enrolled in
a course of study at, or have a letter
of acceptance from, a public college
or university or technical school and
must meet the following qualifications.

### **QUALIFICATIONS** – the student:

- Must be an enrolled member (copy of tribal card) or be a direct descendant of an enrolled member of one of the MIEA constituent Tribes/Bands (must be verified in writing by your tribal Enrollment Department).
- Must have successfully completed and passed all five General Education Development (G.E.D.) equivalency tests with a minimum score of 40 and an average score of 45 and must possess a G.E.D. certificate; or must have graduated from an accredited high school with a 3.00 grade point average; or if currently enrolled at a college, university or trade school, must have an accumulated grade point average of 3.00.
- Must, except for special and extenuating circumstances, attend college, university or trade school on a full-time basis.
- Must complete the provided application form and submit it with required supporting documentation and the mailing must be RECEIVED BY THE COORDINATOR postmarked no later than *June 15, 2017*. (PLEASE NOTE, incomplete or late applications will not be considered).

The application can also be obtained from the tribal education department of each of the constituent Tribes/Bands.

### **STUDENT INCENTIVE PROGRAM 2016/17**

A Student Incentive Program is being offered by the Michigan Indian Elders Association (MIEA) to recognize students who achieve all "A's" for a marking period as well as students who achieve perfect attendance for a marking period.

There will be a minimum of \$3,000 available to fund this program this year. An award of \$25 will be made for each qualified entry up to the minimum available funds in the program. In the event that the number of qualified entries exceeds the funds available, the winners will be determined by lottery.

### TO QUALIFY:

The student must be an enrolled member or be a direct descendant of an enrolled member of one of the MIEA constituent tribes/hands.

- The student must be in Grades 1-12 at a public or private school.
  - Home schooling is not eligible.
- A student must be in Grades 4-12 to qualify for the straight "A" award (A-, A, A+).

For a school system that uses a grading system based on numbers, the equivalent to straight "A's" will be acceptable.

- A student must be in Grades 1-12 to qualify for the perfect attendance award.
  - Perfect attendance means exactly that. A student must be in school or at a school sponsored function each day of the marking period. Excused absences for anything other than a school sponsored/approved function do not constitute perfect attendance.
- The first two (2) marking periods ONLY
   of the 2016/2017 school year will be
   used to determine the winners for this
   lottery. A student can qualify for both
   the perfect attendance and straight
   "A's" for both marking periods. For
   example, straight "A's" and perfect
   attendance for both marking periods
   would mean four (4) chances to win.

### PLEASE SUBMIT THE FOLLOWING ITEMS:

- A parent of the student must complete and sign the Student Incentive Program Application Form in order for the student to qualify for an award.
- A copy of the child's report card signed by the parent or a letter from an administrator of the student's school must be submitted with the

- completed application form to verify the achievement of straight "A's" and perfect attendance.
- A copy of student's or parent's tribal identification card.

The drawing to determine the winners will be held at the April 2017 Conference of the Michigan Indian Elders Association.

### \*\*VERY IMPORTANT\*\*

You must follow these directions for your child to be considered for an award. The completed application form (included with these instructions), a signed report card or verification letter of achievement from a school administrator and copy of the student's or parent's tribal identification card must be received or postmarked no later than *March 15, 2017.* Applications received/postmarked after March 15, 2017, will not be accepted; no exceptions. ### **Program Administration**

Our Goal is to serve the needs of the Tribal Members and Departments in terms of:

- Address Changes (300 to 400 a month), Direct Deposits, Cancellations, adding Voluntary Withholding forms.
- Sending out Letters of verification to Social Security, Social Services, Housing Units, Tribal Health Clinics, Casino HR, other tribes
- Replacing Tribal I.D.s.
- Creating Certifications of Indian Blood for Tribal Members, as well as writing letters of descendants to other tribes, or health clinics.
- Creating labels and lists for departments and statistical reports for departments.
- Filling out Tuition Waivers, filling out Eagle Feather requests
- Working with Accounting on Per Cap, constantly inputting information into Tribal Members
   Data Base and Per Cap Data Base.
- Creating a Tribal Directory every two years
- Helping Tribal Members with Guardianships, or helping the Tribal Member find the department that can service their needs.
- Once a year we go to Muskegon Office to service the individuals in that area with forms, taking our I.D. machine there as well as having forms and the I.D. Machine to the Membership meetings.
- Our daily duties are writing letters, answering the phone (almost 500 a month), working on files, and updating information in data base, helping Tribal members who walk in and want I.D.s or other information.
- Administer the Bereavement Program, helping a person through the paper work and working with the funeral home, to make it easier on the bereaved family.

## Programs that the Enrollment Department Administers

### **Bereavement**

The Bereavement Program was created in 2002 as a benefit to all Tribal Members. The amount is \$7,500.

When a Tribal Member passes on, the family calls our department. We then look in the data base to see who the beneficiary is and then our staff works with the family to let them know that they have \$7,500 as well as walk them through this process. We help the bereaved family as much as we can. We are in constant contact with the Funeral Home, so that they are paid first and that all the paper work is completed in a timely manner. We send flowers to the Funeral Home from the Tribe. We contact the different buildings to have the flags lowered to half-mast and we send a letter of condolences as well as a Tribal Flag to the beneficiary. We are here to help them any way we can before and after the funeral.

### Per Cap (Revenue Allocation Plan)

The Revenue Allocation Plan was created in 2008 by Tribal Council. Per Cap is given out quarterly to Qualified Tribal Members who are 18 and above.

The Per cap is divided into two groups, 18 to 54 and 55 and up.

The Elders 55 and up get double the amount given to 18 to 54 year olds.

This is given out quarterly April, July, October and Dec. 15. The Dec. 15 is given early so Tribal Members can use it for Christmas.

The Payroll Department and Enrollment constantly work together to make sure that Direct Deposits are inputted right. Cancellations have been taken care of and addresses are up to date. We constantly work with Payroll and Accounting on problems that may occur.

### **Enrollment Process**

Even though Enrollment has been closed, it is still open to 18 and below children and individuals who were adopted as children.

The process is a person calls us for an application. When we receive the application, a letter is sent to the person telling them we have received their application and how much time I have to work on it. Application is put in a file folder and given to me. I make sure all the documents that we need are in place, and all information is filled out. If information is missing, a certified letter is sent to them telling what we still need.

After the application is processed and completed. A Recommendation from me (Enrollment Officer) is created and put in file. File is presented to the Enrollment Commission at their next meeting for a Provisional approval. If approved, a letter is sent to applicant telling them they have been provisionally approved.

At the next Enrollment Meeting, the Provisional files are presented with other files, a Final determination is made by the Commission, and they become finally accepted.

The applicant receives a letter from us stating they have been finally accepted and they are now Tribal Members. They are given a Tribal Identification Card, a packet with the Bereavement Forms, Direct Deposit forms and a booklet with all the departments the tribe has and what services are available. We tell them to come in to have a picture added to their I.D.s





### **Recruitment for Anishinaabek Stories and Lifeways Interpreters**

### **Project Description**

It is the Anishinaabek legend - the story of the devoted mother bear and her lost cubs from which Sleeping Bear Dunes National Lakeshore's name is based. This fact alone is testament to the importance of the park's landscapes and natural resources to the Anishinaabek of northwest lower Michigan and their ancestors. Yet, little of their story, past and current knowledge of and respect for its resources of the land, is currently part of the park's interpretation. The park has a current project to further develop partnerships with the region's Anishinaabek Tribes by involving Anishinaabek youth in developing interpretive programs using the knowledge of their cultural patrimony and in consultation with their Tribal Elders. From these resources they can share their story and knowledge of this place with visitors through guided trail walks, distance learning programs, social media, and outreach into the local communities. This project will hire Park Rangers and and an SCA (Student Conservation Association) Resource Assistant to be part of the team to help develop this relationship and be a connection to the greater park community.

### **Duties**

The Interpreter of Anishinaabek Stories and Lifeways Park Rangers will work in the park's division of Interpretation and Education.

The duties will focus on:

- Building Partnerships: Meet with members
  of the regional tribes, establish connections
  and engage tribal youth in park programming.


