The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on January 24, 2018. Following are the minutes of that meeting.

Speaker Riley said this is actually a repeat item they had appropriated this before but it wasn't spent before the year was over so it has to be done again.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said Speaker Riley said it very well that this money was part of a larger request at the end of last year to purchase appliances, mailboxes and window coverings for the ten new Aki Homes. Willis said the orders were placed supposedly with Home Depo but some of the stuff didn't show up before the end of the year and didn't get delivered so it needs to be coded to 2018. Willis said this is the remaining amount of the money that is needed. Willis said Frank Figgels is here should Council have any specific questions but they are just asking for the money that was already requested last year.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said this is the first appropriation from the Bureau of Indian Affairs for the 2018 Self-Governance Compact. Willis said they actually estimate in total that they are going to receive \$1.9 million more or less and so they are on their way to meet that mark. Willis said they just need to accept the money and amend the Operating Budget.

Speaker Riley recognized Councilor Pete.

Bill Willis, Budget Coordinator, represented this agenda item. Willis thanked Speaker Riley. Willis said as he indicated in Agenda Review Monday Item #3 and #4 are actually kind of associated with one another. Willis said back in October of 2017 Council authorized the purchase of new fleet vehicles for the Public Safety Department. Willis said those vehicles were ordered but because they weren't delivered in 2017 they can't expense the money in 2017 so they are basically asking Council to authorize the expenditure of funds that were originally scheduled to be spent in 2017 but didn't get spent and to allow them to spend those in 2018. Willis said two of the vehicles have already been delivered just yesterday so they need to pay for them ultimately. Willis said that is kind of what they are doing is reauthorizing money from last year to be spent in this year.

Councilor Di Piazza said no he was going to invite any of them up for a synopses of it other than they are going to increase the wall.

Speaker Riley asked could somebody come up and speak on what the modification....or the improvements are.

Chuck Fisher, Warrior's Society Chaplin, represented this agenda item. Fisher said they did discuss this matter in Agenda Review. Fisher said it has been a long time coming. Fisher said they have been looking at this ever since they started running out of room on the existing stone to add more Veterans. Fisher said the stone is completely full now and they have 15.....18......

Virgil Johnson said they have about......actually they have about eight people they have to put on the new stone or on a stone and they have to upgrade the feathers on the current stone. Johnson said he just wanted to add to this that the casino back in 2017 purchased the stone that they wanted to put the names on however it is not going to be.....that stone was not secured properly on the platform in the area and it was not positioned where it was very feasible by one of the Directors from the casino. Johnson said Mike Burmeister felt they could do a better job of relocating it and also putting a third stone in the future if they wanted to which they have not paid for and this Budget does not cover that item. Johnson said however what it does is allow for them 24 hour lighting on the stone and reconfiguring the Memorial so they have a place to sit and they will also have a position for their third stone for future names to put in there.

Councilor Di Piazza asked are they going by the revised.....

Speaker Riley asked Councilor Di Piazza if he wanted to make the motion.

Councilor Di Piazza said he will make the motion, yeah. Di Piazza said if there is no further questions or discussion he will make the motion.

Pete said this to him is the backbone of this country and theirs so. Pete said he just wanted to thank them for allowing him to make that comment.

Romanelli said he does want to thank the Warriors for not only their service but also the work on this Memorial because they know it is important. Romanelli said thank you so much and nice to see all three of them again. Romanelli said he glad they are still working within the Tribe in one capacity or another. Romanelli said he also wanted to say they are represented here today by the City of Manistee and to the Mayor's Office. Romanelli said he wanted to say hello to both of them. Romanelli asked do they want to say anything or are they just coming by to sit in.

James Smith, Mayor of Manistee, said they are just coming by to observe. Smith said they just had another recent payment from the Revenue Sharing Board and he would like to thank the Tribe for their generosity. Smith said they had made purchases a few at a time but it helps put the safety and welfare of the City of Manistee. Smith said they truly appreciate the relationship that the city has with

the Tribe and their further cooperation. Smith said they like to come by and feel honored to attend and listen to the proceedings of the Tribe. Smith thanked them.

Ogema Romanelli thanked James Smith. Romanelli said they are always welcome and they do appreciate the relationship that they have between the city and the Tribe also they still have the Units of Government that they meet with and they were here this last week. Romanelli said nice to see them both again. Romanelli said he thinks they had several representatives from the Tribe there too. Romanelli thanked them for coming. Romanelli said that is all he had today.

Speaker Riley said alright. Riley asked are there any questions for the Ogema.

# C. Legislative Affairs Update

Speaker Riley asked at this time do they have anything for Legislative Affairs. Riley recognized Councilor Crampton.

Councilor Crampton said just one thing for the Ogema, Happy Birthday.

Speaker Riley said should they all sing for him.

Ogema Romanelli said it is not good at his age because to get up and getting out of bed is a good thing.

Councilor Crampton said the one thing he had to say was there is a case before the Supreme Court Docket called Huera v. Wyoming which is about off-reservation Hunting Rights. Crampton said the last time this was tried from the Mille Lacs Band v. Minnesota and there was a narrow victory for the American Indians. Crampton said that was five to four. Crampton said since that decision the board has changed and only two of the Justices decided with the Natives are still on there. Crampton said they have been joined by some heavy leading conservatives. Crampton said so this is a case that they really need to watch.

Speaker Riley said okay anything else for Legislative Affairs.

## D. Public Comment Period

Speaker Riley said alright Public Comment. Riley said at this time do they have any Public Comments. Riley recognized Virgil Johnson.

Virgil Johnson, Tribal #0336, said he thinks he got it right. Johnson said anyways he just wanted to stop by on behalf of the Warrior's Society, after these two resolutions had passed, he wanted to say Miigwech, Miigwech and Miigwech. Johnson said they really do appreciate their support and it was unanimous. Johnson said it means a lot to all of them and he is going to share this information back to the Warrior's Society when they meet on the first Saturday of February.

Johnson said the other thing he noticed sitting in the audience verses the other place. Johnson said one thing they might want to consider in their meeting is putting name tags in front of each person because in the audience when they have guests here that may not identify who they are and their role and so forth. Johnson said it would be better for them to see that and they can attach a face with the name in front here. Johnson said he thinks a nice little addition to have. Johnson said Miigwech.

Speaker Riley thanked Virgil Johnson. Riley asked anything or anybody else for Public Comment.

The purpose of closed session is to discuss business matters considered privileged or confidential involving consideration of bids/contracts, pending legal issues, and/or personnel matters.

Speaker Riley said he will entertain a motion to end first open at 10:29.
