

# LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL REGULAR MEETING WEDNESDAY, JANUARY 25, 2017 LITTLE RIVER BAND GOVERNMENT CENTER

#### OPEN SESSION MINUTES

The Little River Band of Ottawa Indians held a meeting at the Little River Band Government Center on January 25, 2017. The first part of the Tribal Council Meeting was not recorded until Public Comment. This modification is for the BIA 2016 Self-Governance Climate Change Program.

Bill Willis, Budget Coordinator, represented this agenda item. Willis explained that the Tribe had received additional funding from the Bureau of Indian Affairs under Rights Protection specific to the Climate change Program.

Julie Wolfe, Tribal #1062, commented that this is a good program and that they are doing a good job with it. Wolfe asked how much funding this program has received so far from the Department of Interior.

Frank Beaver responded that the estimated funds for this program are similar and stable to what they have received for the last two consecutive years.

2. Acceptance of grant funds from the Michigan Department of Health and Human Services and approving a modification to the Operating Budget MB-2017-\_\_ in the amount of \$44,500 The Tribe has received a new grant for the Community Service Block Grant.

Bill Willis, Budget Coordinator, represented this agenda item. Willis said the Tribe was awarded grant funding from the Michigan Department of Health and Human Services under a Community Service Block Grant to assist Tribal families become self-sufficient.

Julie Wolfe, Tribal #1062, asked what Tribal members or families would benefit from this program.

Jason Cross, Director of Family Services, responded that the Self-Sufficiency Program and the grant funds assists those seeking employment with utility, rent, transportation, and child care funding. Cross said this grant the Tribe has had for the last three years and it has helped over 50 Tribal families. Cross noted that the grant is income based.

Utility Ordinance #01-500-05, Section 6.06 gives authority to the Utility Department to set a Fee Structure and be posted for 30 days prior to adoption by Tribal Council.

Gary Lewis, Utility Department Director, represented this agenda item. Lewis said these are the upcoming rates for 2017. Lewis said they post them for a 30 day comment period and hold an open meeting for the community before they are adopted by Tribal Council.

Julie Wolfe, Tribal #1062, asked Gary Lewis if he could give a brief summary on what those rates are.

Gary Lewis responded that the rates will be posted on-line and in every Tribal building.

# B. Approval of Update to the Little River Band of Ottawa Indians Tribal Transportation Plan (TTP) Roads Inventory and Long Range Transportation Plan

The Tribes TTP Roads Inventory and Long Range Transportation Plan needs to be updated and submitted to the Bureau of Indian Affairs to include the proposed road for the new Child Care Early Development Center.

Steve Parsons, Planning Coordinator, represented this agenda item. Parsons said as he explained during Agenda Review this is an update to the Roads Inventory that has to be submitted to the Bureau of Indian Affairs for the Little River Band and the road construction that will be going on for the new Child & Family Development Center.

Acting Recorder Di Piazza asked if Steve Parsons could explain what the initials for TTP stand for.

Steve Parsons said he talked about this with Grace Hendler who also asked. Parsons said TTP stands for Tribal Transportation Program verses TTIP that stands for Tribal Transportation Improvement Plan. Parsons said he hopes this clears up any confusion and doesn't make it worse.

Julie Wolfe, Tribal #1062, asked if the funds for the road repair were coming out of the grant for the Child Care Center or if this was additional. Wolfe said she thought the Tribal members were told that the Child Care Center would have no out of pocket expenses from the Tribe.

Steve Parsons answered that the funding will be coming out of the Roads Grant.

Speaker Johnson said he would like to clarify that this is not just a Child Day Care Center but an Early Childhood Development Center and encompasses more than just child care.

D. Authorization of Transfer of Interim Casino Building from the Little River Casino Resort to Little River Band of Ottawa Indians Tribal Government valued at December 31, 2016, Net Book Value

The Tribe recognizes that the Interim Casino Building located at 2840 Orchard Highway is a recorded fixed asset of LRCR and the building has been designated for another use therefore it needs to be transferred over.

Steve Wheeler, Tribal CFO, represented this agenda item. Wheeler explained that the Interim Casino Building at 2840 Orchard Highway is recorded as an asset on the books of the casino. Wheeler said the Tribe has designated the building for another use and needs to be transferred from the books (Accounting Records) of the casino to the Tribal Government. Wheeler said it will be transferred at Net Book Value as of December 31, 2016. Wheeler said Net Book Value means the total original cost plus capital improvements over the years less all of the depreciation that been recorded through December 31, 2016 equals Net Book Value.

Julie Wolfe, Tribal #1062, asked if they could clarify if this had been done before and that she thought it was done prior to the approval to move forward with the Child Development Center.

Tribal Council said no.

Julie Wolfe asked what the approximate value of the building was.

Councilor Crampton responded that the building is worth \$3,487,717.94.

The Natural Resource Commission affirms the applicability and enforceability of all CORA Regulations related to Commercial Fishing on its Tribal members engaged in Commercial Fishing in the 1836 Ceded Territory.

Councilor Medacco said they know about the Tribal History with Commercial Fishing and suggested that it would be a good idea to have work sessions while this is posted to get a clear understanding from all the parties about what should happen so they don't repeat past mistakes.

Councilor Crampton said that even though the posting was going up for 30 days doesn't mean that Council has to act after the 30 days.

Boo Battice, Tribal #2644, said he is also the Natural Resource Commission Chair. Battice said that the records for the previous regulations were not well kept and the commission determined it was better to start fresh. Battice said the commission had started creating guidelines or rules for getting licensed so that it would be a whole process.

Acting Recorder Di Piazza explained that this is a baseline to get something in place and that the commission has taken steps to work on the next guidelines they need in place.

Boo Battice said he is a Commercial Fisherman and thinks he is the only one because he followed the regulations. Battice said that he wants to work with all parties; the Tribal members, the department, and Council to come up with the best way to bring fishing back to their people.

Ogema Romanelli said he doesn't have any names to bring forward for the Election Board or the Binojeeuk Commission. Romanelli said there are no applications and there wasn't a response for the background checks. Romanelli said he has names for the Oversight Committee and will submit those to Council. Romanelli said their Human Resource Department is understaffed and the lack of their report caused the Operations Reports to be delayed because they were not

complete. Romanelli said the Round Dance scheduled for February is not taking place. Romanelli said he is watching for updates.

Julie Wolfe, Tribal #1062, asked for an update on the Shoreline Project and if the land was taken into trust yet.

Ogema Romanelli said they are waiting for the Federal Government. Romanelli said their application is with the Department of Interior now and they know how long that takes.

#### B. Legislative Affairs Update

Councilor Crampton mentioned the appointments for the President's Cabinet with some of them being a little scary. Crampton said also the Patriot Bill is coming forward. Crampton said with the President's Executive Order the pipelines are moving forward and that will be a big mess again.

#### D. Public Comment Period

Julie Wolfe, Tribal #1062, said just that there is a lot of confusion with the election and with the ballots that are coming out to individual Tribal members. Wolfe said they have received three in the mail and they are color coded. Wolfe said they are differently coded and she just thinks it is going to be a hard time for Elder Tribal members to understand. Wolfe said she doesn't know if there is some kind of education piece or something they can send out that the white ballot with the blue strip is the incorrect one. Wolfe said the blue ballot and color linked is the correct one for the primaries and that the Special Election with the green strip on the white card is the proper one. Wolfe said there is so much stuff on Face Book. Wolfe said there is ten pages and everyone is putting something different on there. Wolfe said she just wished their government would be proactive. Wolfe said she knows the Election Board has their own thing going on with this committee and stuff but she wished there was something that could be done to benefit members so that it is more clear and stop this confusion. Wolfe said she had personally promoted voting in public and she got a comment yesterday that the Special Election is not allowed to hand carry their ballots in when the Election Company is here......

Speaker Johnson said to Julie Wolfe that he doesn't want to interrupt.....

Julie Wolfe went on to say.....just re-enforce that they don't use that company again.

Speaker Johnson said to Julie Wolfe that he understands that. Johnson said first of all this is an issue that Council cannot address other than the contract with the company and they can vote on that however on the Policies and Procedures on how the Election is overseen and run is not done by Council but by the Election

Board itself. Johnson said this kind of issue needs to be addressed in front of the Election Board and not Council, okay.

Julie Wolfe said well she is asking her government to put out some clear communication out for the benefit of members so it is a good election and is not asking them to change the electoral process. Wolfe thanked him for his response. Wolfe said she had a second comment. Wolfe said oh, she has it on here. Wolfe said as everyone knows they had a Tribal member that did have an accident recently and is in Munson Medical Care. Wolfe said there is a fundraiser for Jamie Friedel of the gas station that is happening on Friday, February 3<sup>rd</sup>, from 4:30 to 7:00 p.m. and she is involved with that as a Tribal member taking donations for the Silent Auction so......

Speaker Johnson said they know she is involved with it but this is coming across as a campaign issue. Johnson said all she has to do is announce the individual that they are having a thing there but she doesn't have to say that she is doing it, okay.

Julie Wolfe said she was letting the community know that she was the person taking donations but if that is campaigning to him she apologizes. Wolfe said she apologizes to the membership because that wasn't her intent. Wolfe said her intent was letting people know she is available.

Ogema Romanelli said he wanted to answer the information that goes out from the Election Board about the ballots has to come from the Election Board and they have the venue that they would use probably would be with either the Currents which is a slow process for the way the elections are going or the Rapid River News. Romanelli said if they don't get the information from the Election Board it shouldn't be them who is putting the information out because they might put out the wrong information. Romanelli said he knows there is some stuff on Face Book that has been incorrect or at best and there was some information that was going out so they would suggest that the Election Board put out any information if there is clarity that is needed. Romanelli said he knows they are under a lot of stress with the double or triple, whatever they want to call it, elections so that is hard. Romanelli said he did meet with the Election Board he thinks last week on a few of these items and talked to them. Romanelli said he also.....the suggestion has been made that maybe the Election Board should do a separate mailer and a separate paper of sorts aside from the Currents. Romanelli said there was a snafu that happened and it was.....his understanding resolved depending on if they are looking at Face Book or go to actuality the situation was resolved. Romanelli said his suggestion was that they probably....the Election Board do a separate mailer so it is just election information. Romanelli said it is a little more costly that way and the Election Board let him know that it is very costly to do so but because there is always this underlined informational thing he thinks it might be.....he made the suggestion that they do a separate mailer. Romanelli said they did meet on different things such as the company in question because there is

information put out that is incorrect, in his opinion, and he knows that there are other Tribes that use this company and sometimes they ask for three submissions from different companies. Romanelli said he thinks in this case there aren't 20 different companies that they can utilize and they discussed that too. Romanelli said he will let the Election Board speak more on that. Romanelli said that is it for that but now he had another separate issue that came up last week regarding the adoption process. Romanelli said he did speak with the individual afterwards and he called and wanted his consideration of the adoption process in specific. Romanelli said he told him to go through.....they know.....he talked about the closing of Enrollment and again, it has been done and there aren't too many options that they can do. Romanelli said he could put forth some kind of a request to reopen it which is not an easy task and there was some other things that they talked about. Romanelli said he answered him and they had the discussion but he is not sure that he was okay with his answers but he gave the best answers that he could. Romanelli said there were also comments that were made last week that it seemed to.....he hoped.....would not leave the impression that their Enrollment or their Tribe does not handle elec.....the adoptions properly or that there is some people within the Tribe that shouldn't be there because of something illegal or improper. Romanelli said he just wanted to assure everyone that their Tribe and through their Audits is one of the Tribes that are best handling Enrollment Information. Romanelli said they are absolutely audited on a regular basis and that from every indication that he has they are absolutely okay. Romanelli said aside from that they also had..... a while back......Tribal Council did pass a resolution of Certified Enrollment which basically says from that point on it doesn't matter which way they go so he just wanted that cleared up.

Councilor Crampton said yeah most of the comments came from him speaking with Patrick Wilson and he thinks a lot of people got the wrong idea of what he wanted to explain to him. Crampton said basically it was what Ogema Romanelli said but that in order to open the Enrollment it takes a referendum of the membership and one person can start that referendum.

Ogema Romanelli said that is correct.

Speaker Johnson said okay any other public comments.

Boo Battice, Tribal #2644, said this is just informal and to the best of his knowledge the money that was spent for the fishermen was set aside by Consumers Power and that is why they are for WF from 07 and 08 is because they allocated that for that power plant for the fish that was sucked up which is why. Battice said so they are not going from any other source and another thing to the best of his knowledge is the contract is coming up pretty soon. Battice said if there is anything left they should show that they are use it that way when the negotiations come up they can justify that they may need more help to carry on at least through 2020.

Julia Nickelson, Tribal #0384, said she would like to know why so many Indians....they are not quitting because they have to they are getting wrote up so they quit then. Nickelson said they know that they are going to get fired the second time. Nickelson asked why doesn't the Council look into this and see why just the Indians are getting wrote up because a lot of them call her.

Speaker Johnson said to Julia Nickelson that he is going to try to respond because she is asking the question towards Council. Johnson said personnel issues is something that Council does not address because they are Legislators and write regulations and so forth. Johnson said when they deal about personnel issues that has to be handled especially when she is talking about the Executive side. Johnson said the Executive, the Ogema, and his staff have to address those issues. Johnson said they only have two people currently who work directly to Council that they handle under personnel issues so they do not address that at all. Johnson said he has Councilor Crampton then the Ogema.

Councilor Crampton said he believed that Julia Nickelson is talking about the casino and doesn't think she is talking about the Government Building. Crampton said that Council doesn't have that power and they didn't have that power before because they didn't have Primary Management Official Licenses but now they have Council members who will be going on the new Oversight Committee and the Oversight Committee will have the power to look into issues like that.

Julia Nickelson said yeah something should be done because give it back to the Indians.

Ogema Romanelli said personnel issues are very complicated and quite honestly he doesn't think that employees that are in that situation should be making phone calls because that can lead to misinformation again. Romanelli said there are processes that they have in place and again the Oversight Task Force allows for some but that won't give them what is being asked here. Romanelli said he doesn't believe it will be the Council that has the oversight of all of the hiring at the Resort just the management.....General Manager. Romanelli said the General Manager can be asked for example and get some information from there but it won't be the full ask every time there is somebody that is gone.

Speaker Johnson asked are there any other public comments.

Councilor Crampton said he just wanted to add to that issue. Crampton said the issue that Julia Nickelson is talking about is basically a standard issue that exists in almost all corporations. Crampton said that if a Director sees somebody coming up that they know they are going to replace their job they automatically start finding a problem in that person, saying something is wrong with them, and getting rid of them essentially because they might be taking their job. Crampton said no industry is immune to that but the allegations are here and it does need to be looked into and it will be.

Speaker Johnson asked are there any other public comments.
